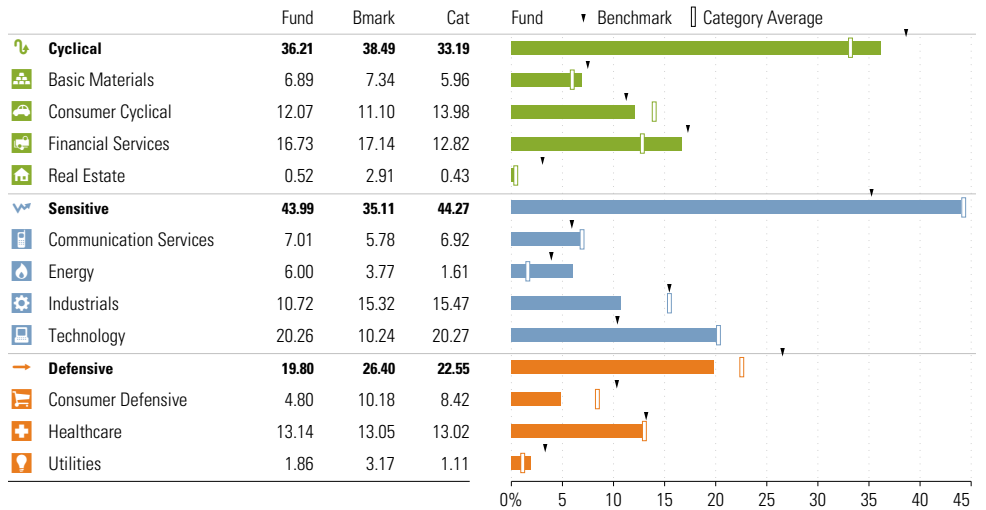

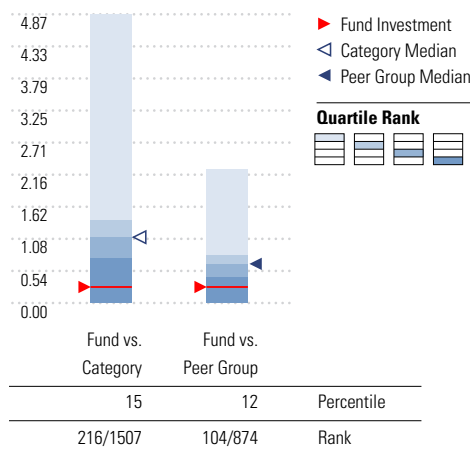

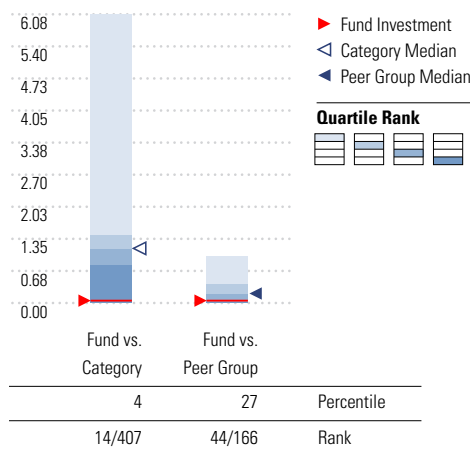

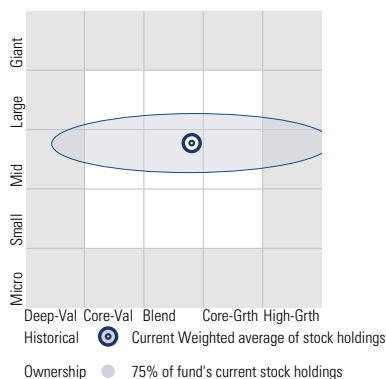

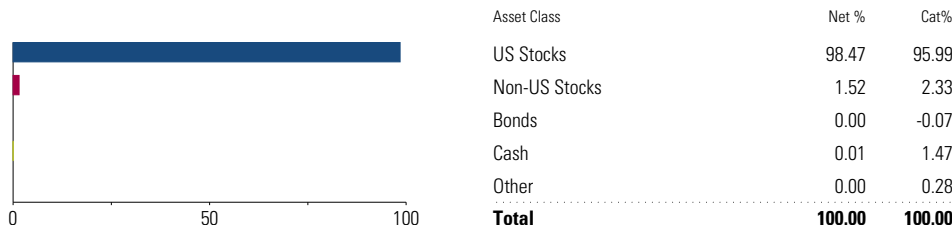

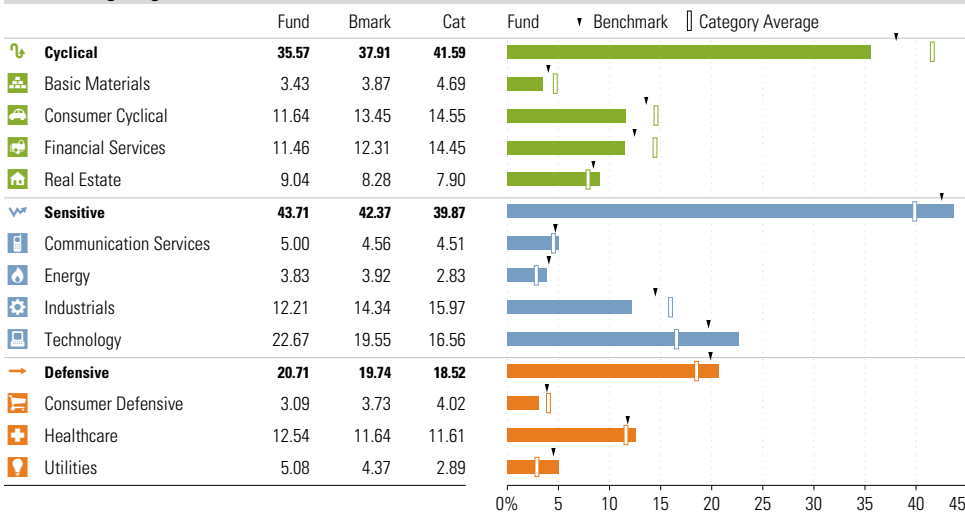
Style Breakdown

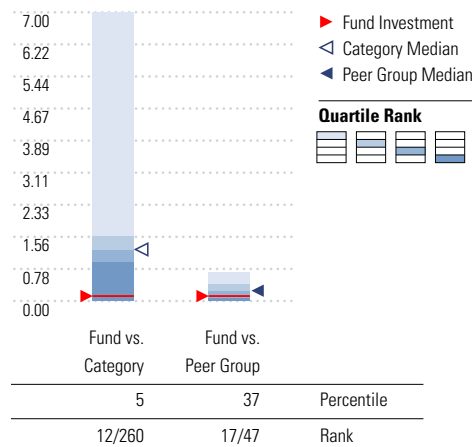

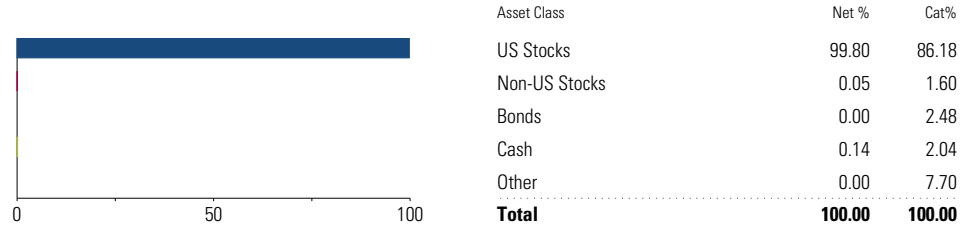

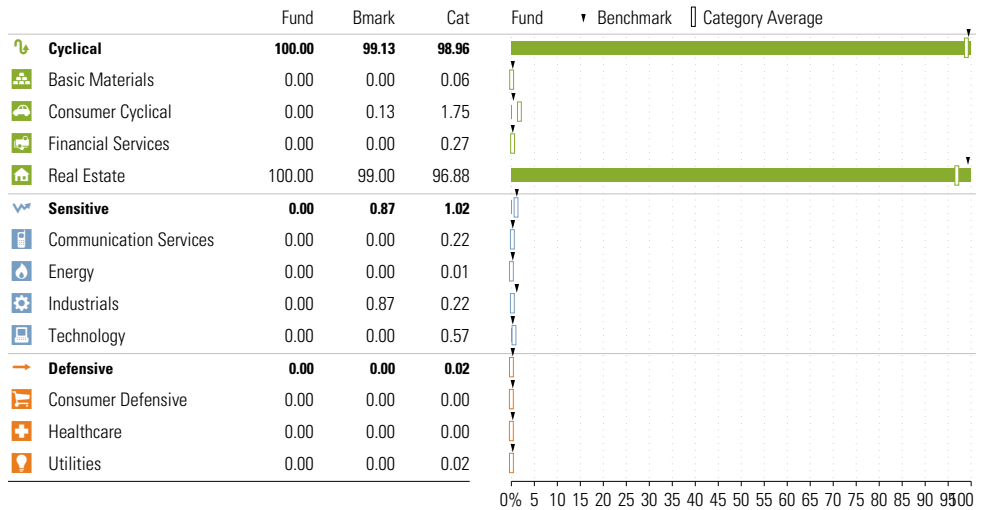
Style Breakdown
