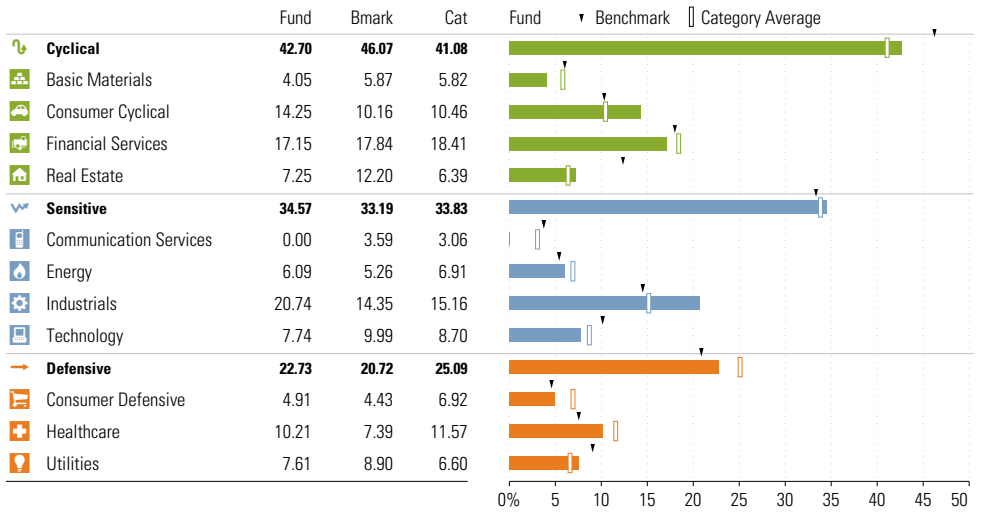

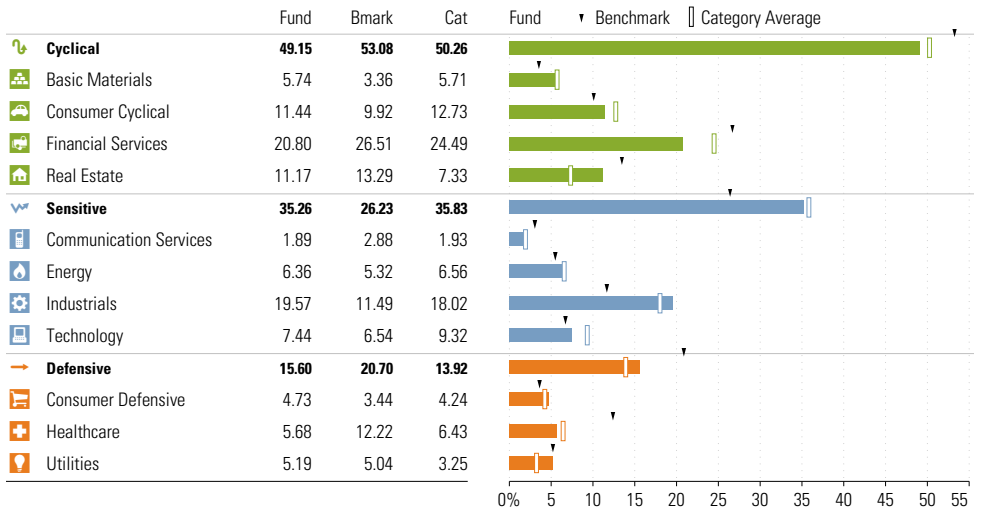

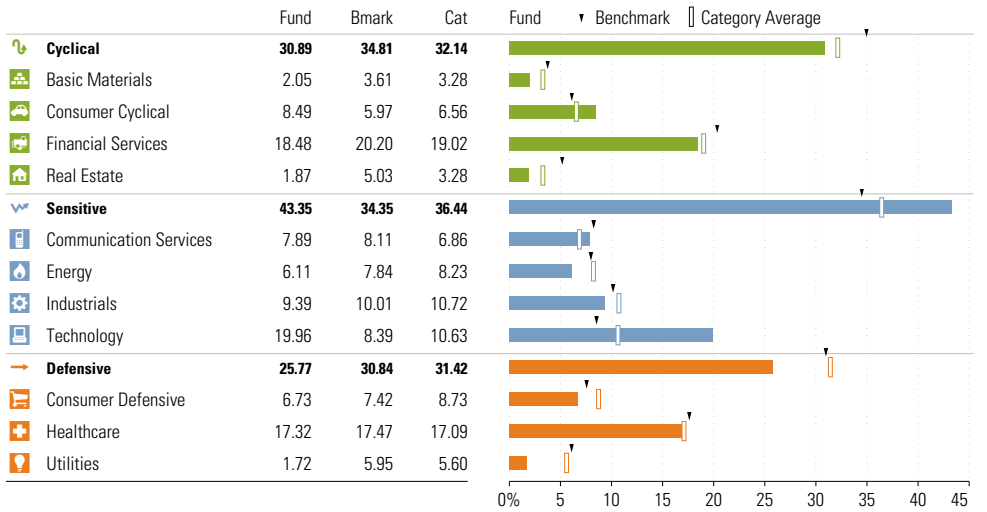
Style Breakdown
