The fund can take on up to 40% of assets in high-yield corporate debt and up to 20% in equities. With this enormous flexibility comes heightened volatility, and although over the long term the fund has achieved solid returns in exchange for that volatility, we are skeptical of that tradeoff, given the fund's multisector bond Morningstar Category.

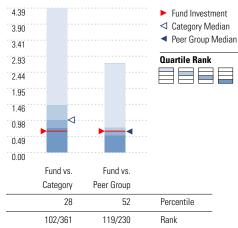
