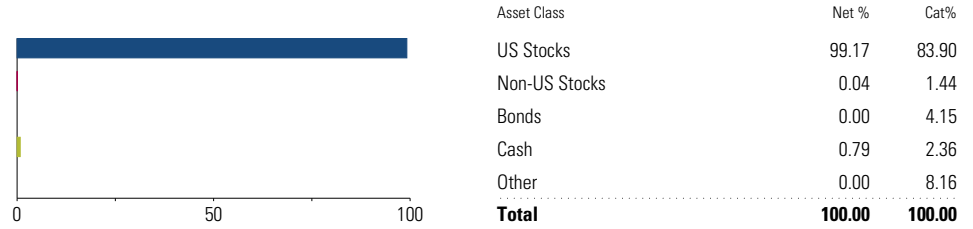

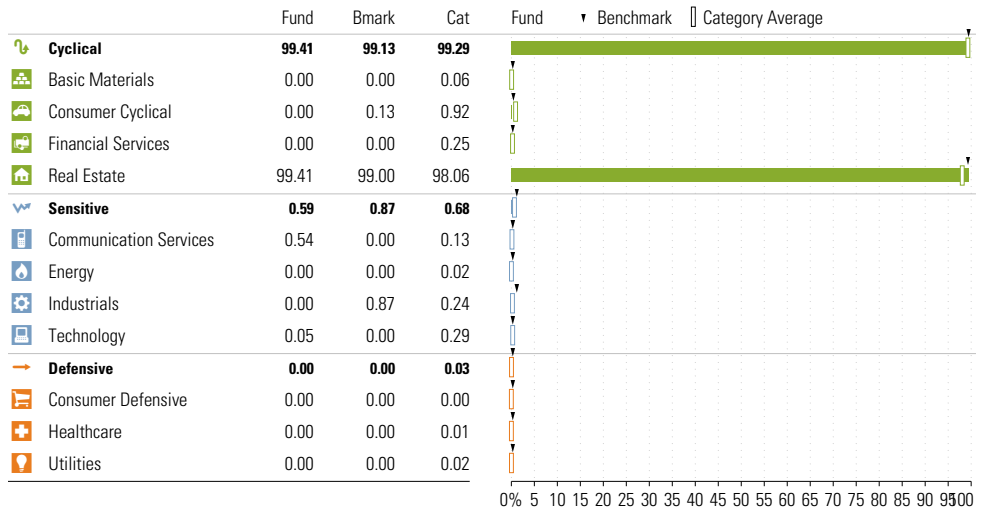

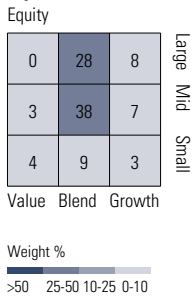

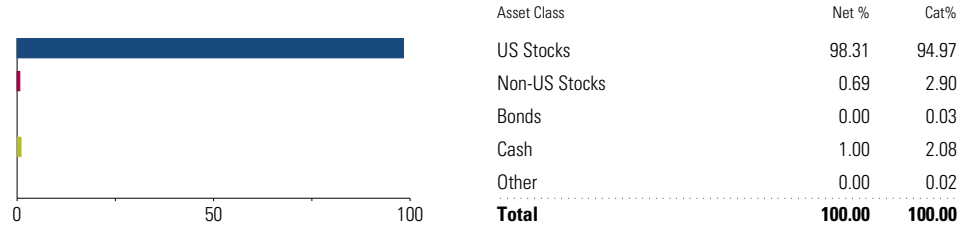

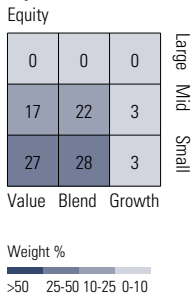

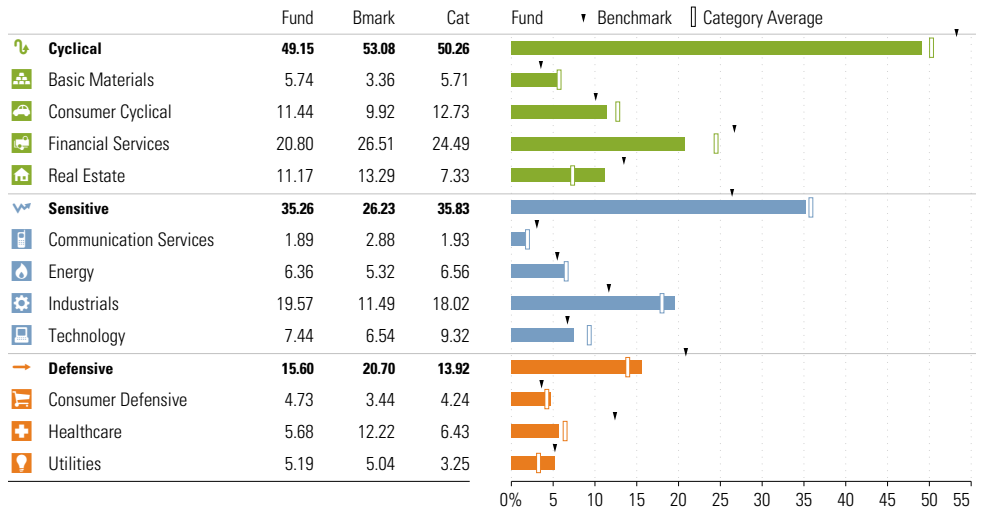
**Asset Allocation** as of 09-30-2022
