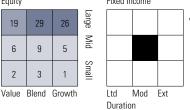


Asset Allocation as of 09-30-2022

Vanguard Target Retirement 2030 Fund VTHRX Asset Allocation as of 09-30-2022

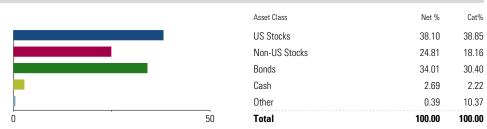
