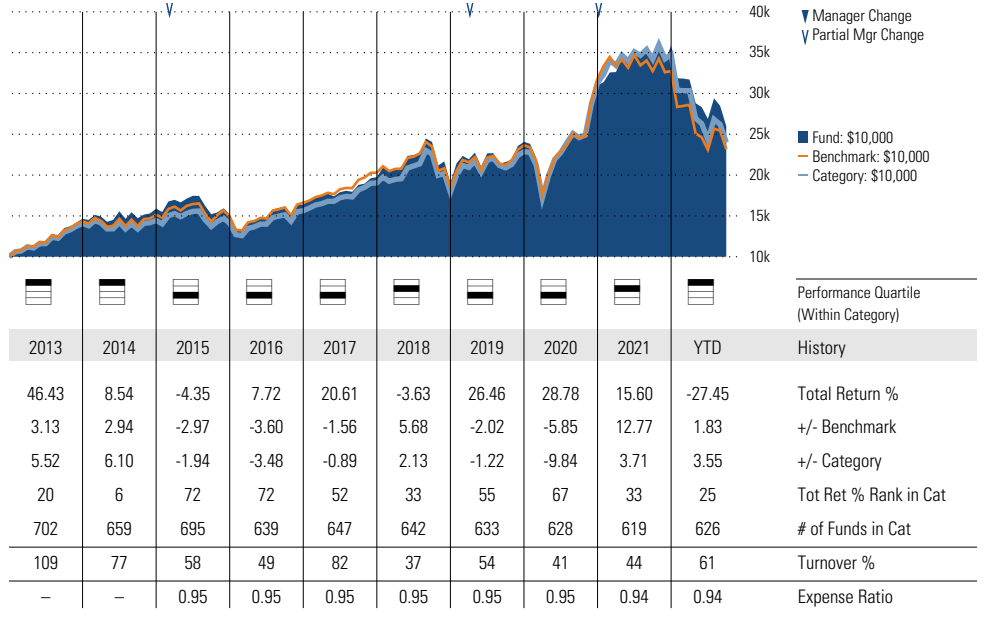

## Growth of \$10,000



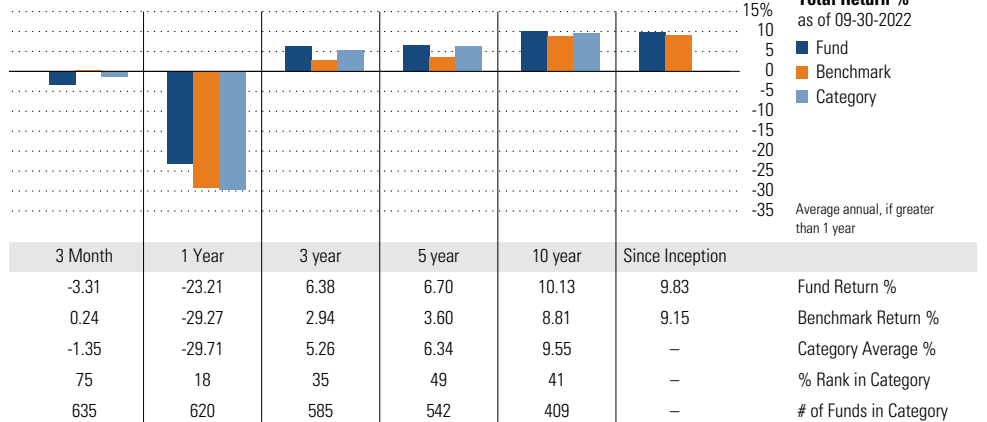

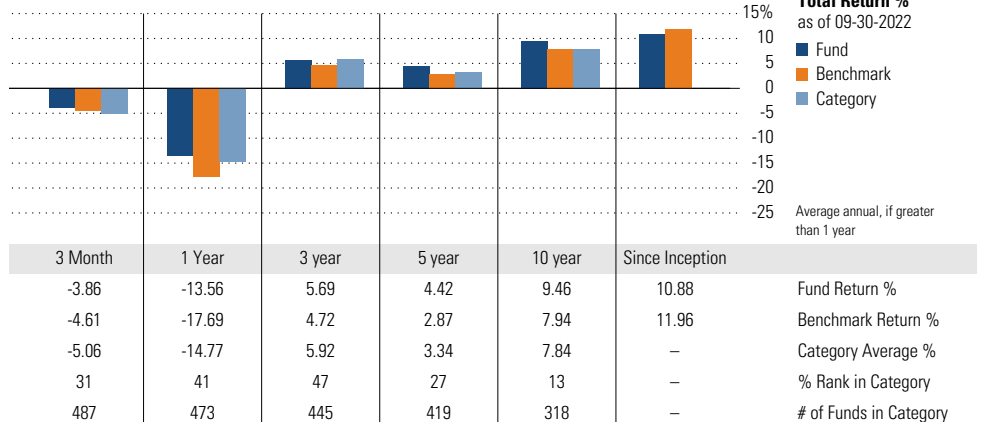

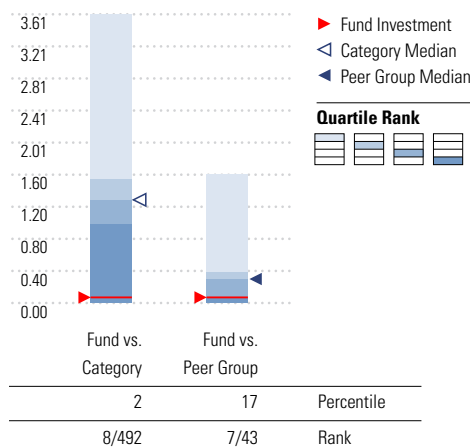

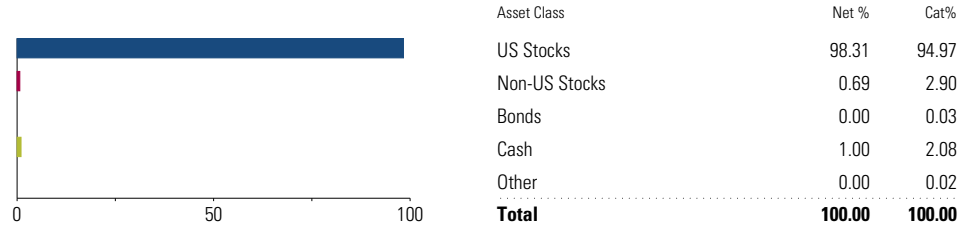

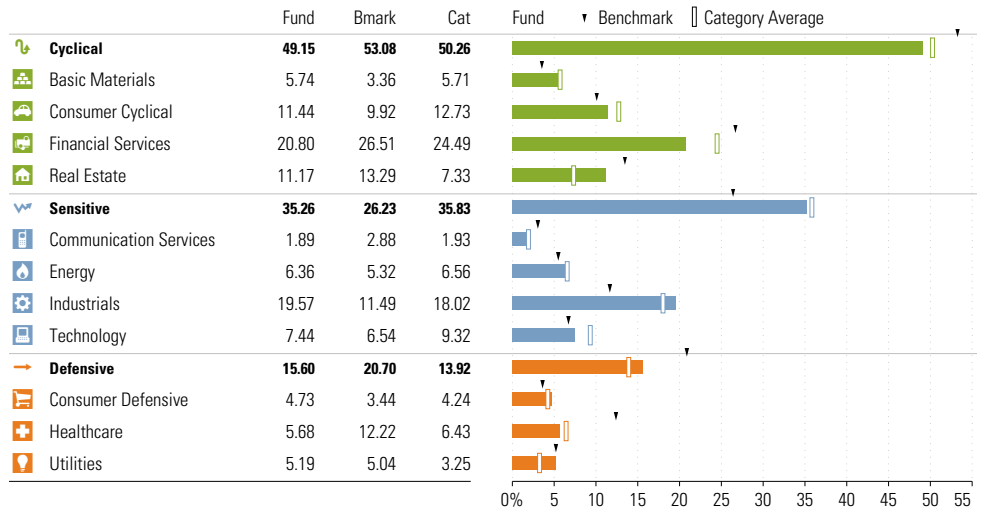

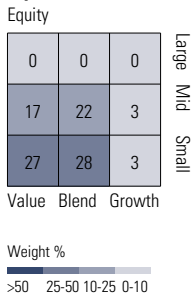
## Asset Allocation as of 09-30-2022
