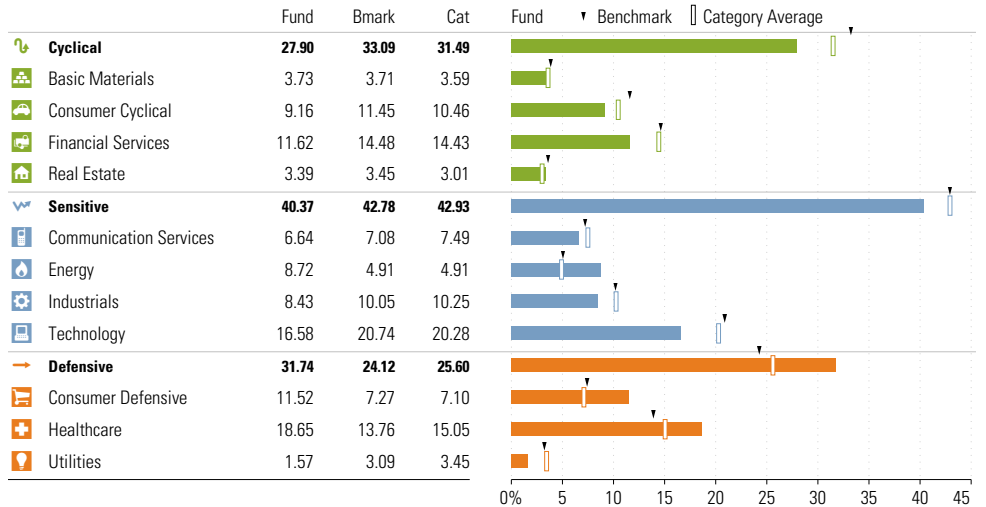

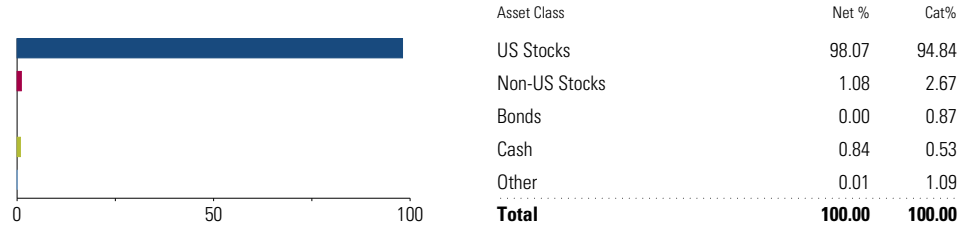

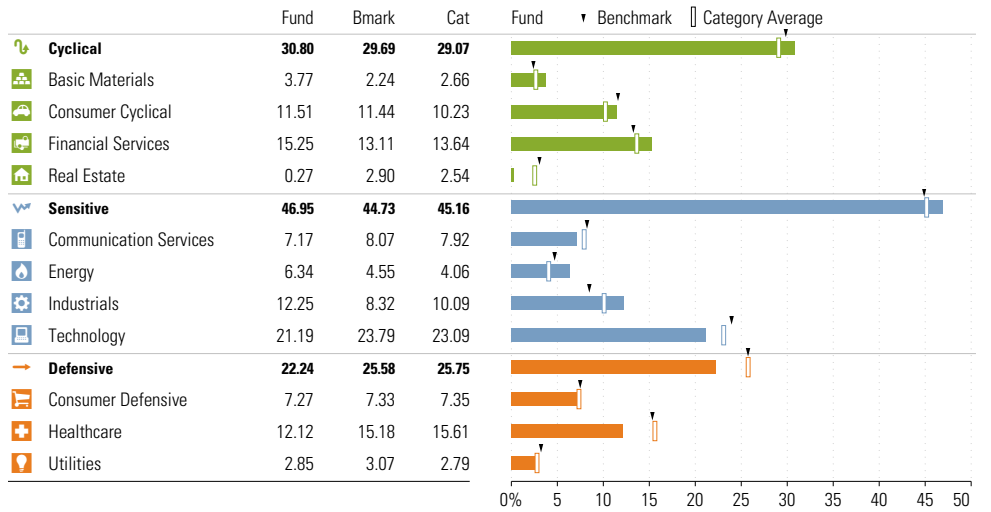

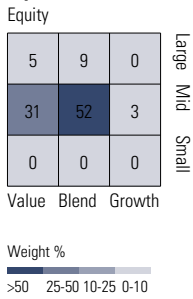

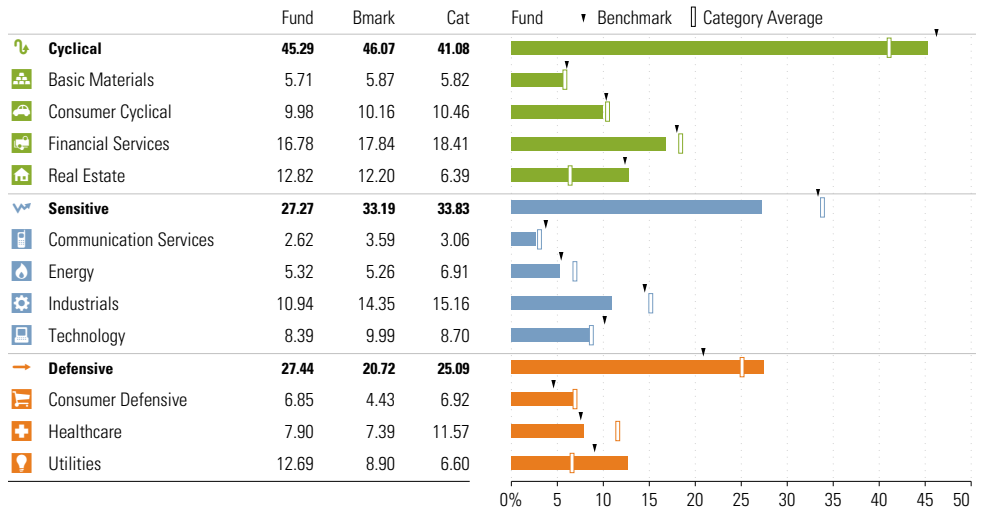
Asset Allocation as of 09-30-2022

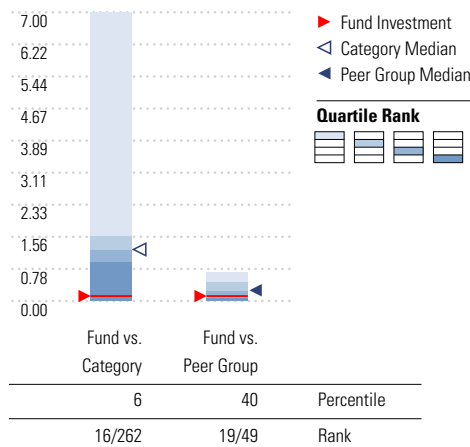

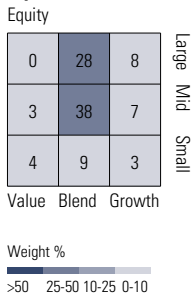
Asset Allocation as of 09-30-2022
