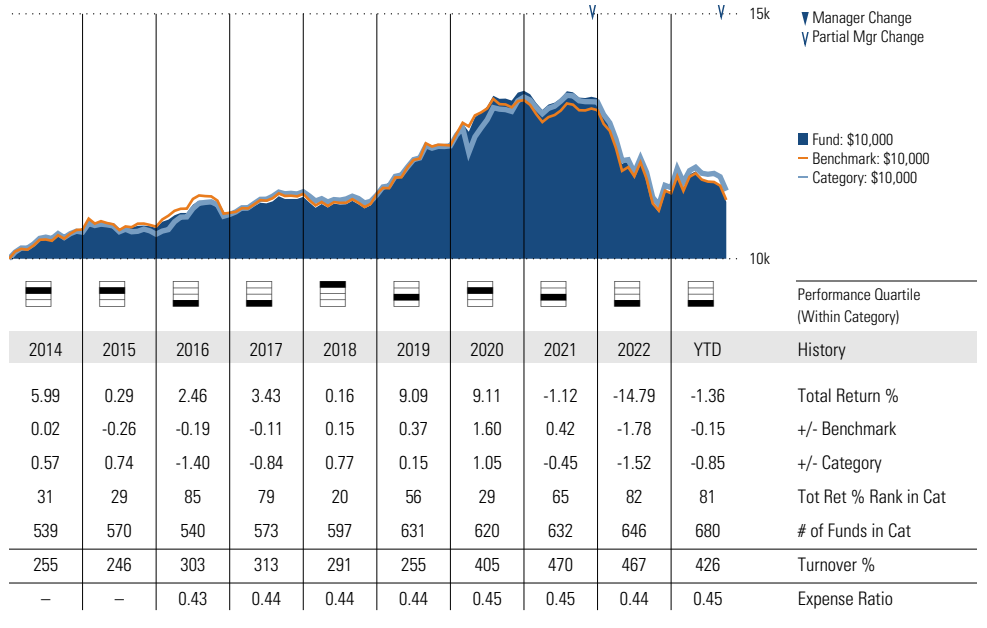
## Morningstar Investment Management LLC Analysis

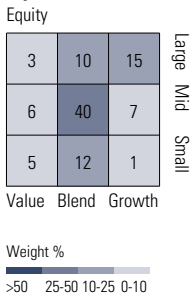
