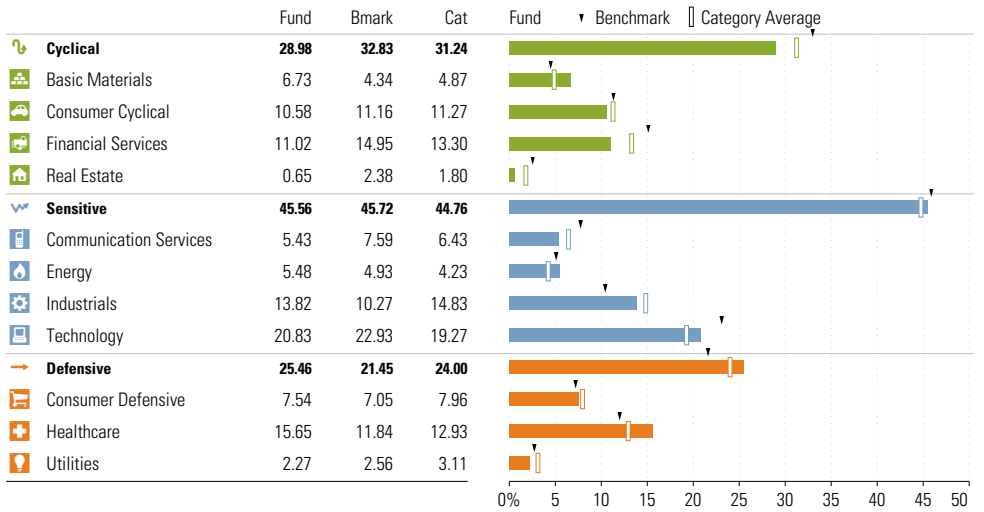

Growth of \$10,000



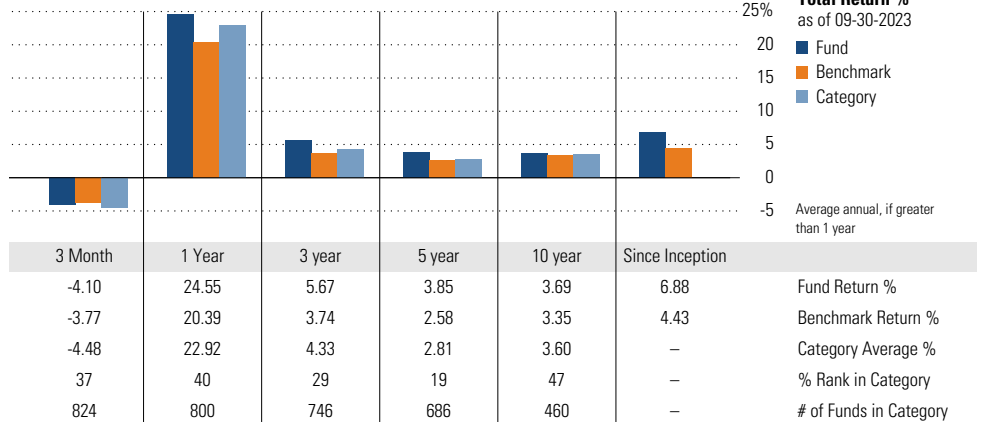

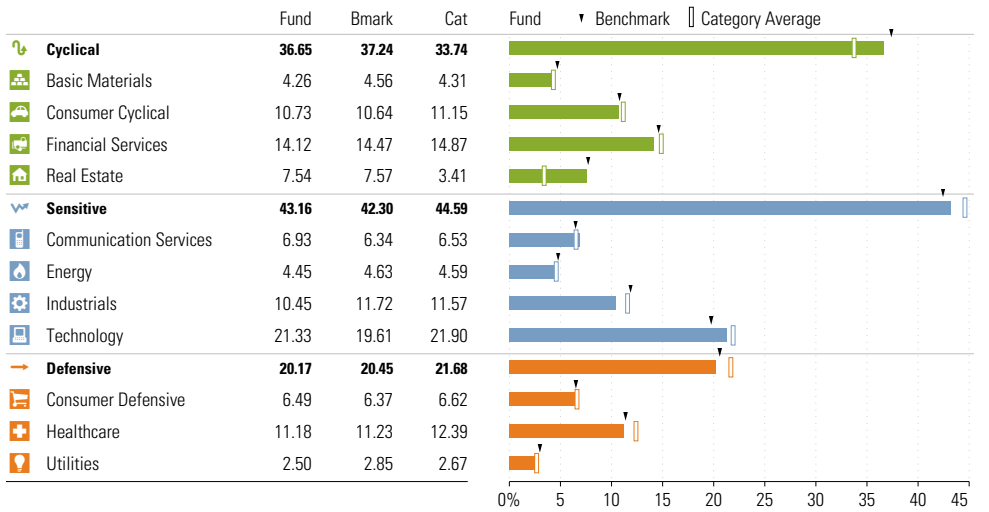

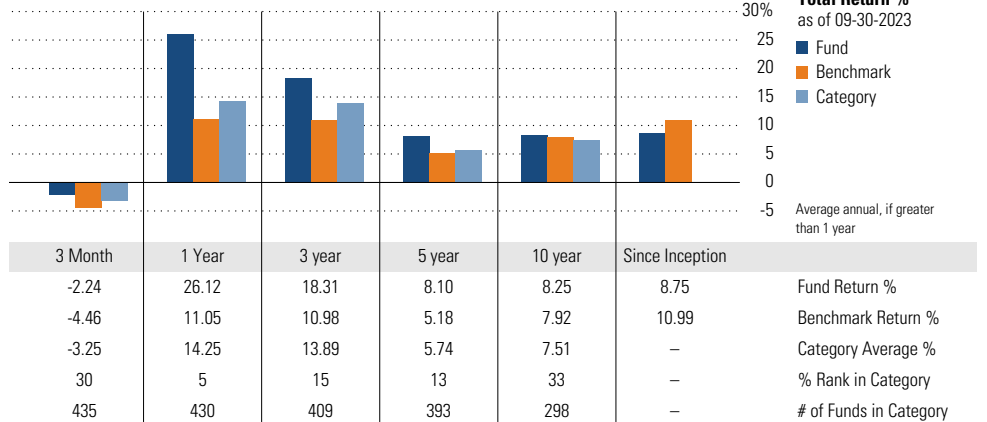

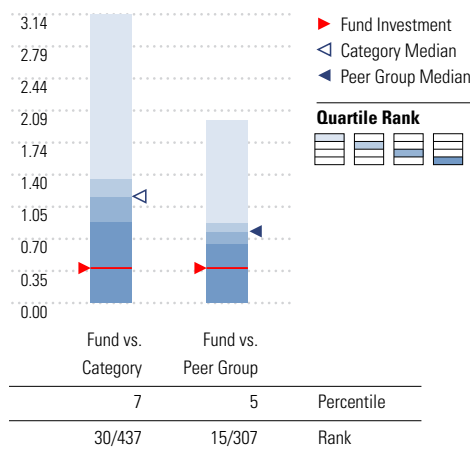
Growth of \$10,000

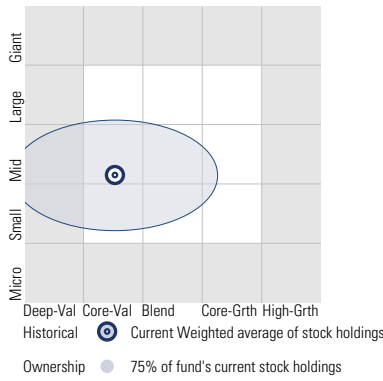

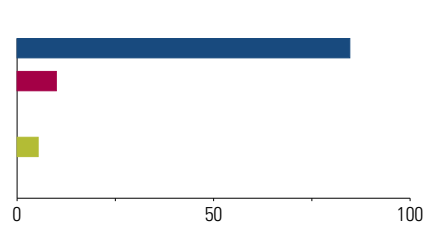

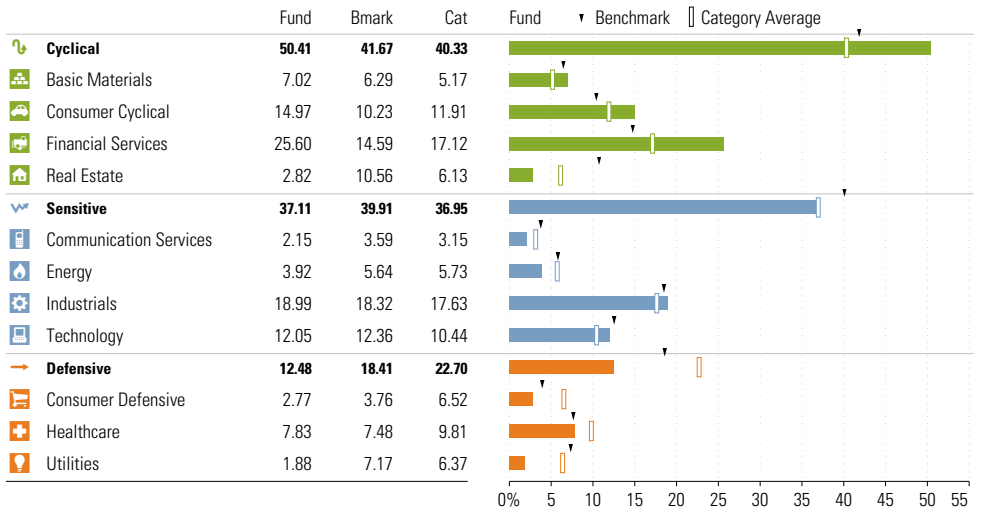


Asset Allocation as of 09-30-2023

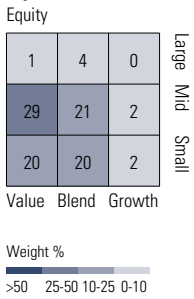
