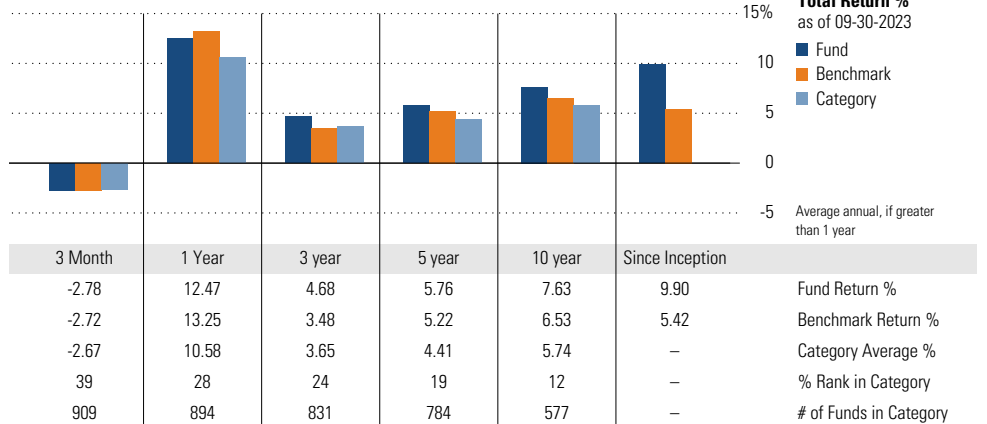

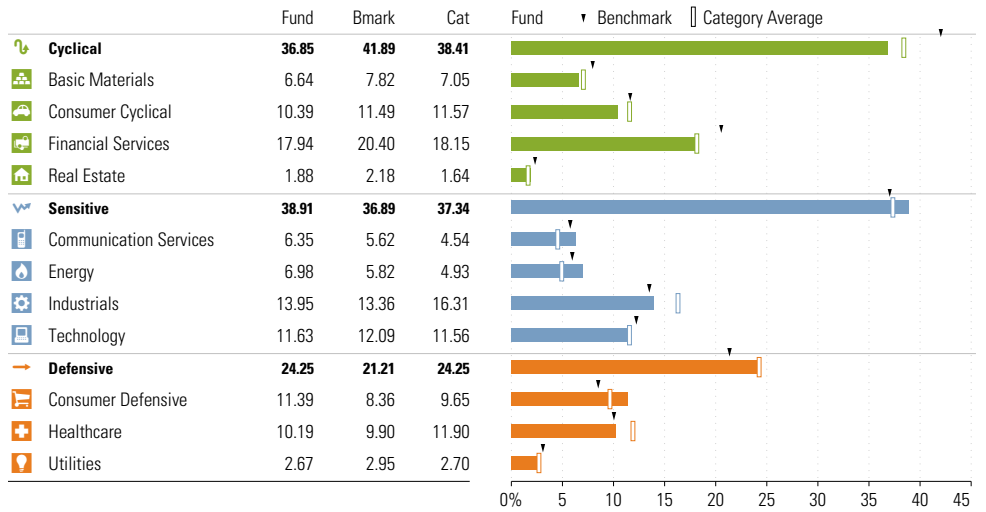

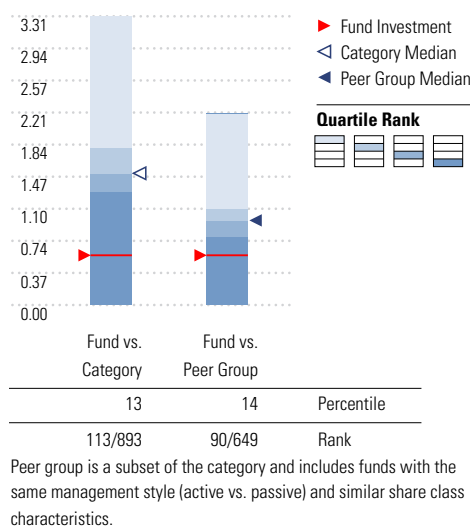

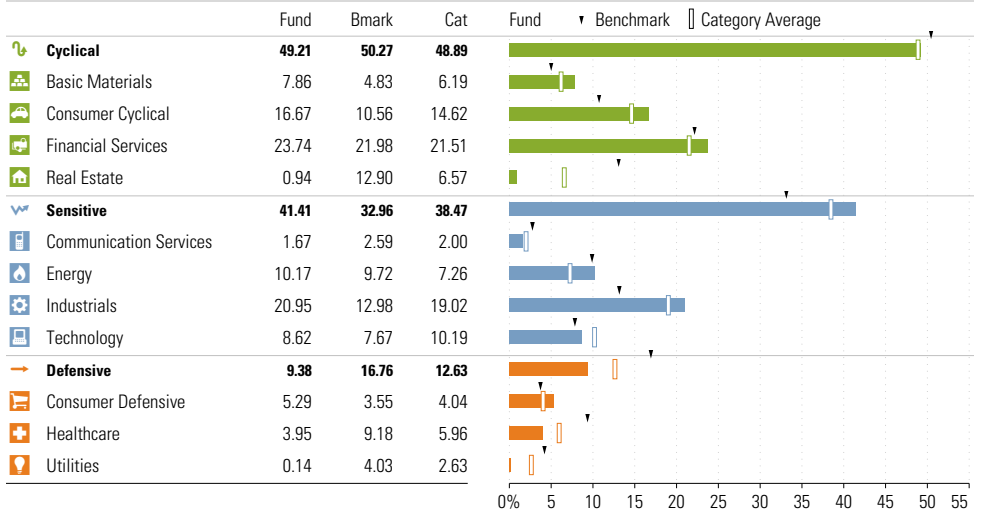

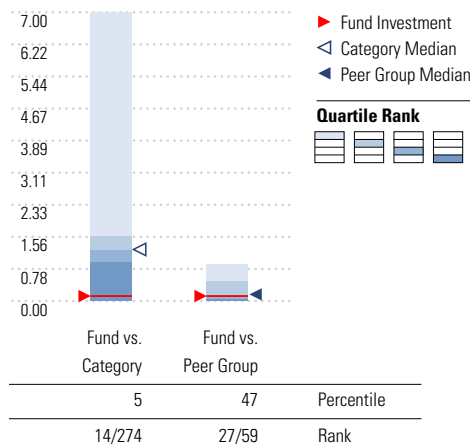

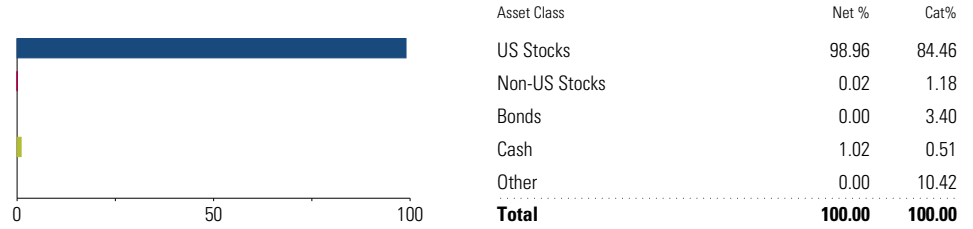

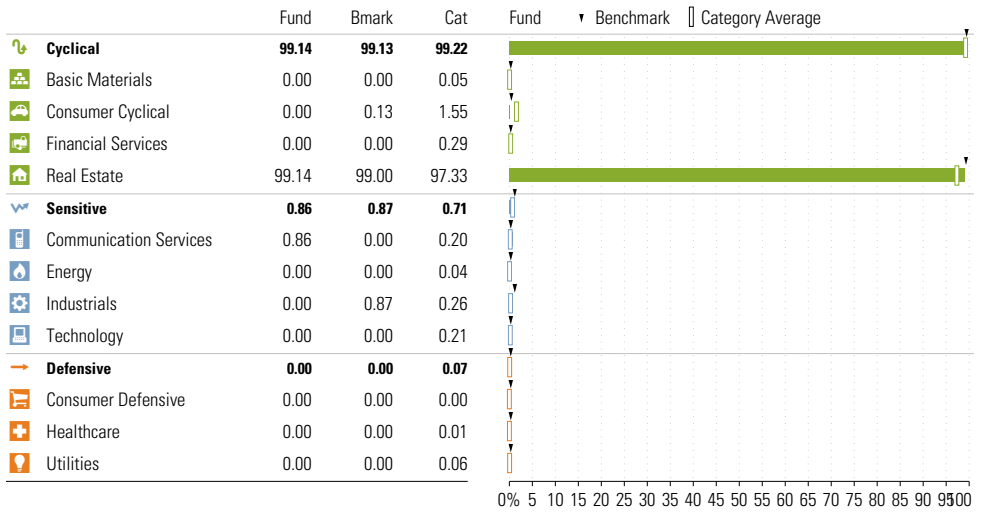
Style Breakdown
