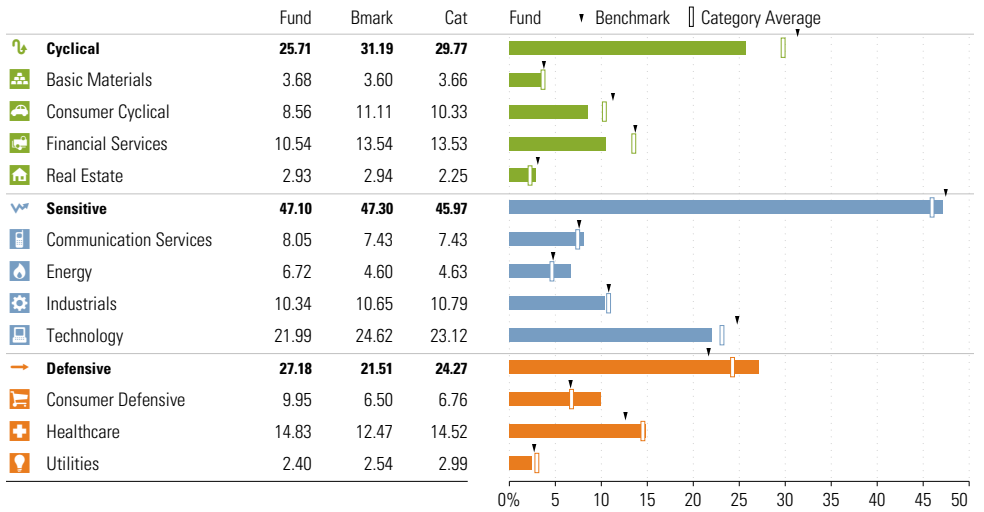

Growth of \$10,000



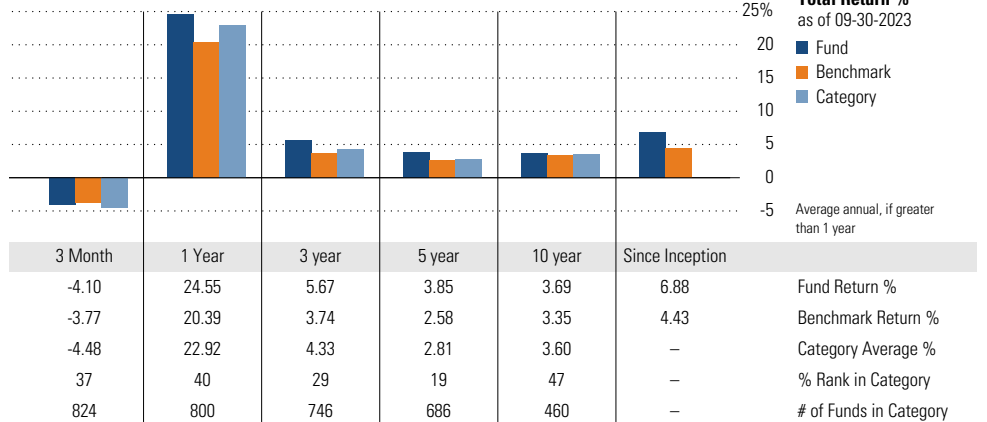

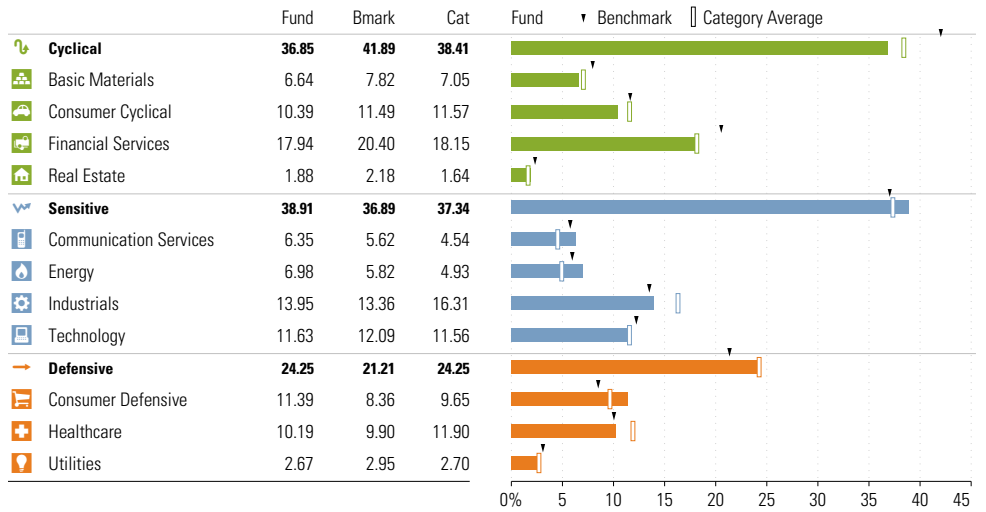

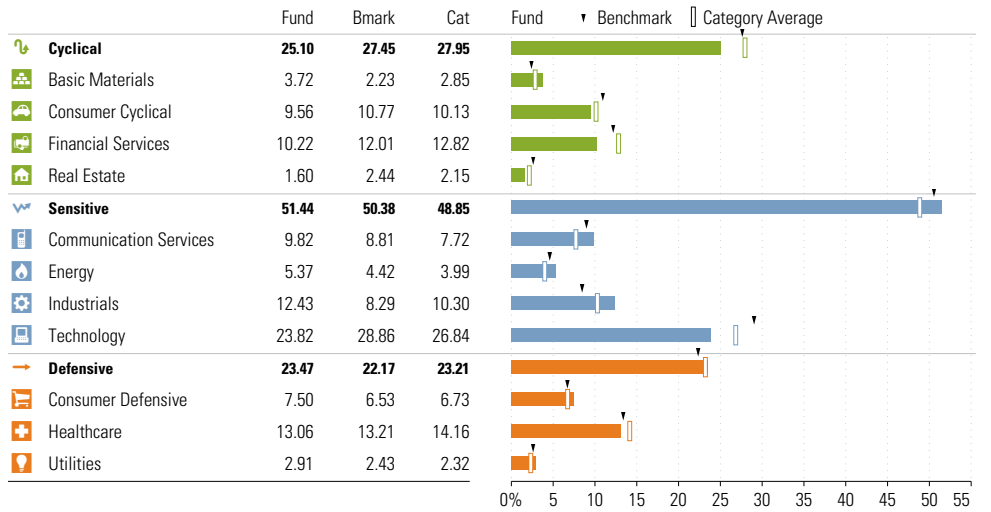

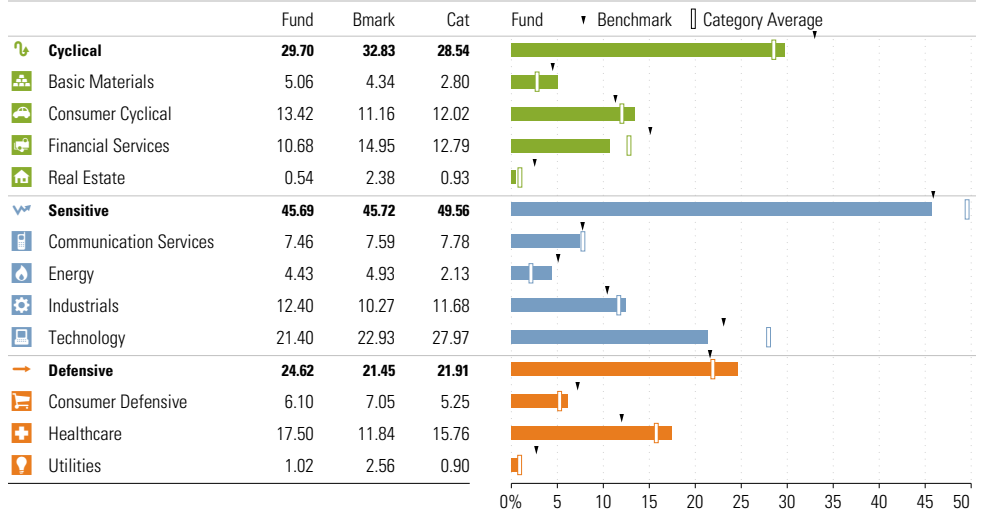

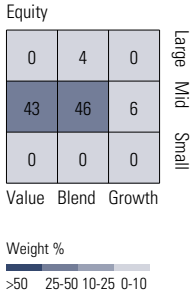
Asset Allocation as of 09-30-2023

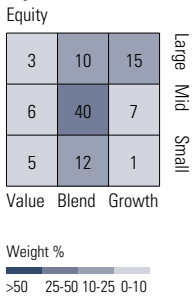
Asset Allocation as of 09-30-2023

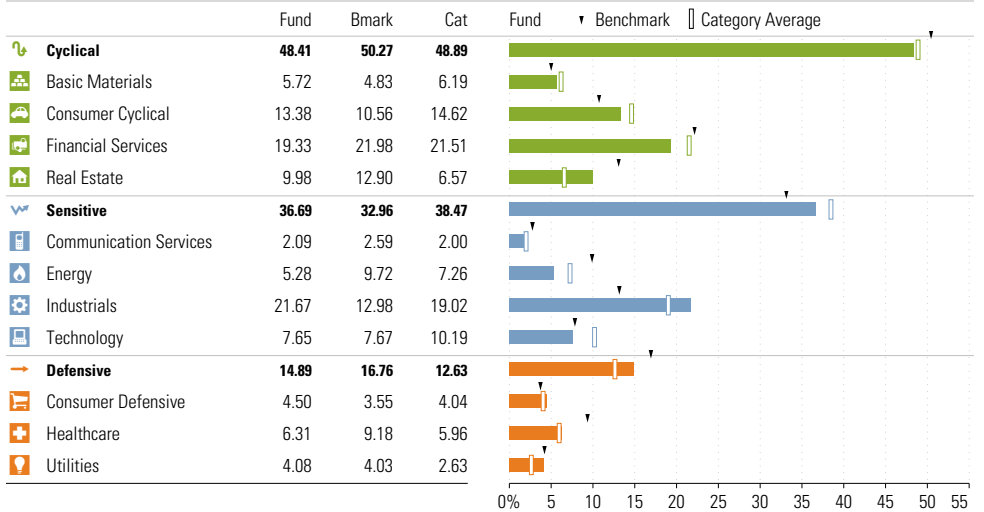
