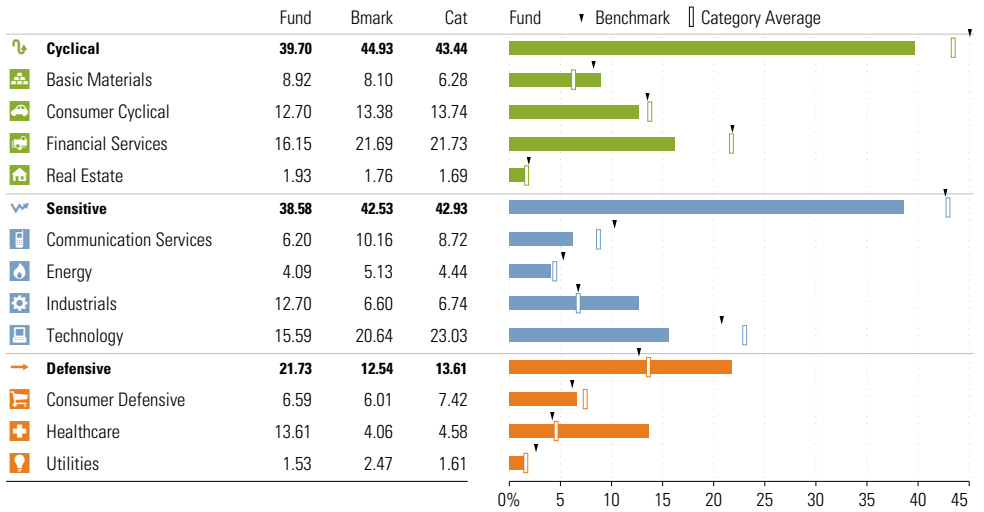

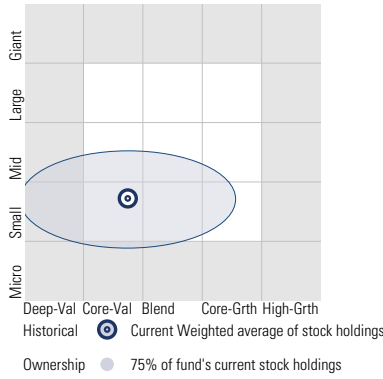

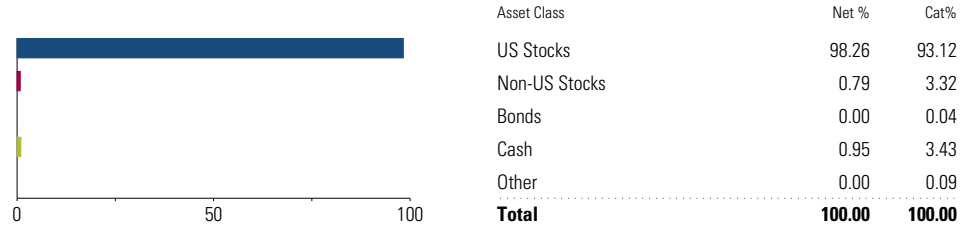

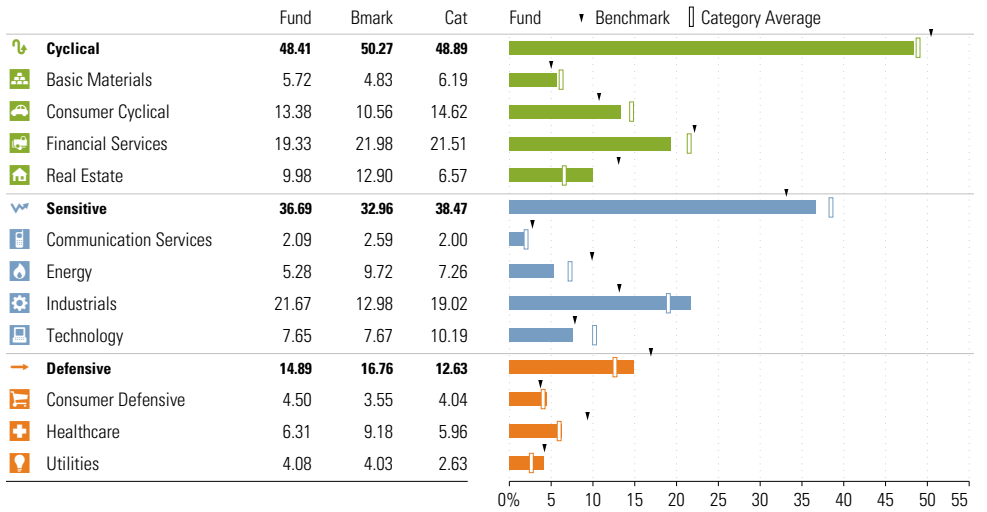
Style Breakdown
