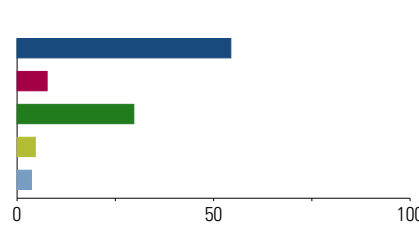

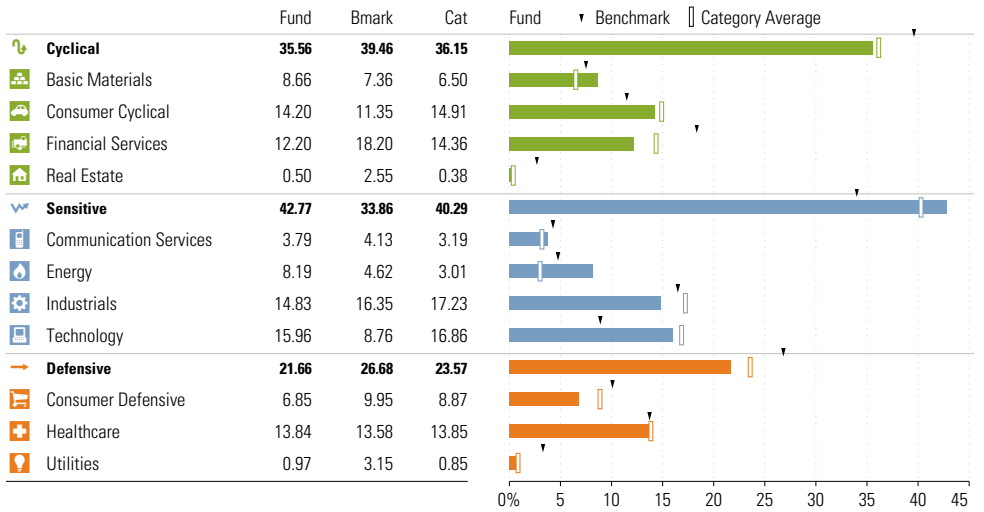

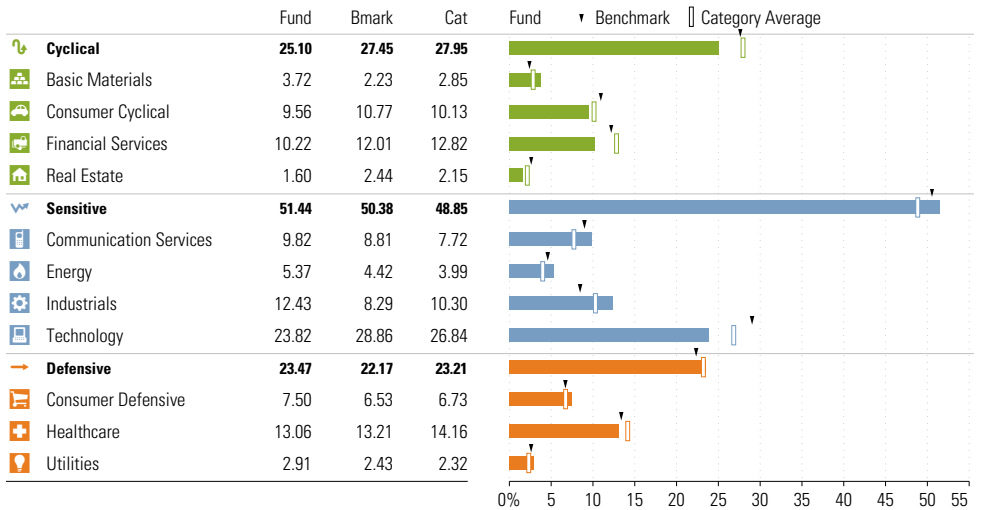

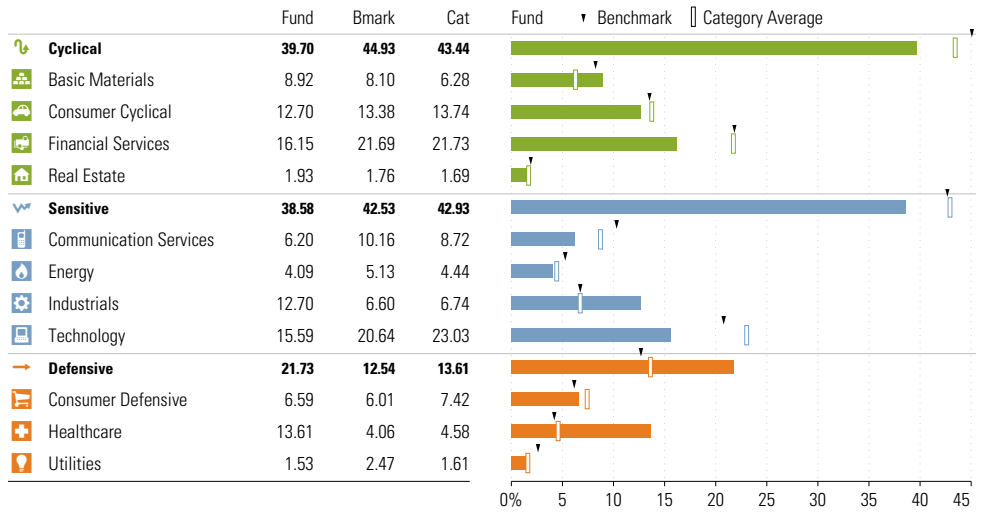

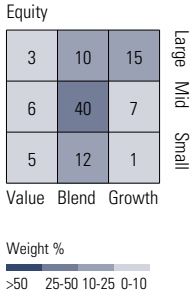

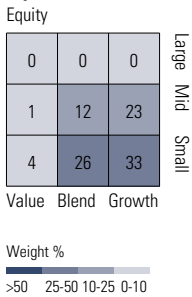
Asset Allocation as of 09-30-2023

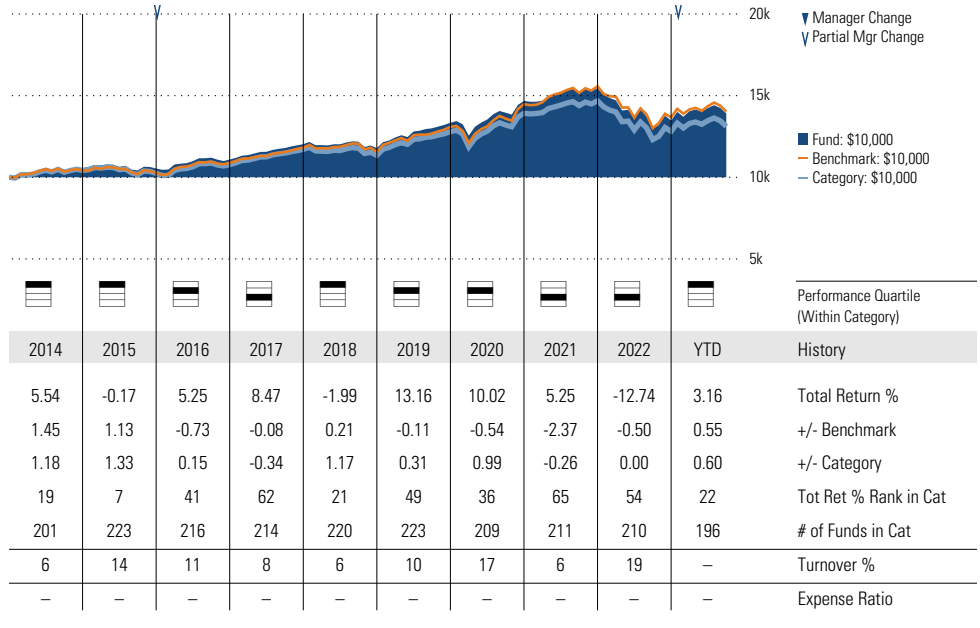

Growth of \$10,000



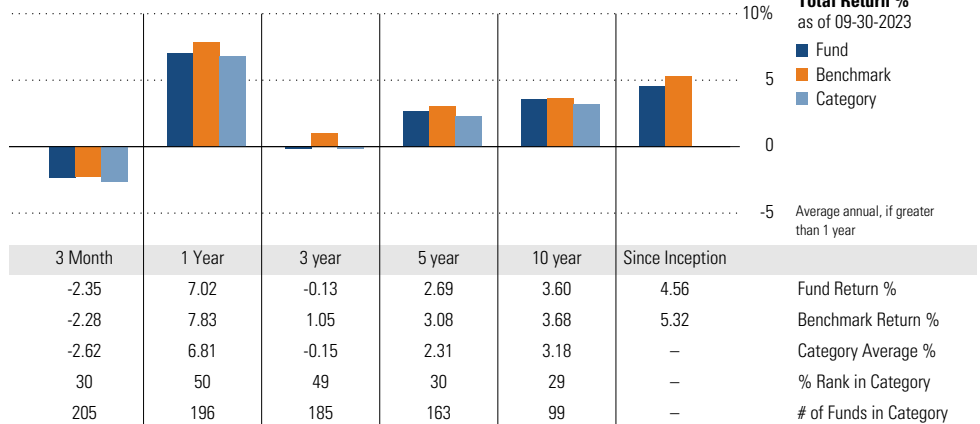

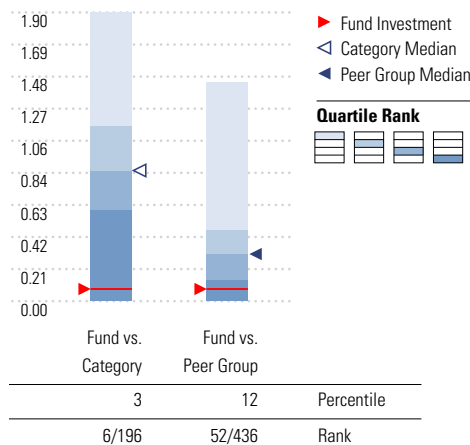

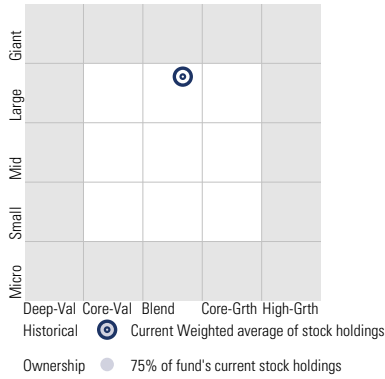

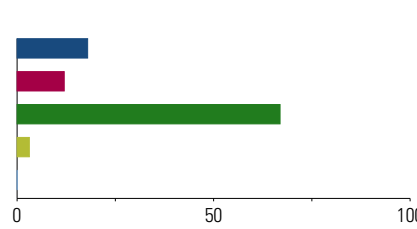

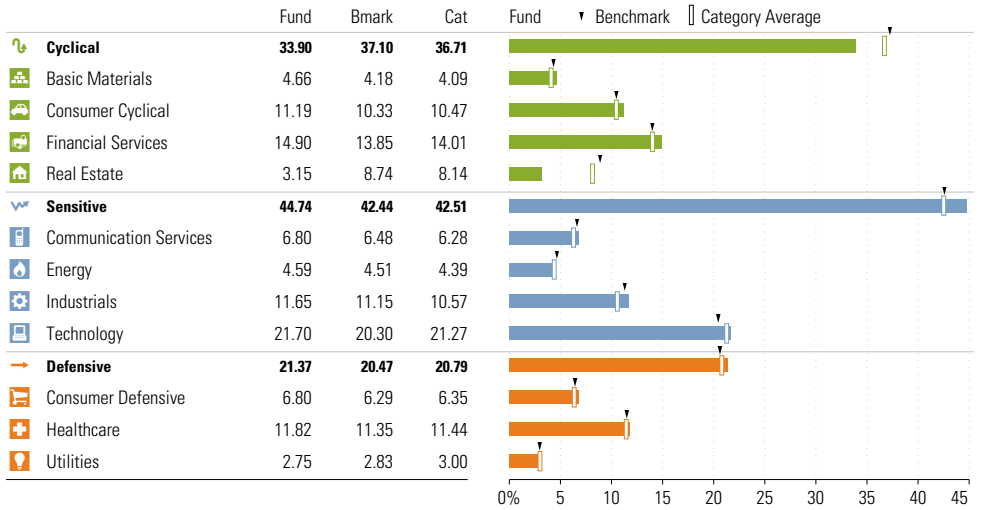

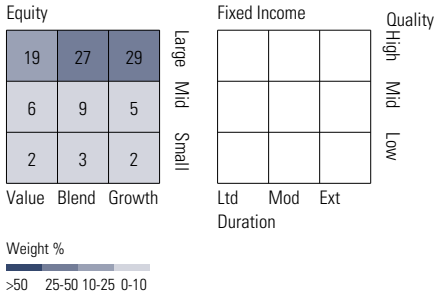
