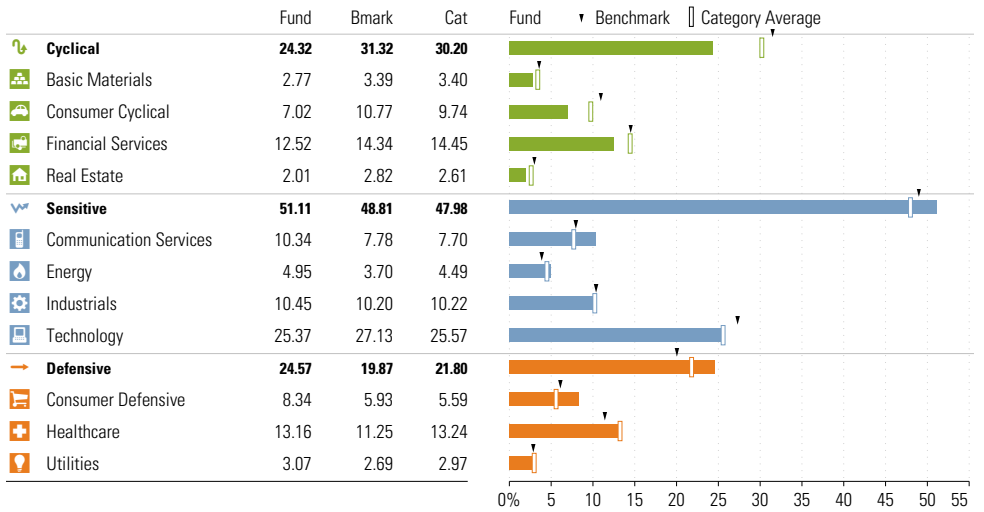

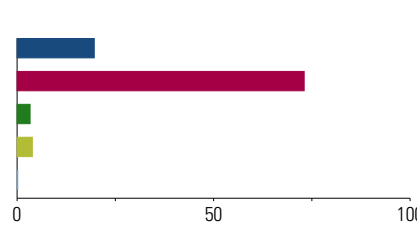

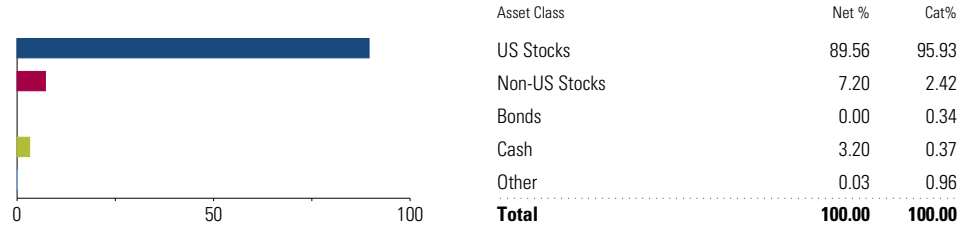

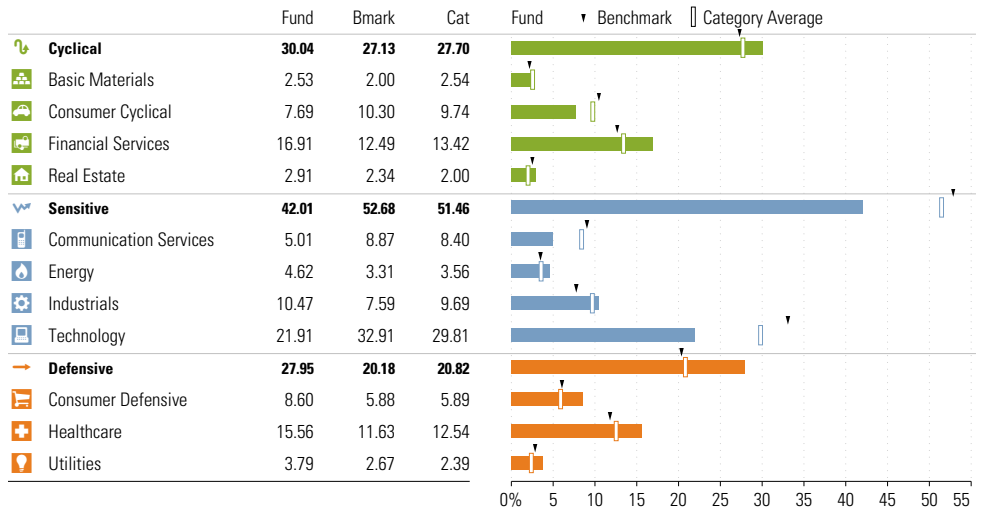

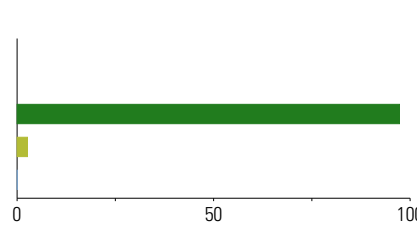

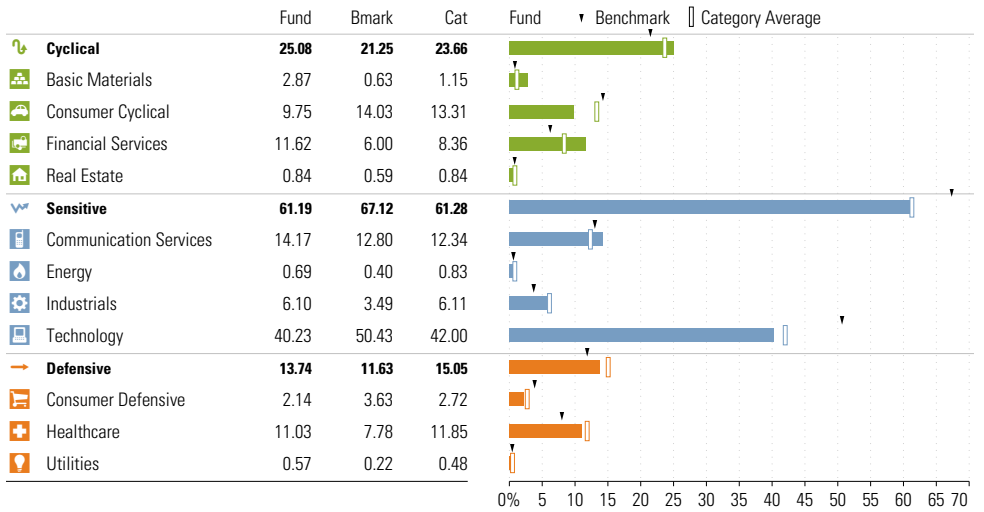

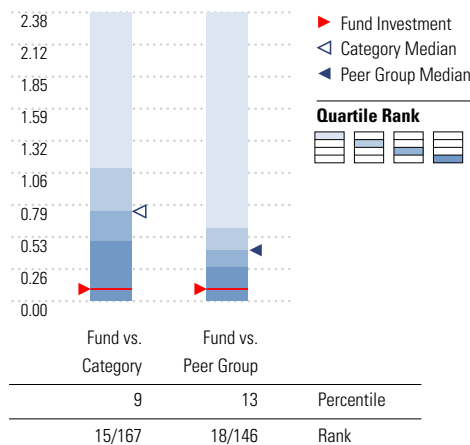

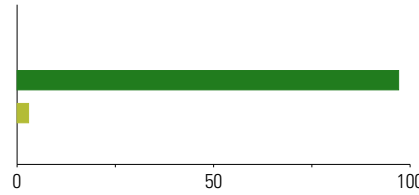

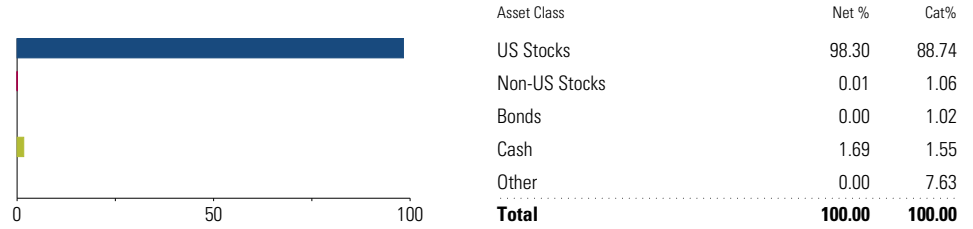

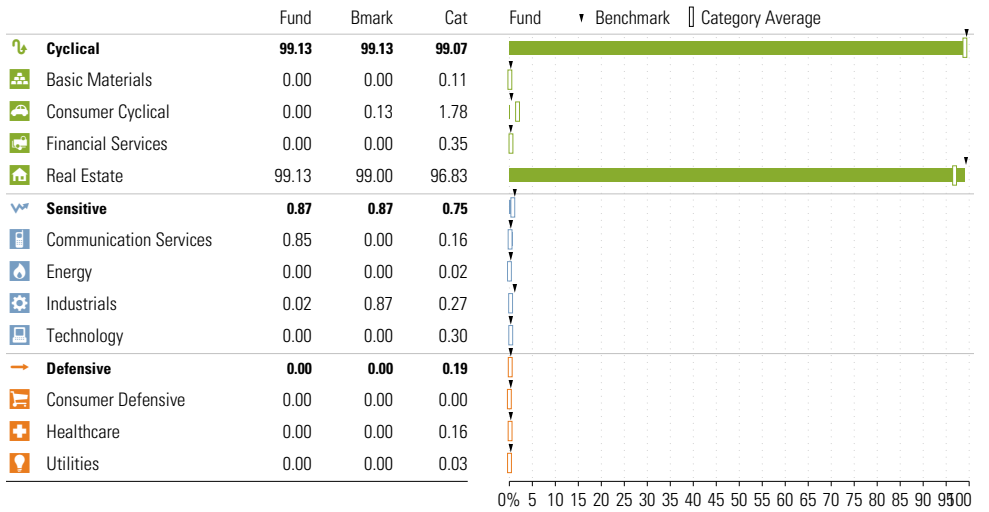

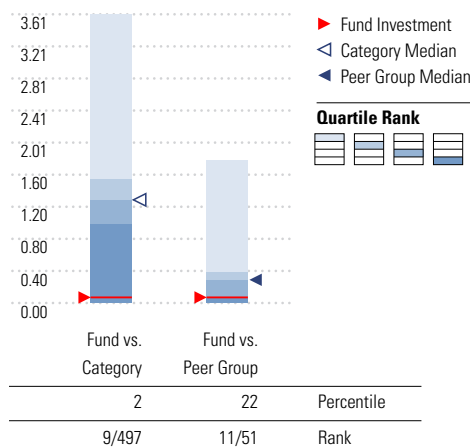

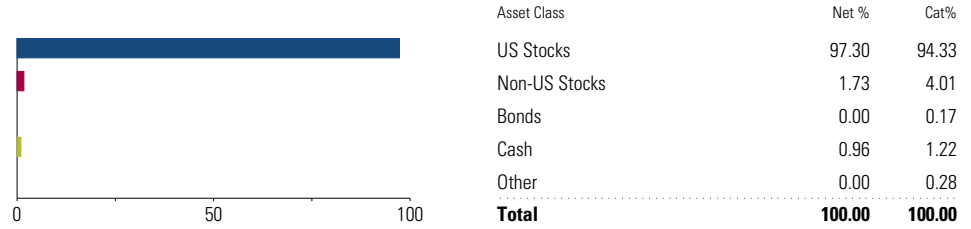

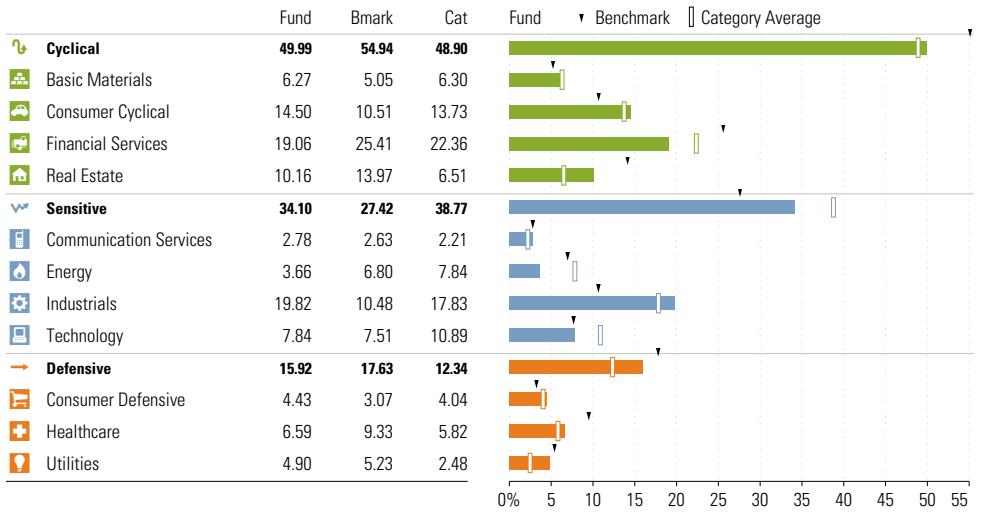
Style Breakdown
