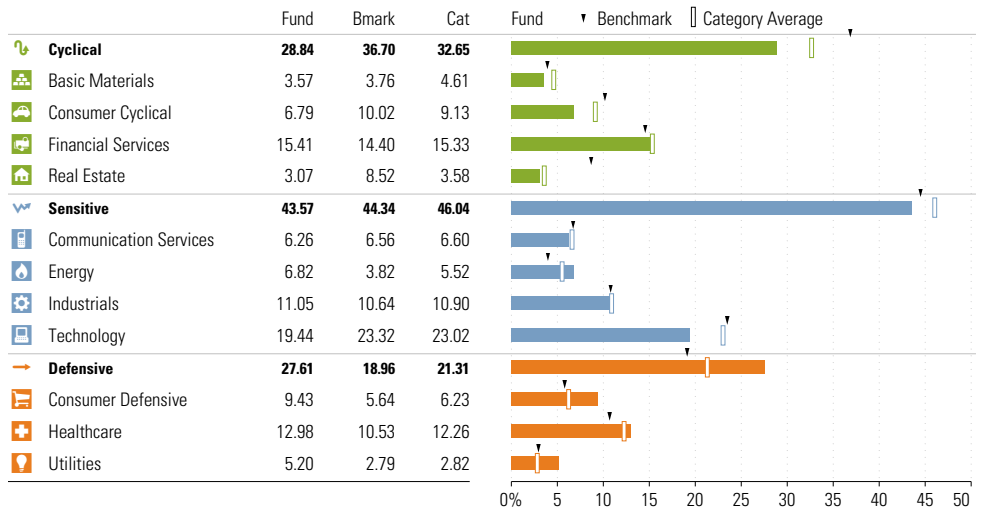

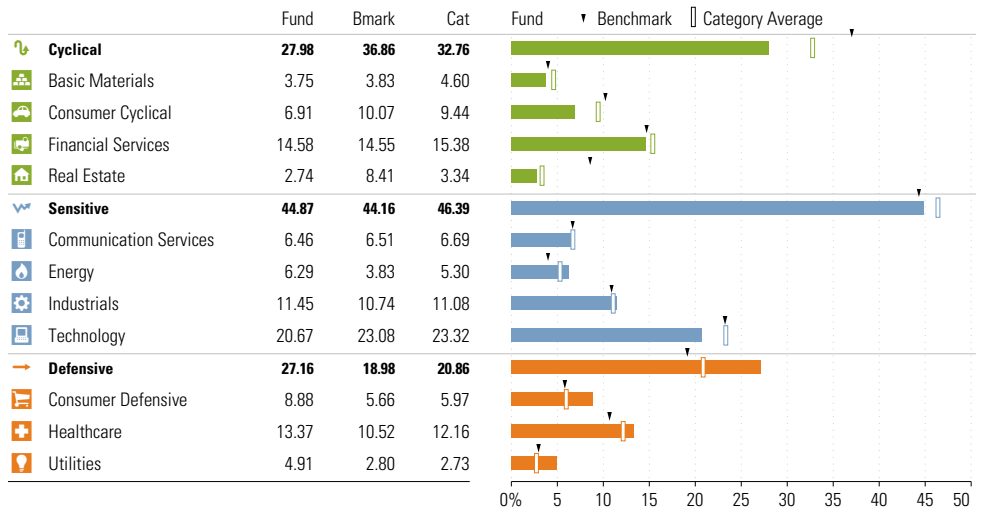

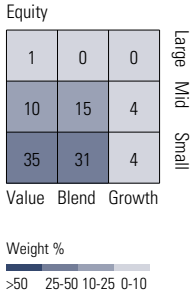

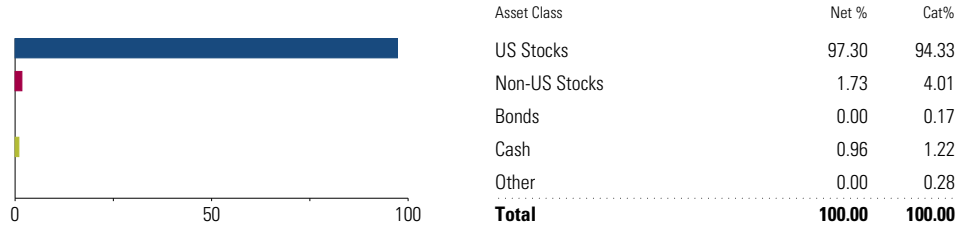

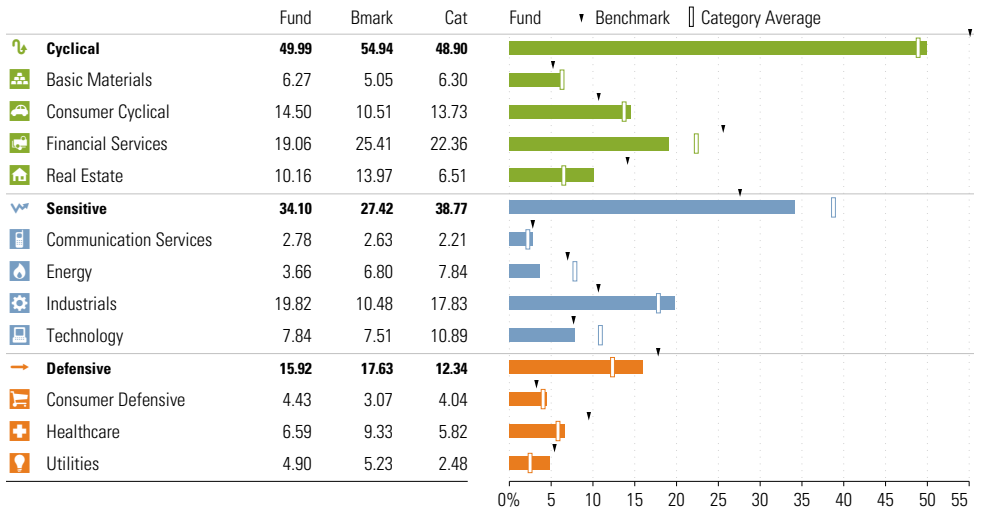
Style Breakdown

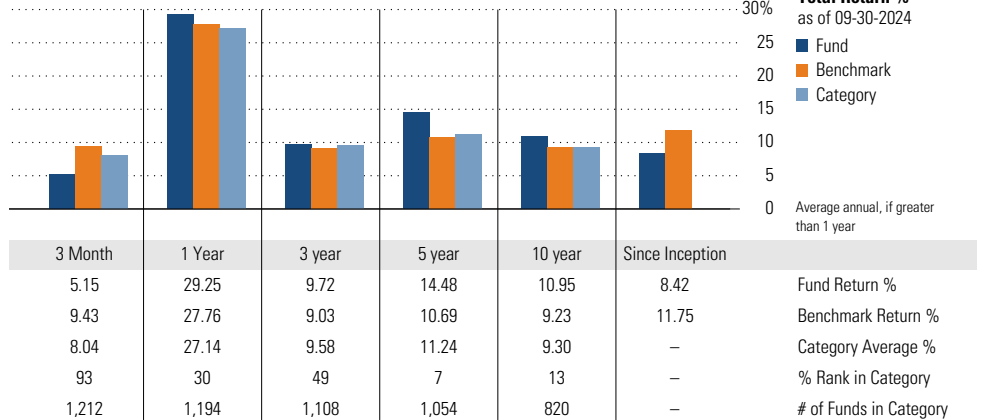

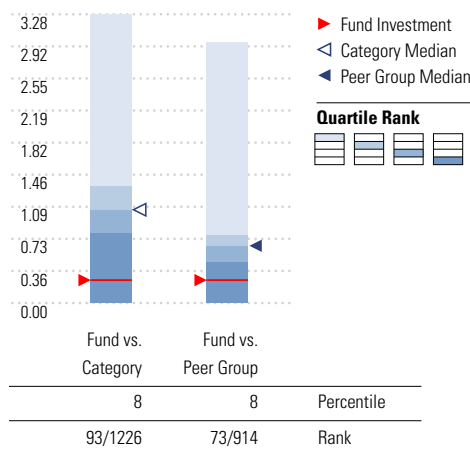

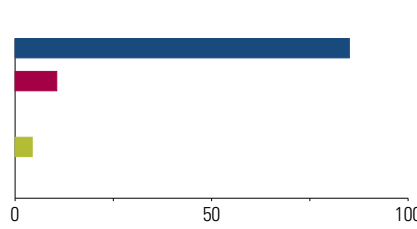

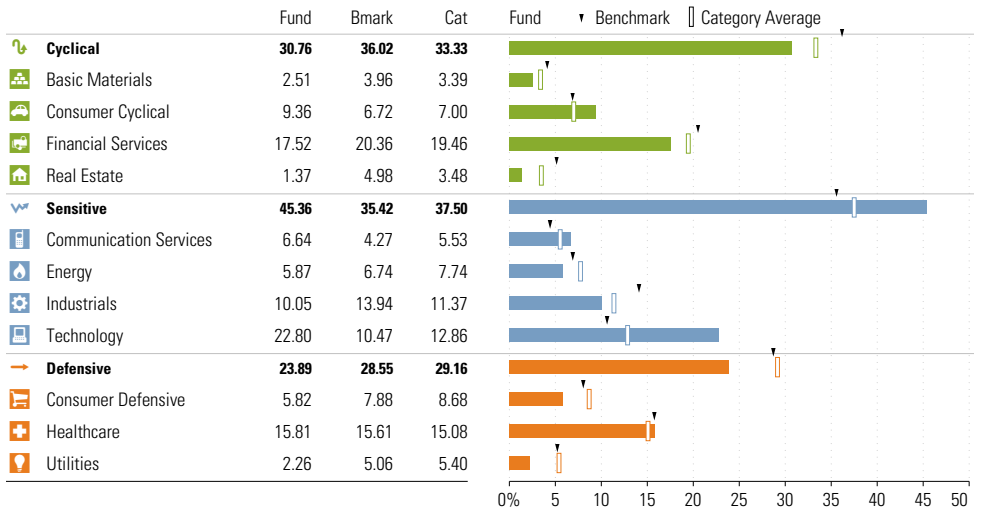
