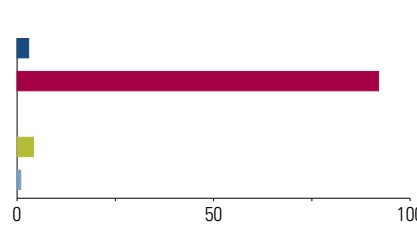

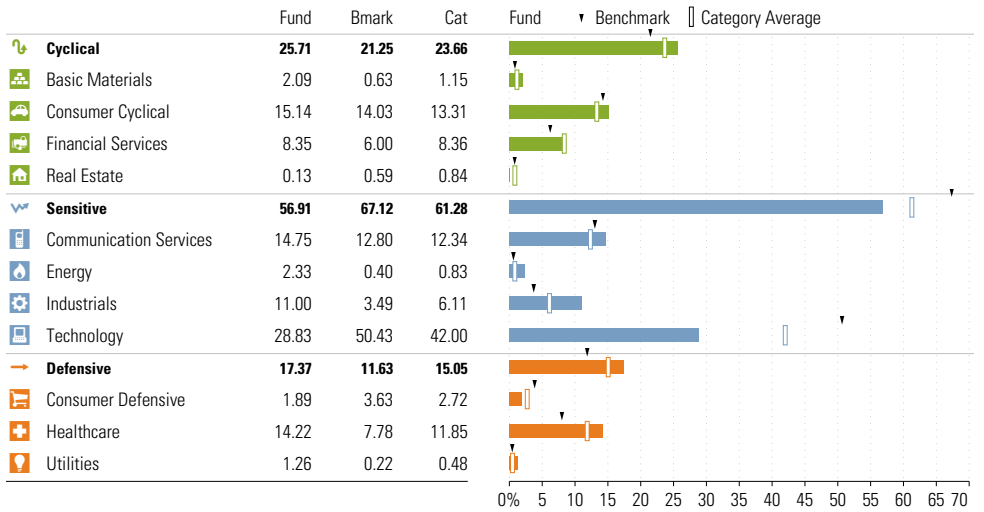

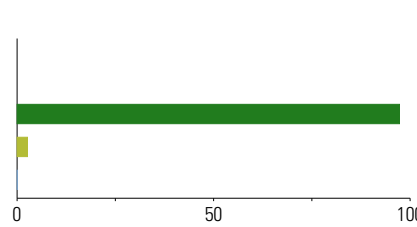

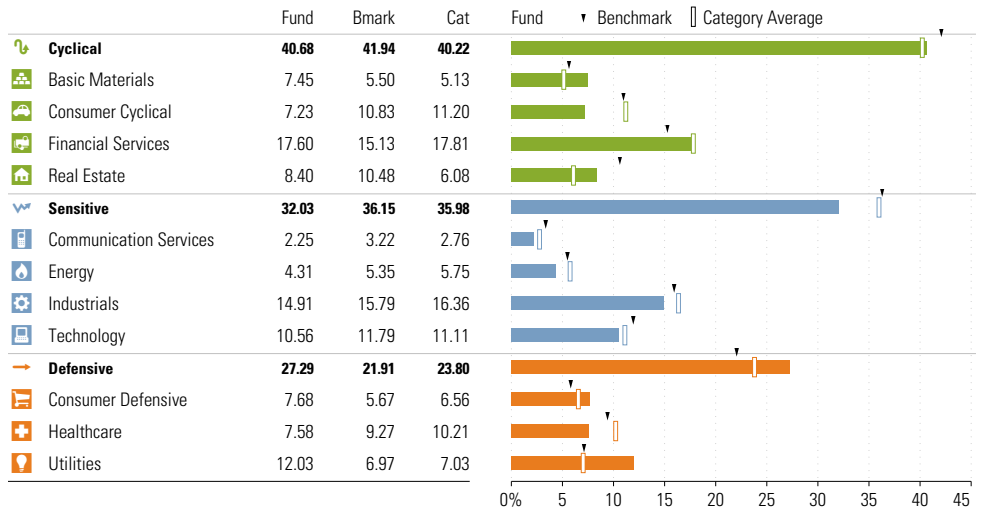
Asset Allocation as of 09-30-2024

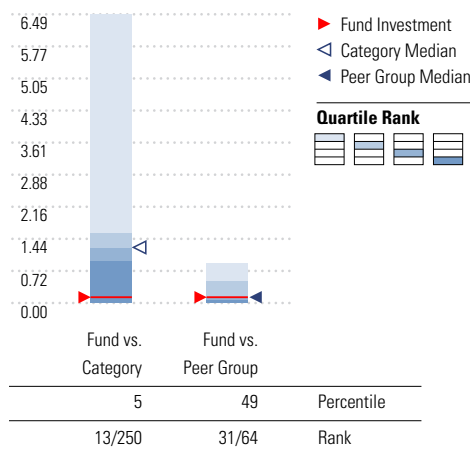

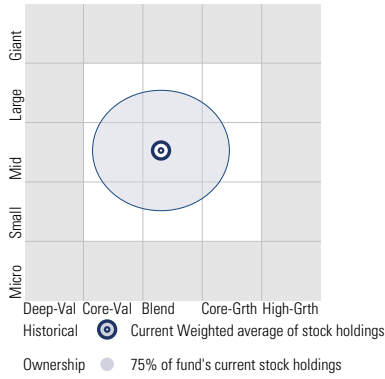

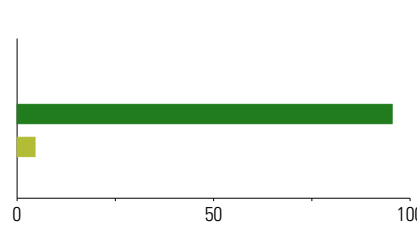

Asset Allocation as of 09-30-2024

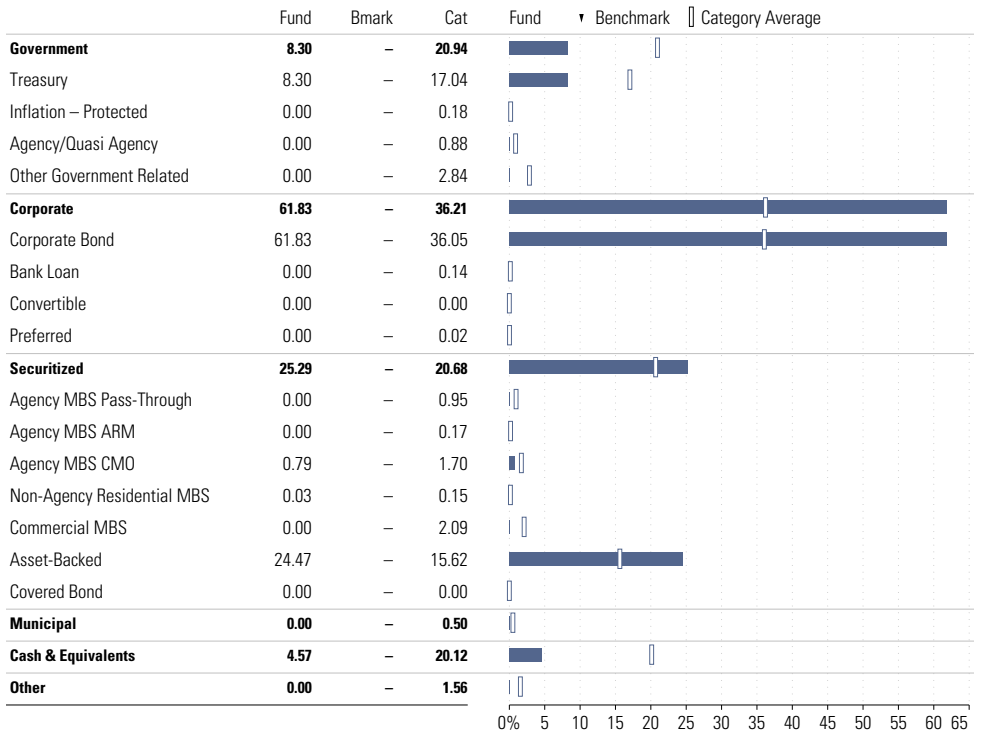

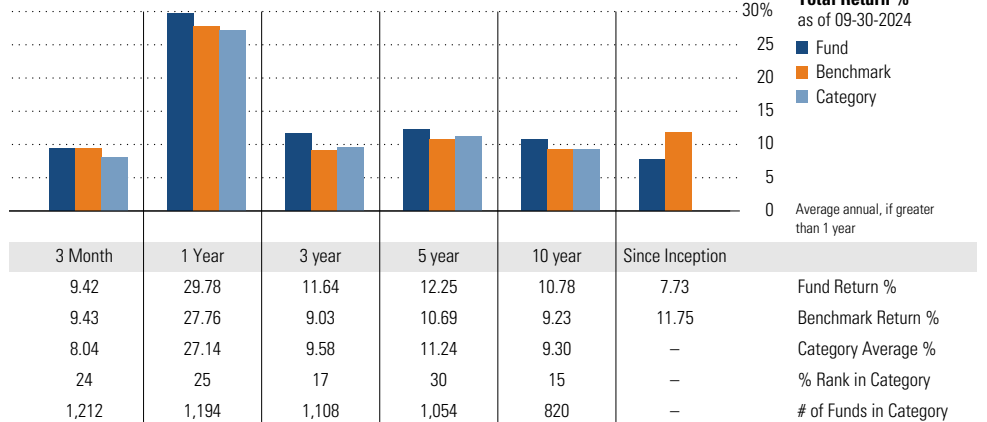

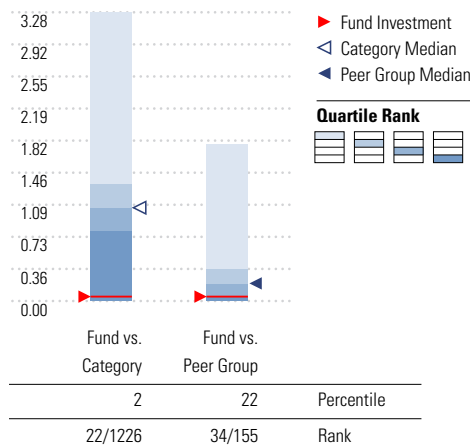
Growth of \$10,000

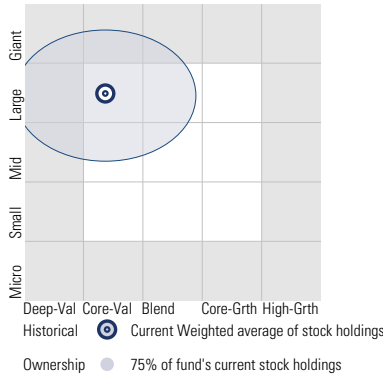

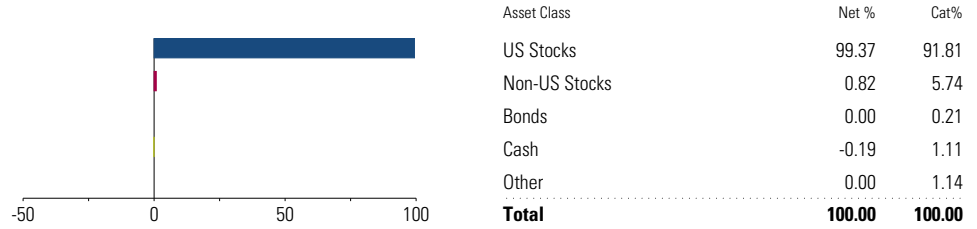

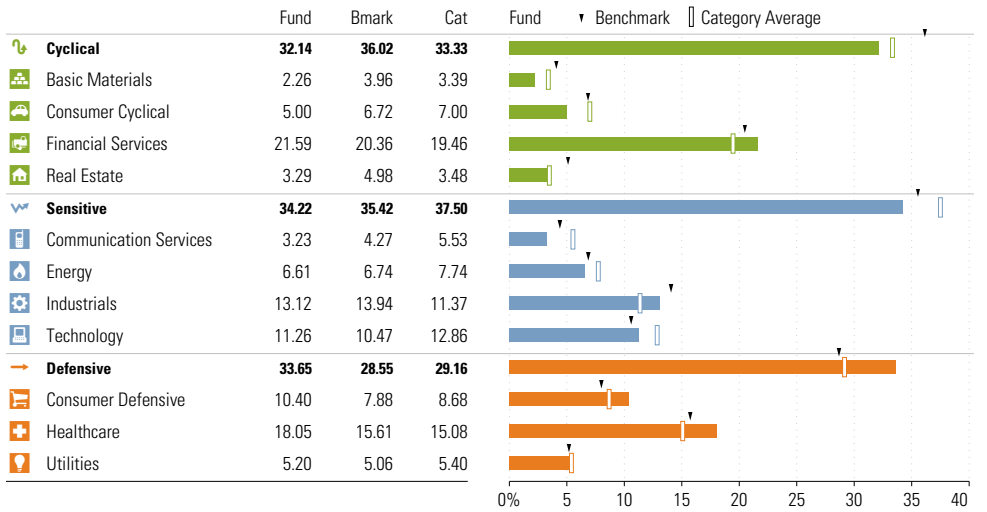
Style Breakdown
