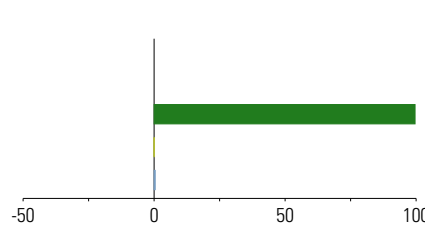

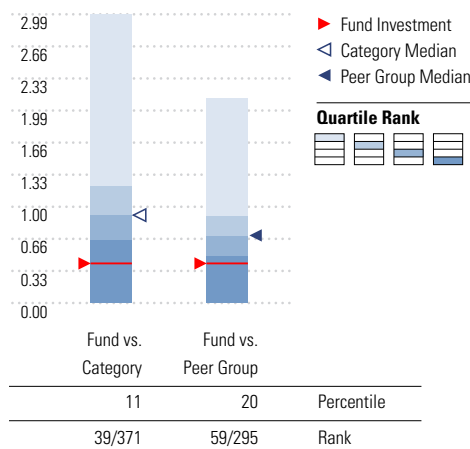

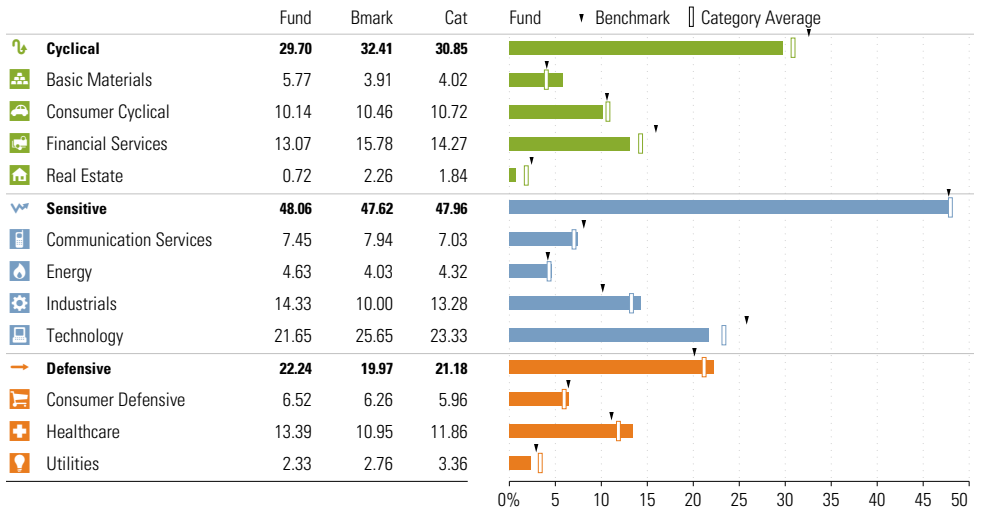

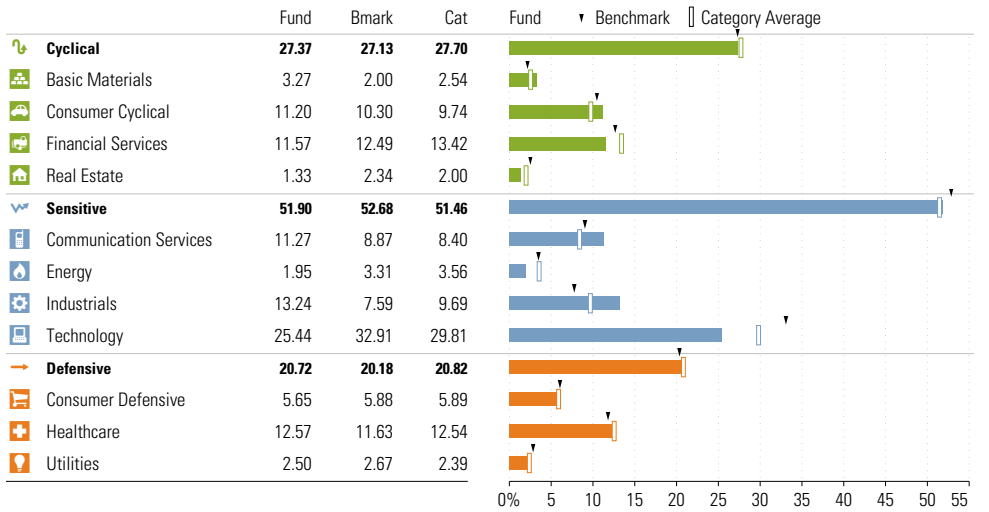

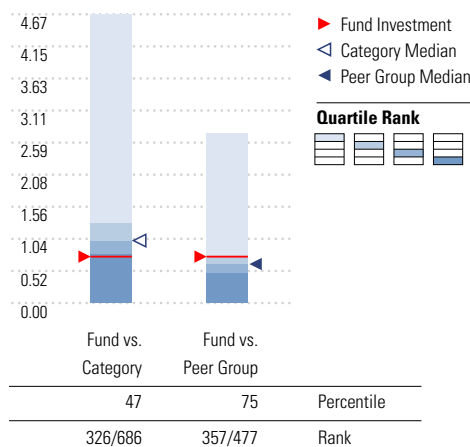

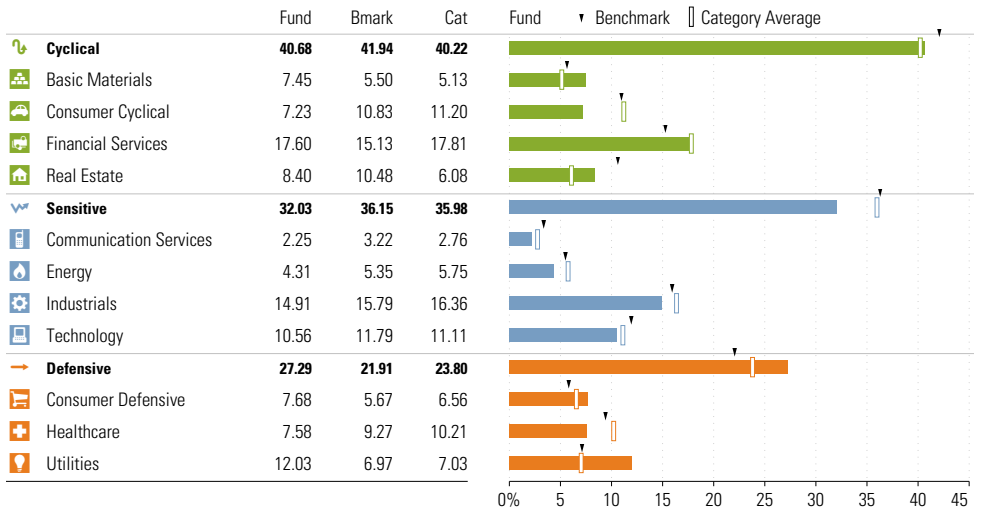

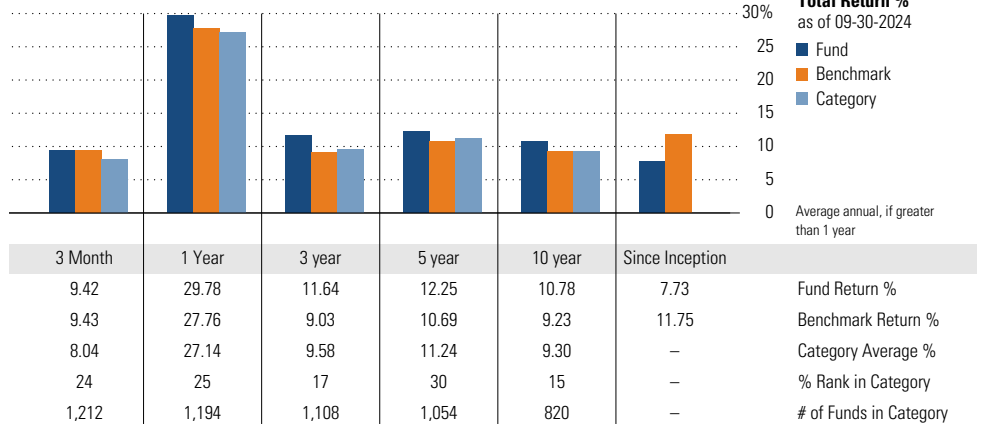

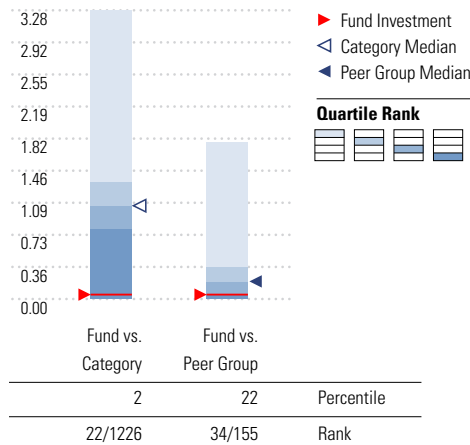

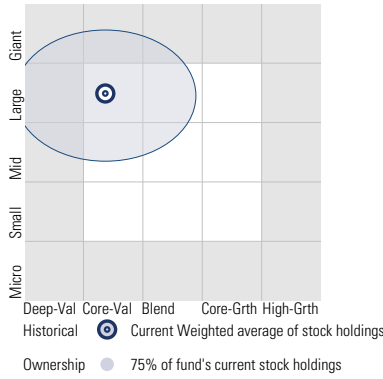

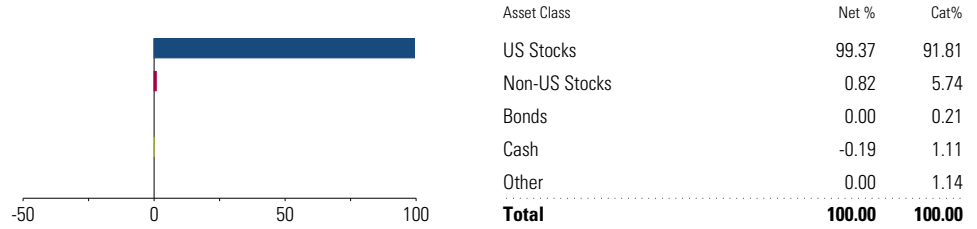

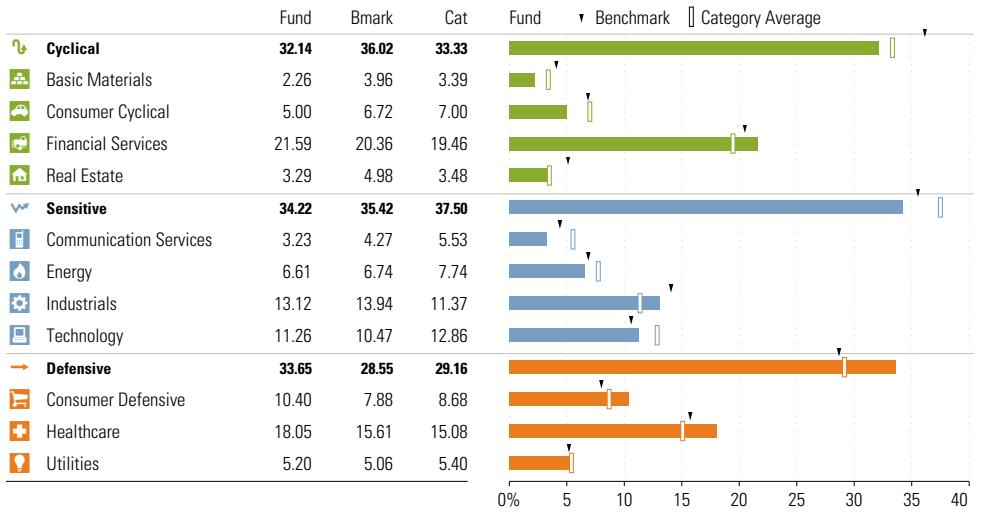
Style Breakdown
