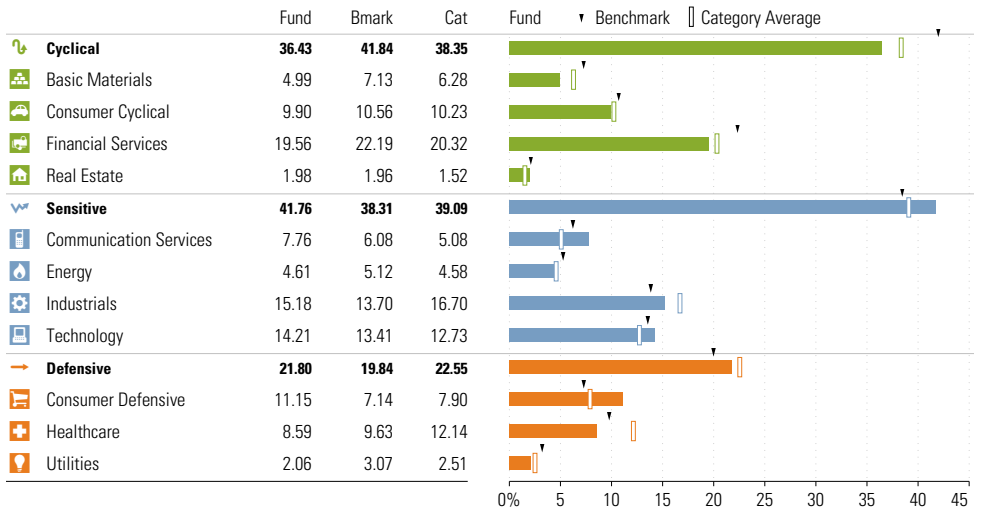

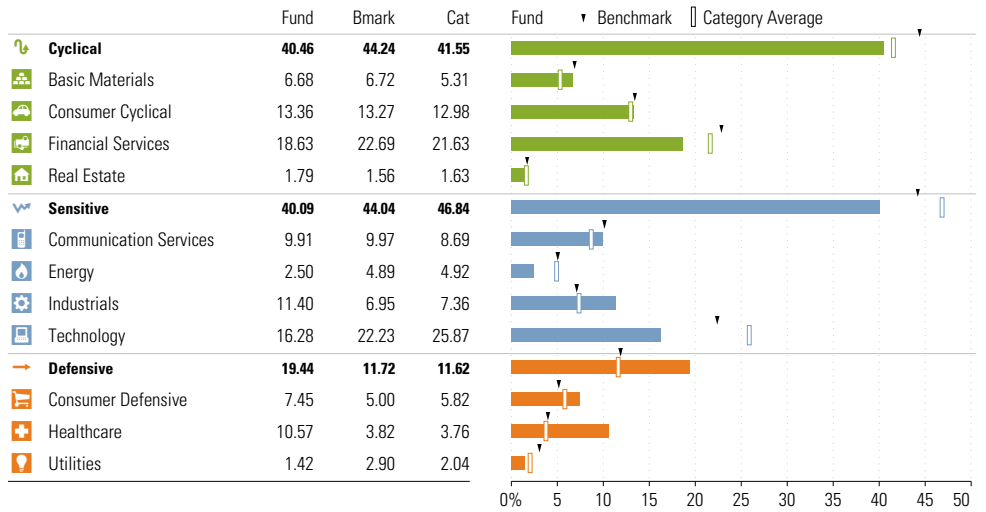

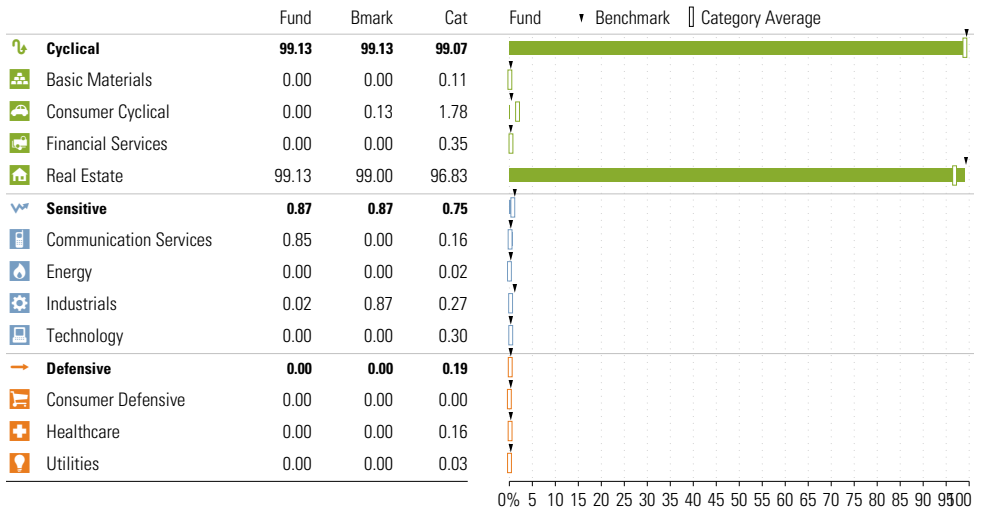

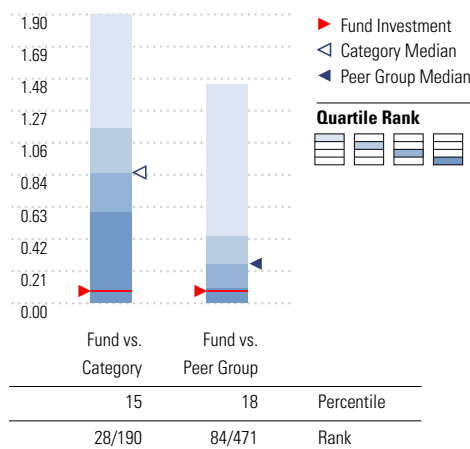

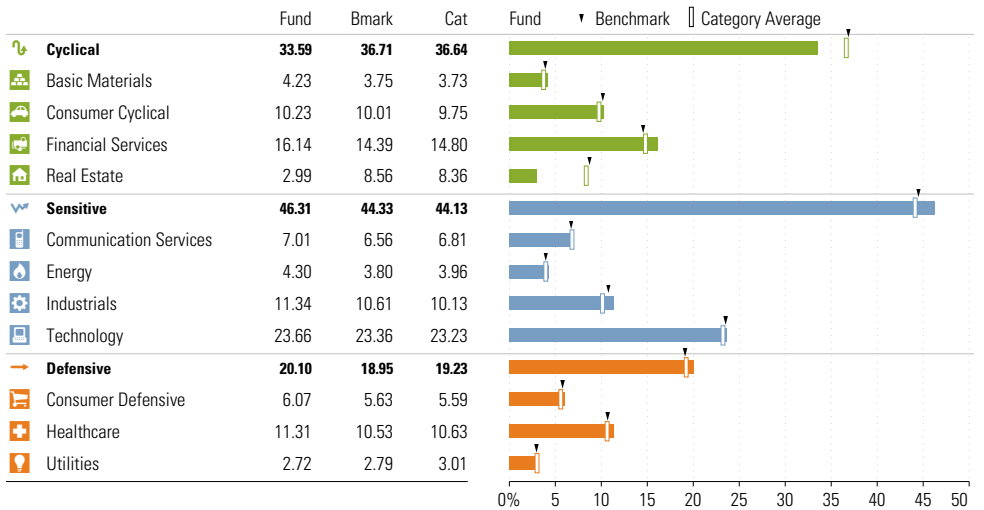

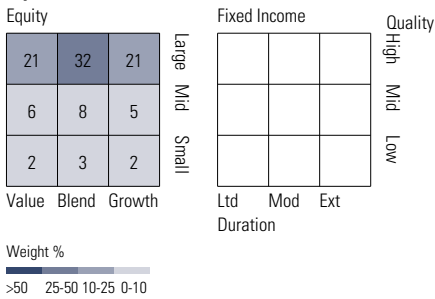

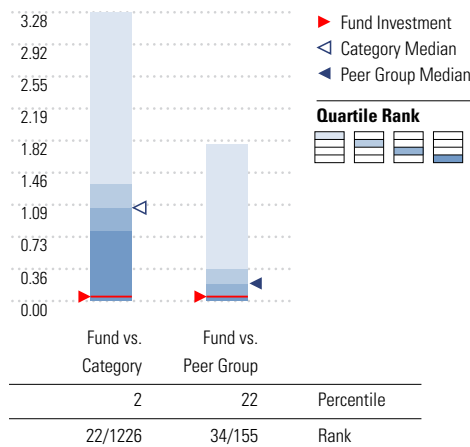

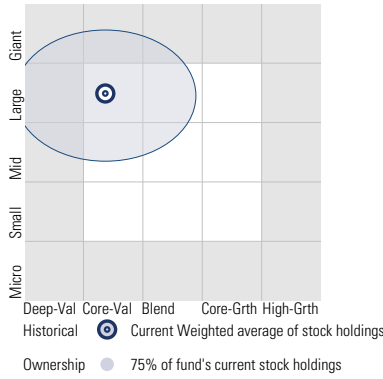

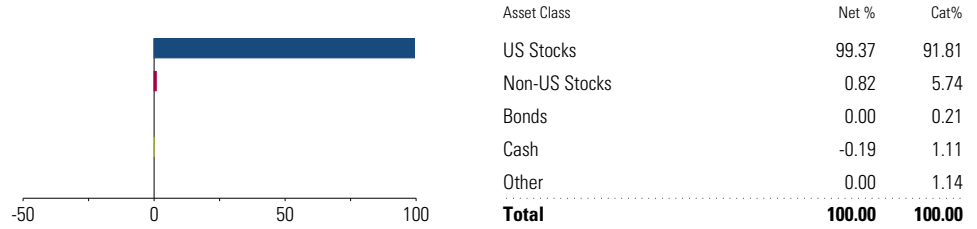

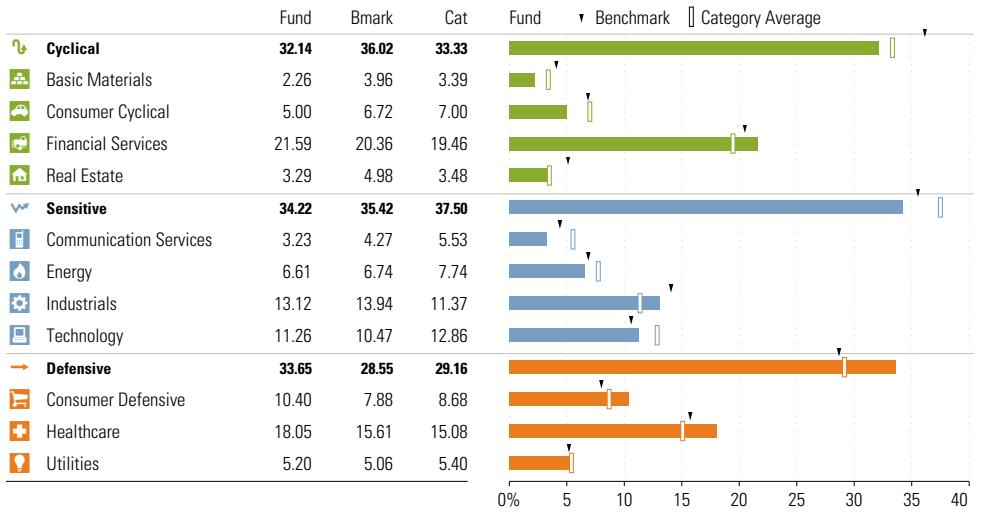
Style Breakdown
