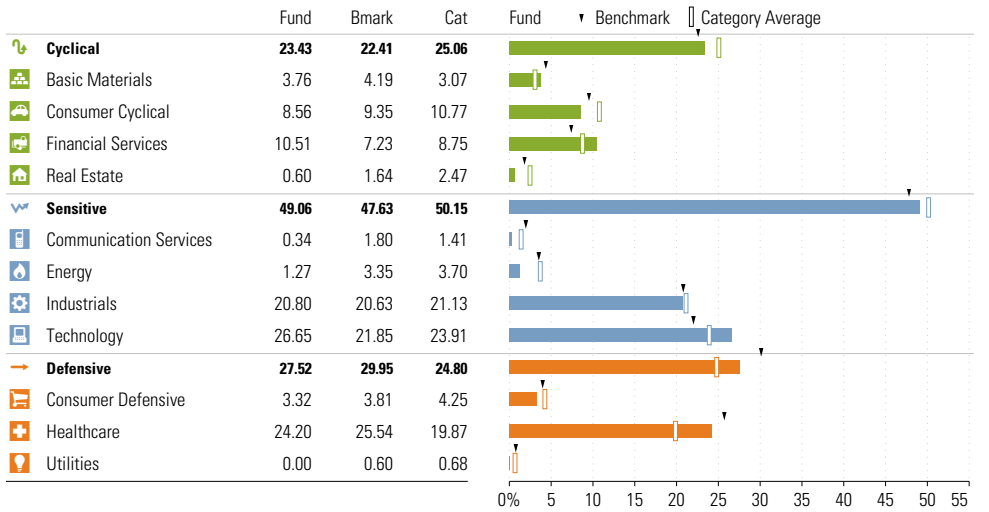

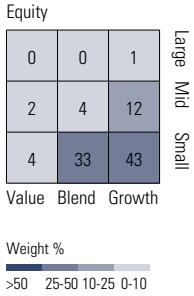
Asset Allocation as of 09-30-2024

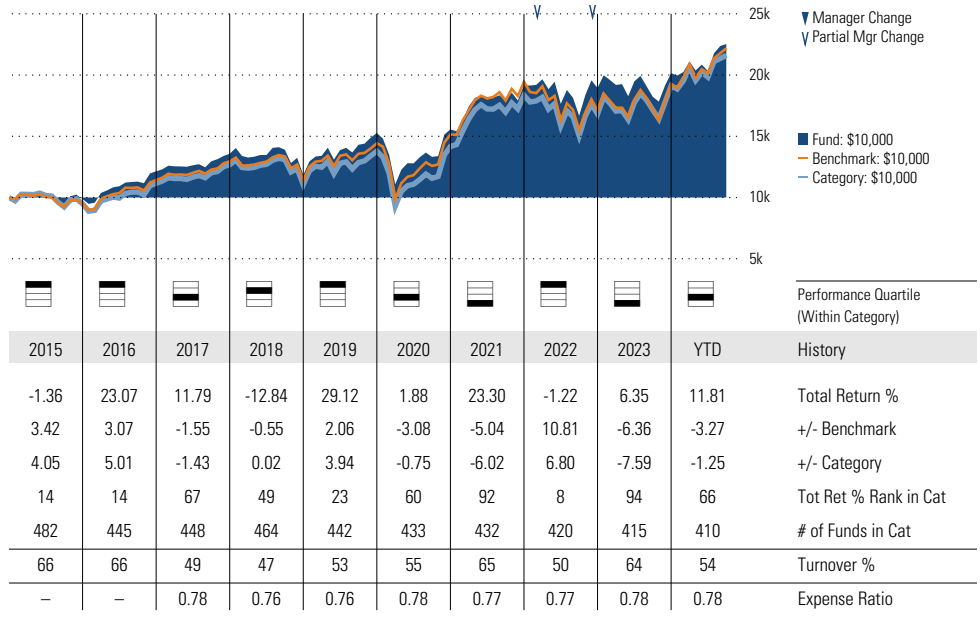

Growth of \$10,000



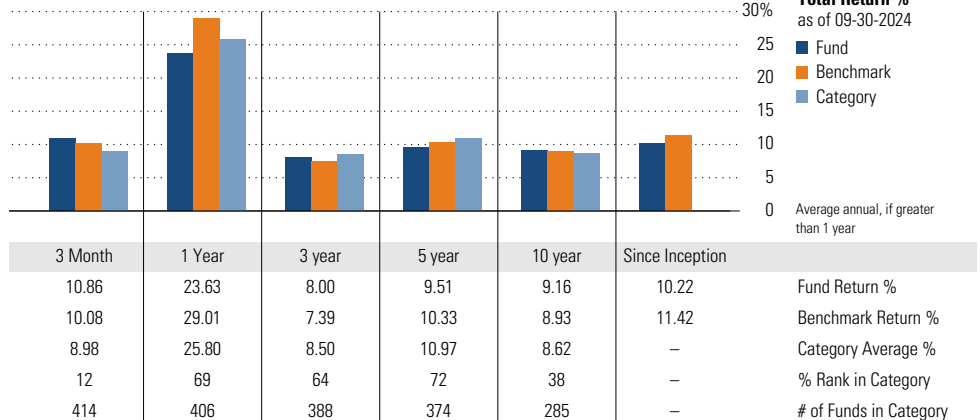

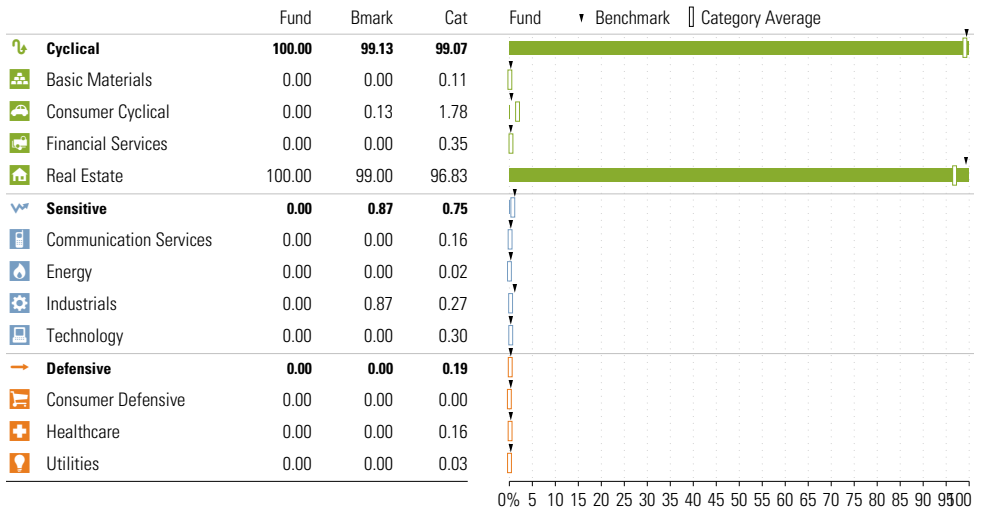

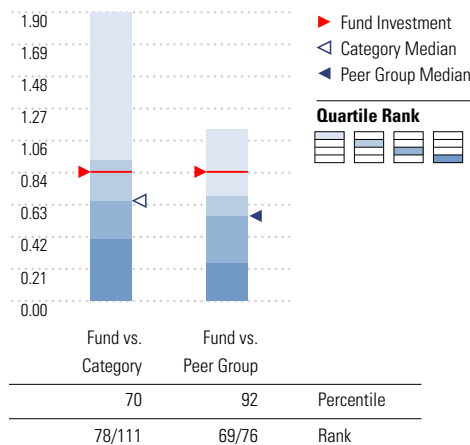

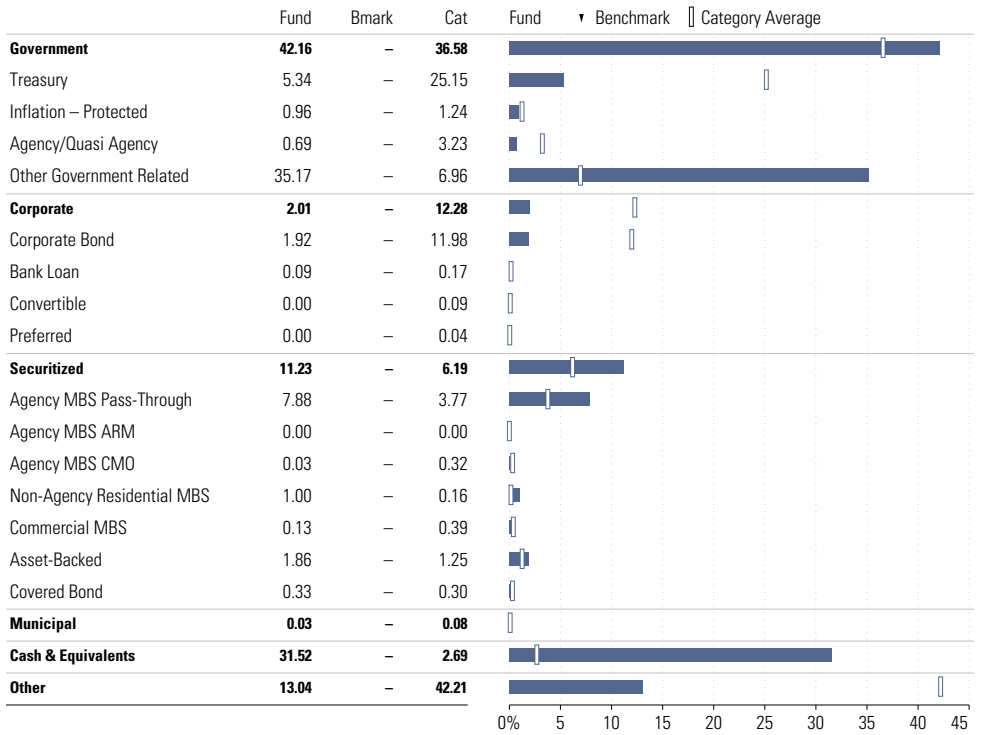

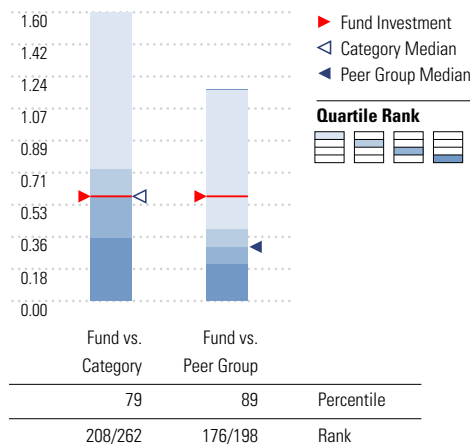

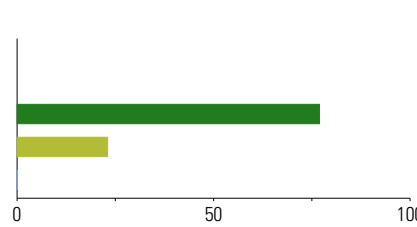

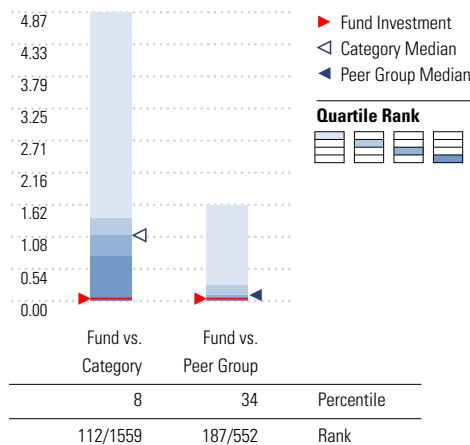

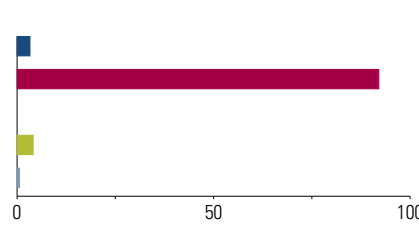
