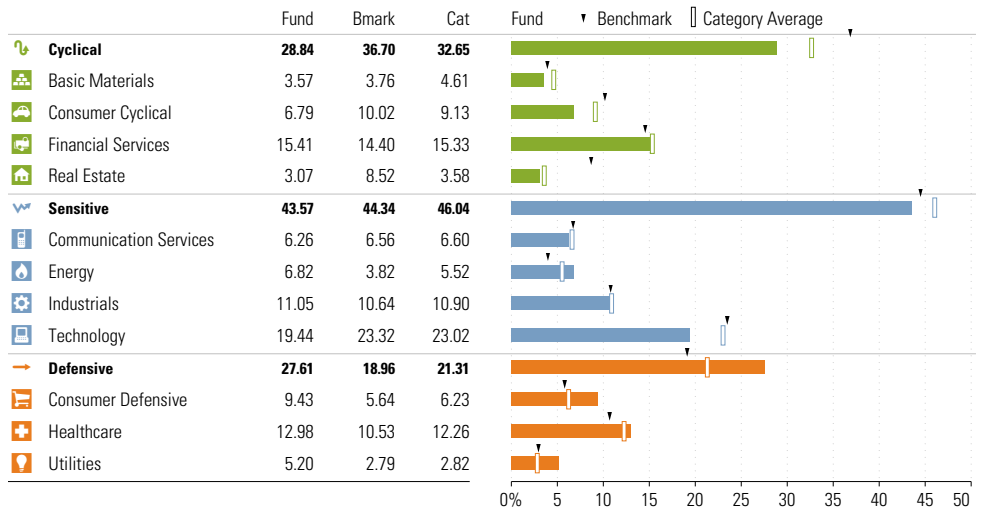

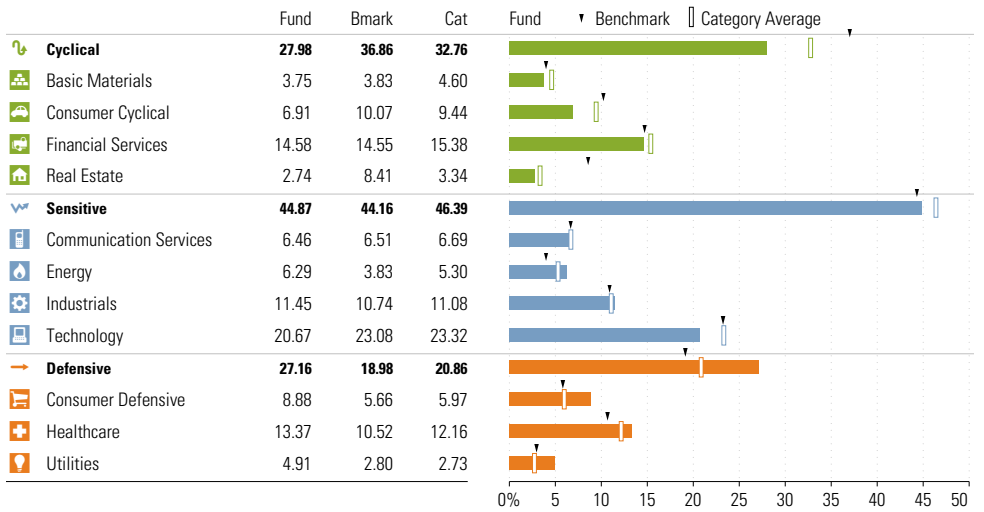

Remains on watch as performance struggles continue. Through September 2024, performance has landed in the bottom decile for the trailing year-to-date, 3- and 5-year periods. In 2020, the portfolio started to tilt towards more risky fare—lower-quality names (declining ROIC, declining net margin, and rising debt to capital levels versus the category average) with higher valuations. In 2022, more speculative healthcare holdings that provide services to biotech/pharma companies significantly weighed on performance. In 2023, performance appeared to stabilize (outside of the impact of mid-sized banks First Republic and Western Alliance Bancorp during the regional-bank crisis). But in 2024, underperformance was driven by weak stock picking across a number of sectors.

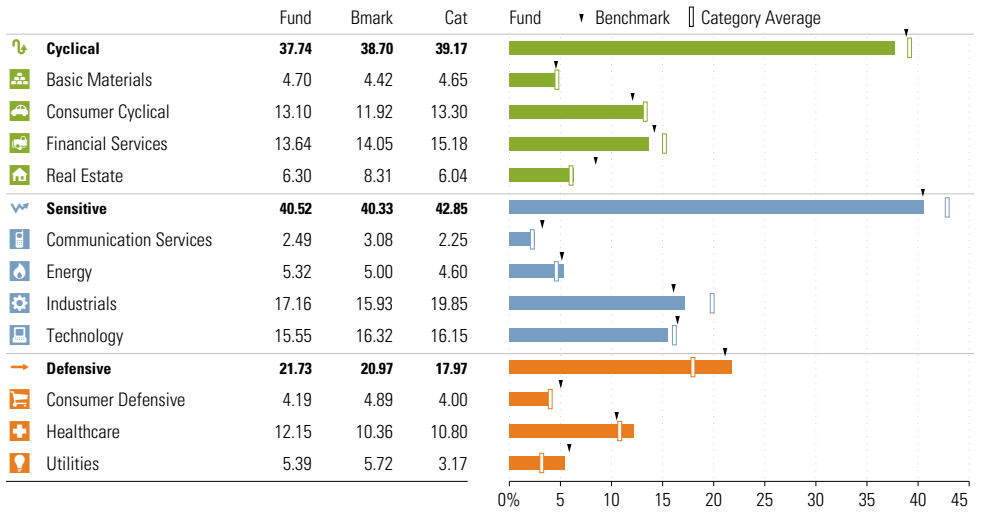

We are removing Western Asset Core Bond from fiduciary coverage due to concerns about the fund's elevated risk profile and the ongoing SEC investigation of portfolio manager Ken Leech. We have lost conviction in the strategy's ability to manage risk and are removing it from our approved universe.

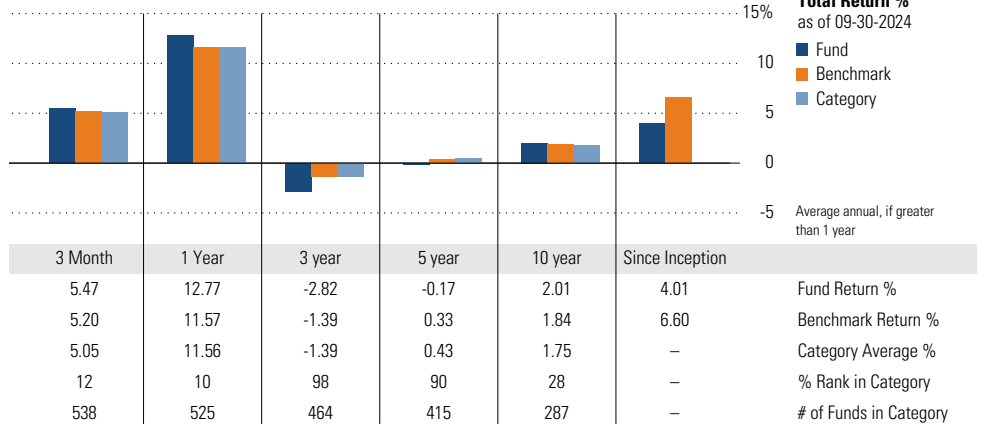

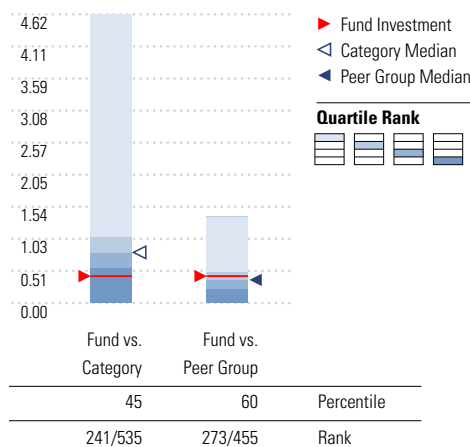
Growth of \$10,000

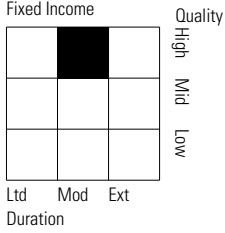

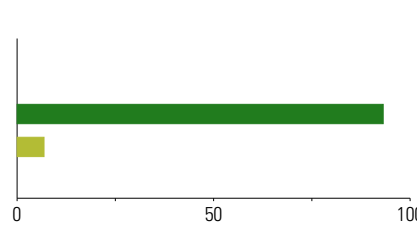

Asset Allocation as of 09-30-2024

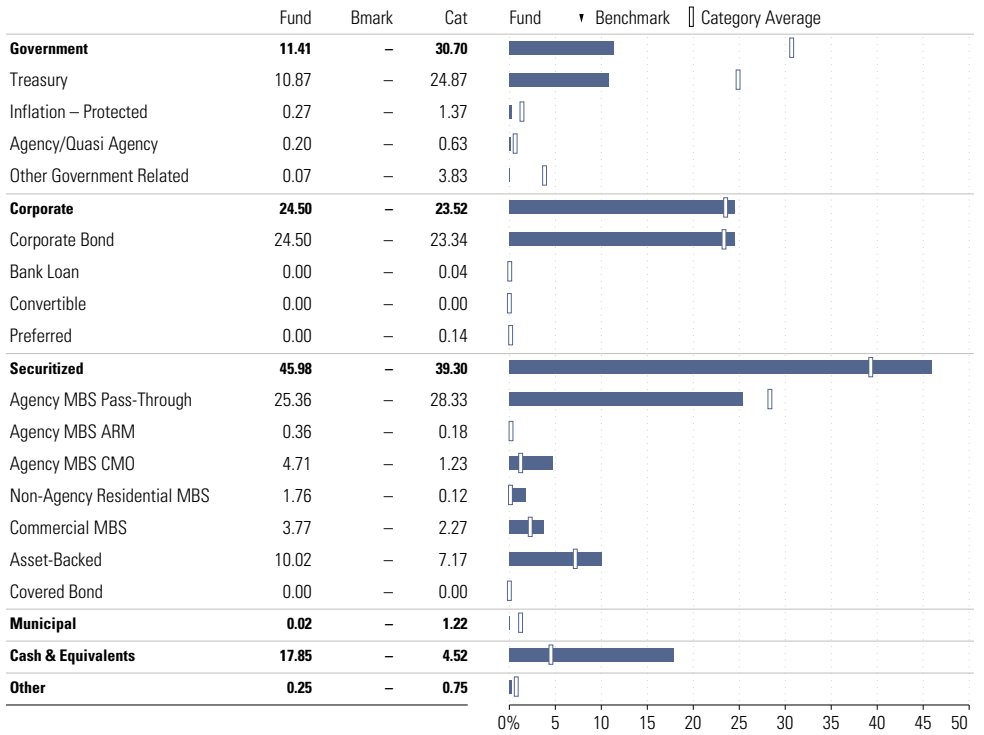
