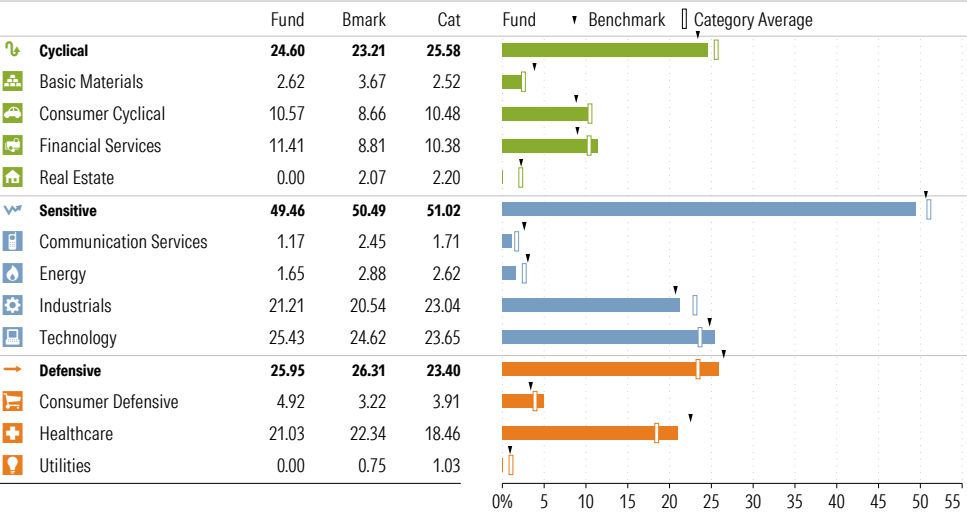

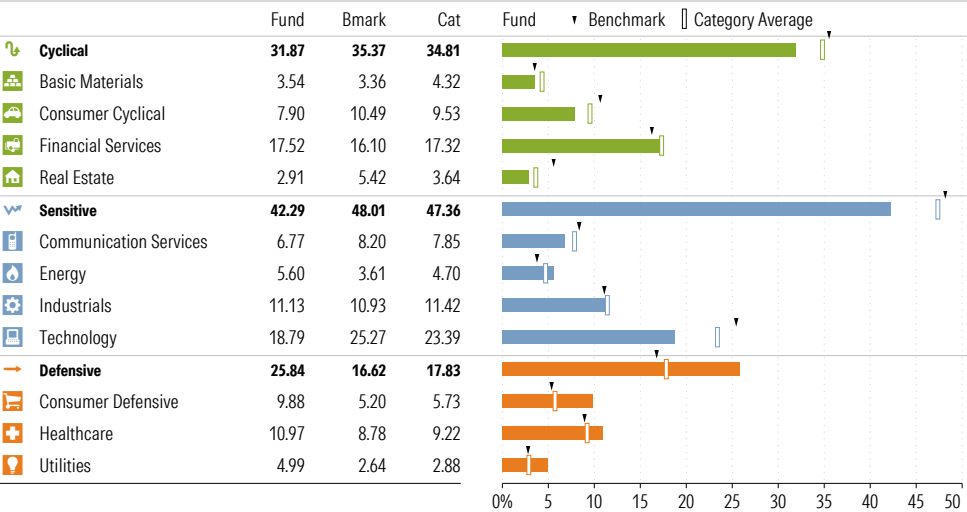

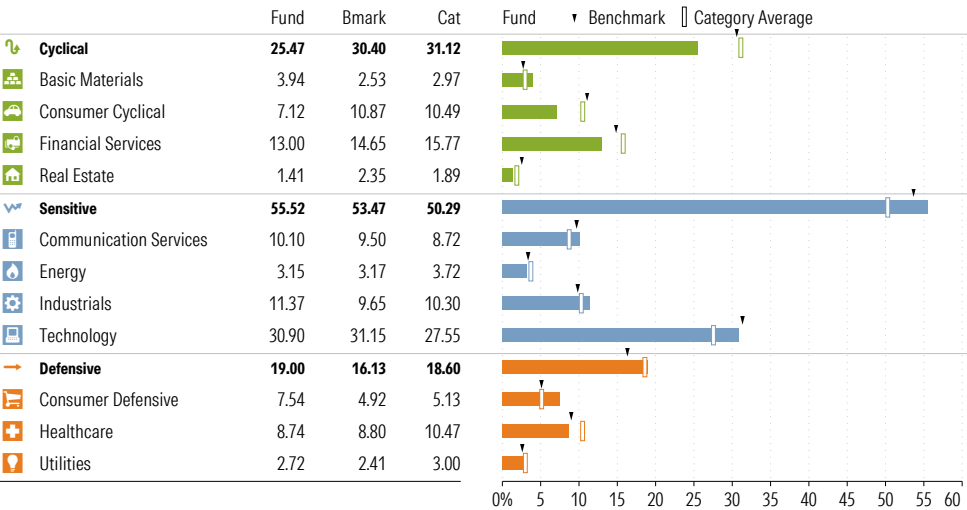

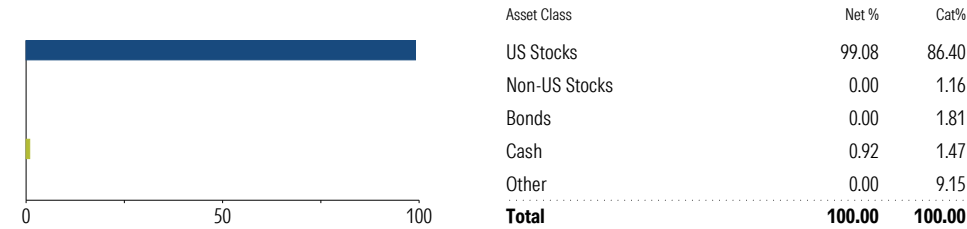

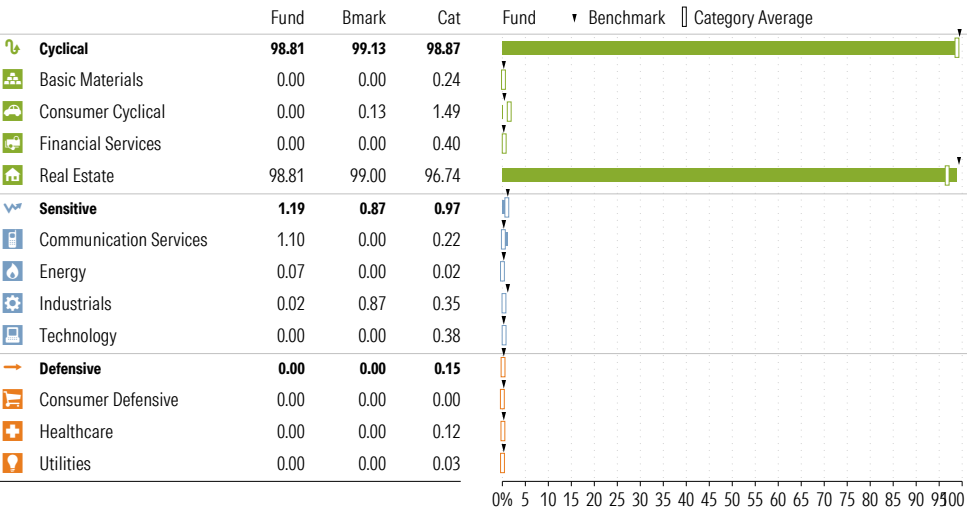
Style Breakdown

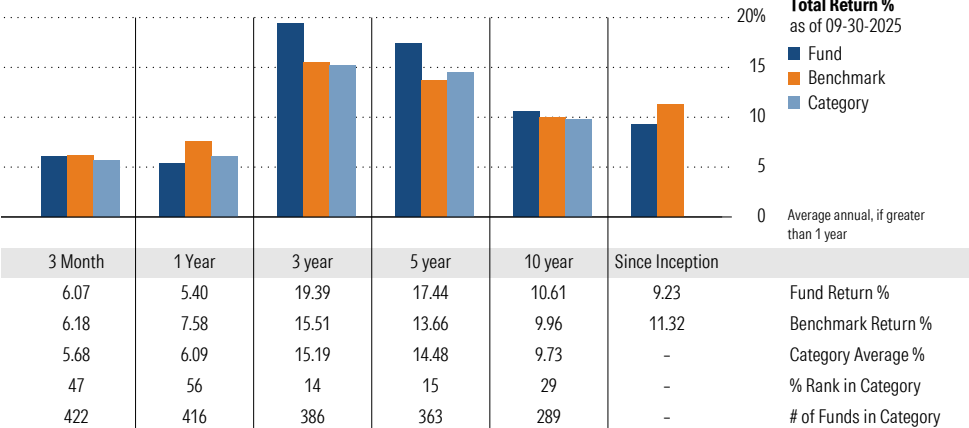

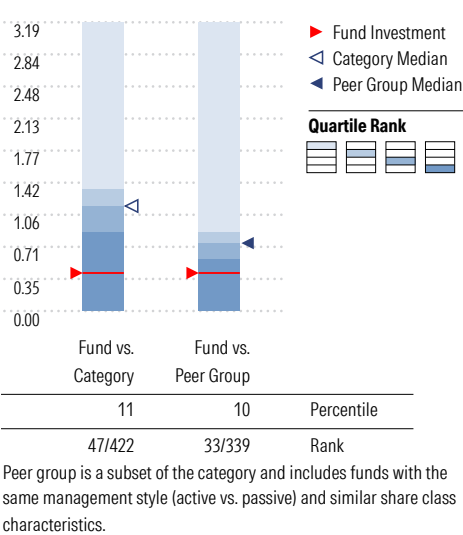

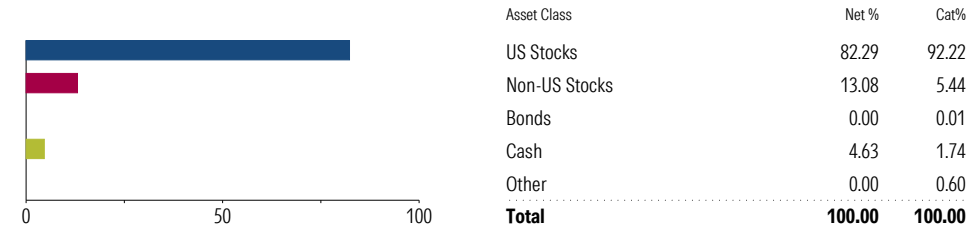

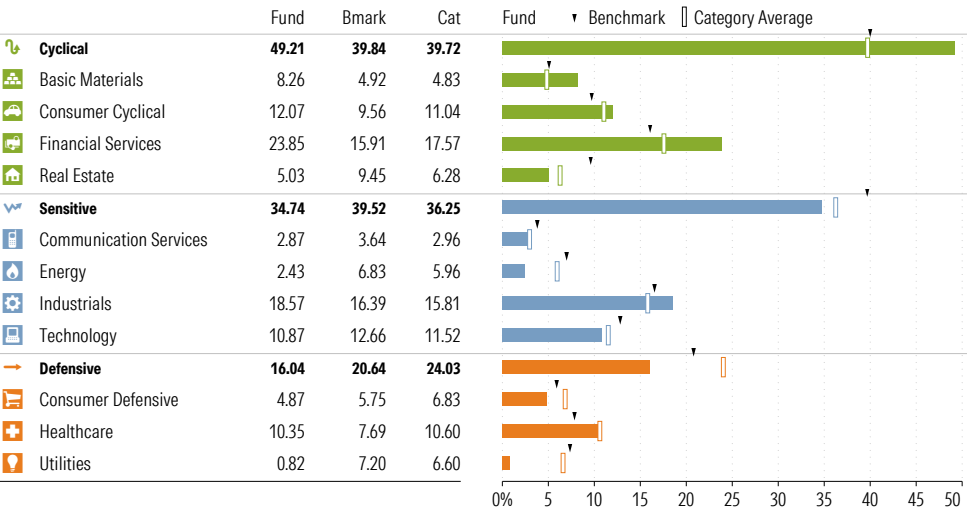
Style Breakdown
