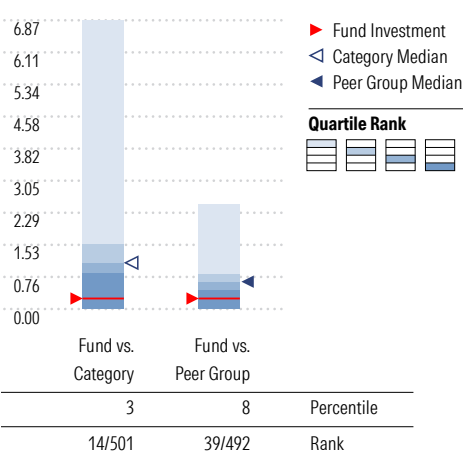

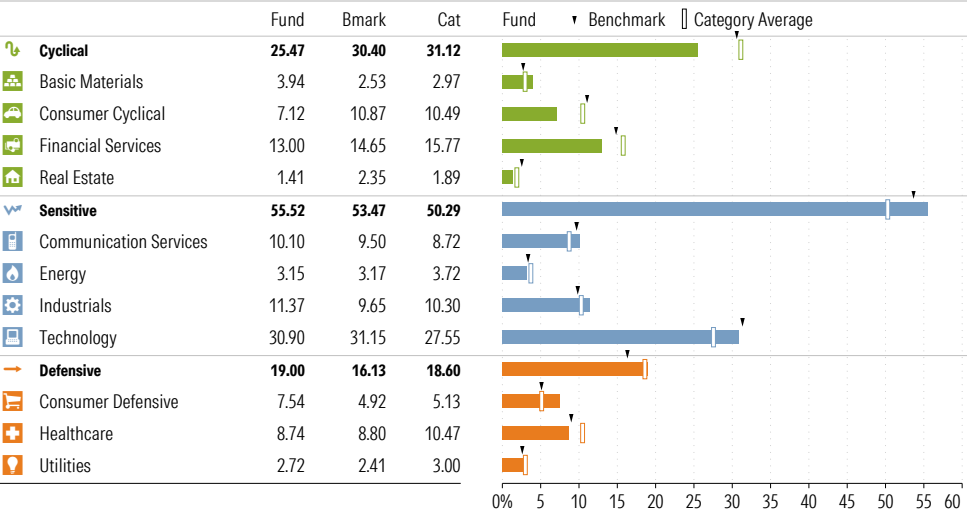

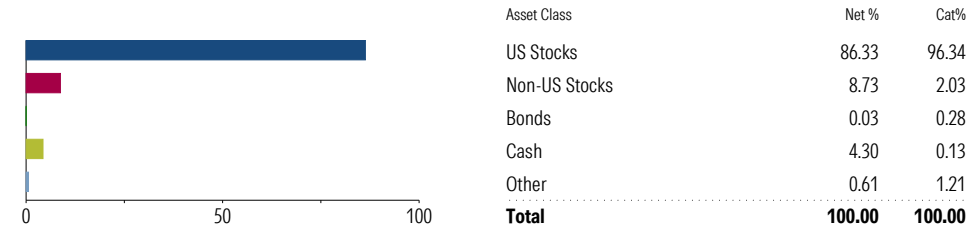

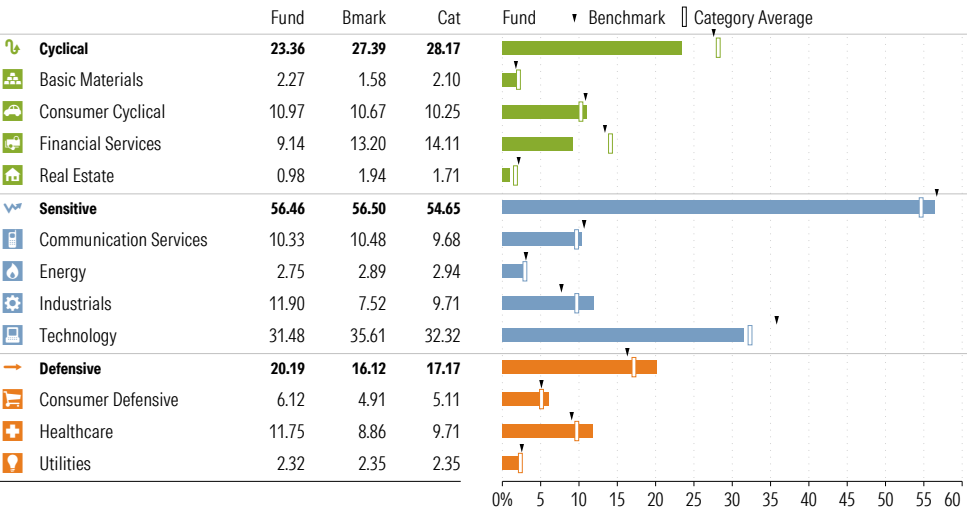

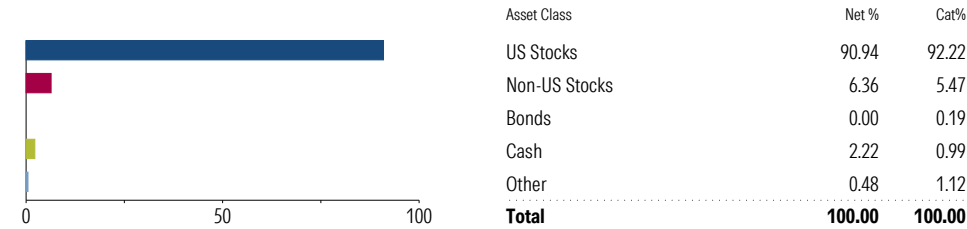

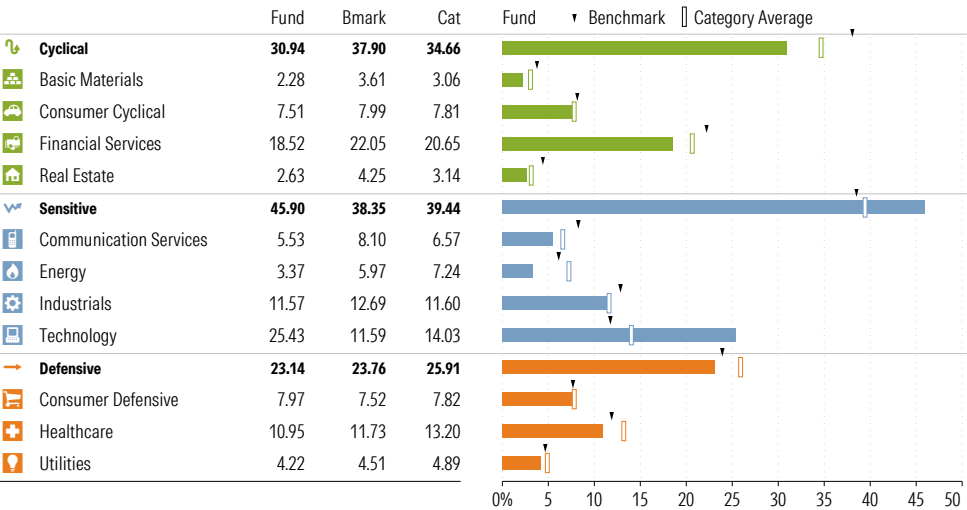

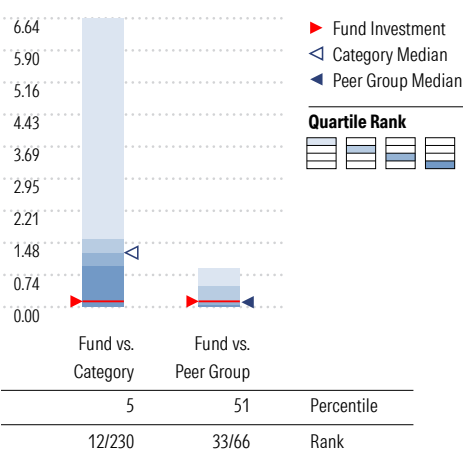

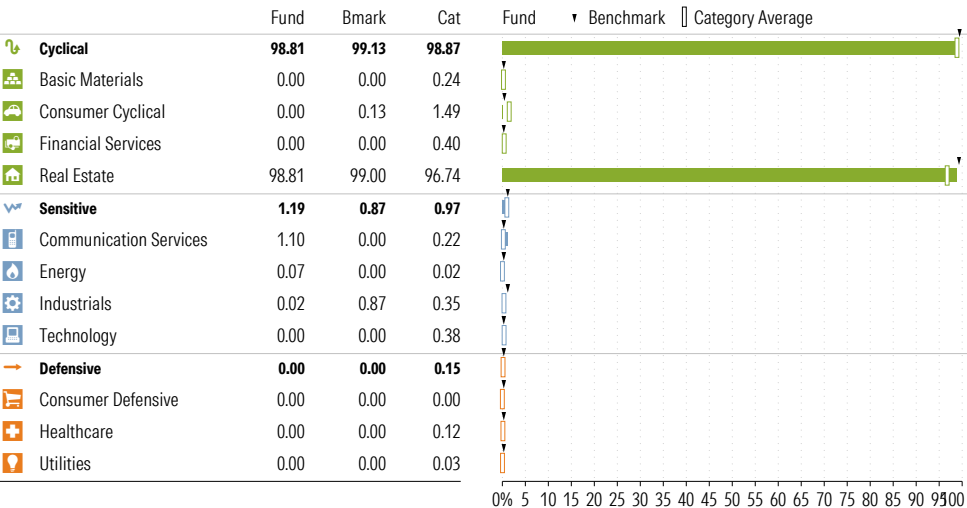

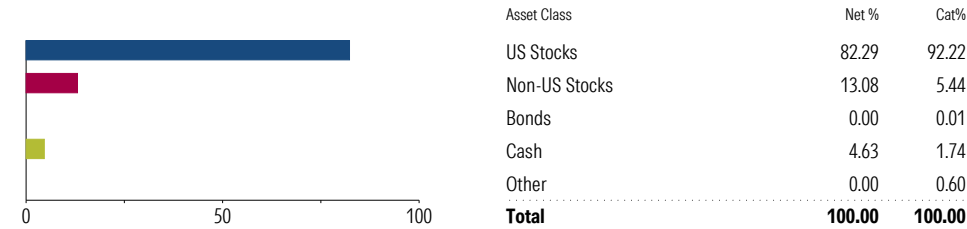

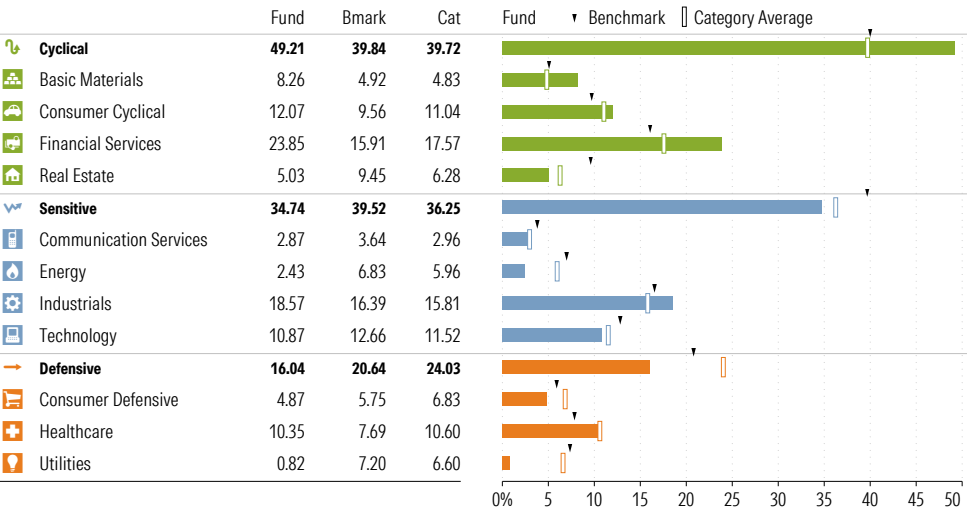

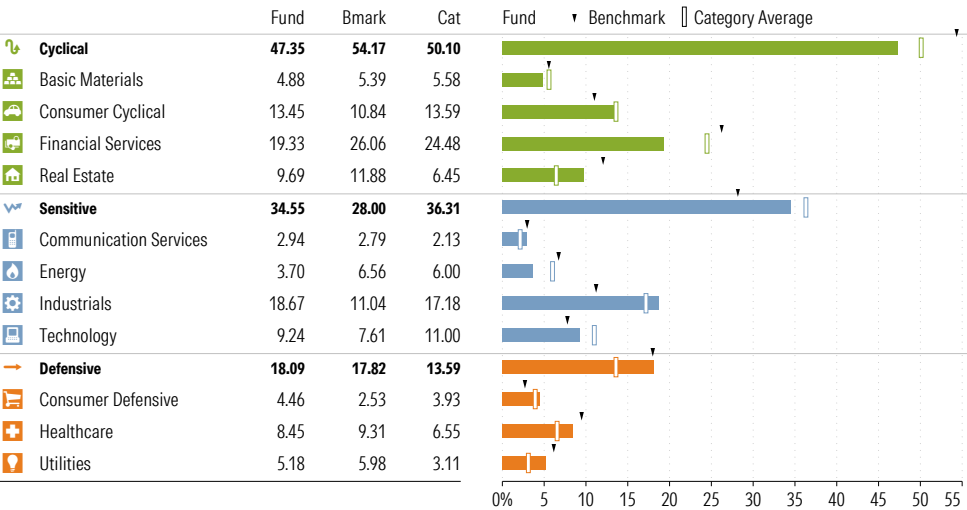
Style Breakdown
