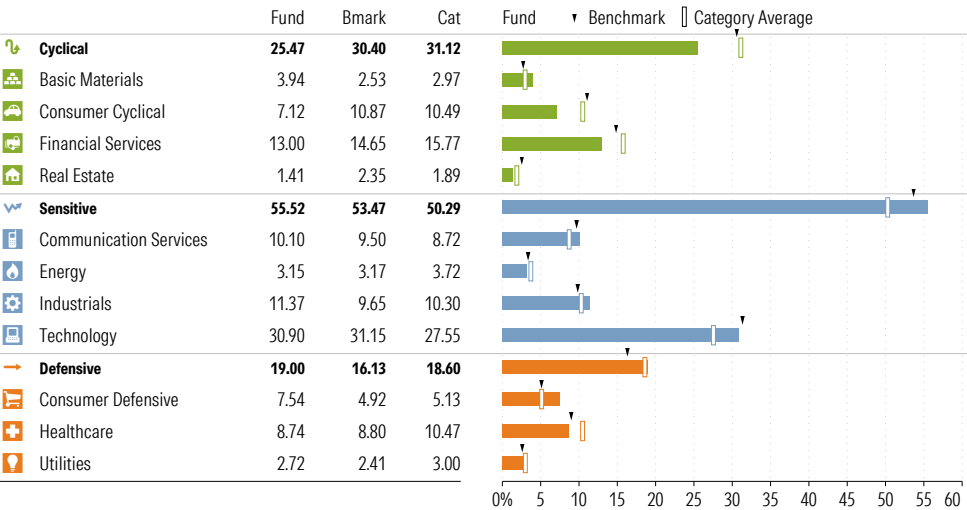

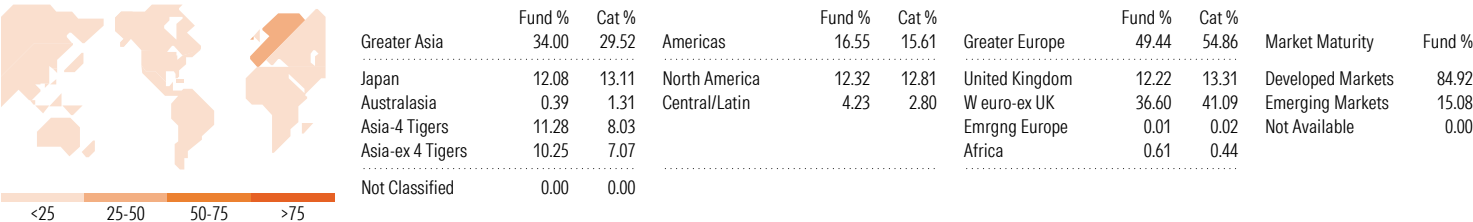
Asset Allocation as of 09-30-2025

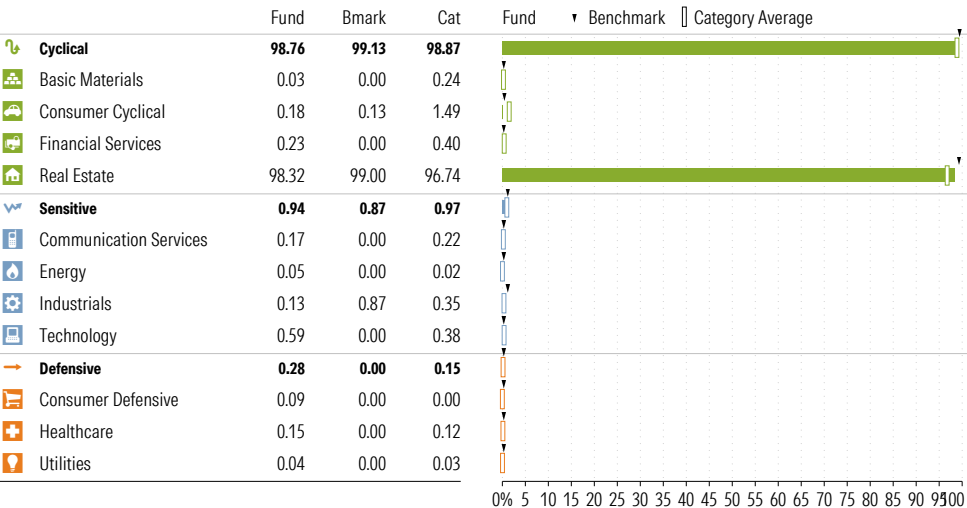

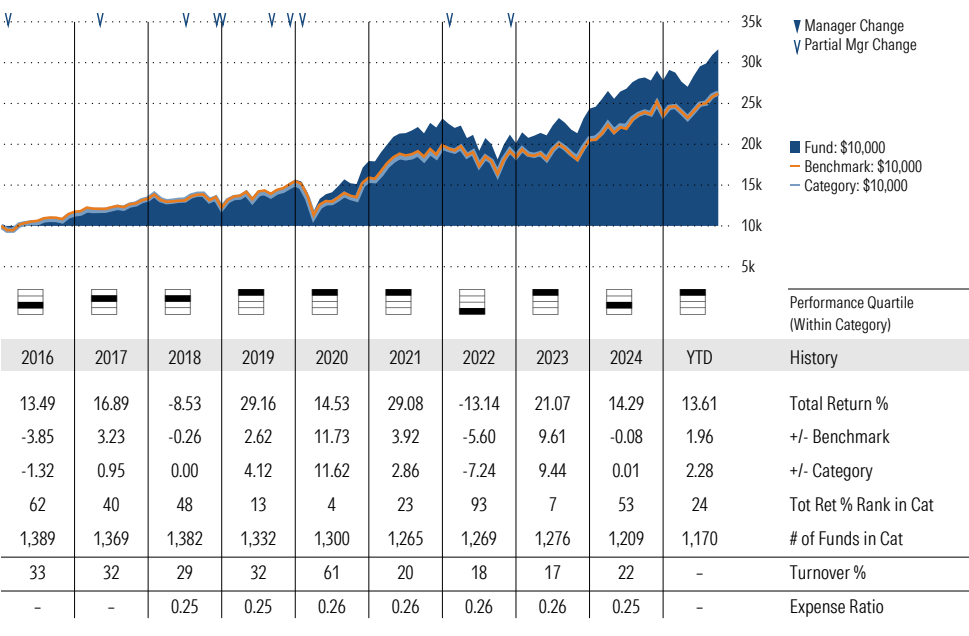
Morningstar Investment Management LLC Analysis

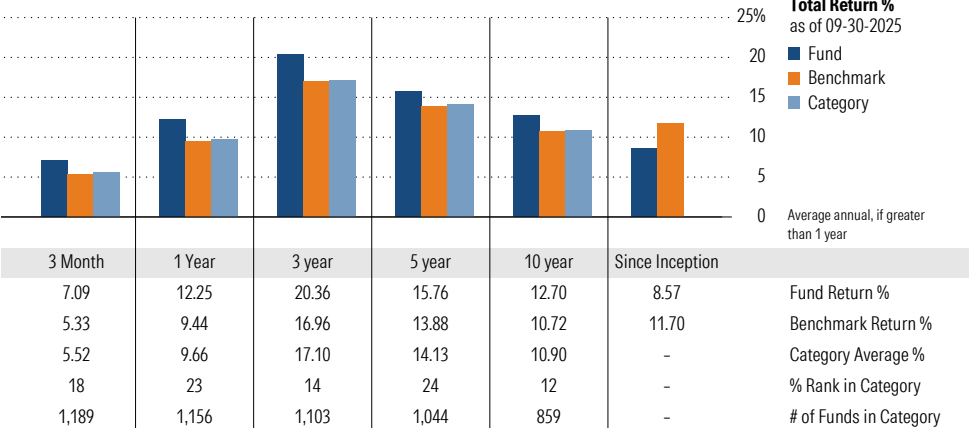

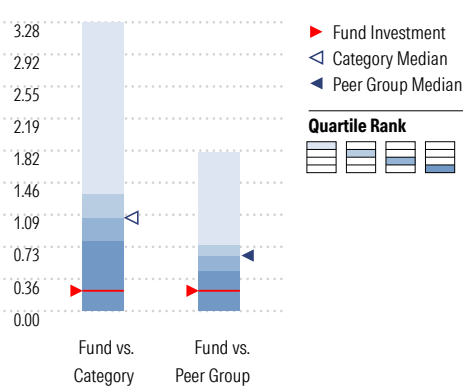
Growth of \$10,000

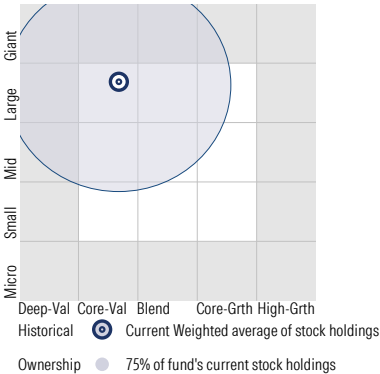

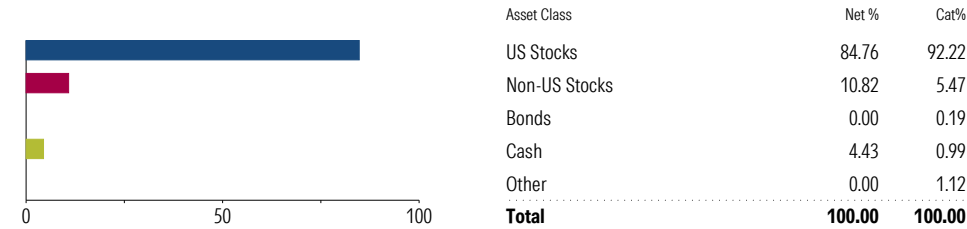

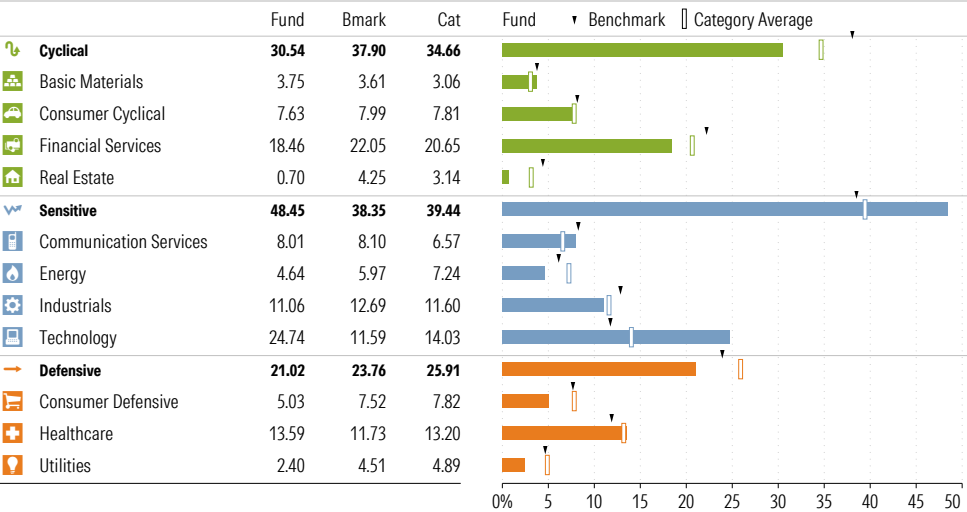
Style Breakdown
