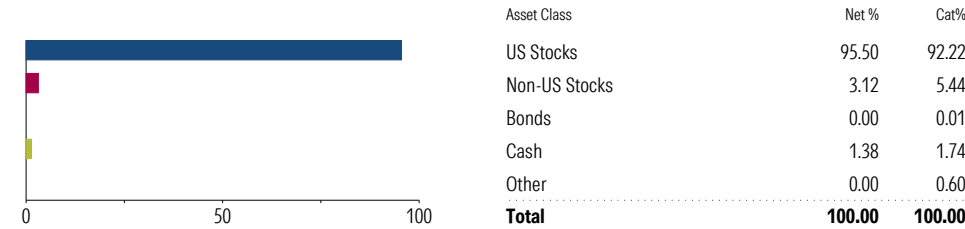

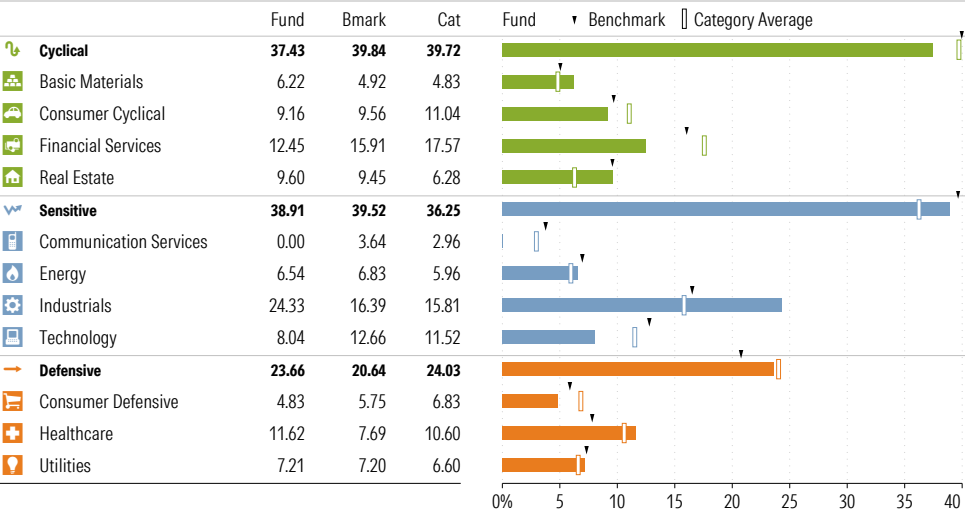

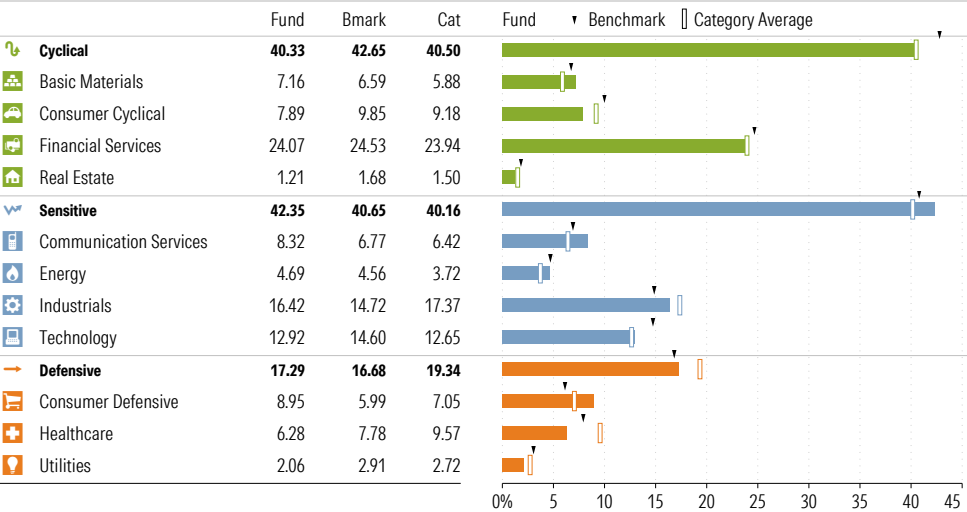

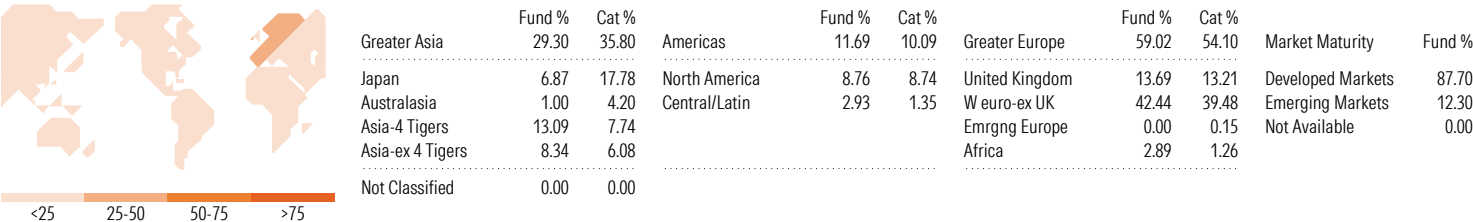

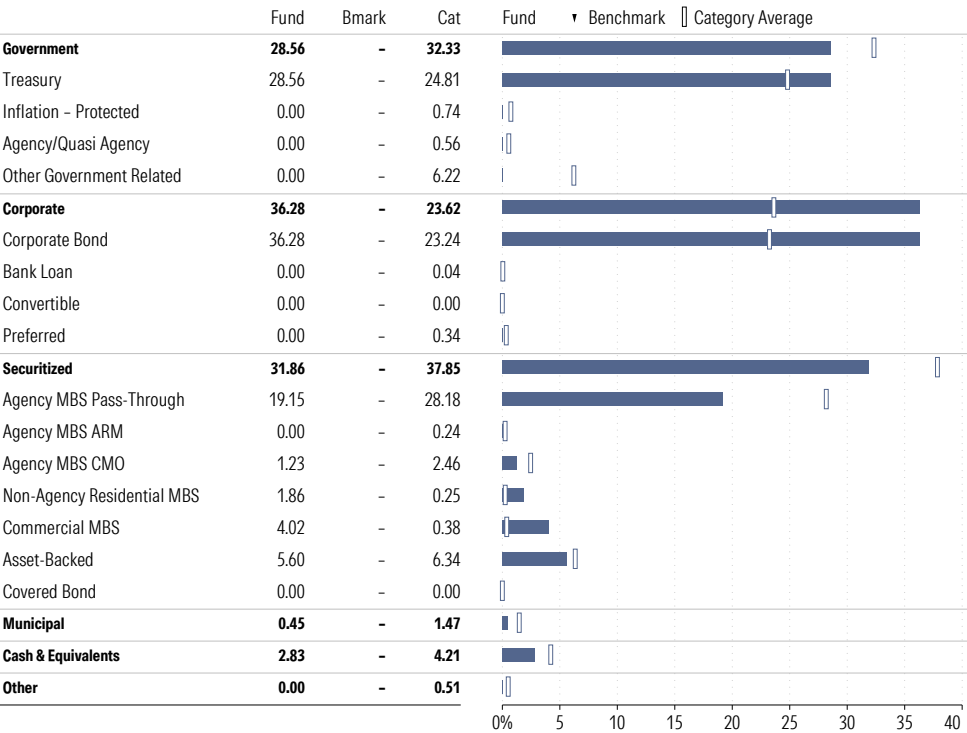

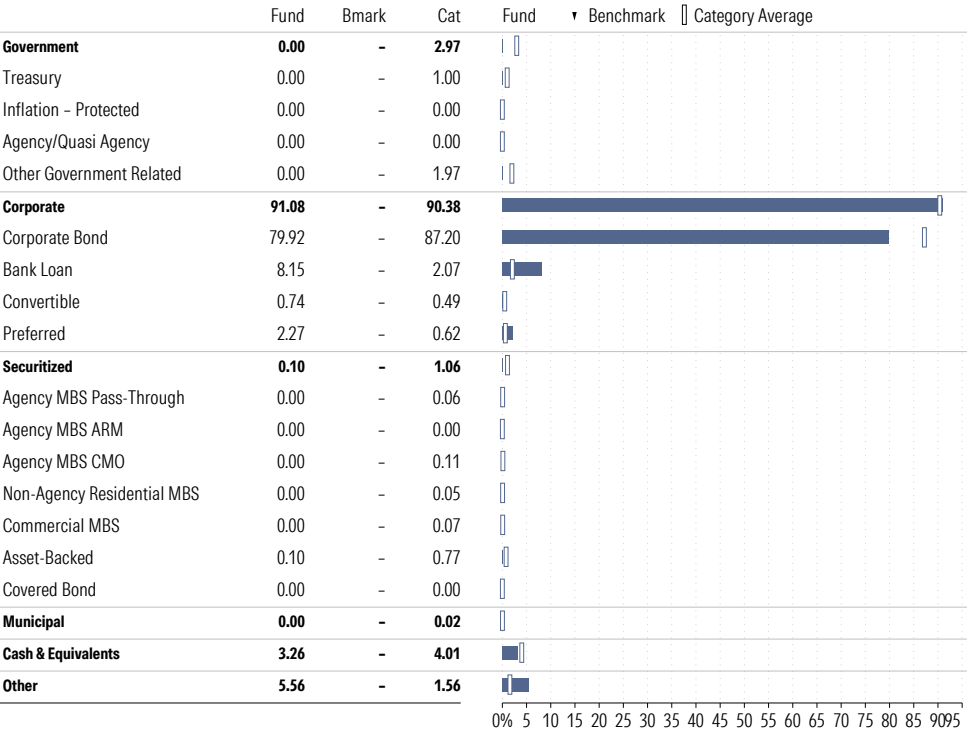

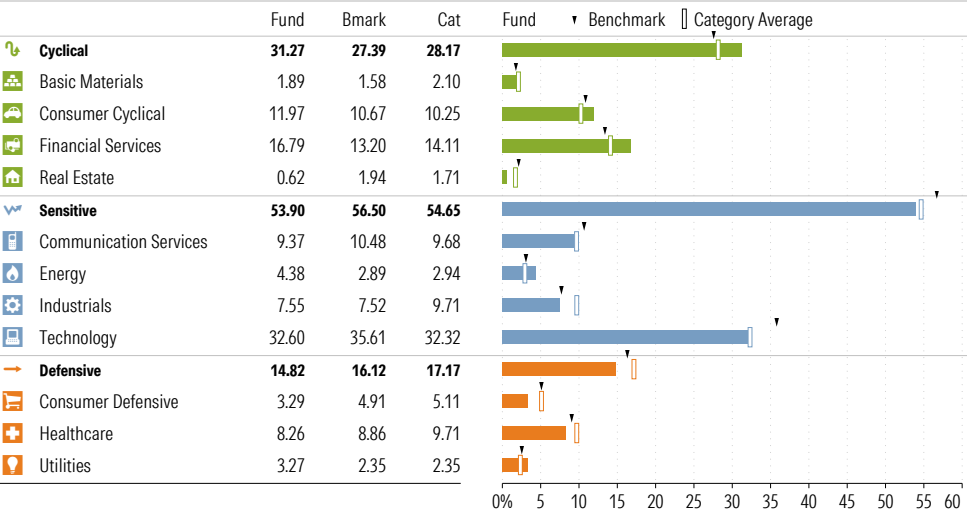

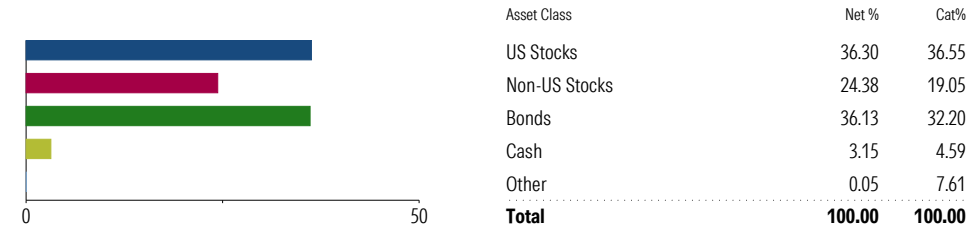

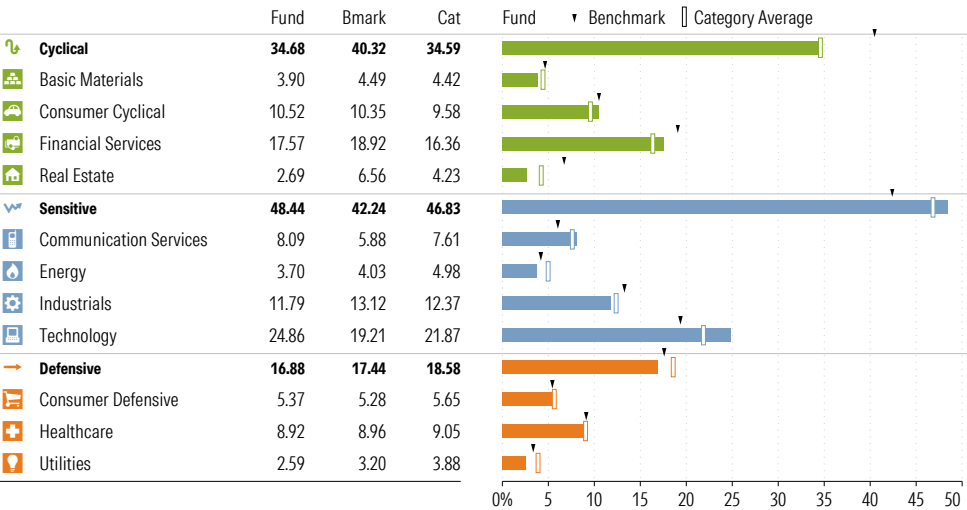

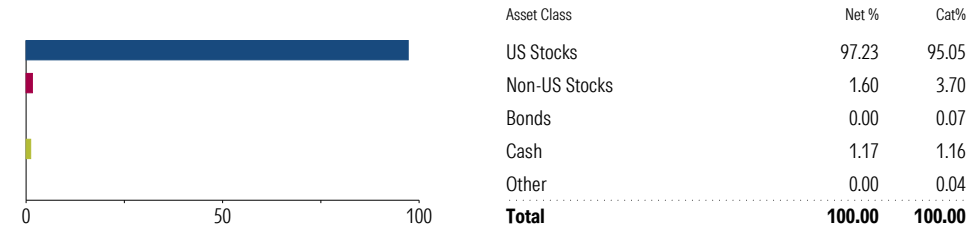

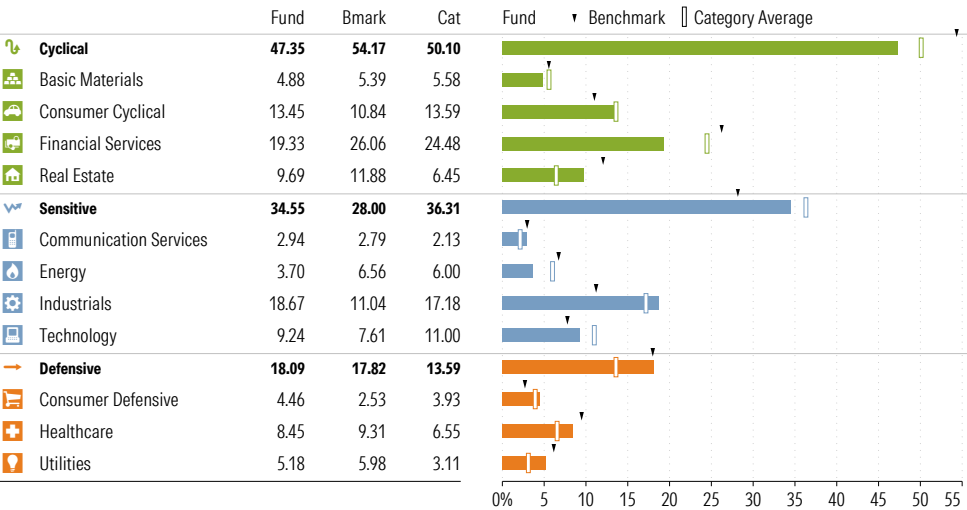
Style Breakdown

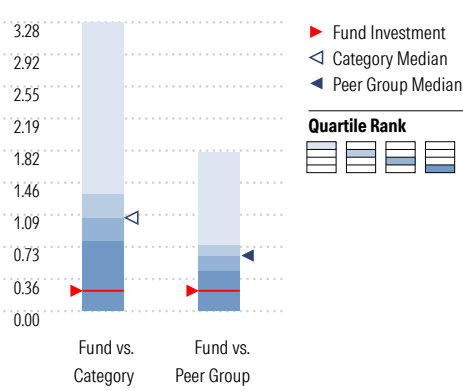

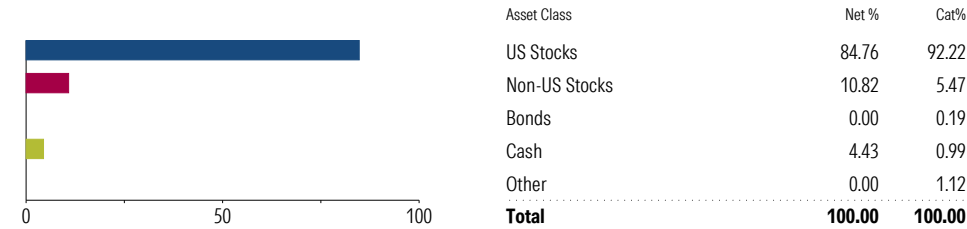

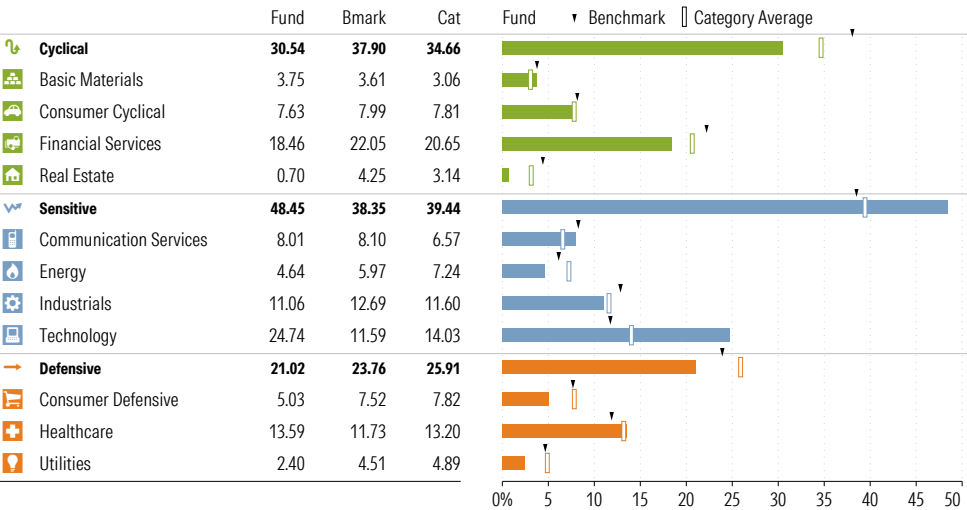
Style Breakdown
