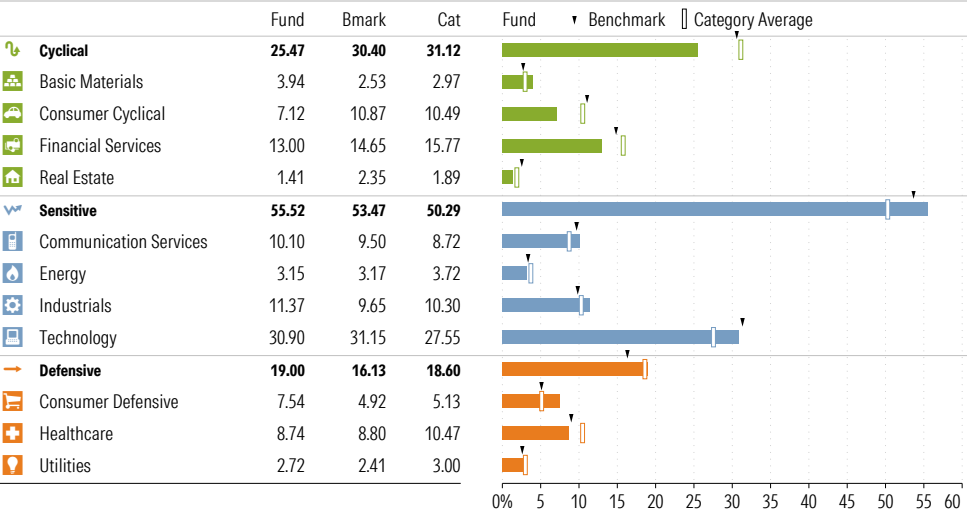

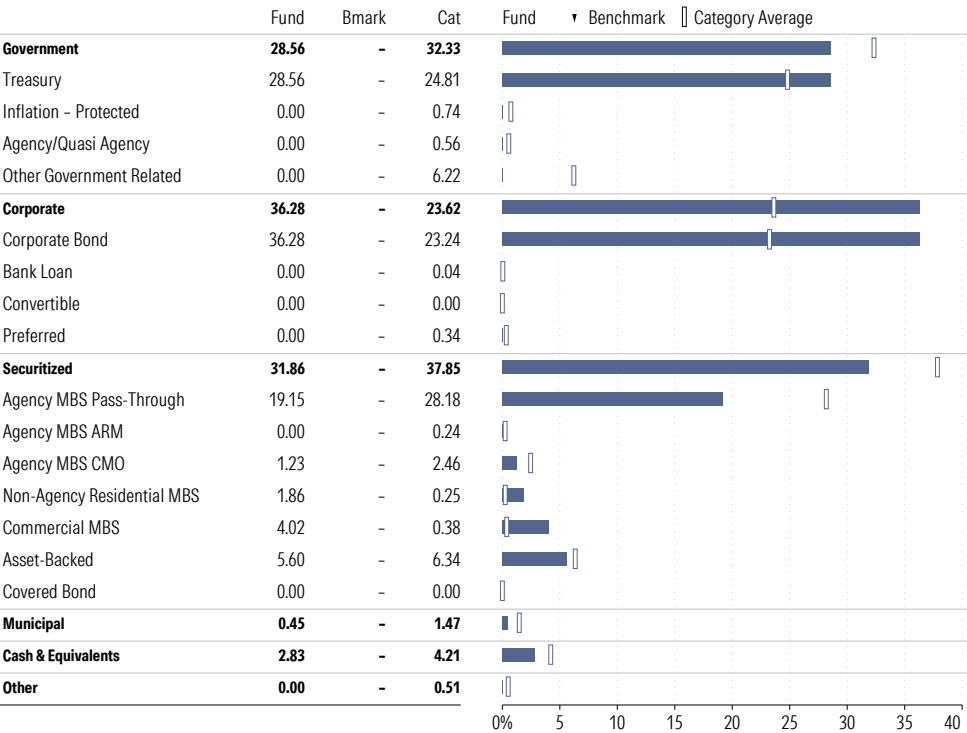

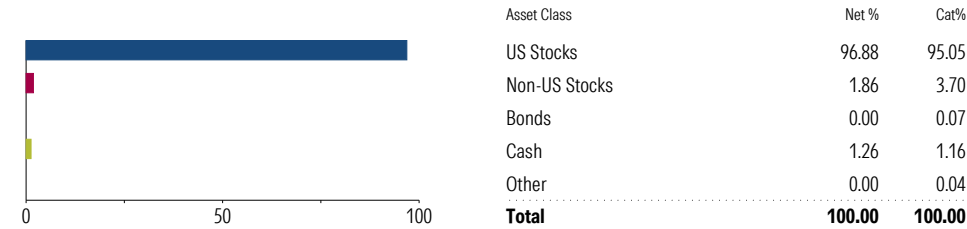

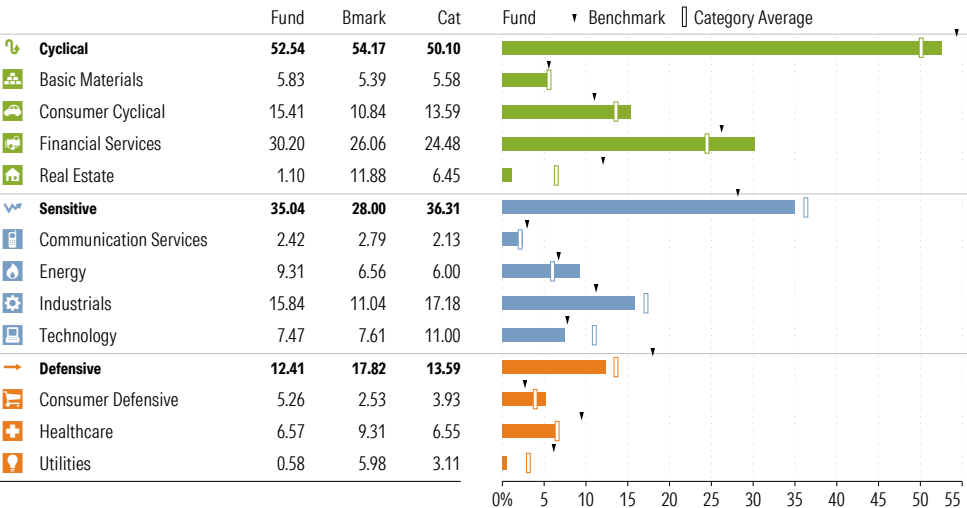

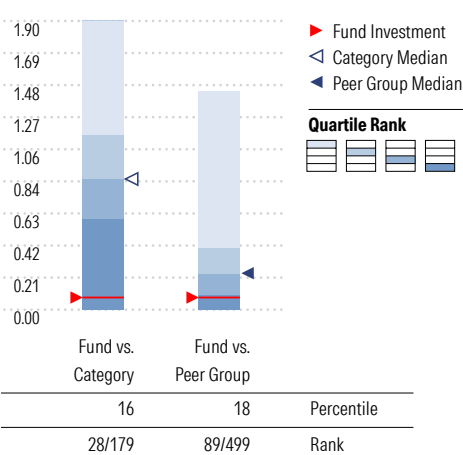

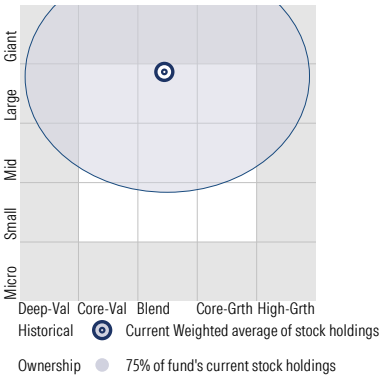

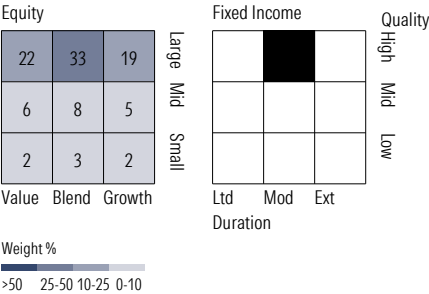

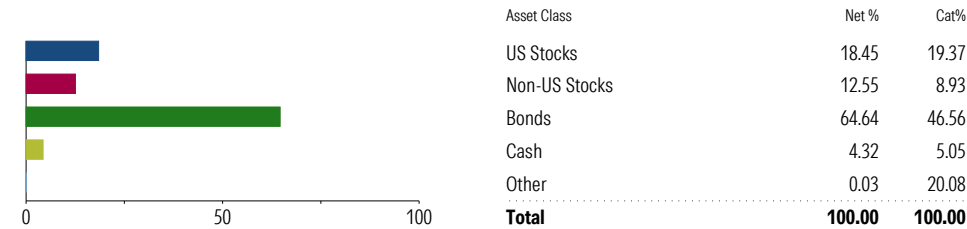

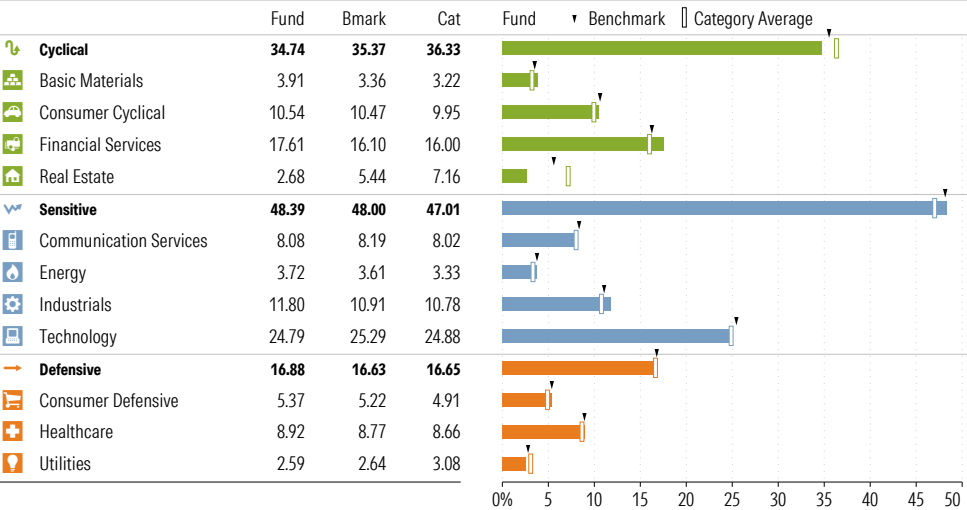
Style Breakdown
