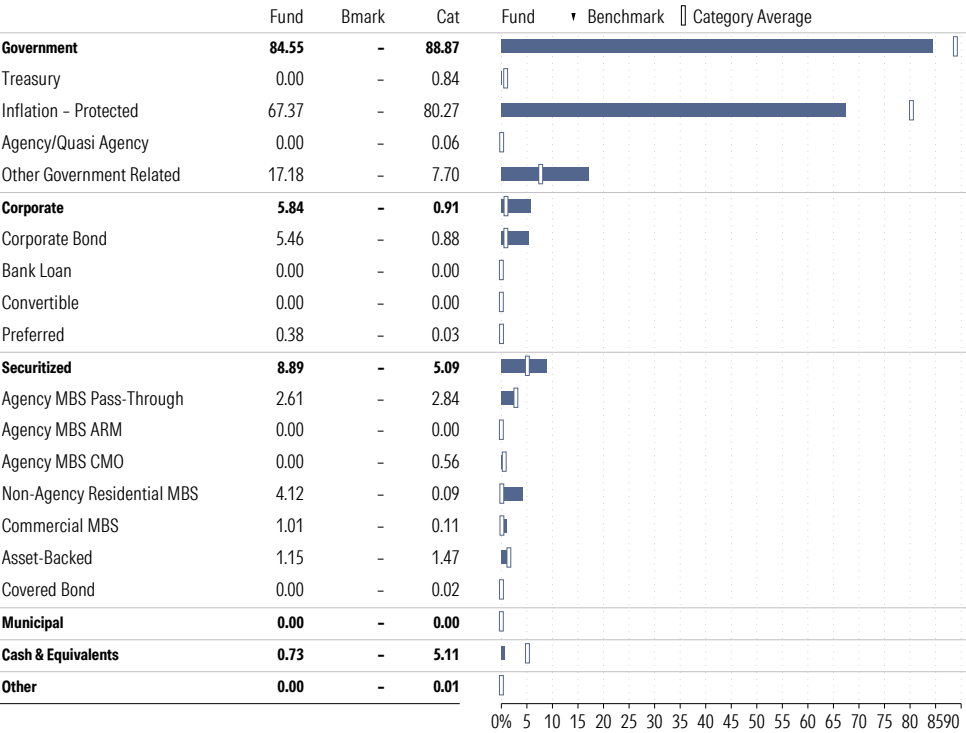

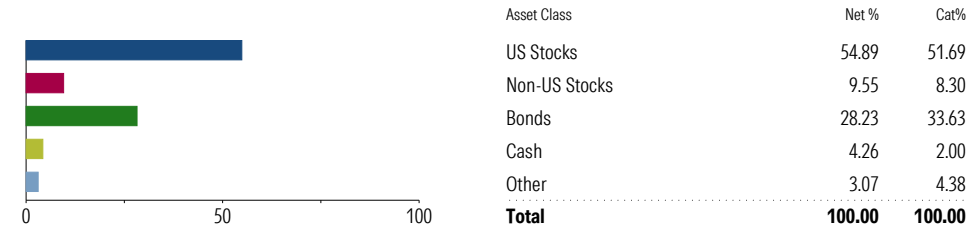

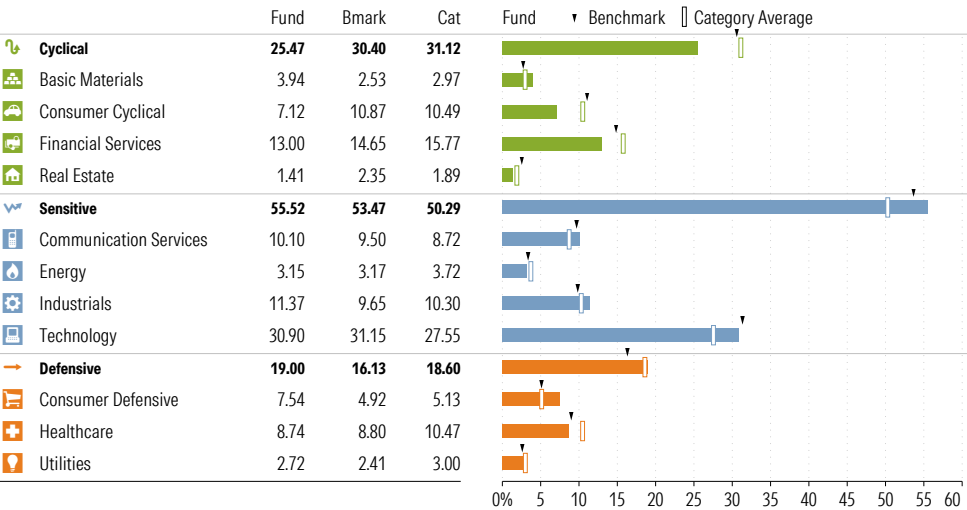

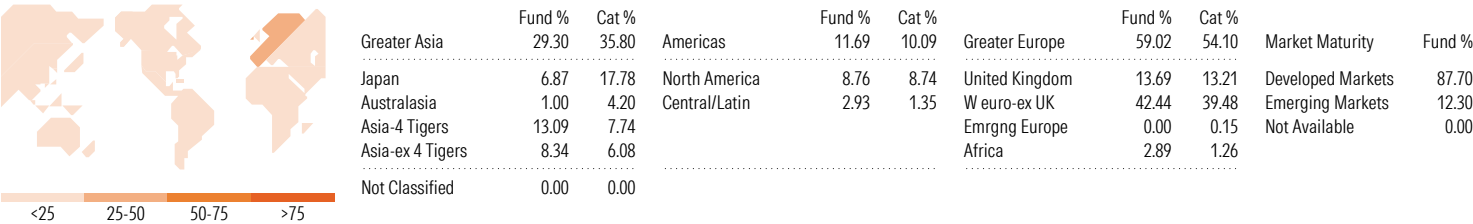

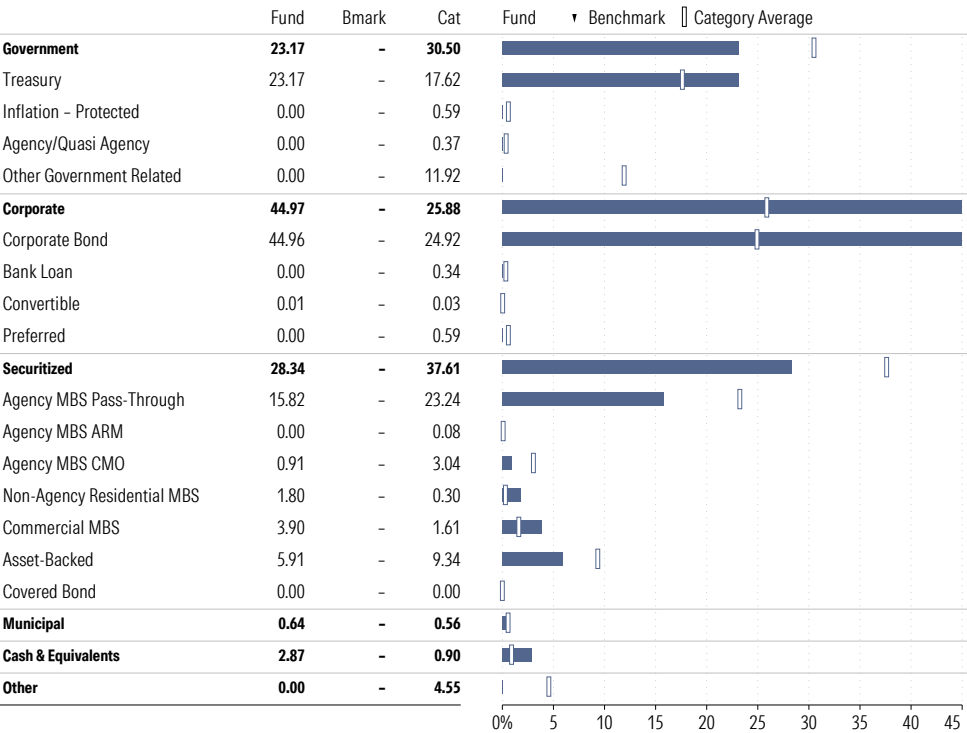

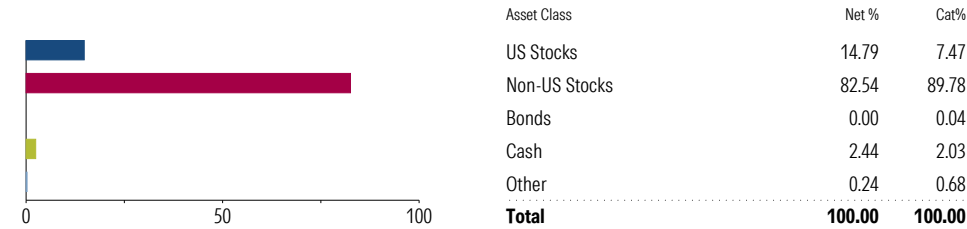

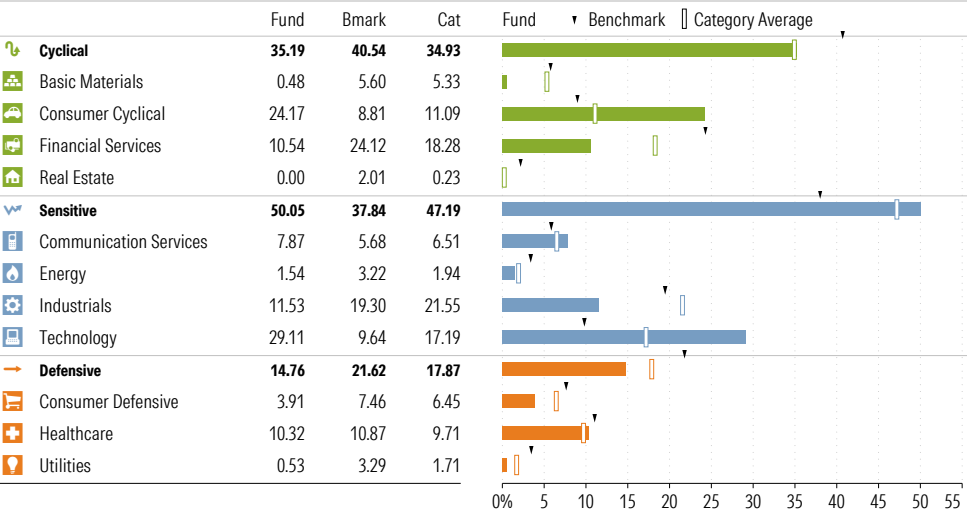

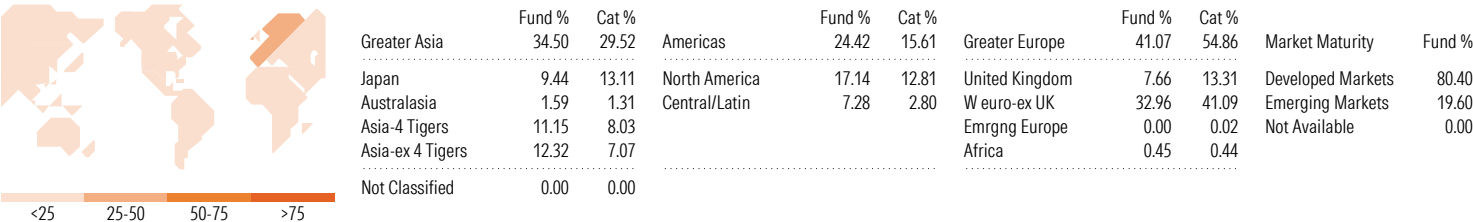
Asset Allocation as of 09-30-2025

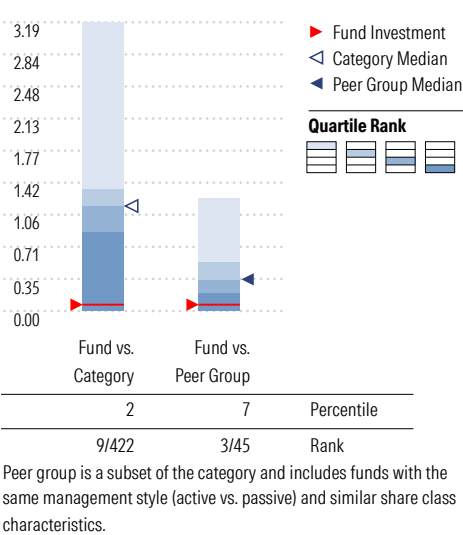

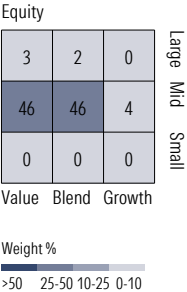

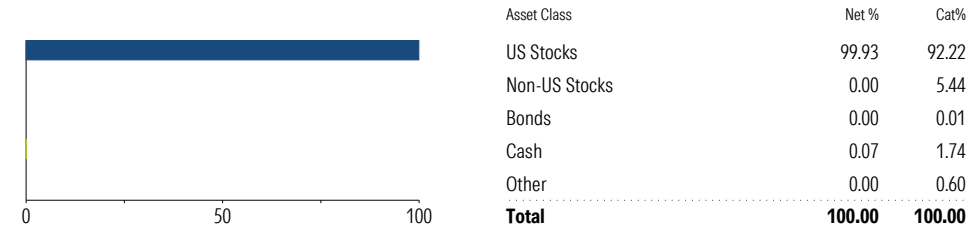

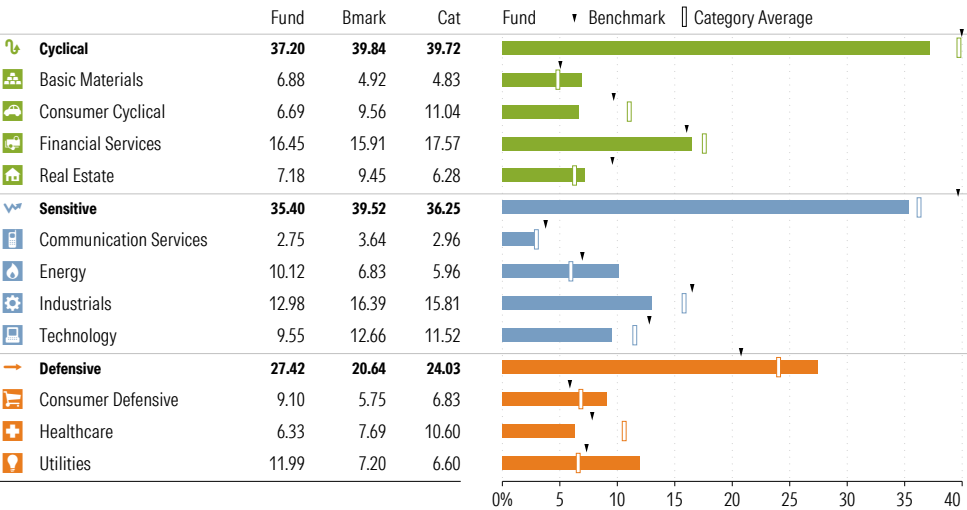
Style Breakdown

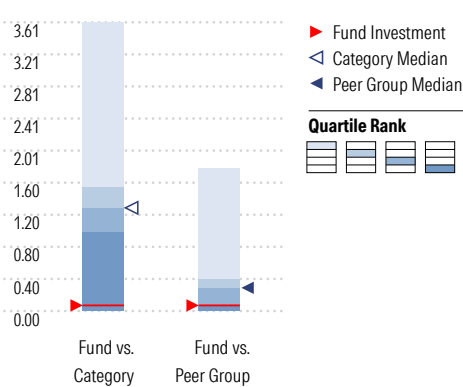

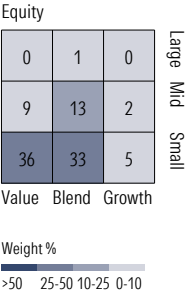

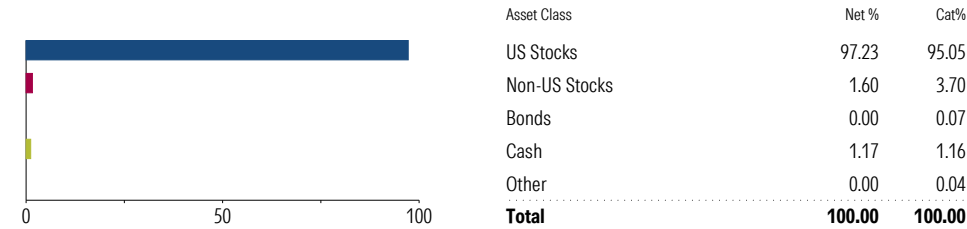

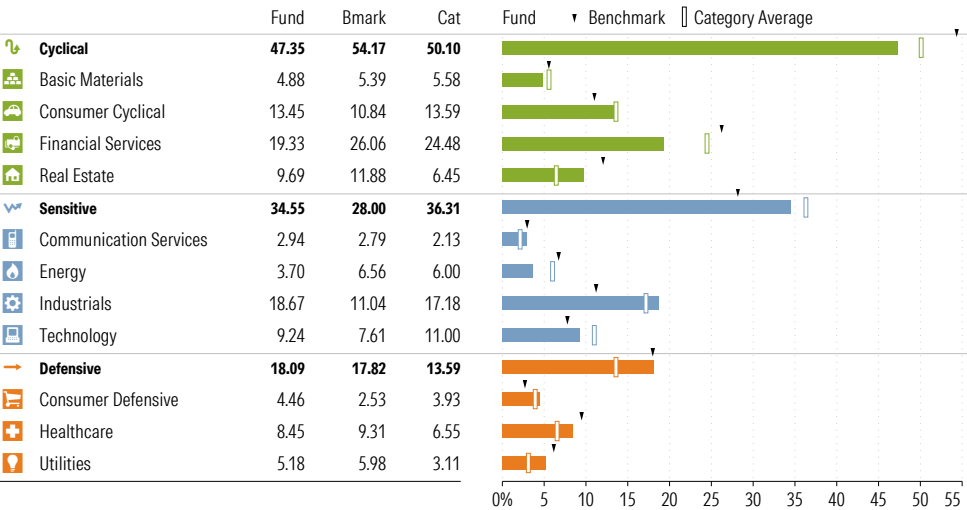
Style Breakdown
