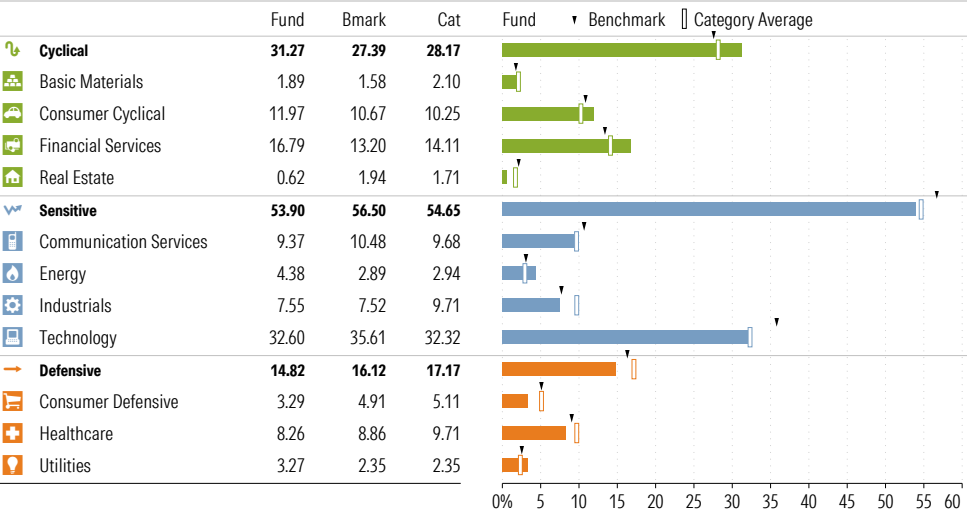

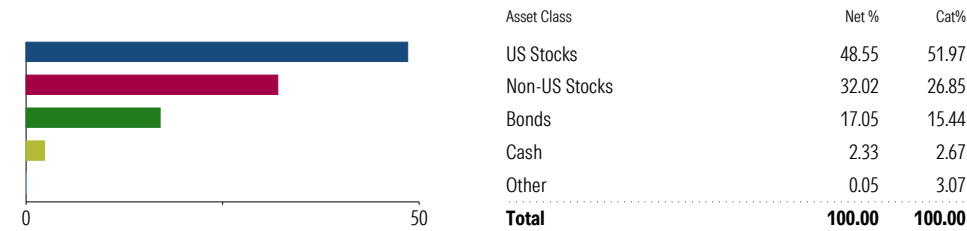

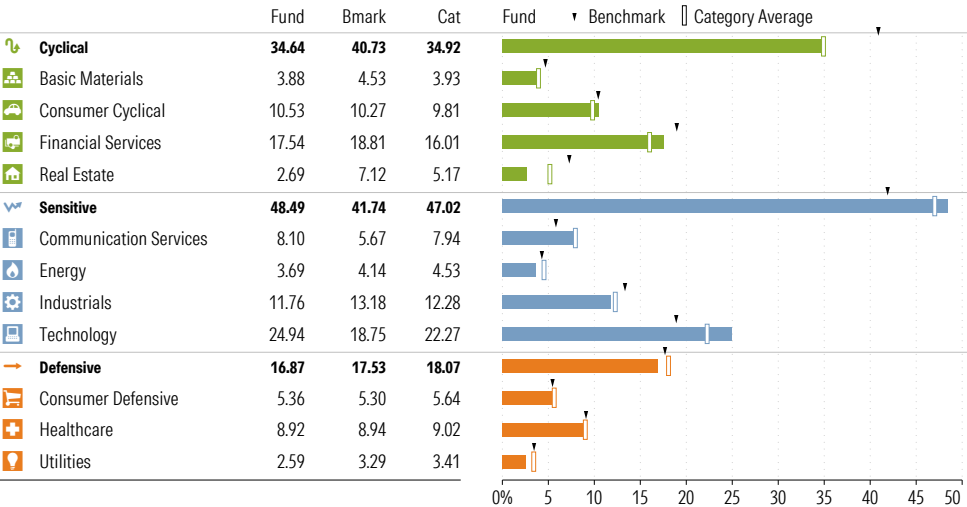
Style Breakdown

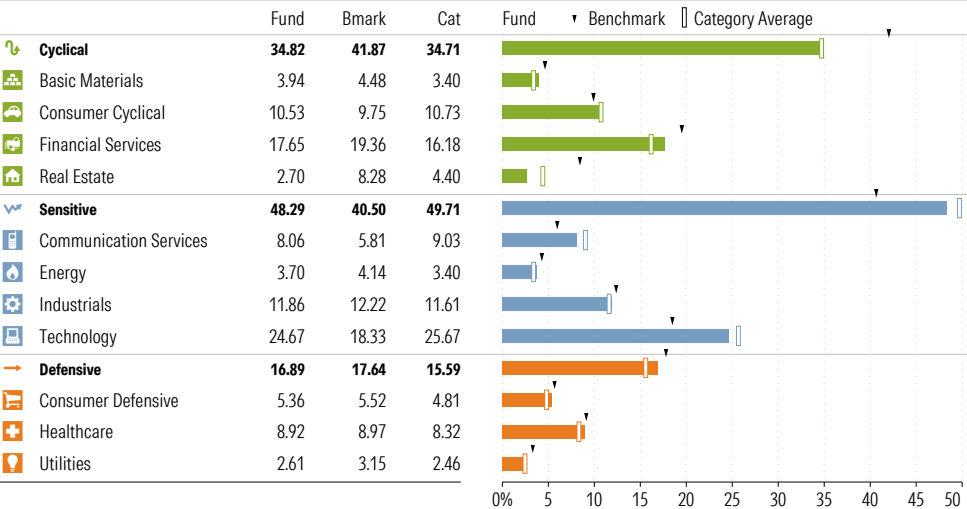

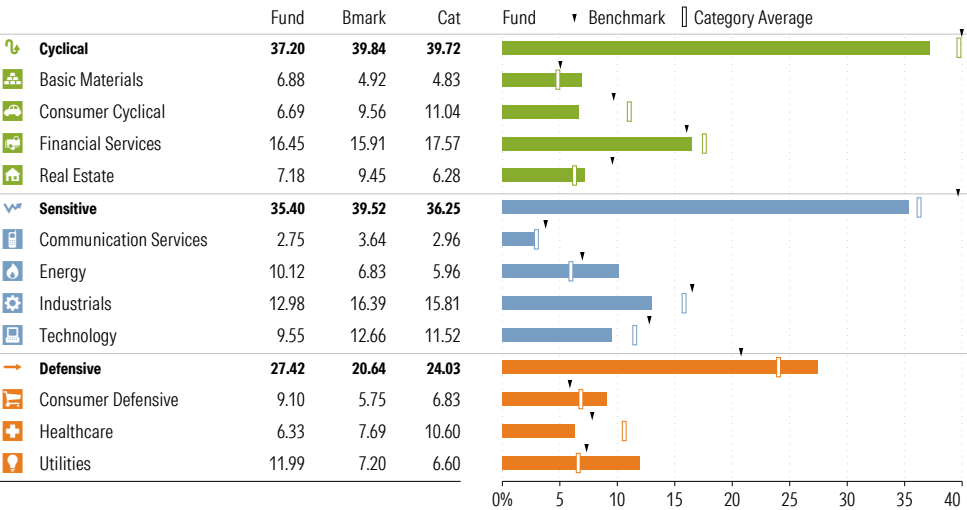
