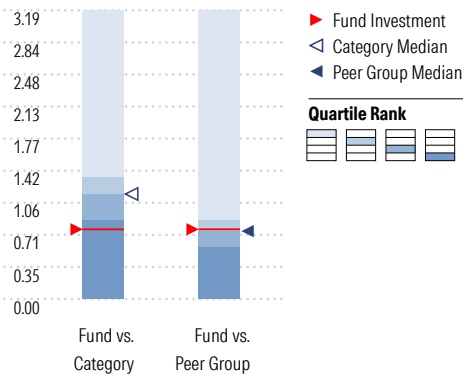

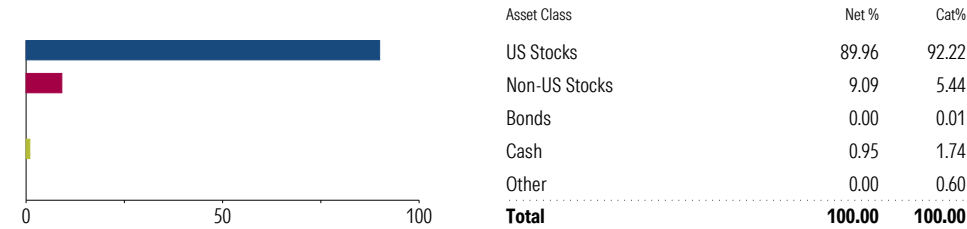

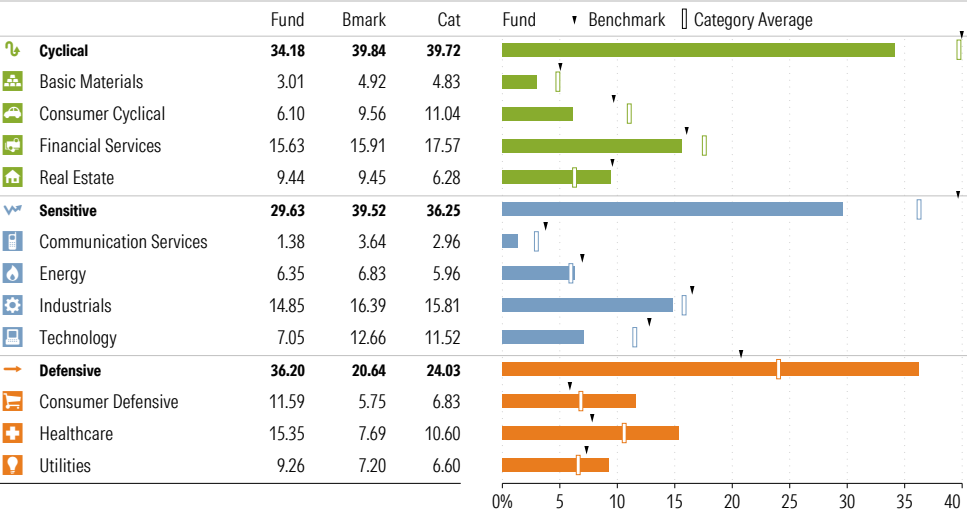

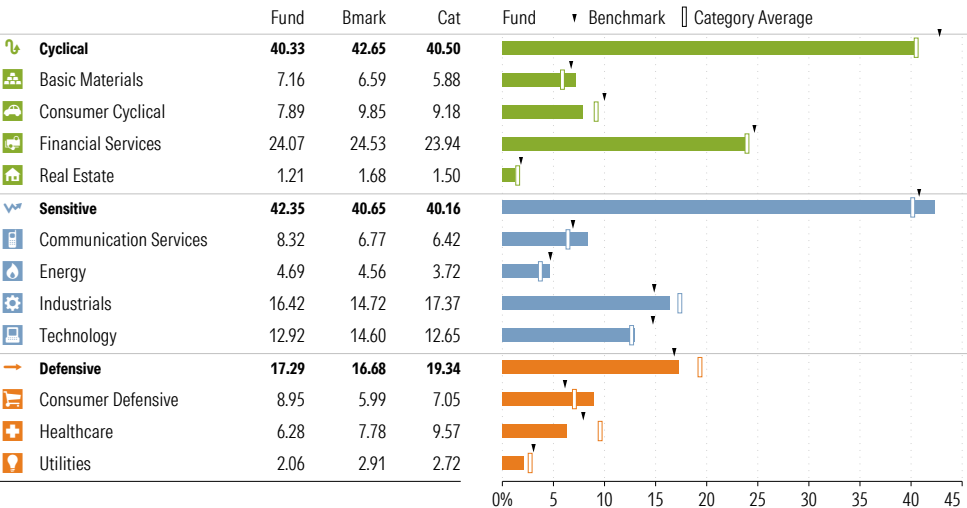

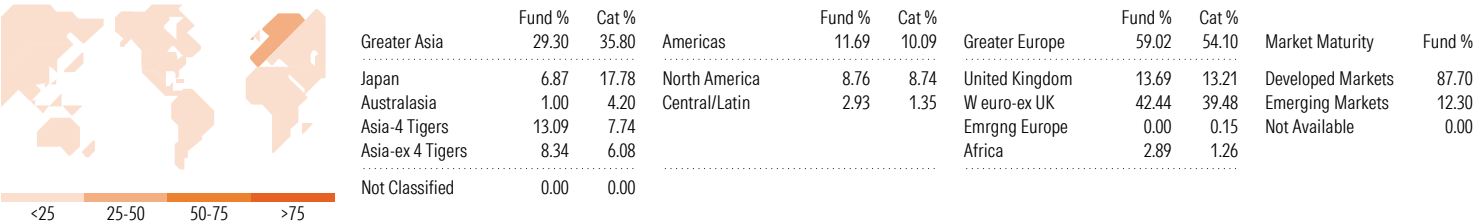

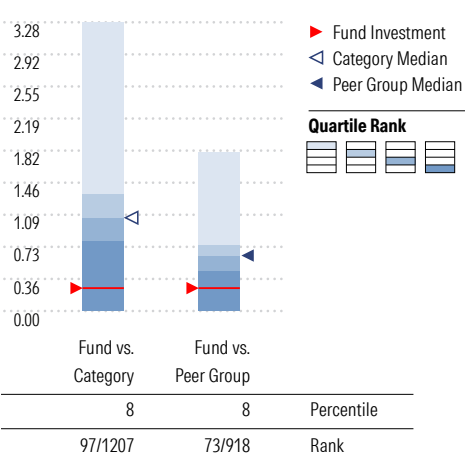

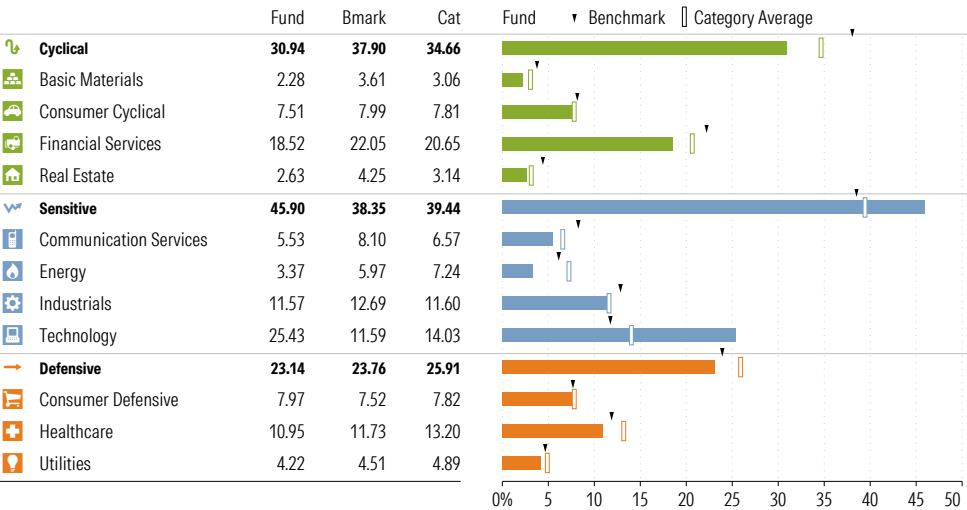

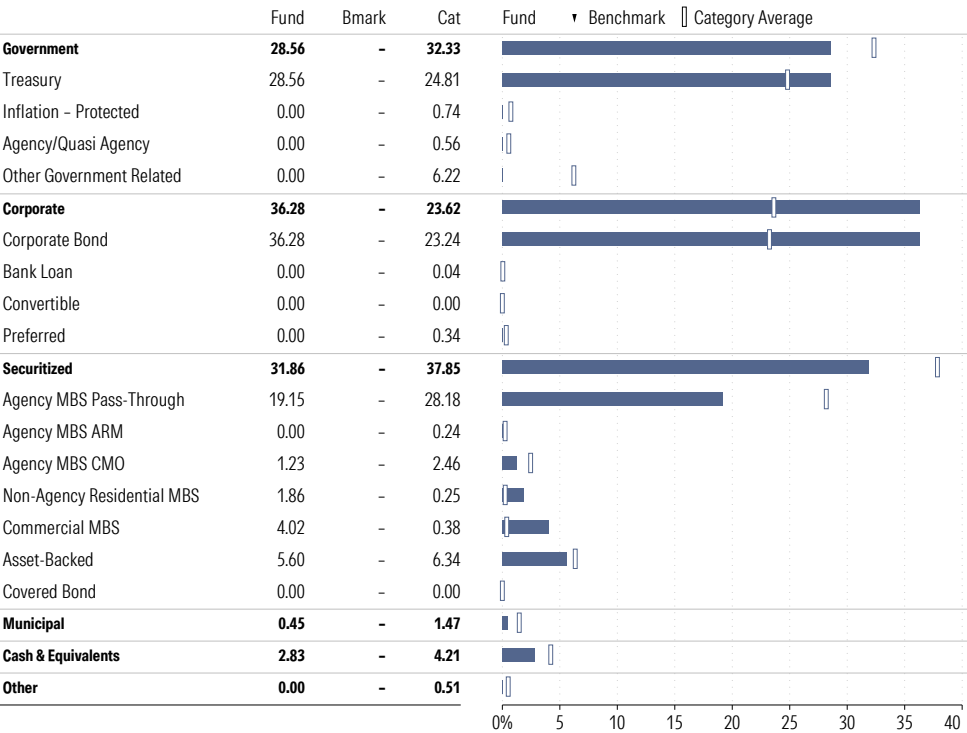

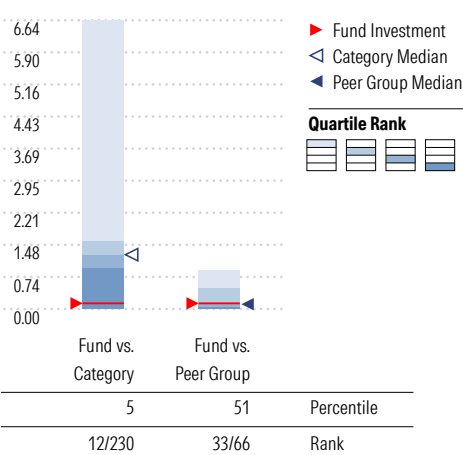

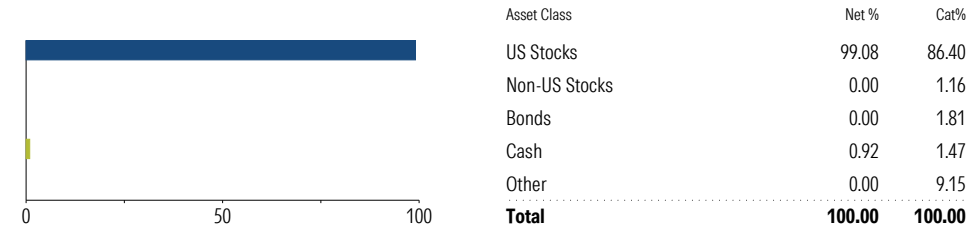

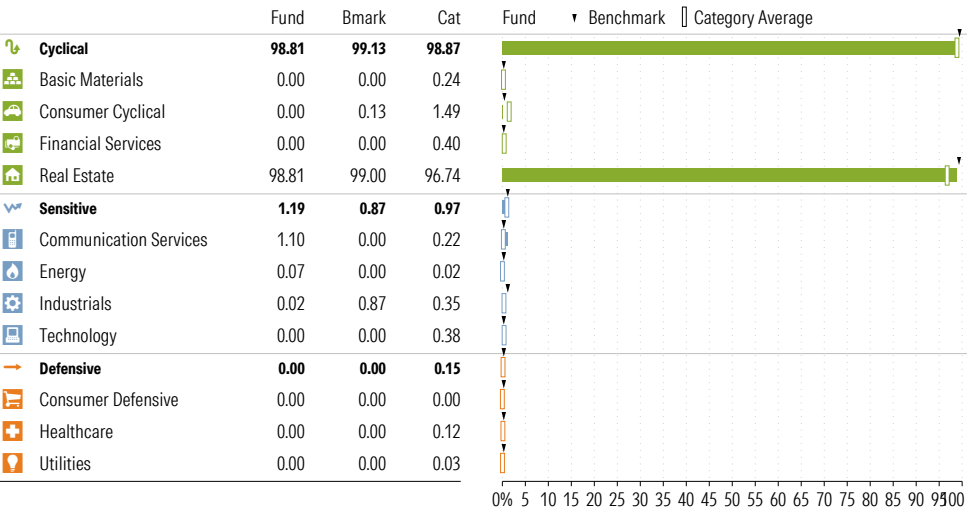
Style Breakdown
