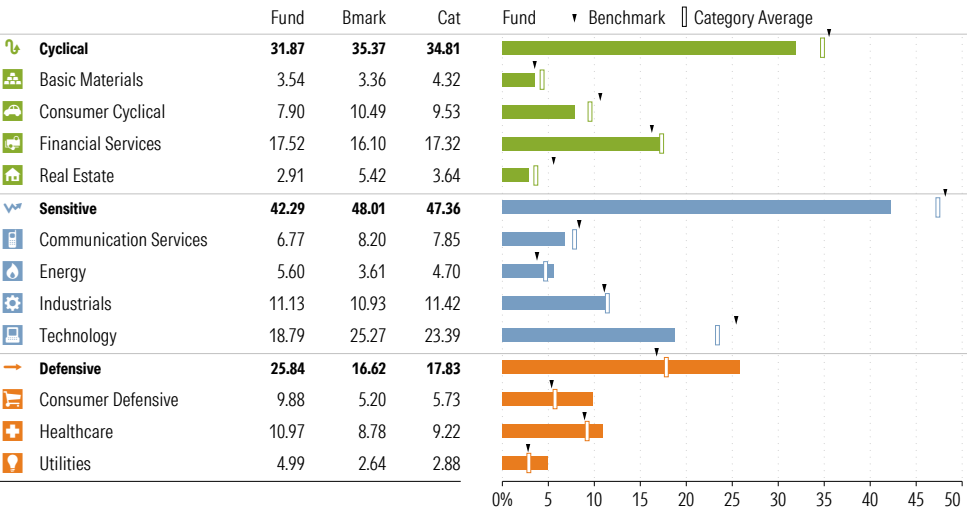

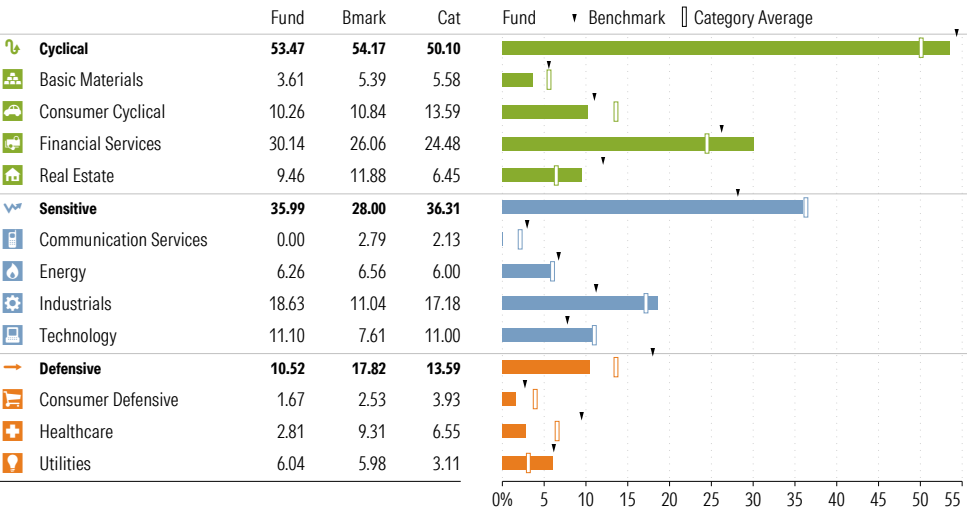

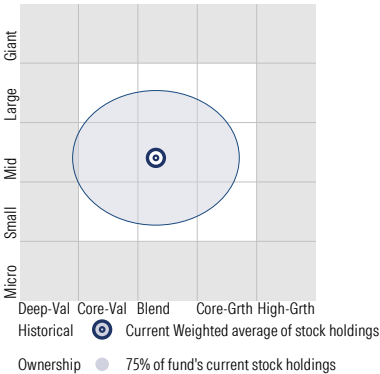

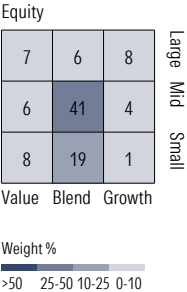

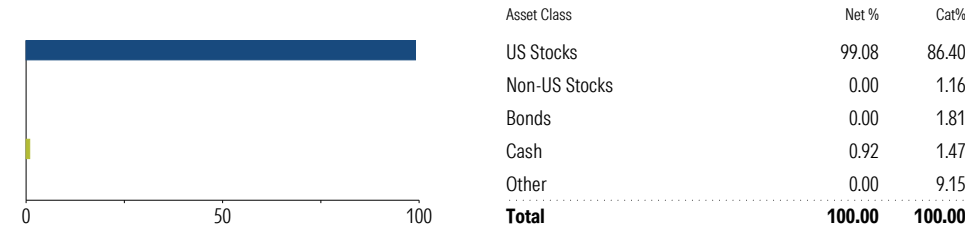

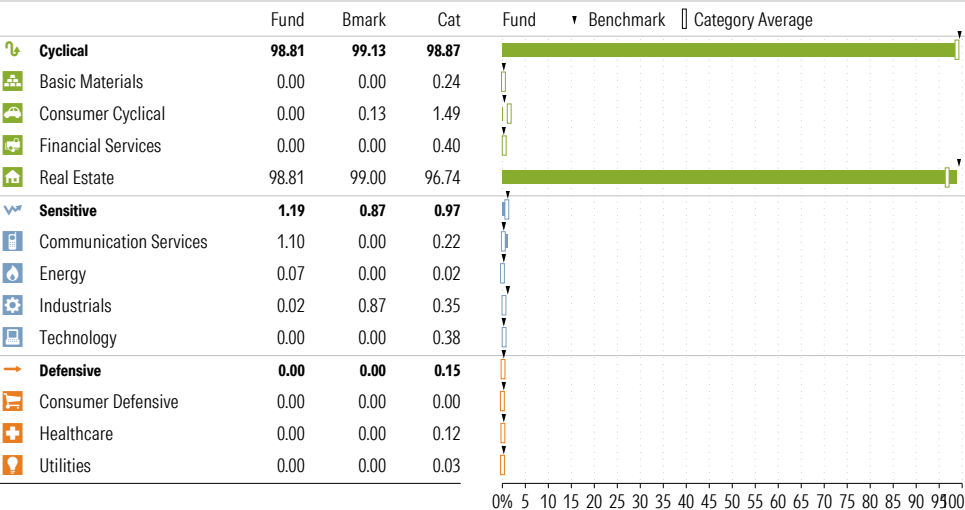
Style Breakdown
