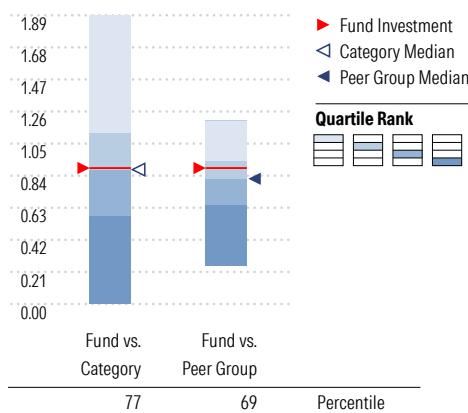
## Growth of \$10,000

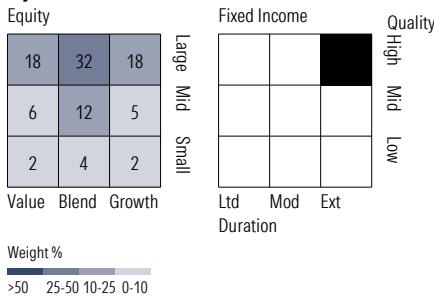

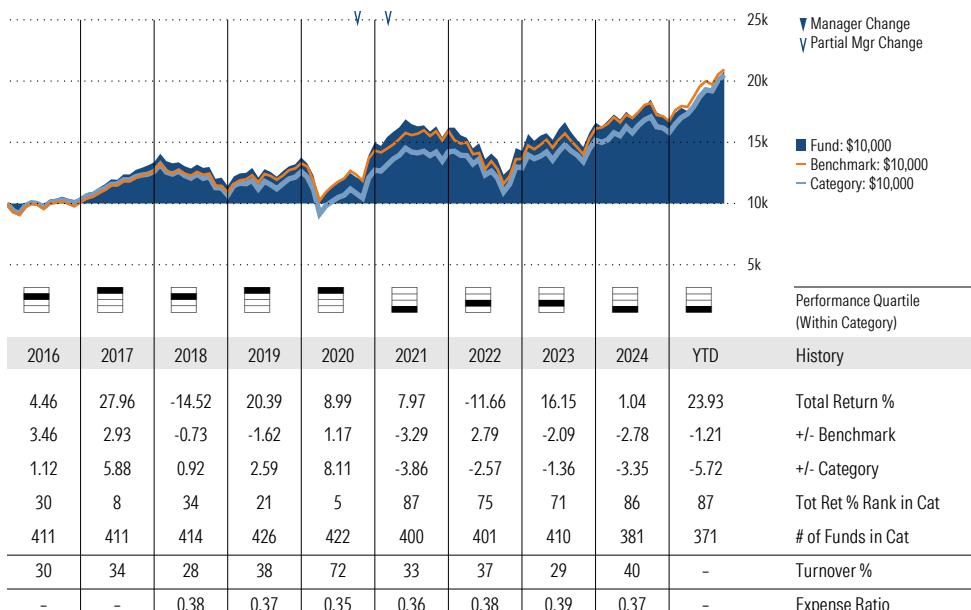
## Morningstar Investment Management LLC Analysis
