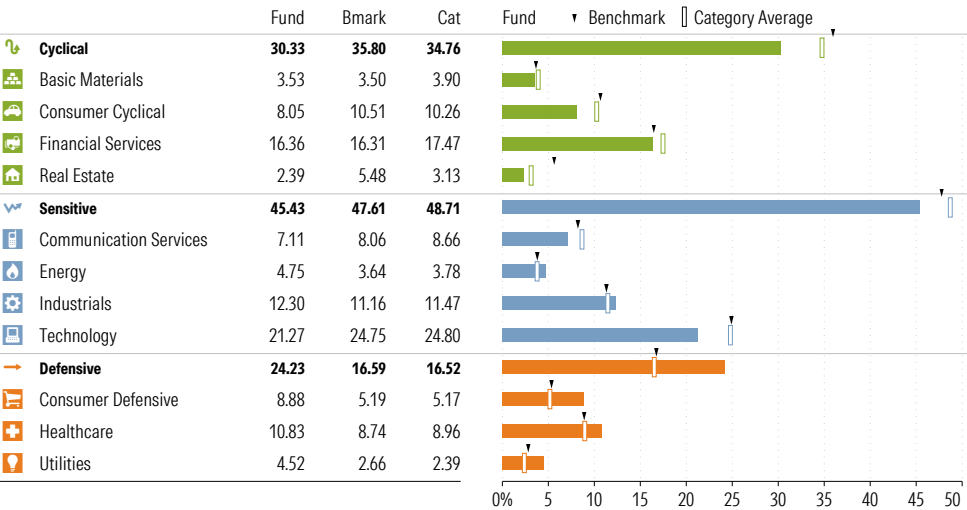

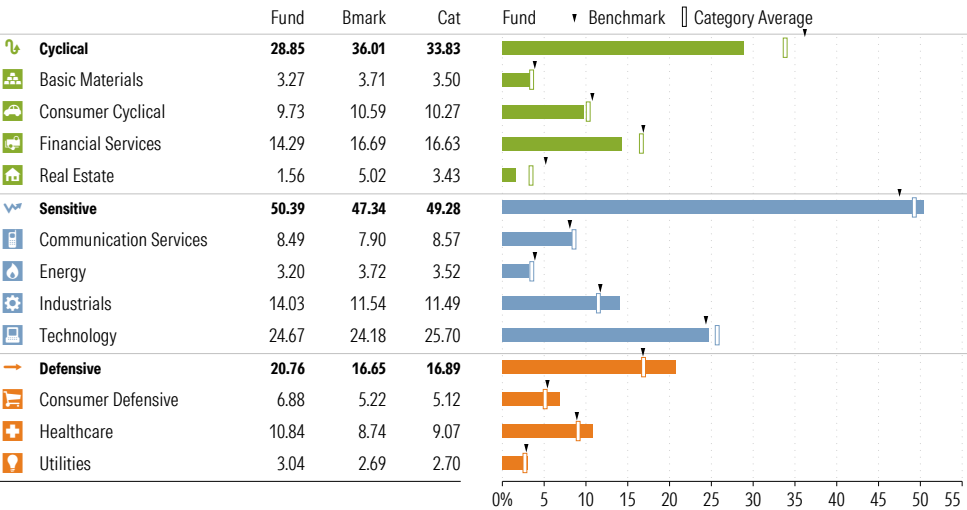
Style Breakdown

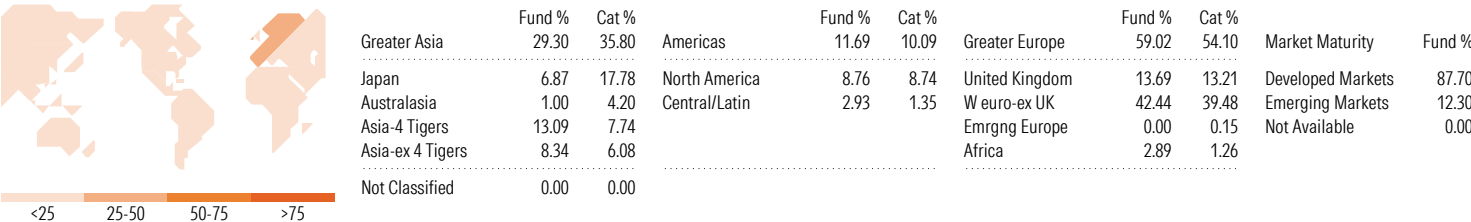

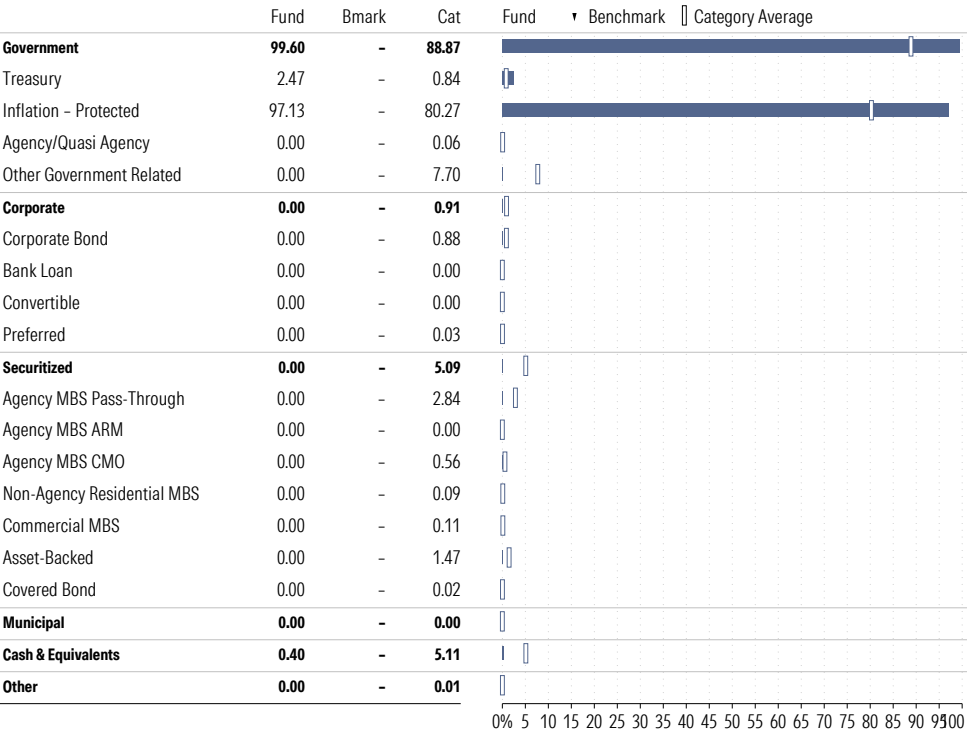

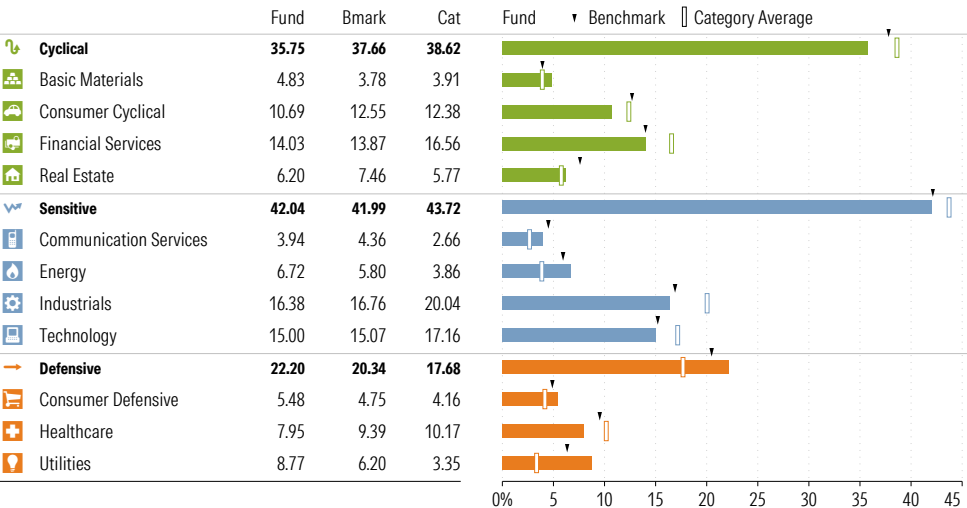
