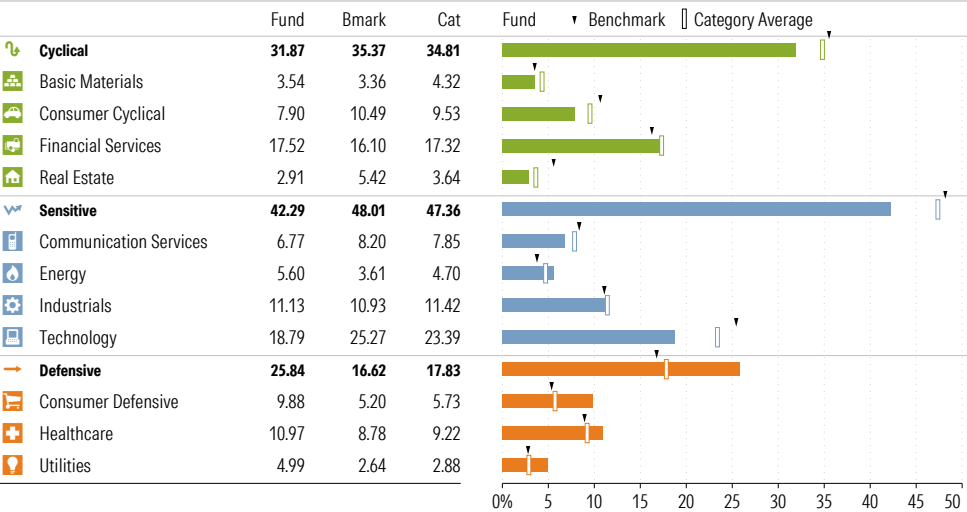

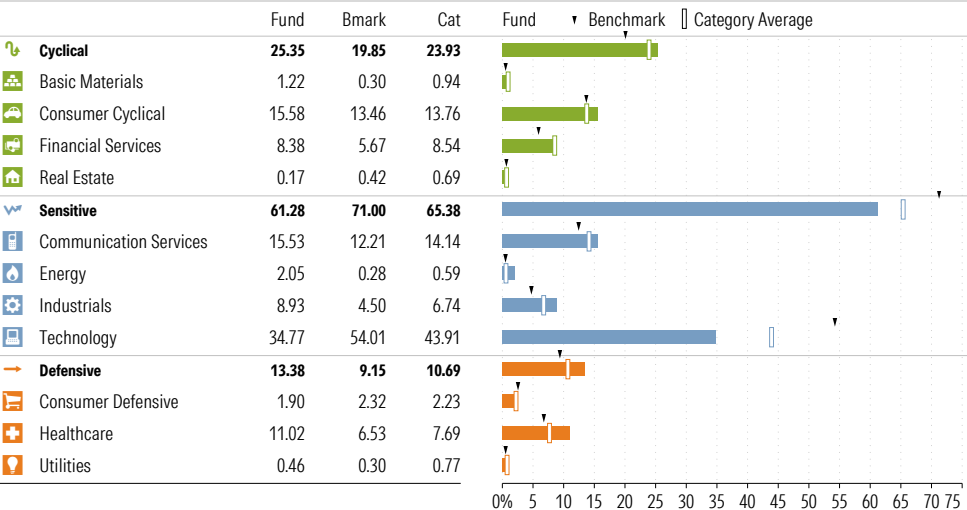

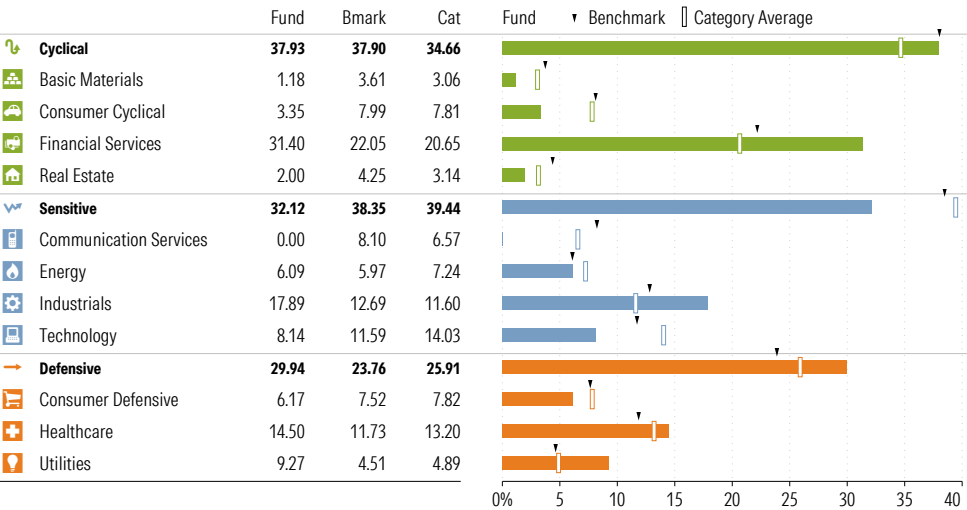

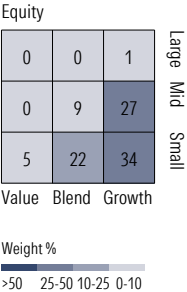

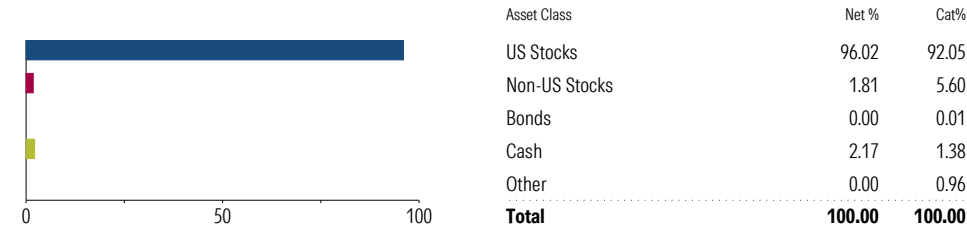

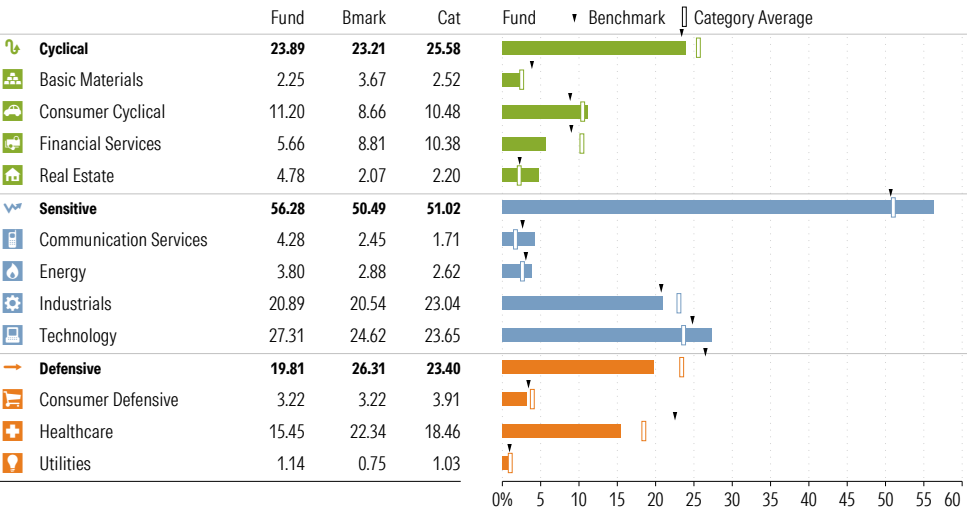
Style Breakdown

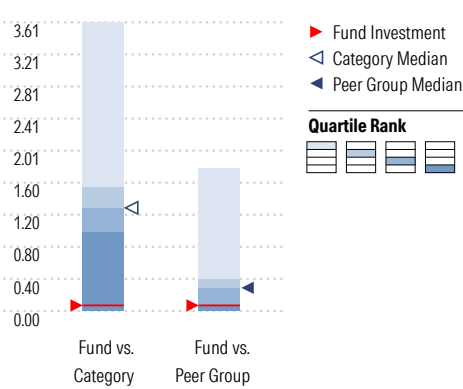

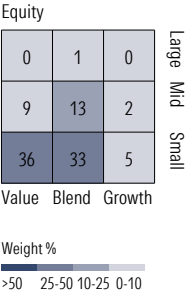

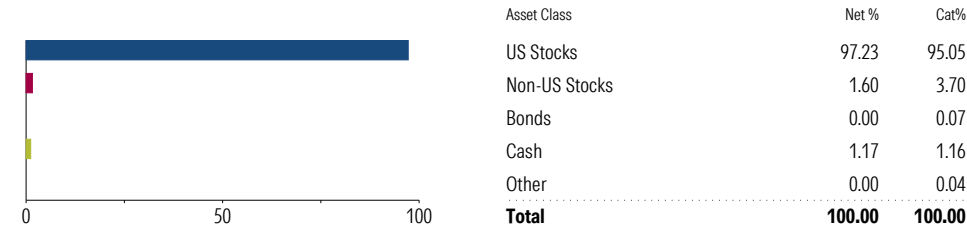

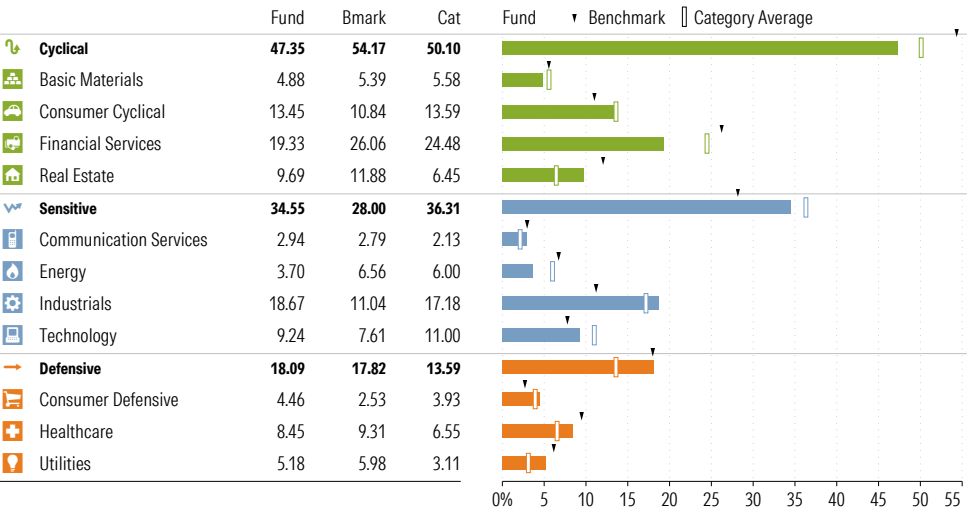
Style Breakdown
