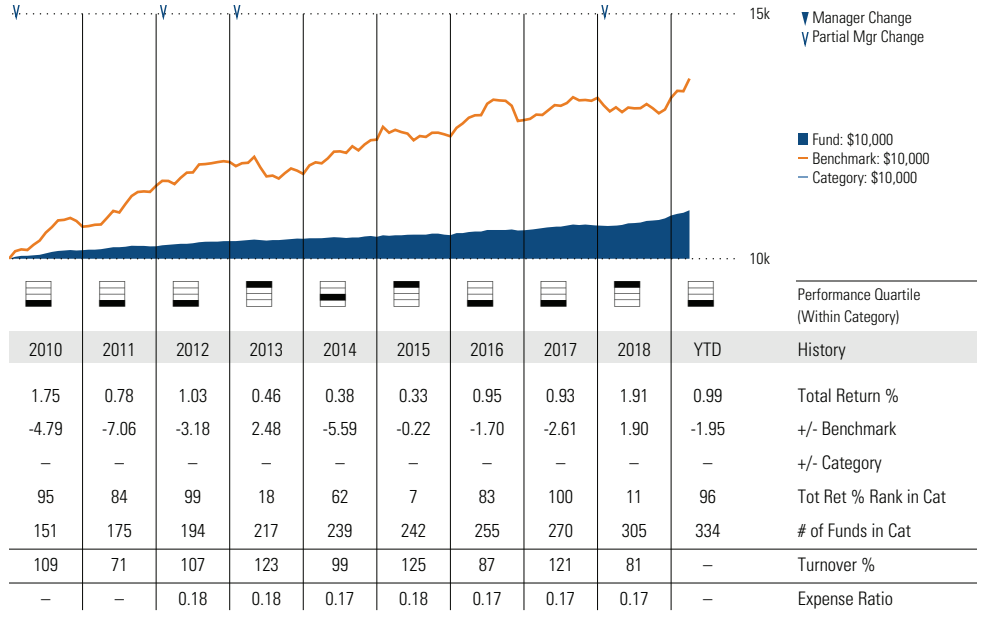

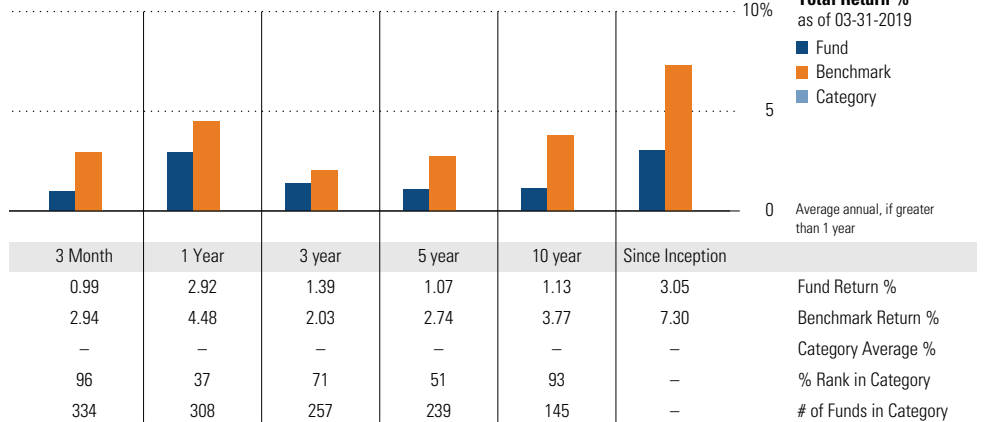
Morningstar Investment Management LLC Analysis

DFA Two-Year Global Fixed Income was placed on watch in Q4 2017 due to poor performance. Its mandate, which keeps the fund's average duration at two years or less and limits managers from buying credit rated below AA, has stymied performance in the current market environment. While its shorter duration makes it less sensitive to interest rate movements than most peers, it can limit the fund's return potential. Additionally, its peers can take on more credit risk, for which they have been rewarded in recent years. Ultimately, we believe its inability to maneuver in various credit markets makes it an inadequate world bond selection for retirement plans. Therefore, the fund is being removed from fiduciary coverage.

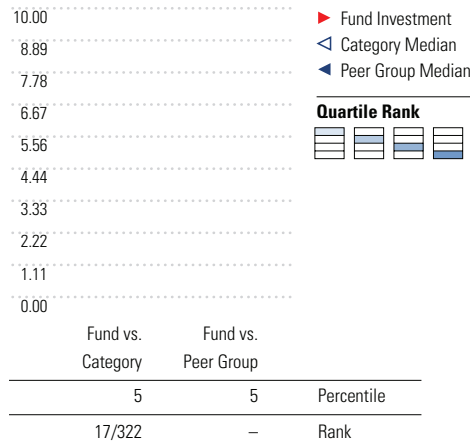
Growth of \$10,000

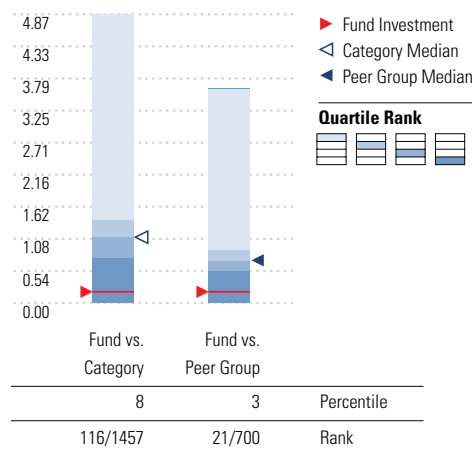

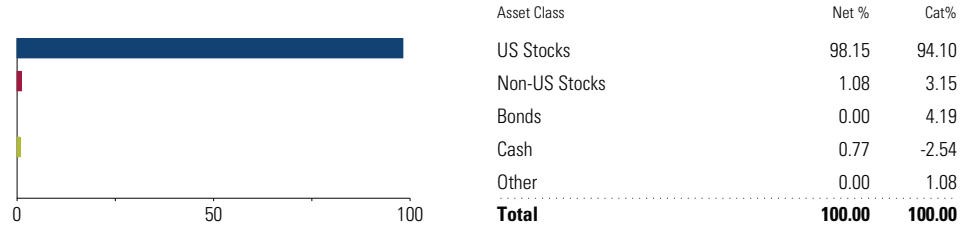

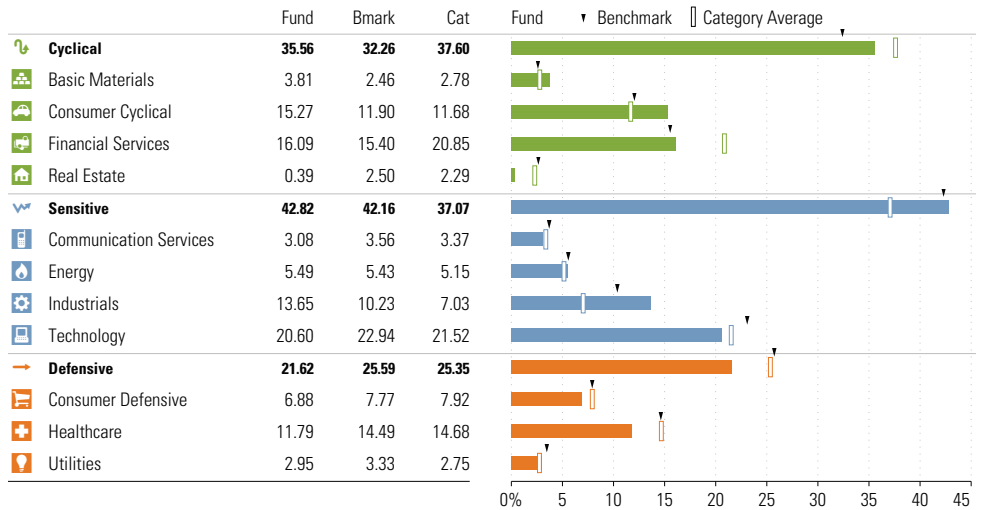

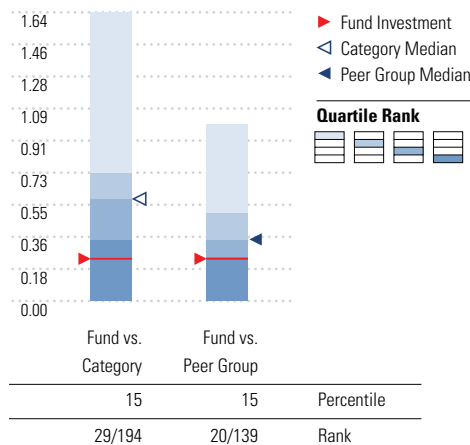

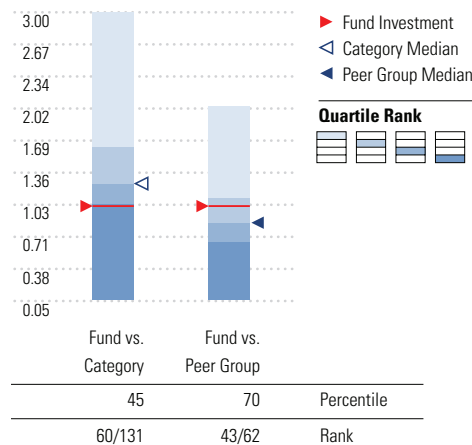

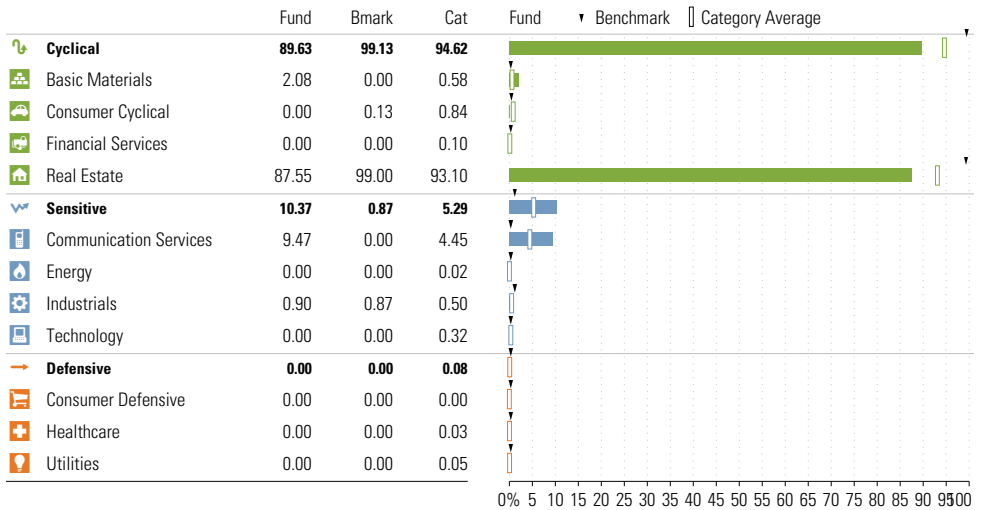

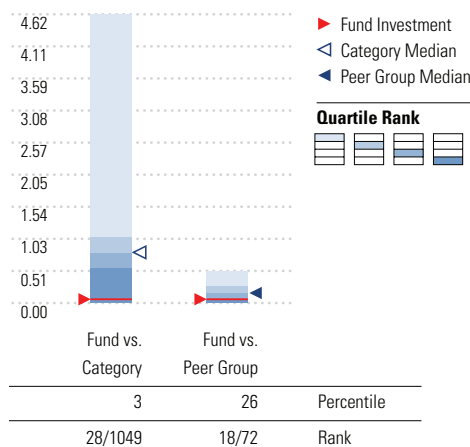
Growth of \$10,000

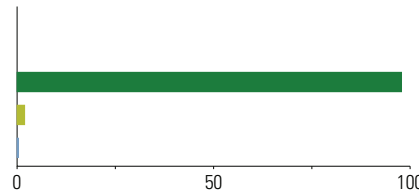

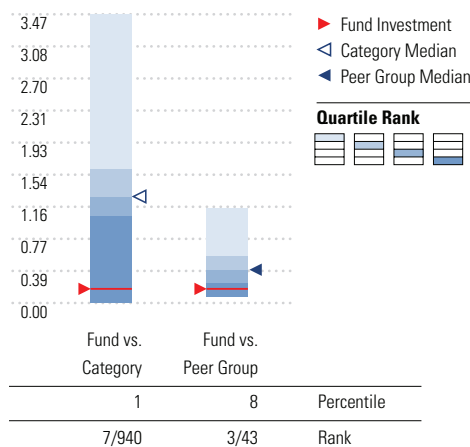
