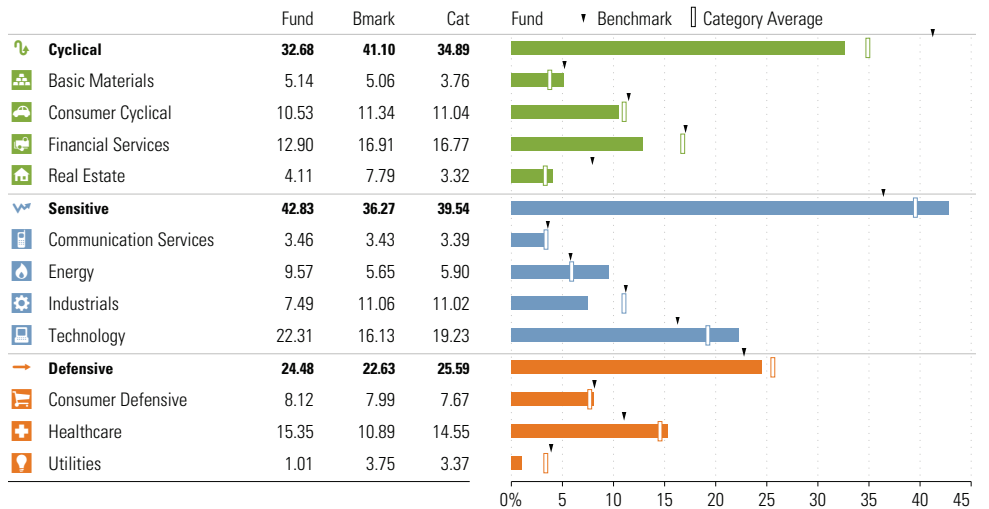

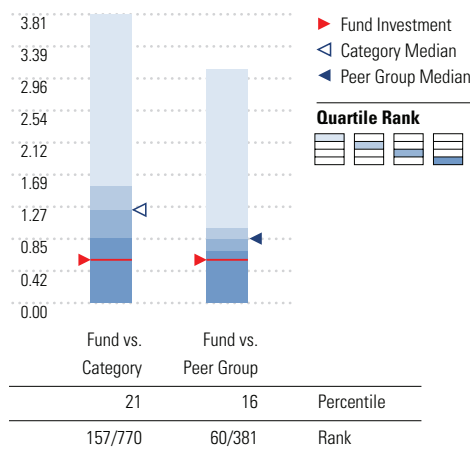

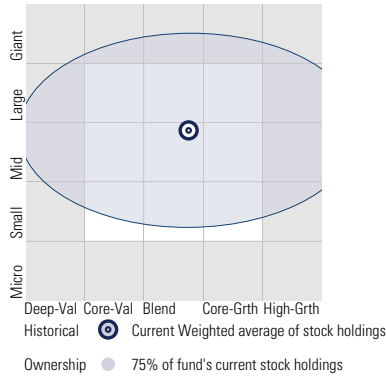

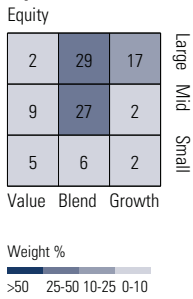

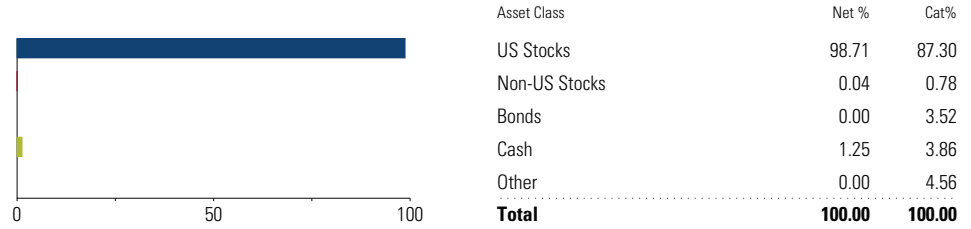

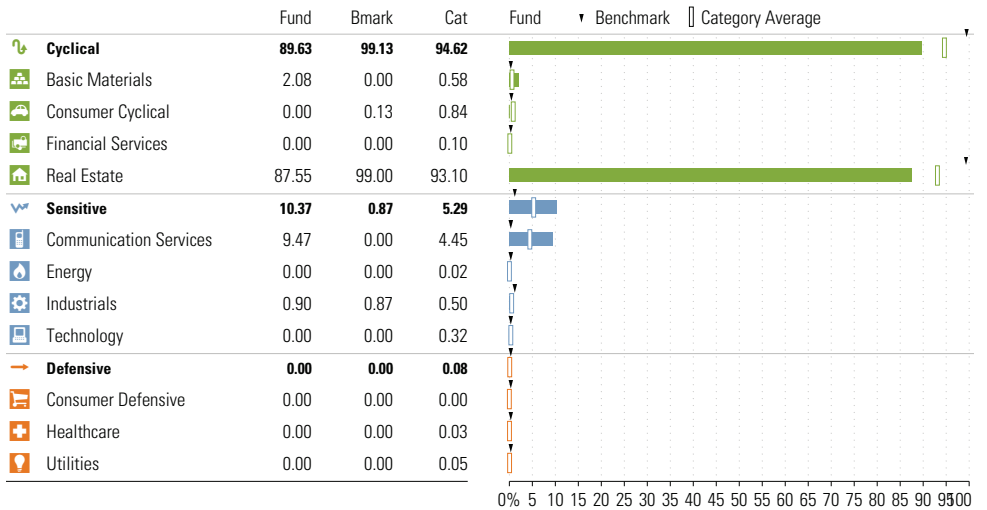
Style Breakdown
