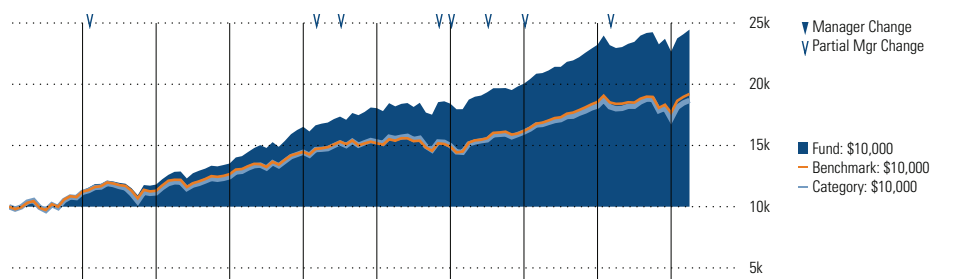

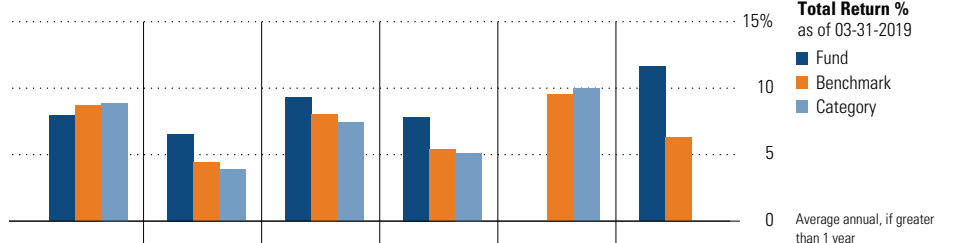

Growth of \$10,000



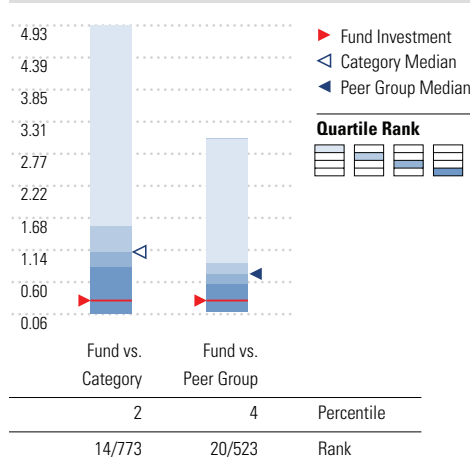

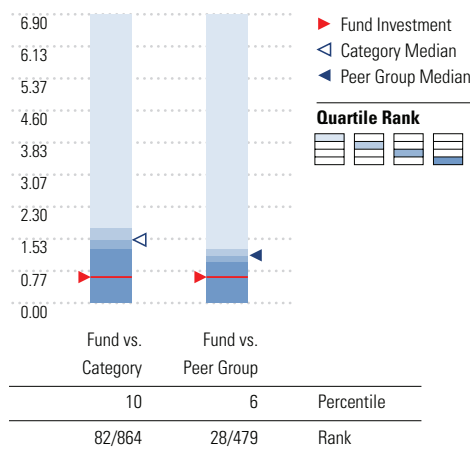

Additionally, the team will undergo a reshuffling of its global analysts, which could have implications for this fund, given that it relies on bottom-up stock research by the analysts. We view Scott's departure as a loss, and we will be watching for a smooth transition over the next year while the fund is on watch.

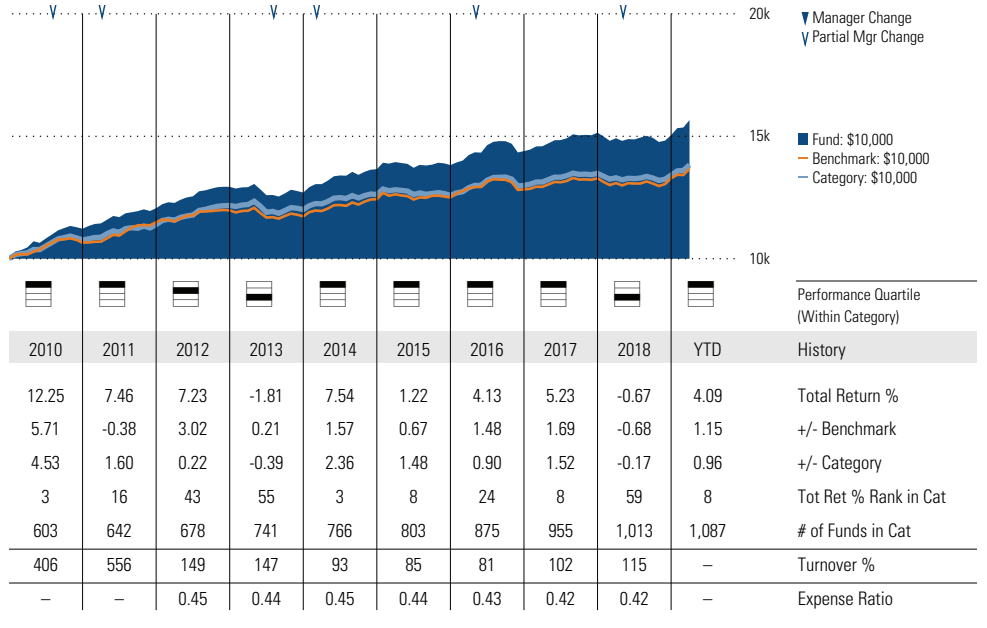

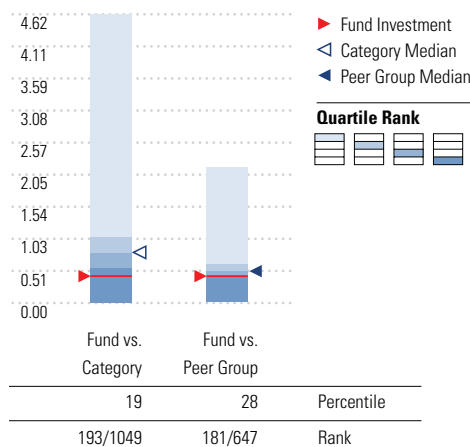
Growth of \$10,000

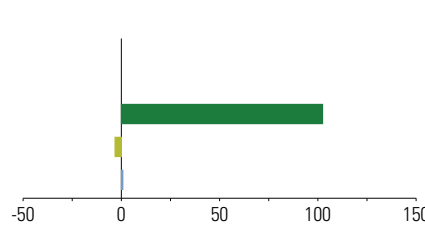

Asset Allocation as of 03-31-2019

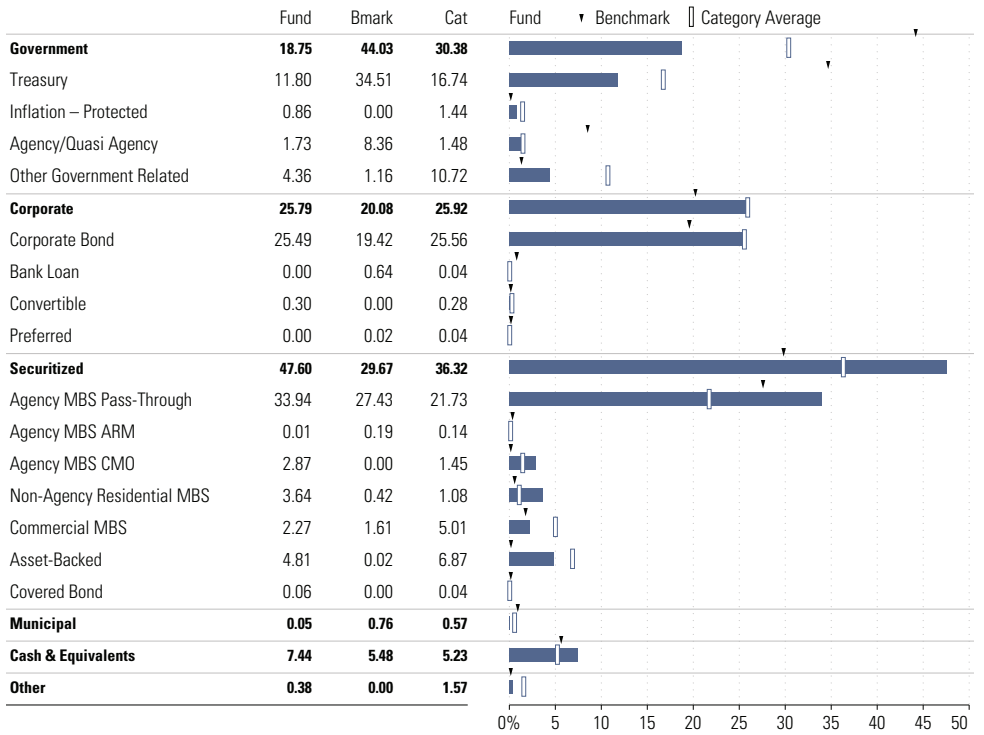
