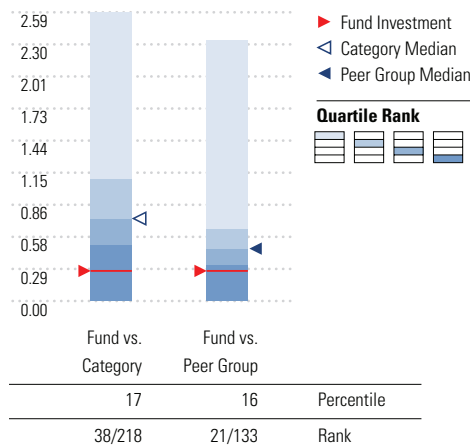

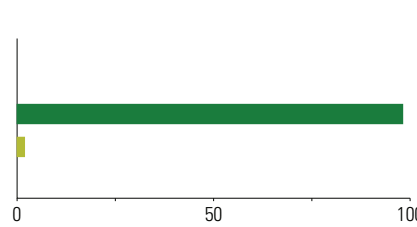

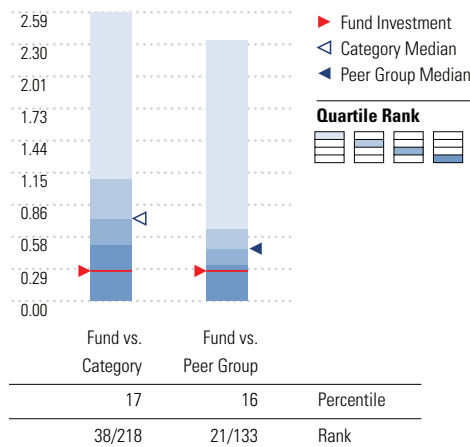
Growth of \$10,000

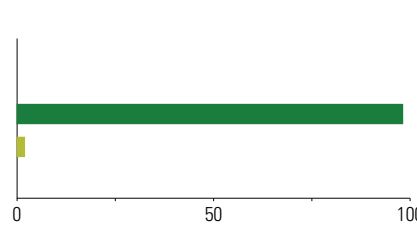

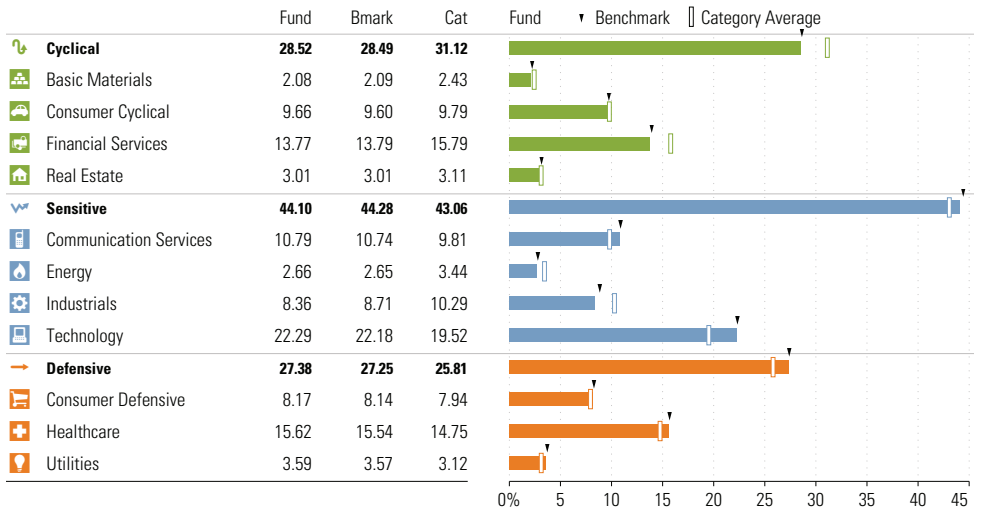

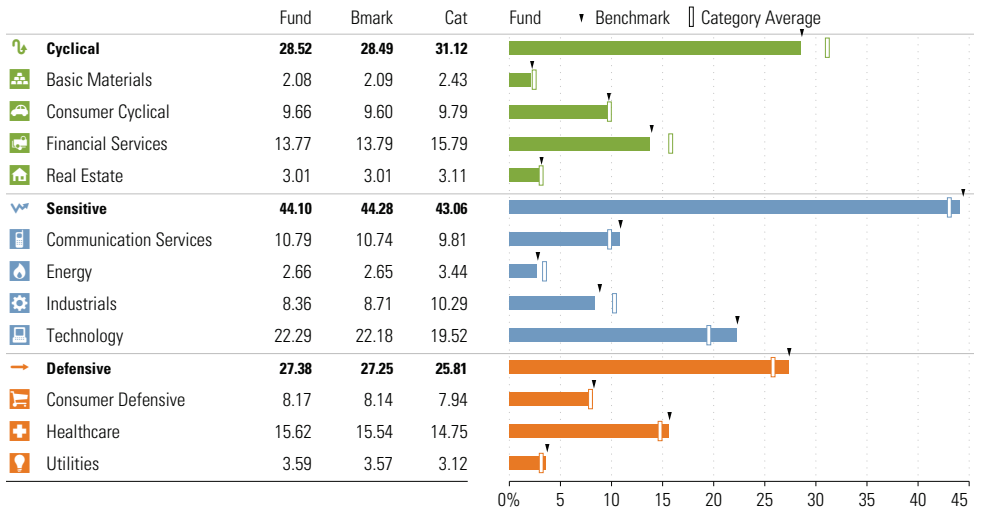

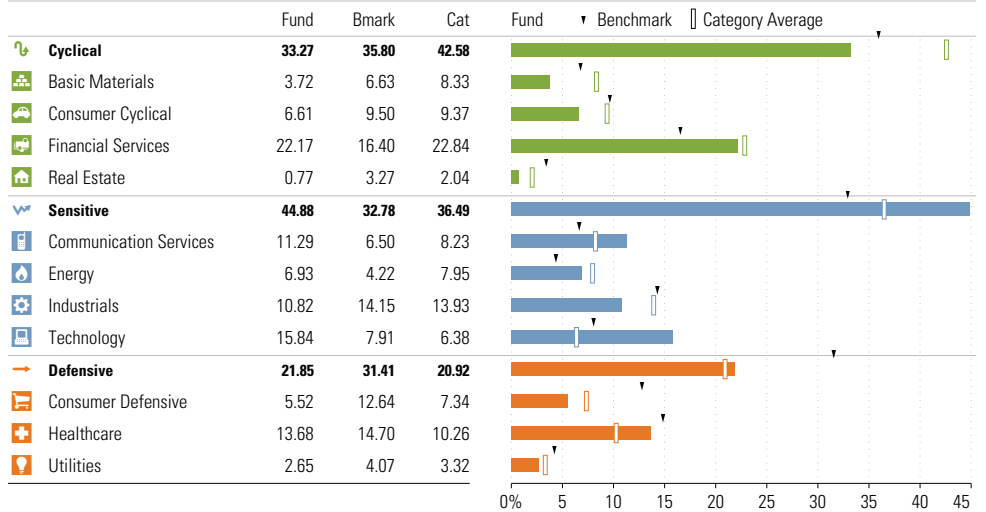

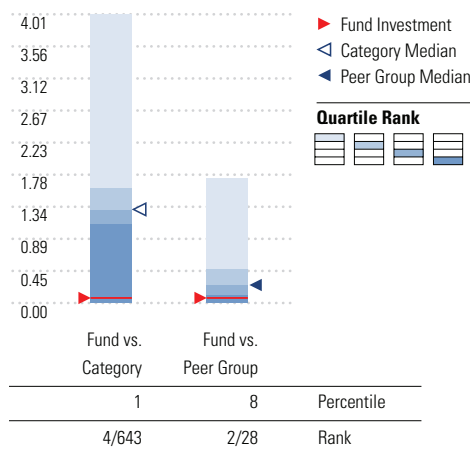
Growth of \$10,000

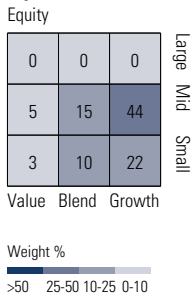

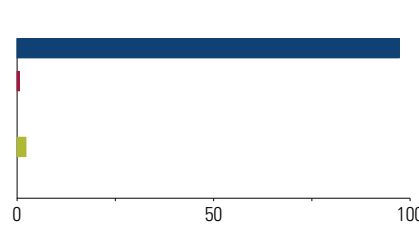

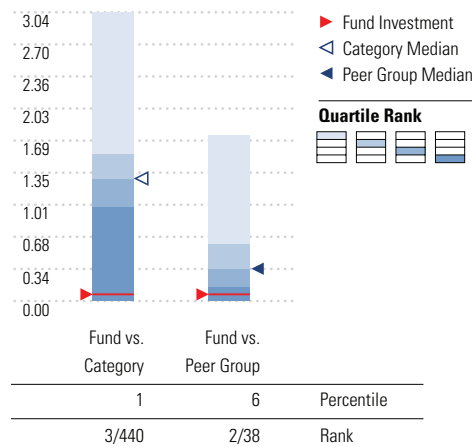
Growth of \$10,000

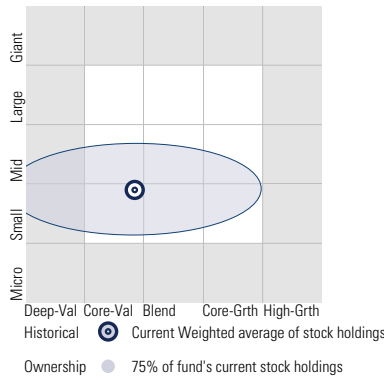

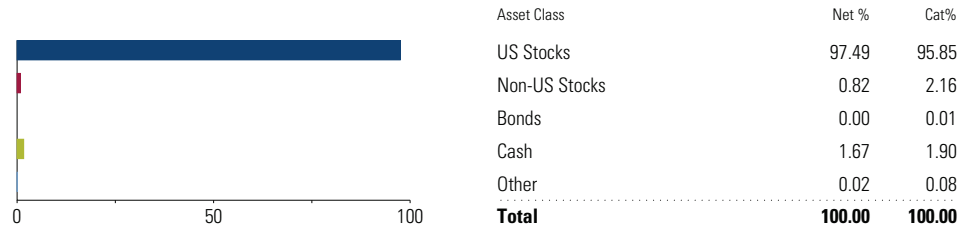

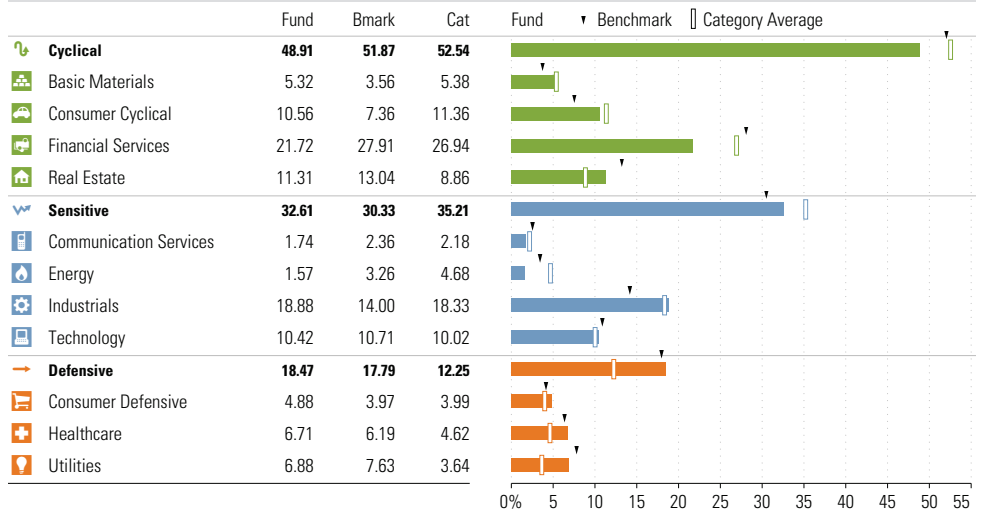
Asset Allocation as of 03-31-2020
