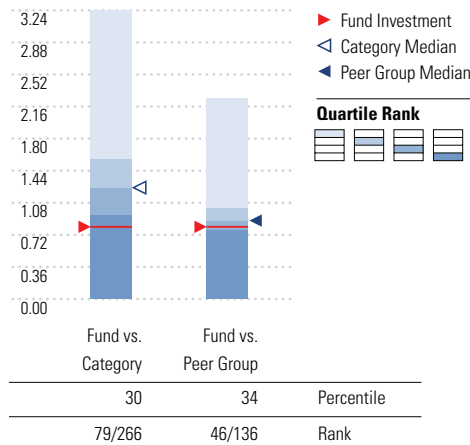

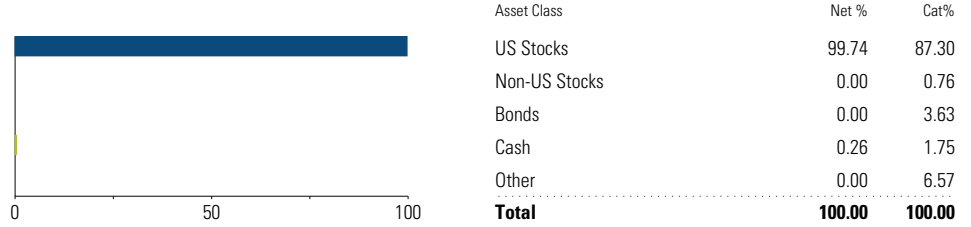

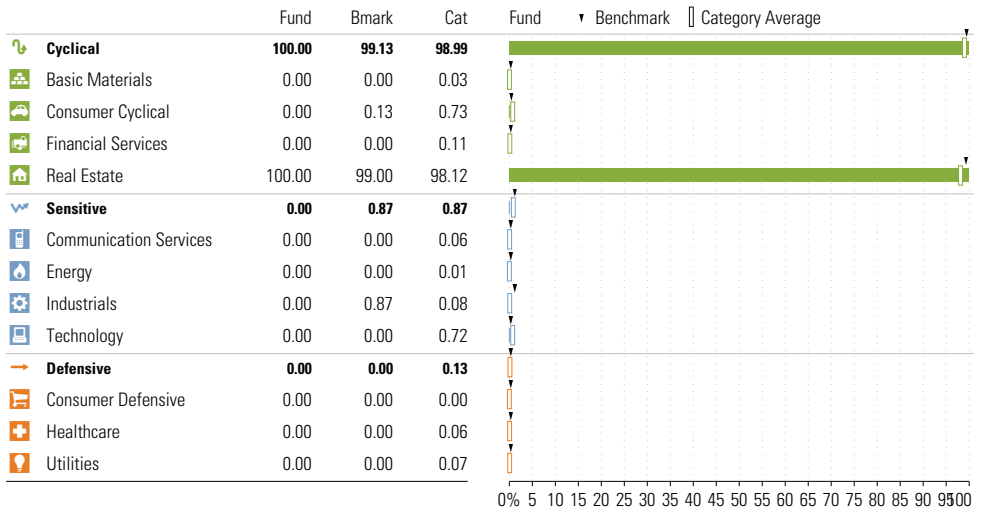

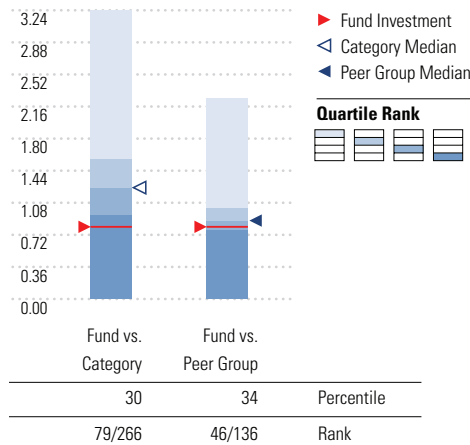

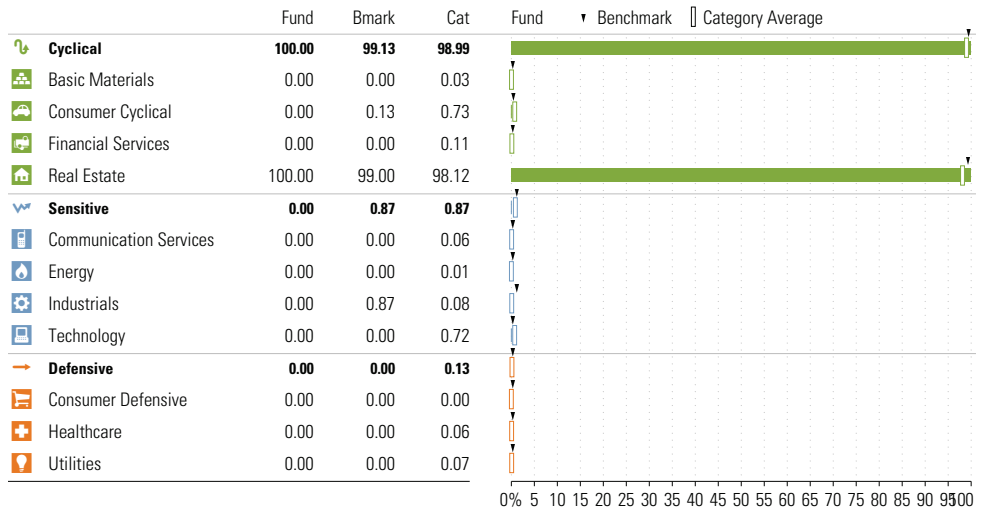

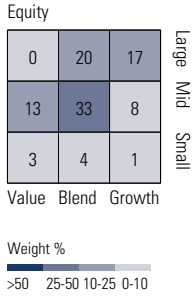
Asset Allocation as of 03-31-2020

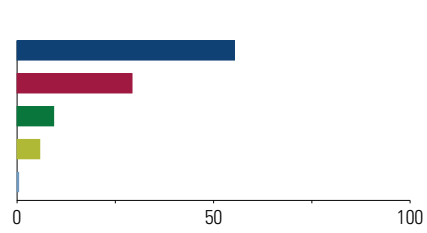

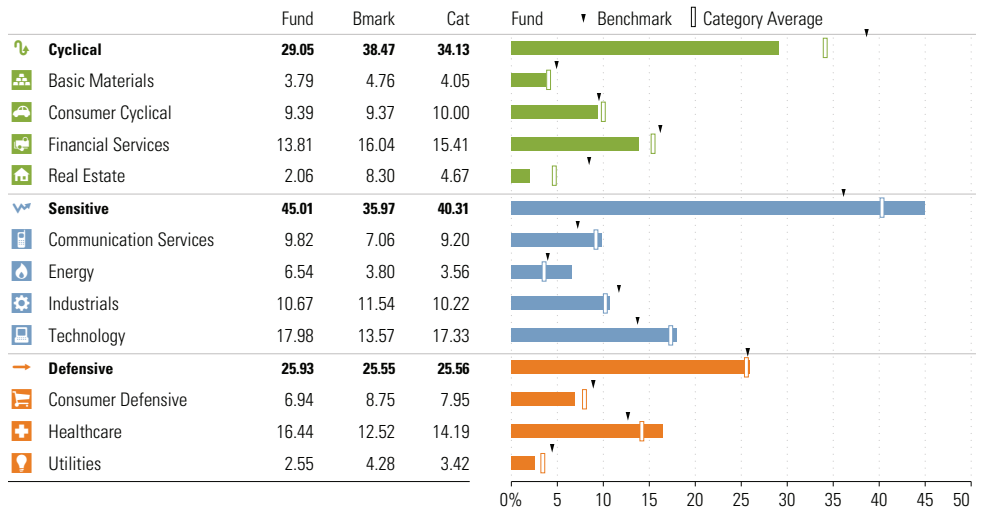

Although the fund benefits from PIMCO's extensive resources and the current managers are experienced (but new to the team) we believe the fund merits watch status while we closely monitor its results after Worah's departure. 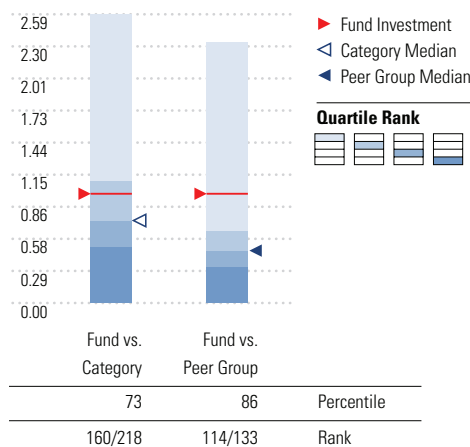

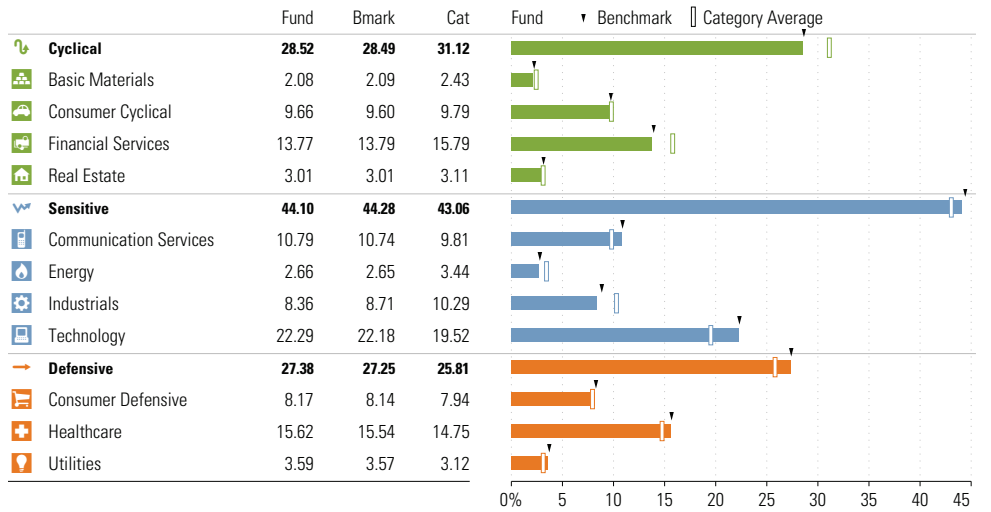

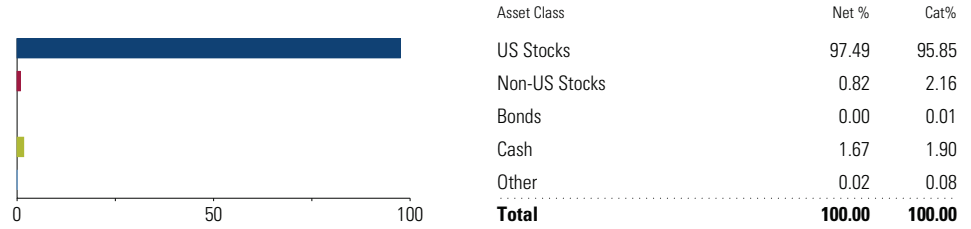

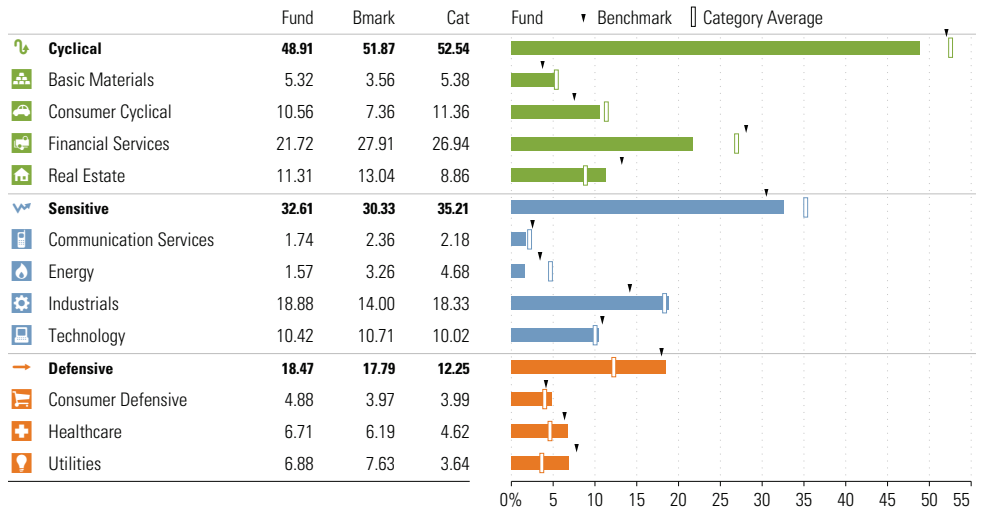

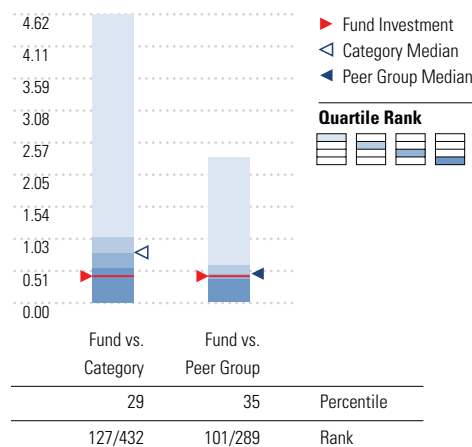
Growth of \$10,000

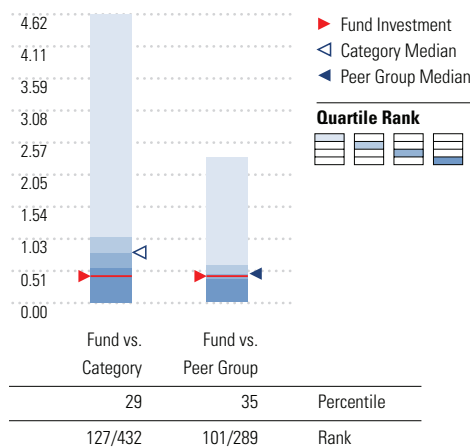
Growth of \$10,000

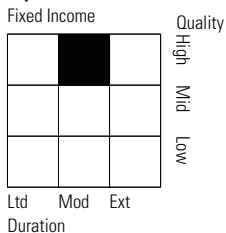

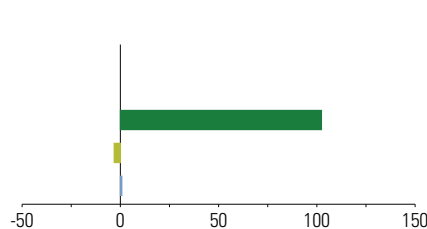

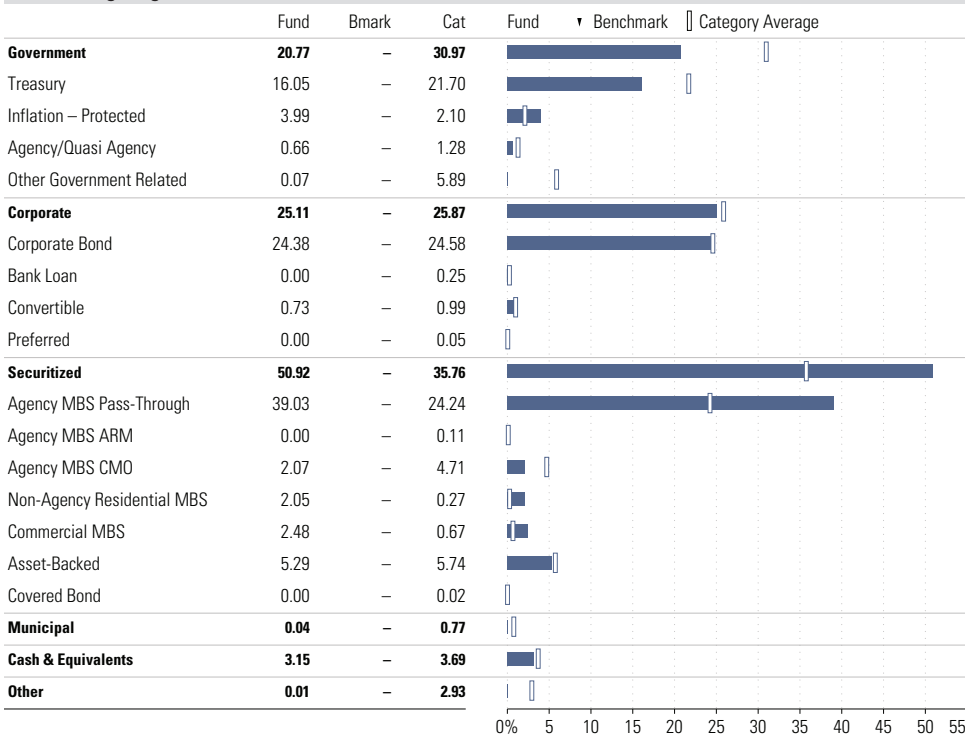
