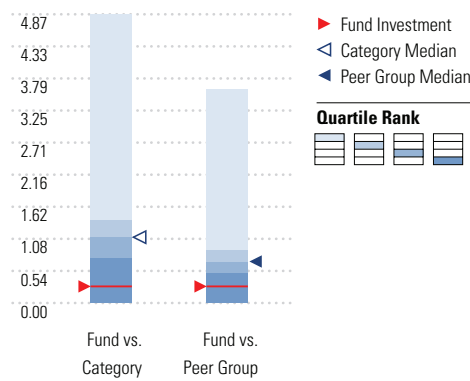

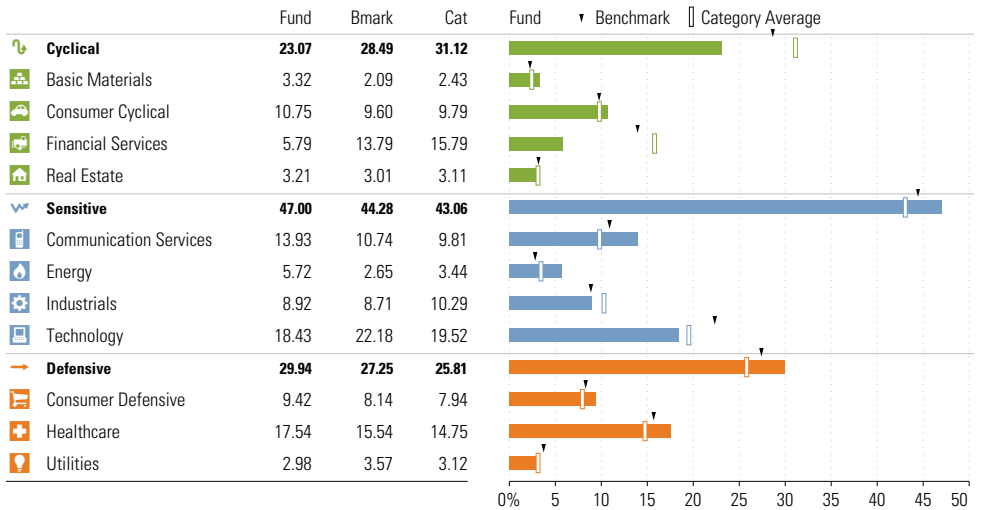

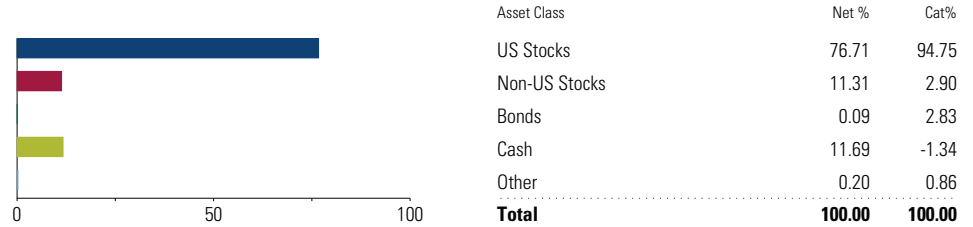

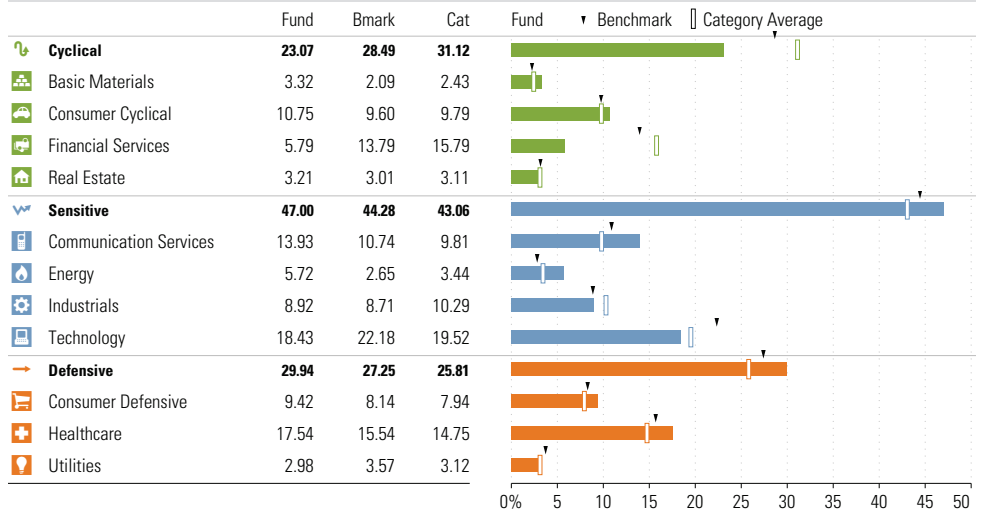

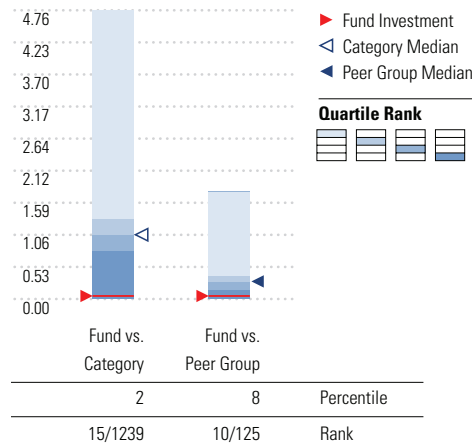

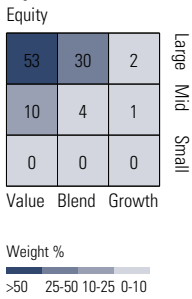

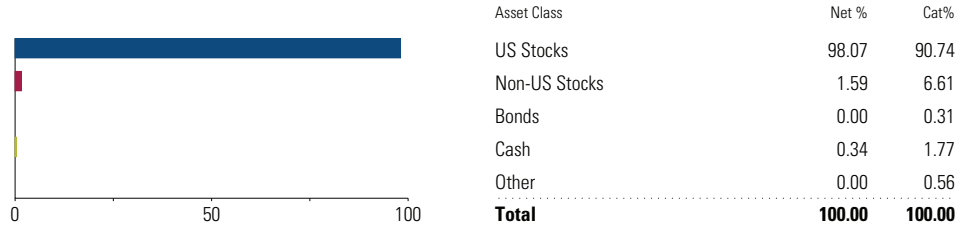

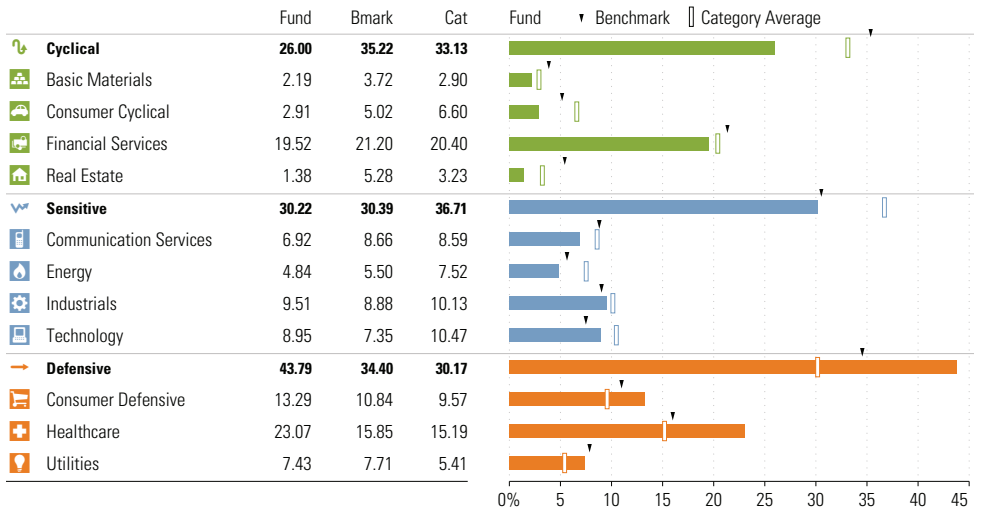
Style Breakdown

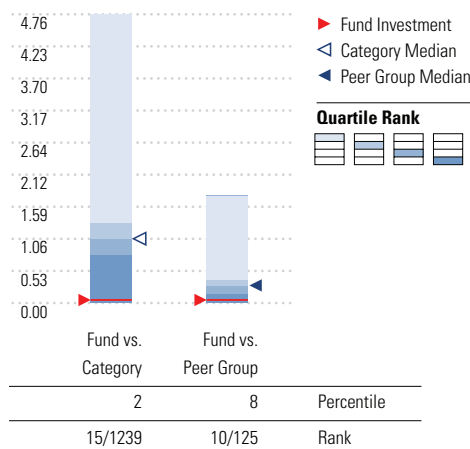

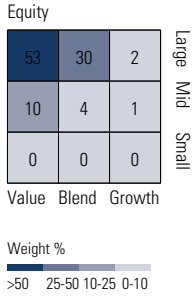

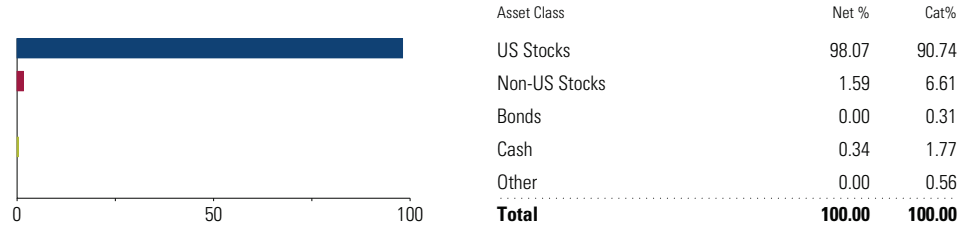

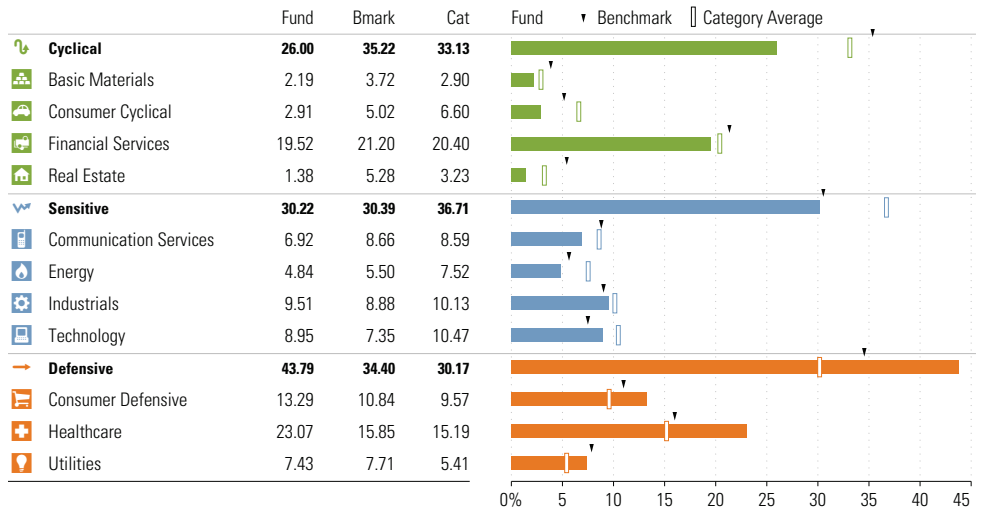
Style Breakdown
