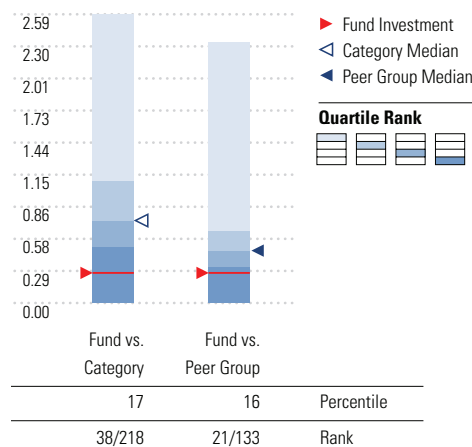

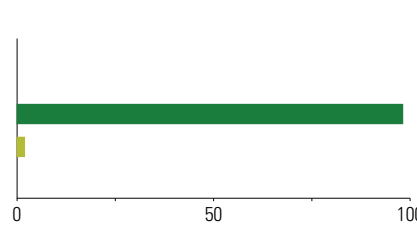

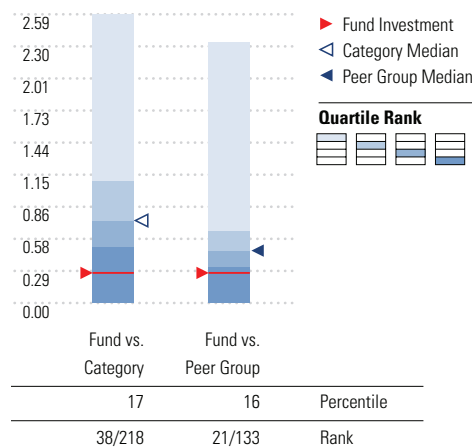

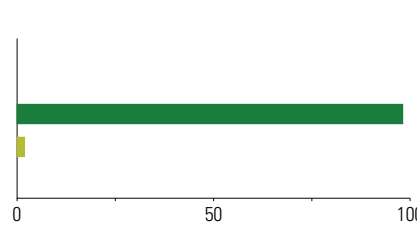

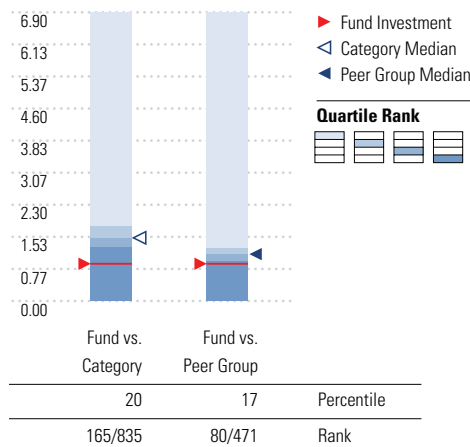

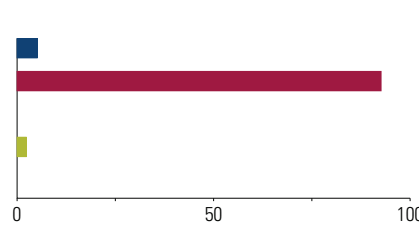

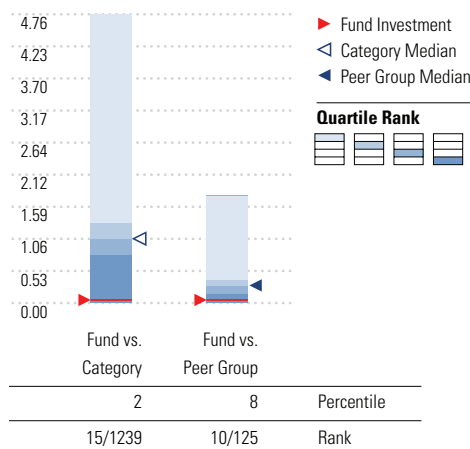

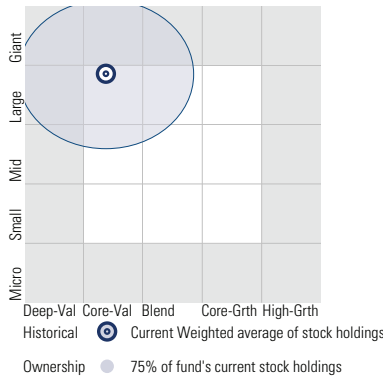

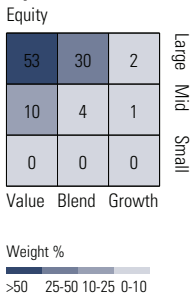

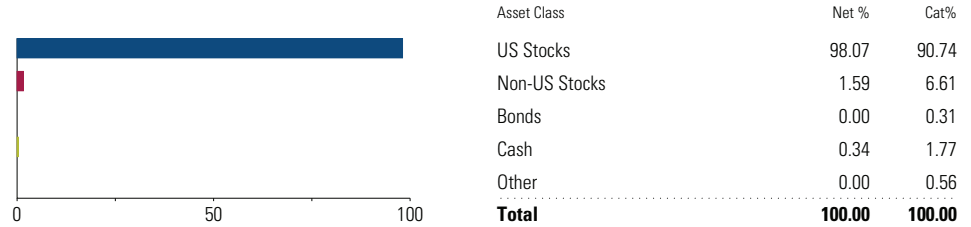

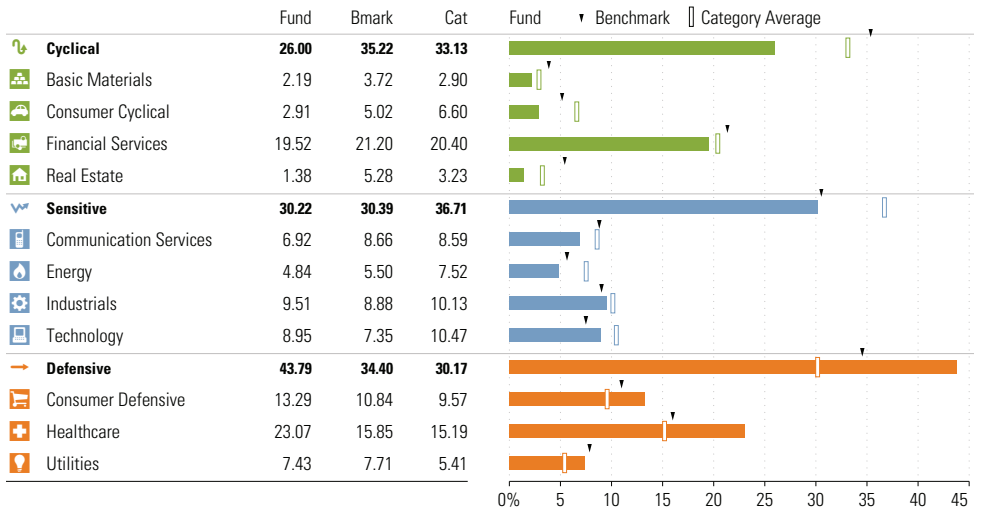
Style Breakdown

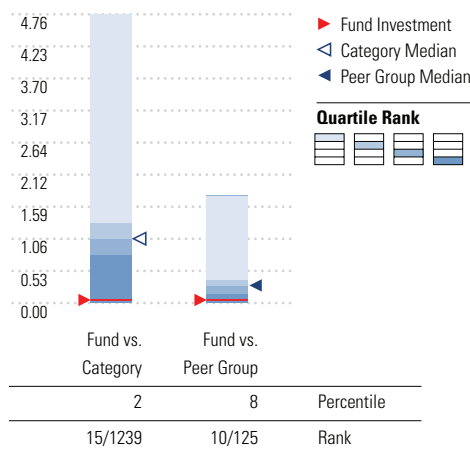

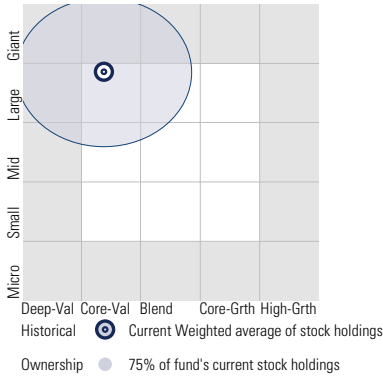

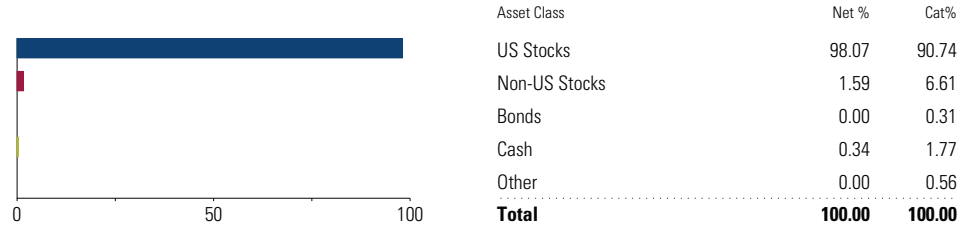

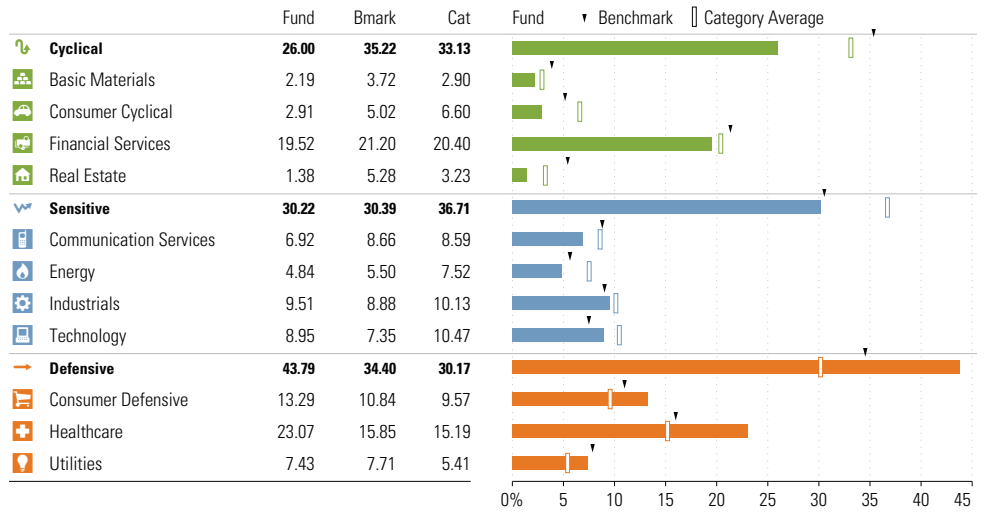
