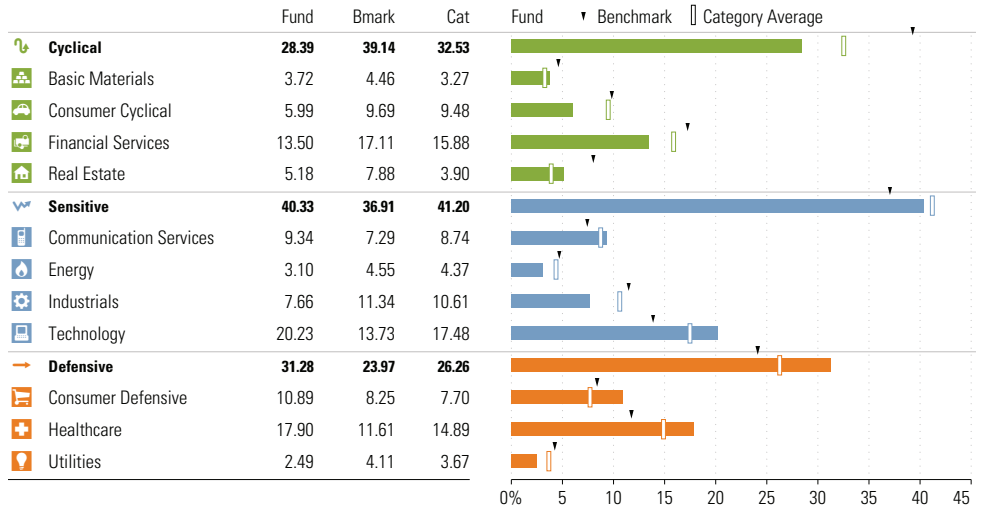

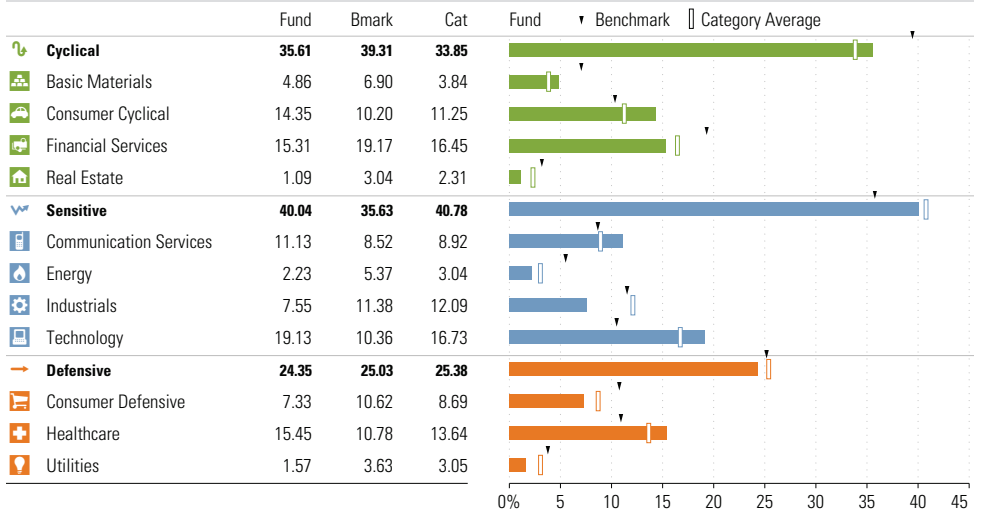

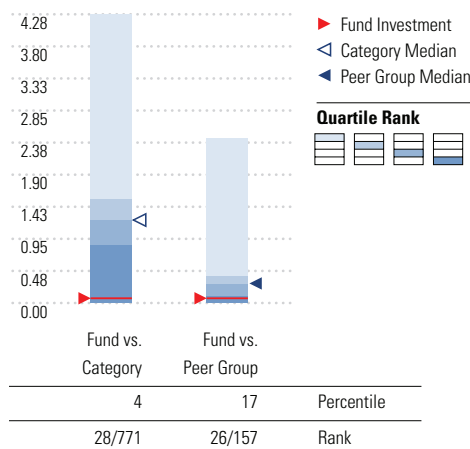

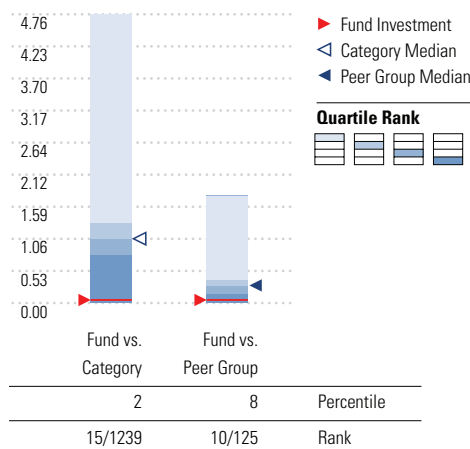

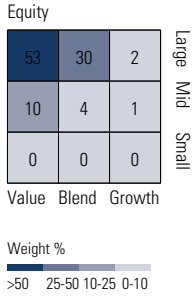

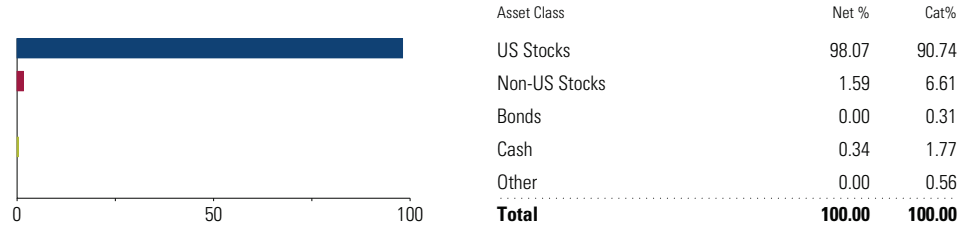

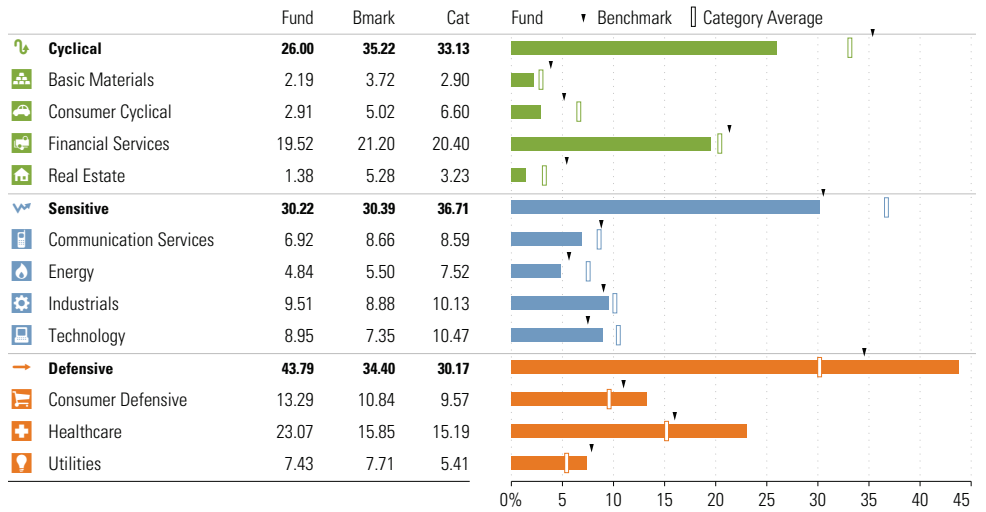
Style Breakdown

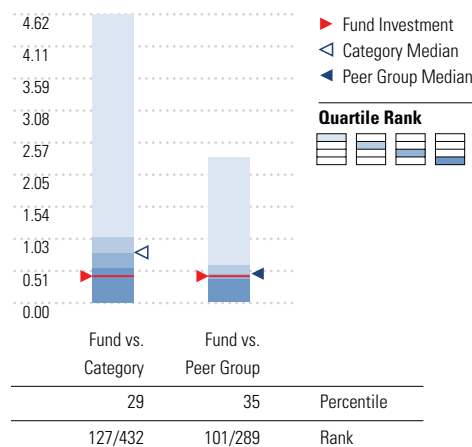

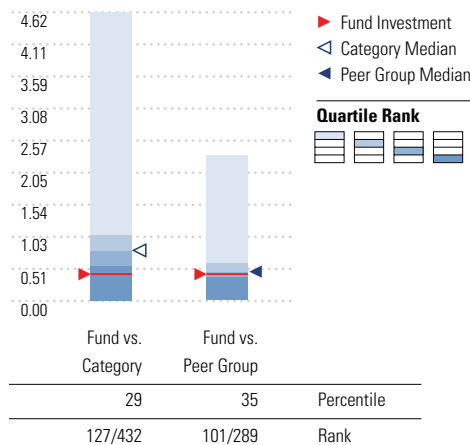
