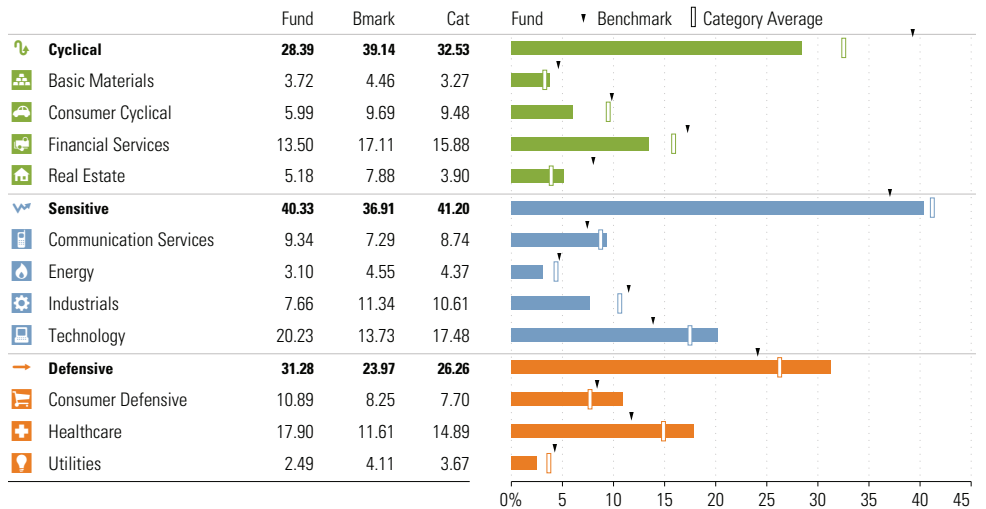

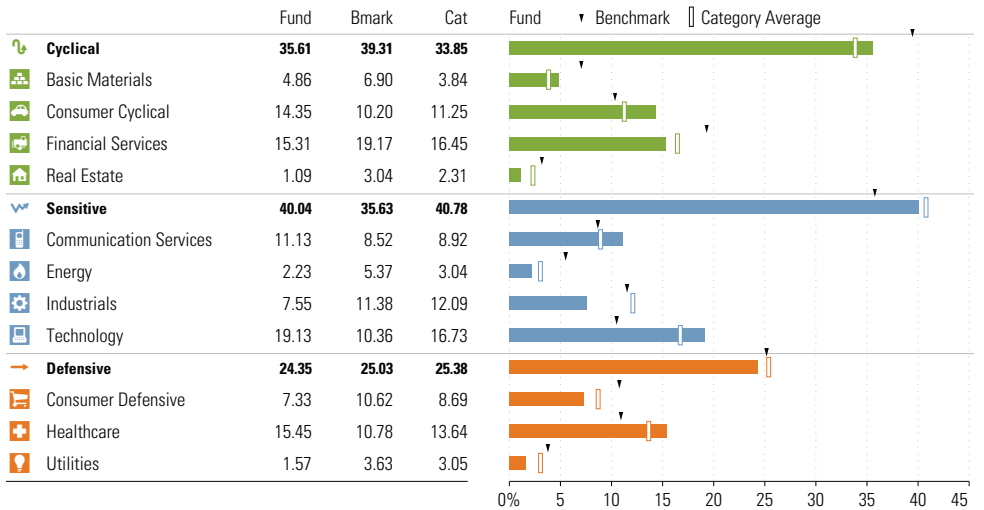

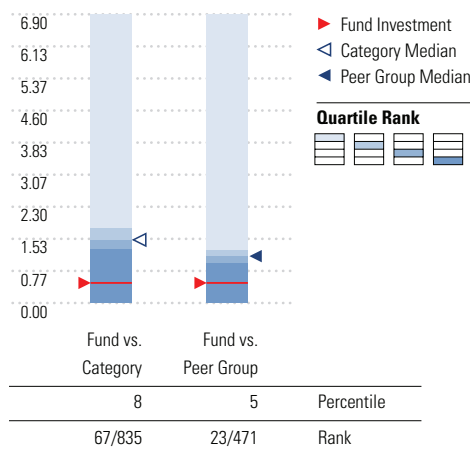

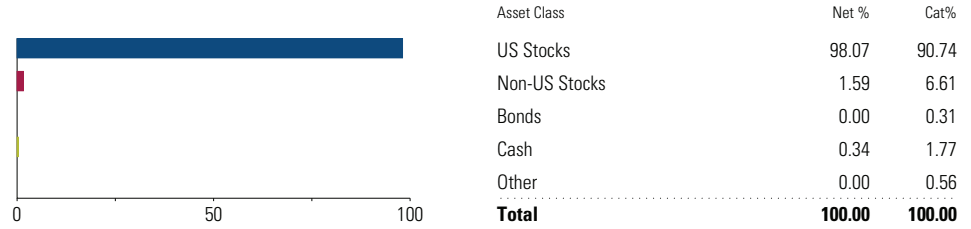

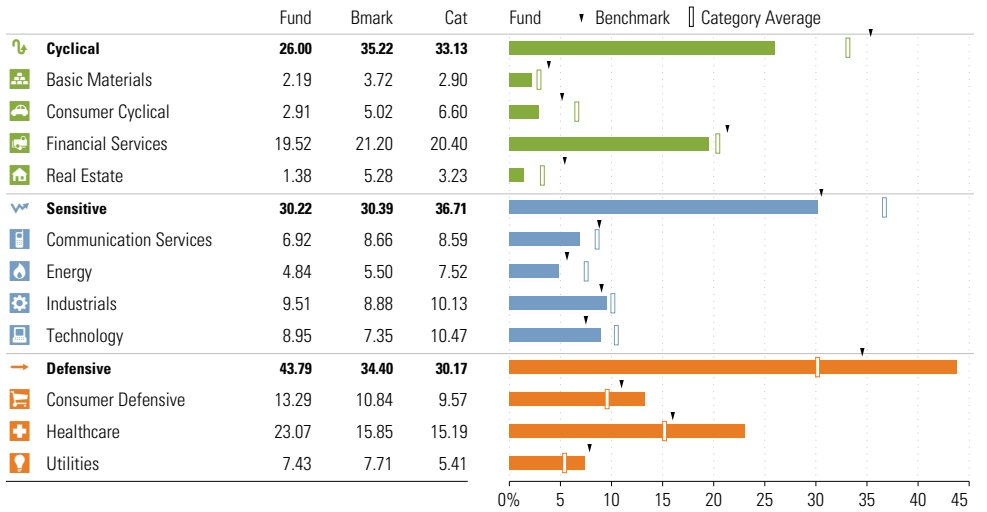
Style Breakdown

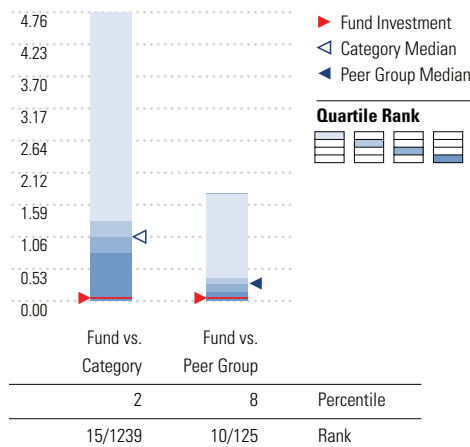

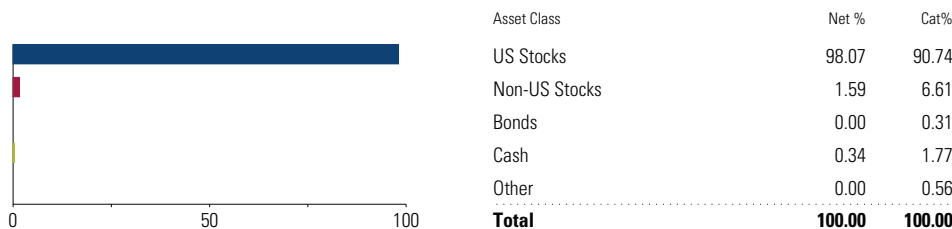

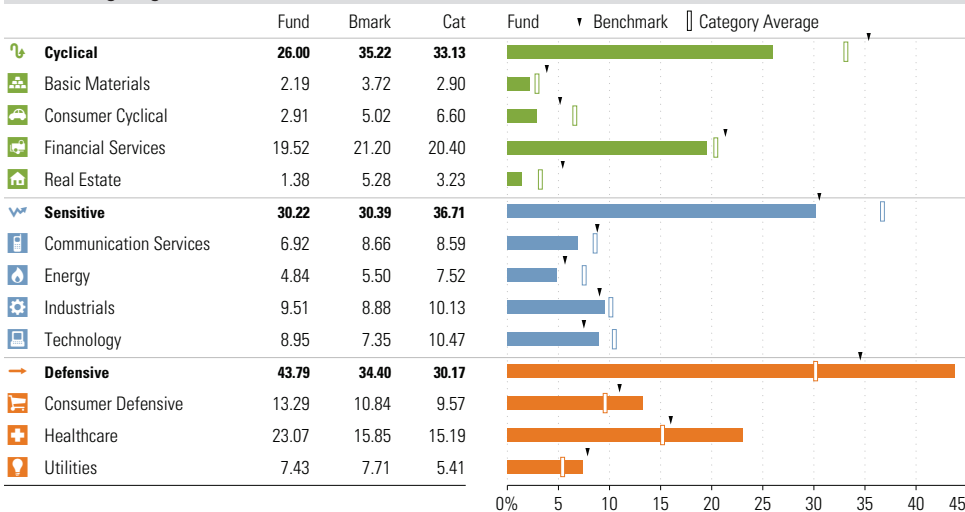
