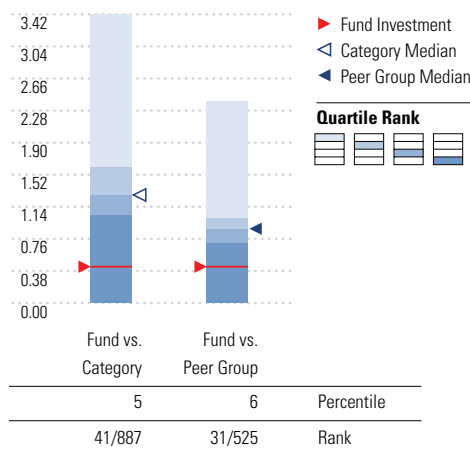

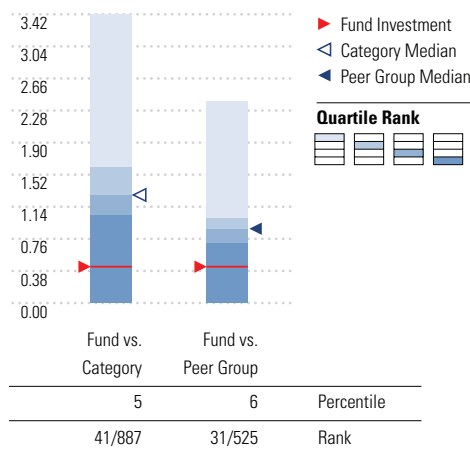

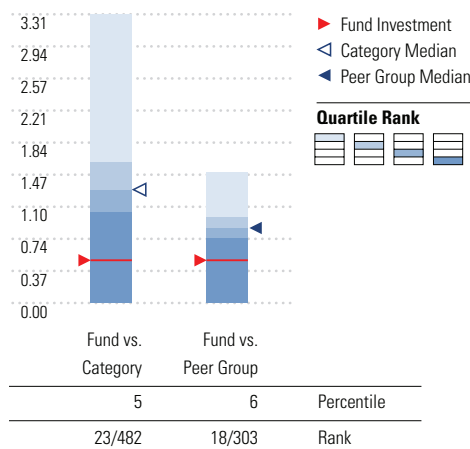

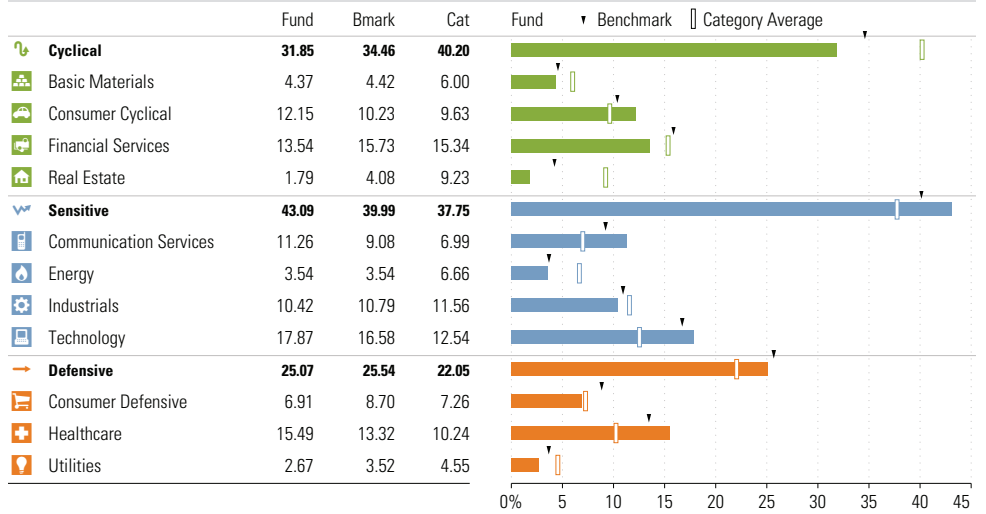

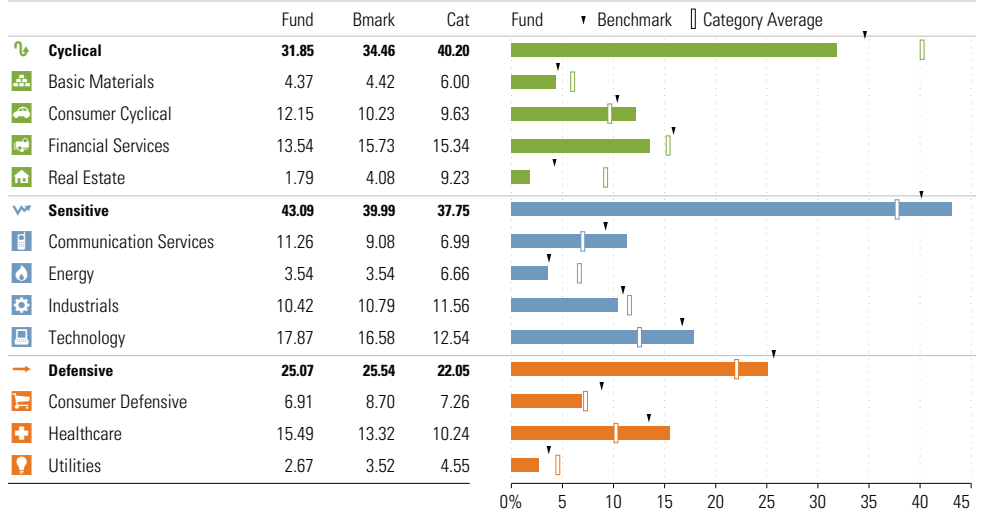

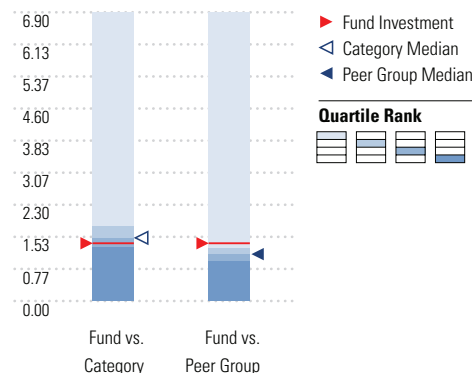

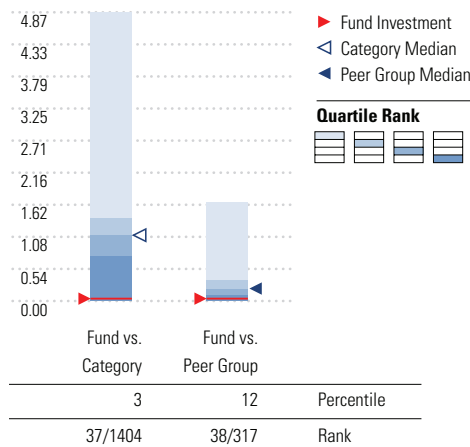

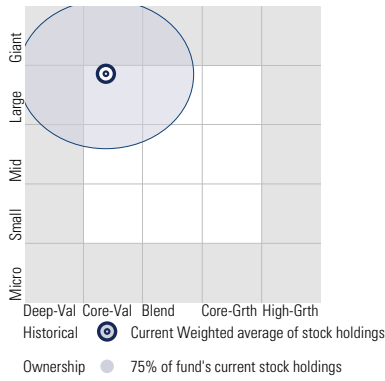

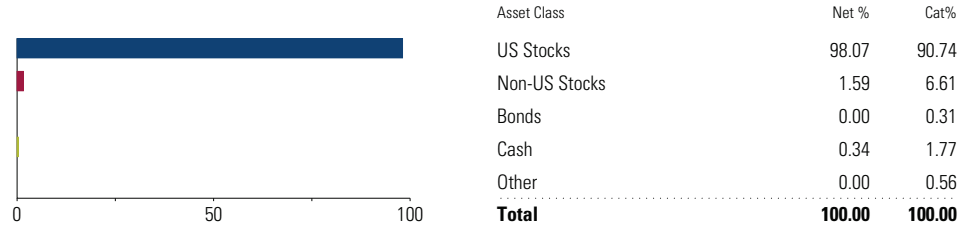

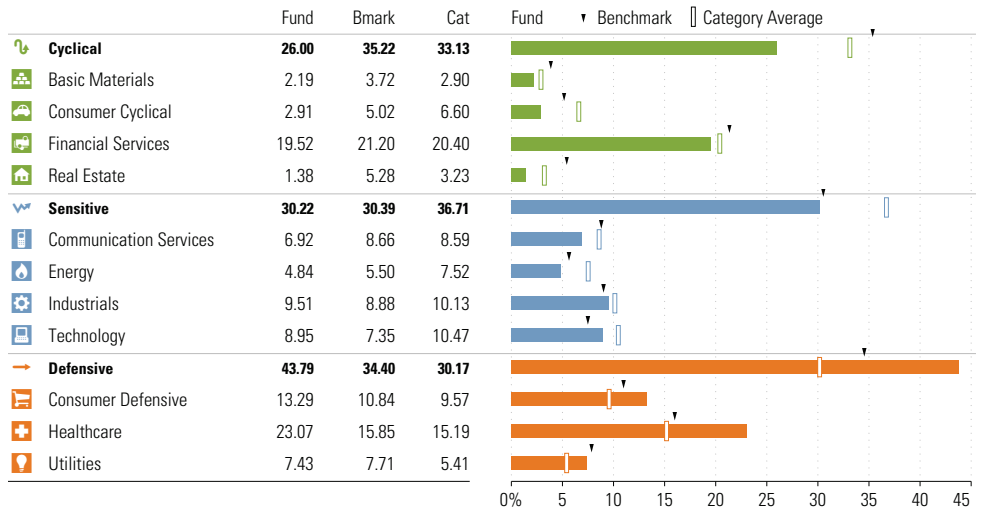
Style Breakdown
