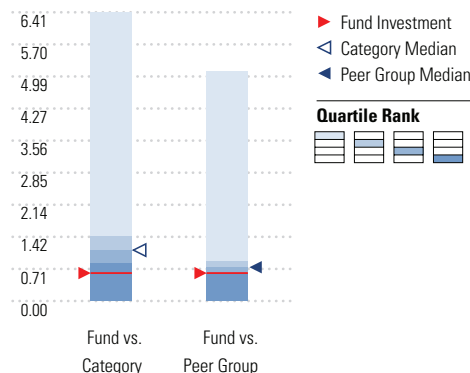

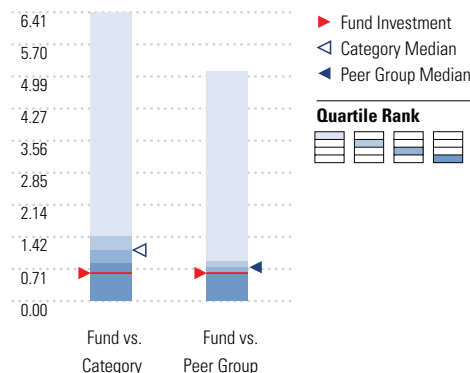

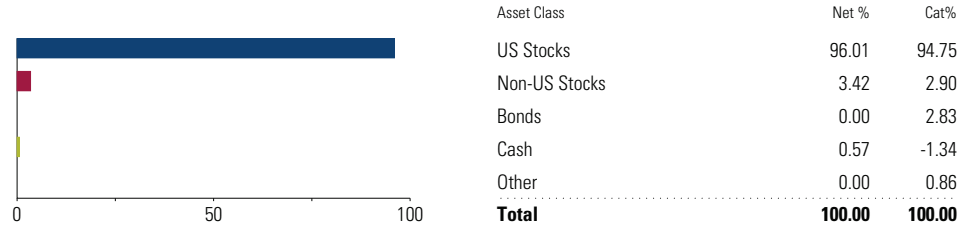

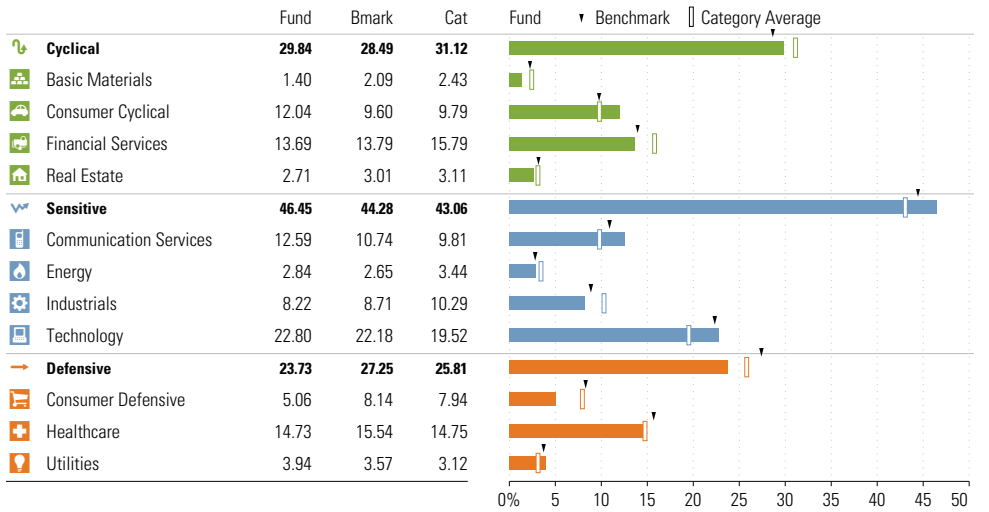
Style Breakdown

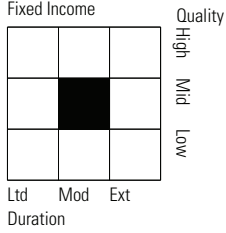

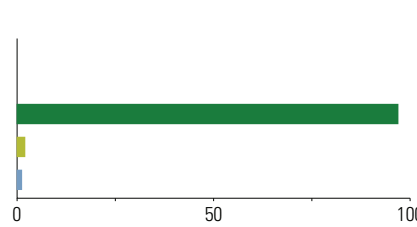
