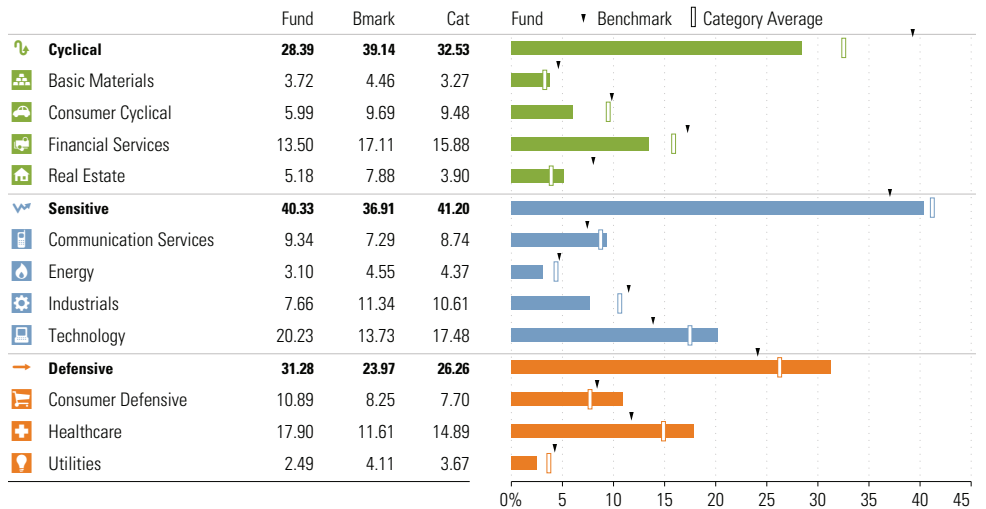

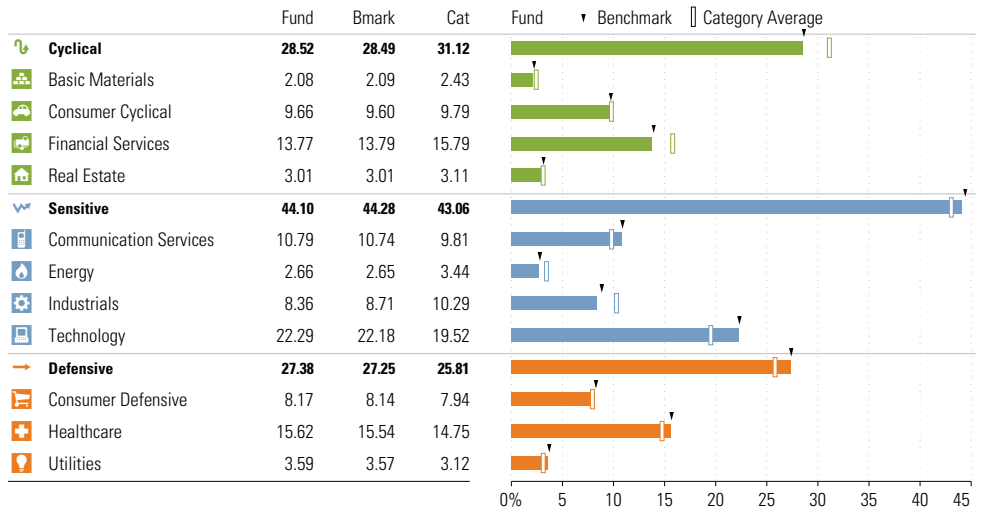

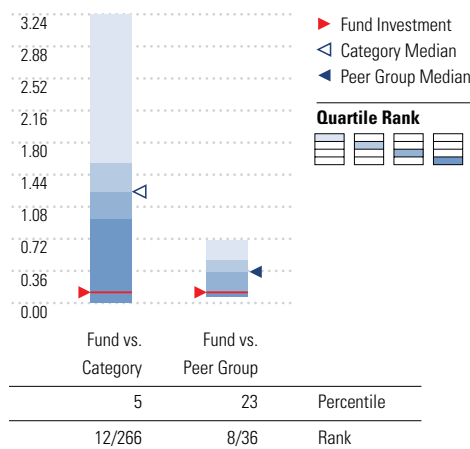

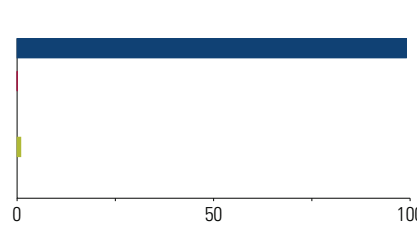

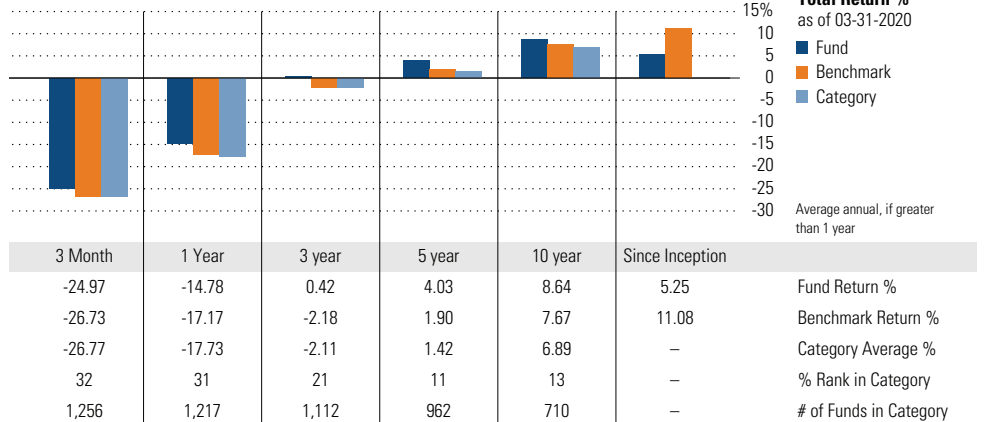

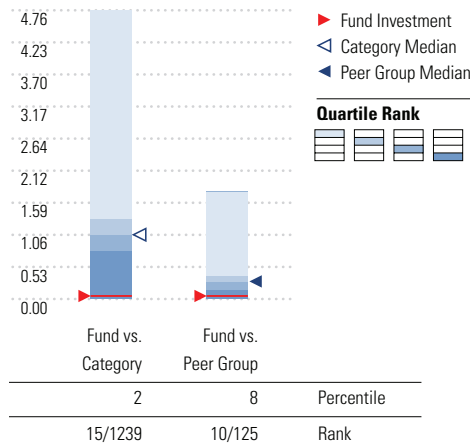

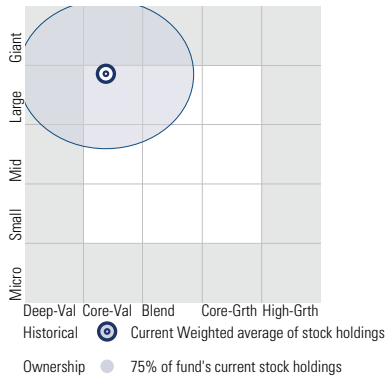

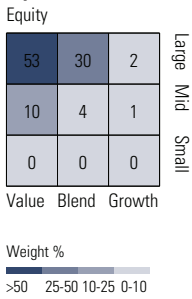

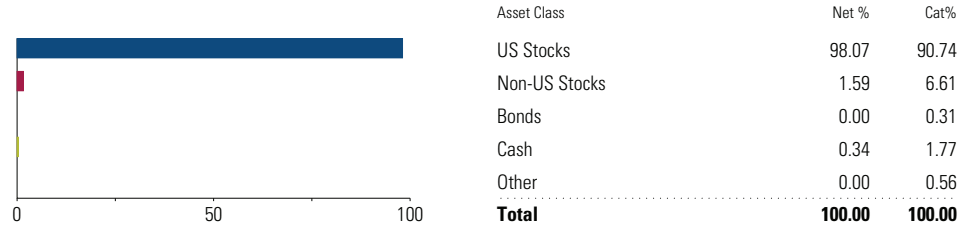

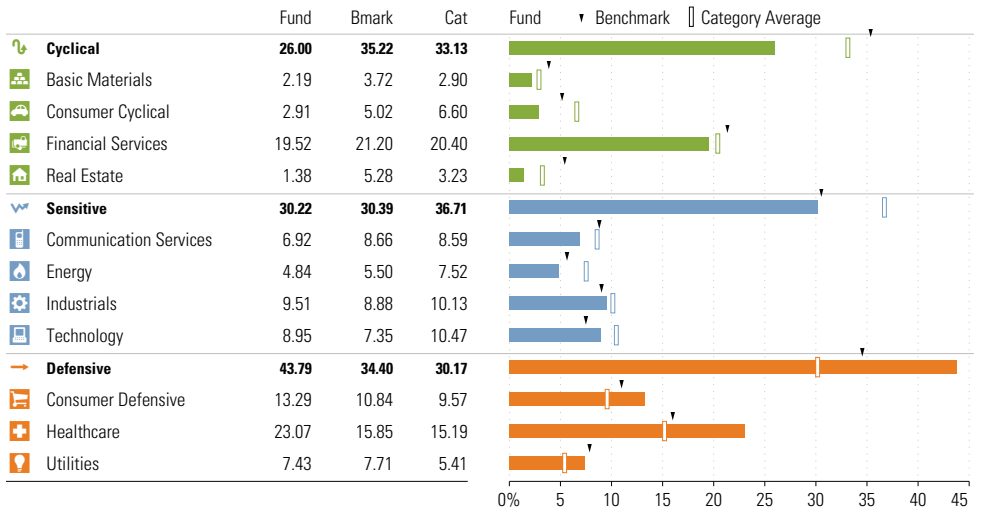
Style Breakdown

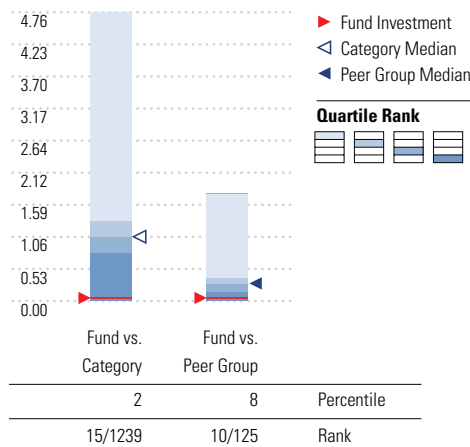

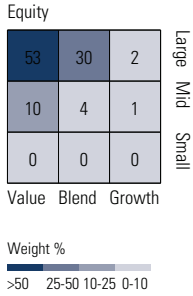

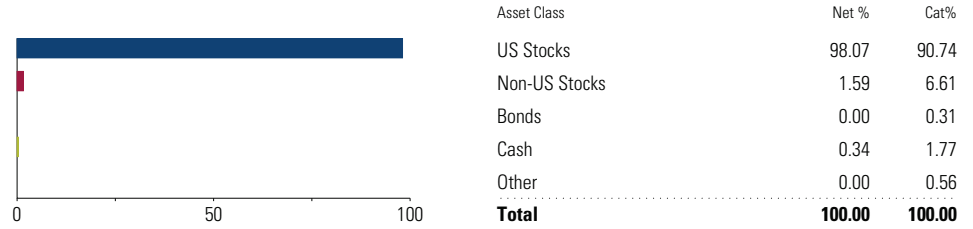

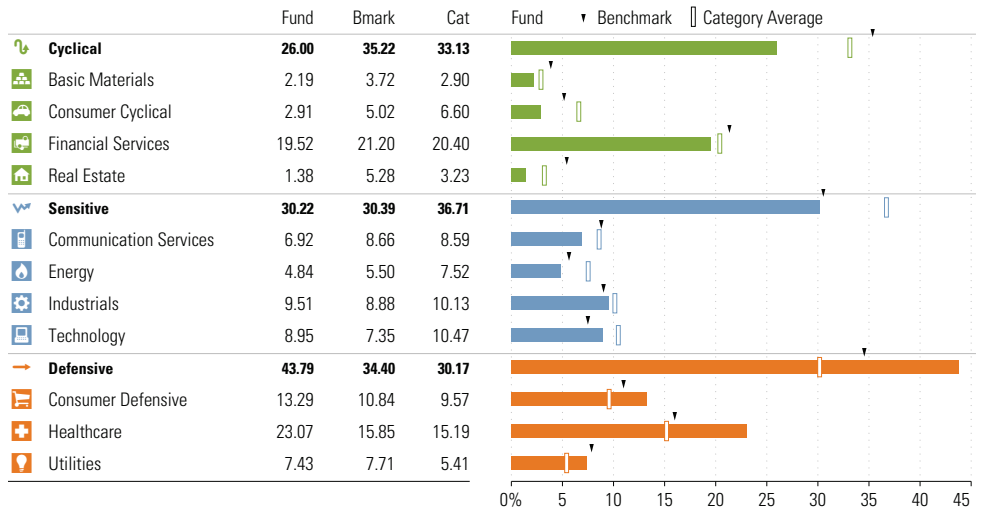
Style Breakdown
