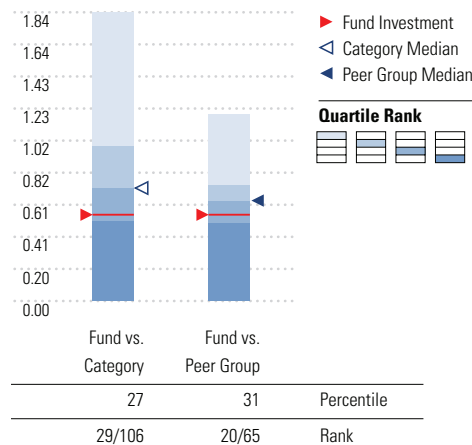

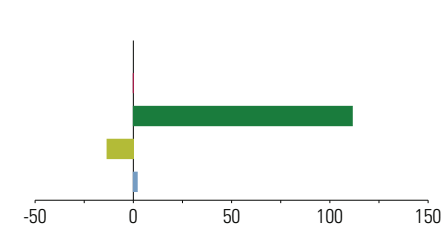

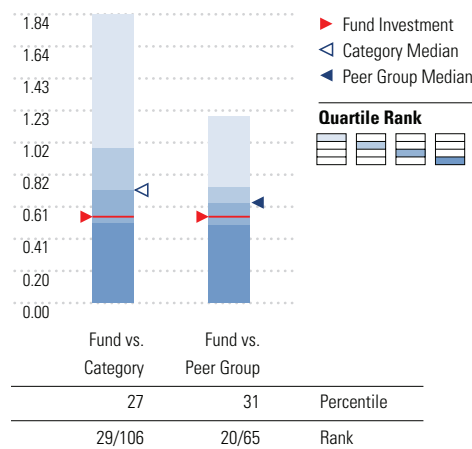

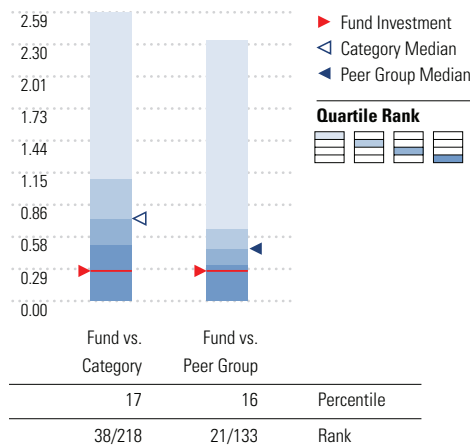

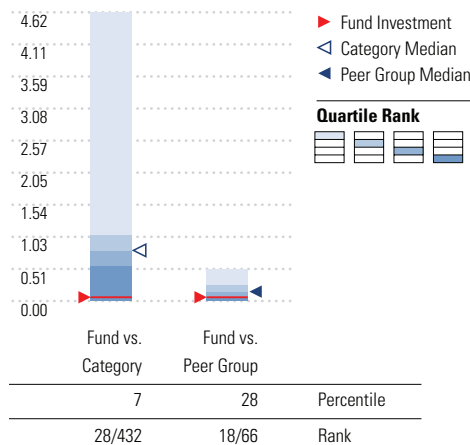

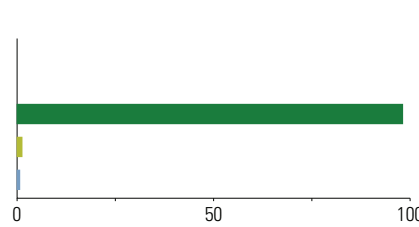

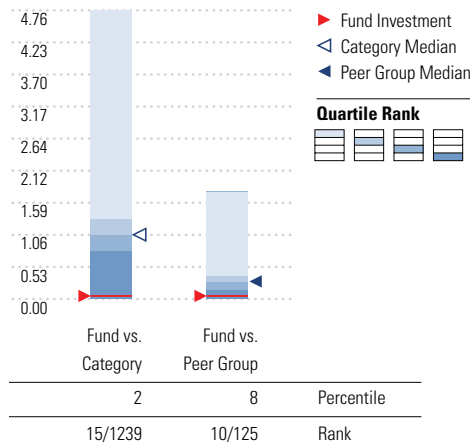

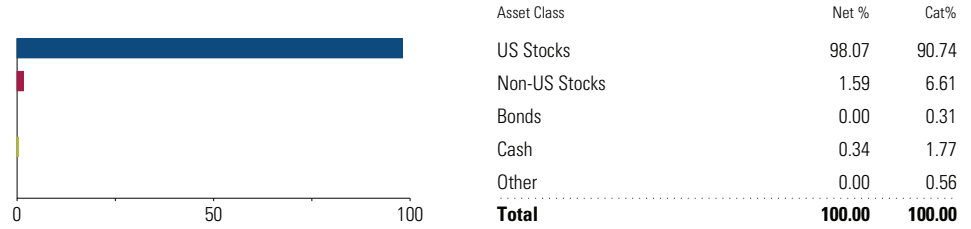

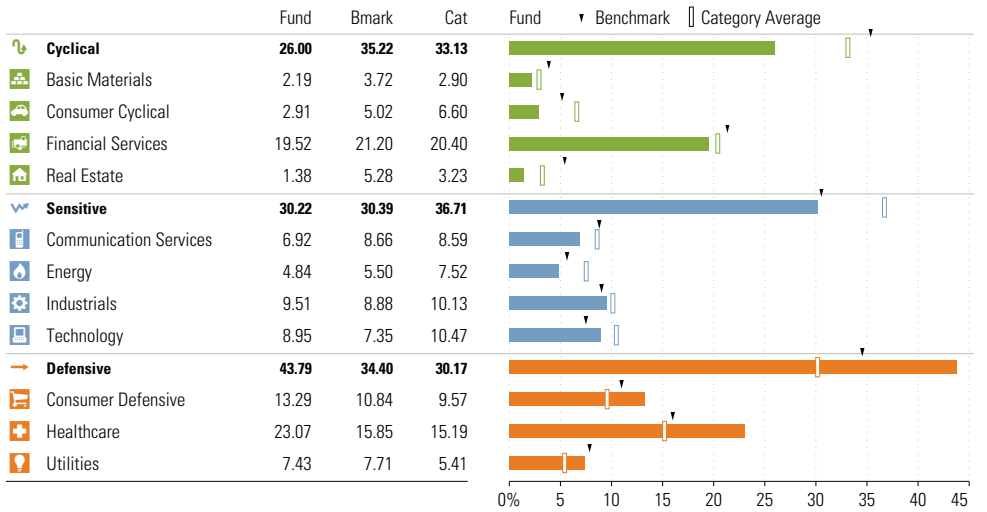
Style Breakdown

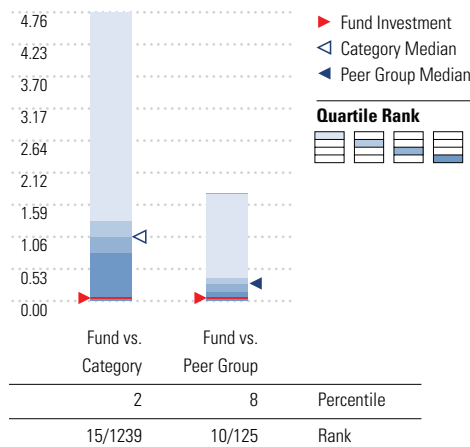

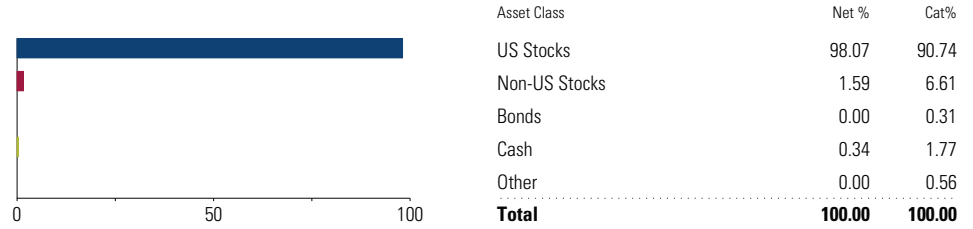

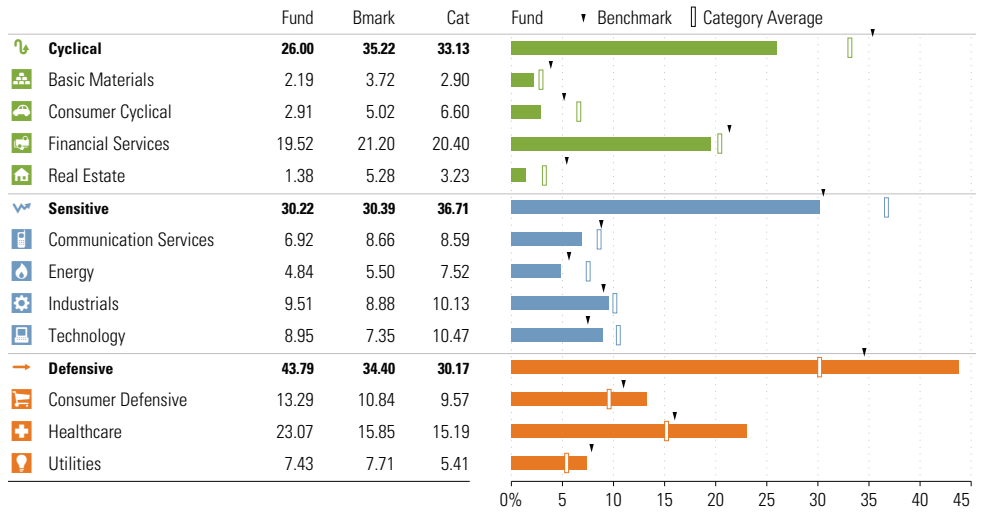
