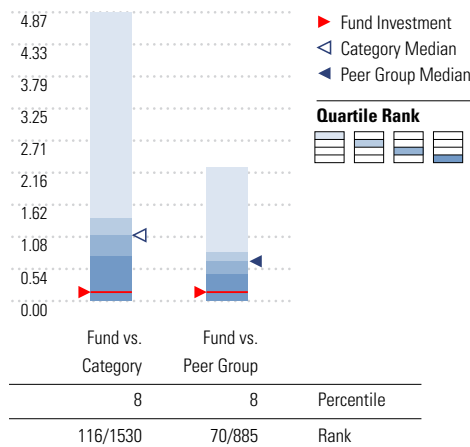

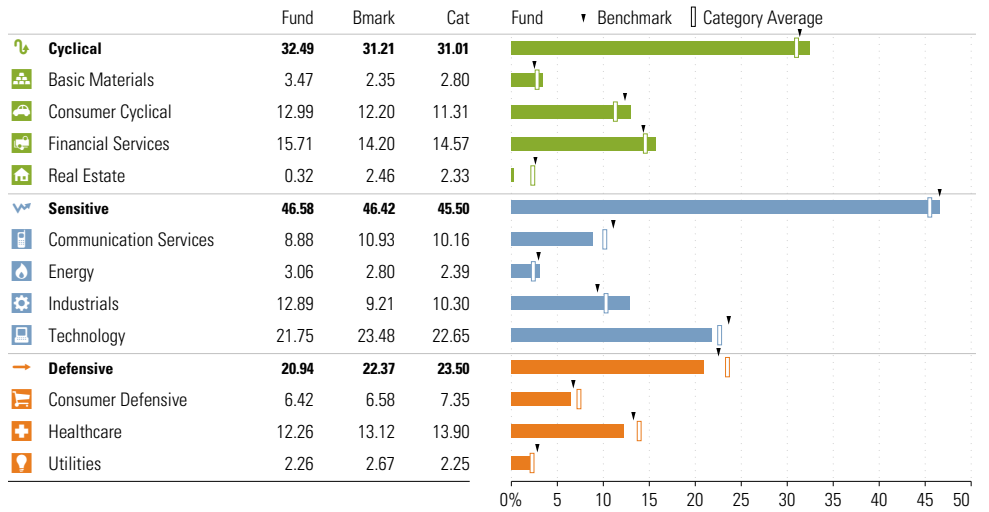

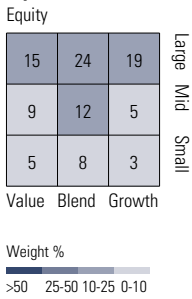
Asset Allocation as of 03-31-2021

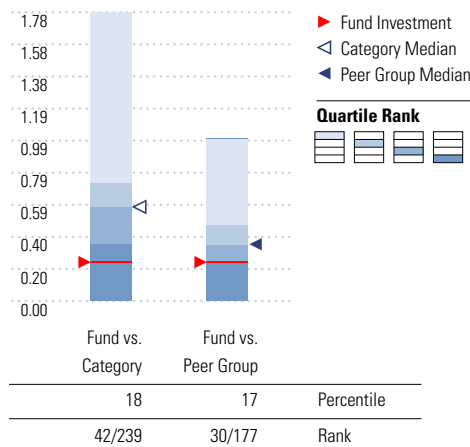

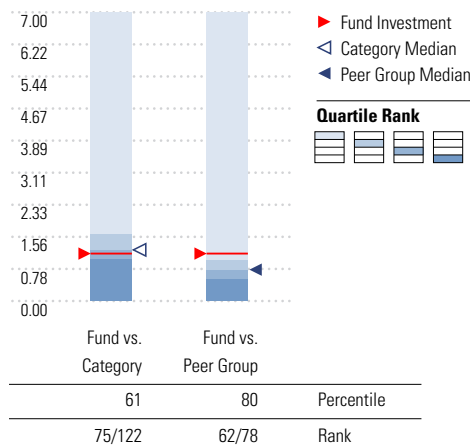

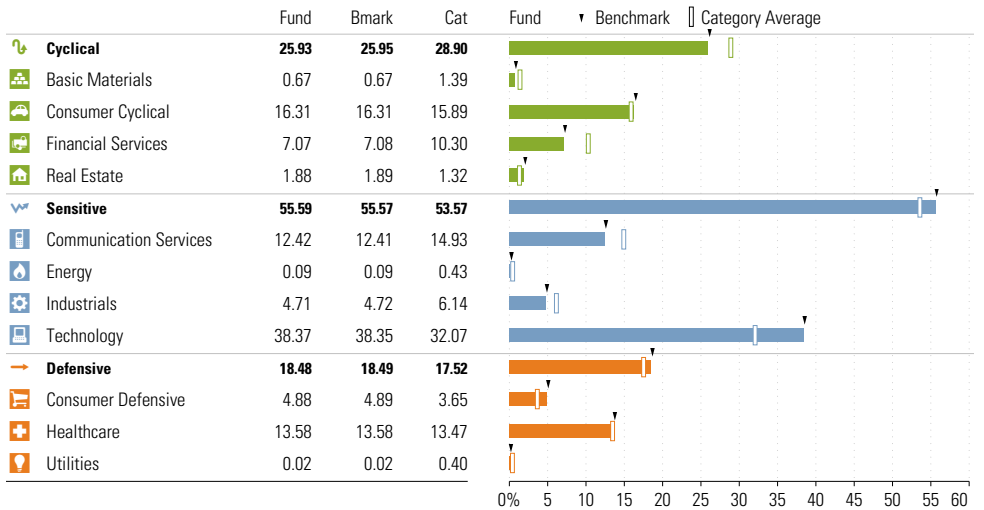

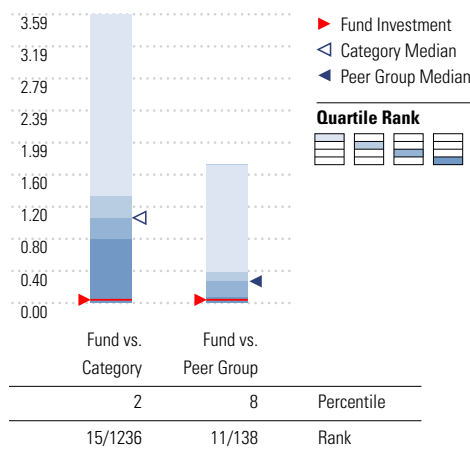

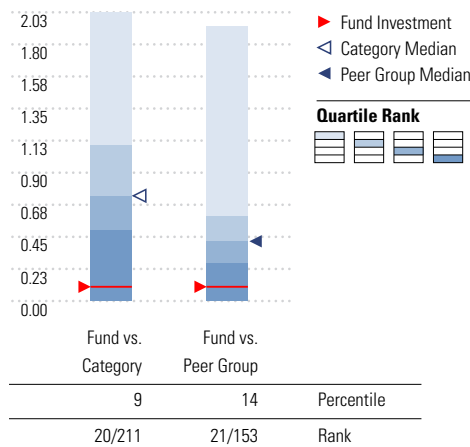

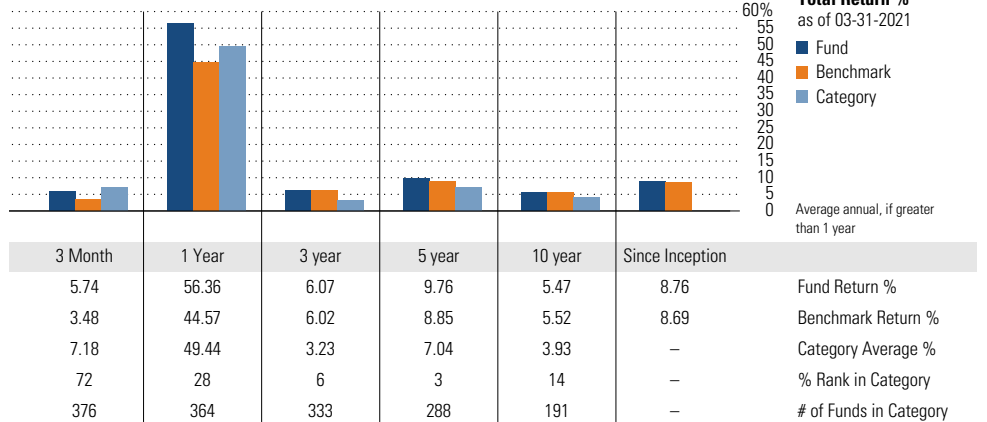

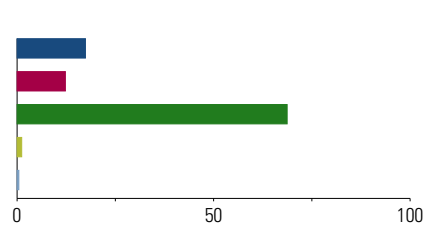

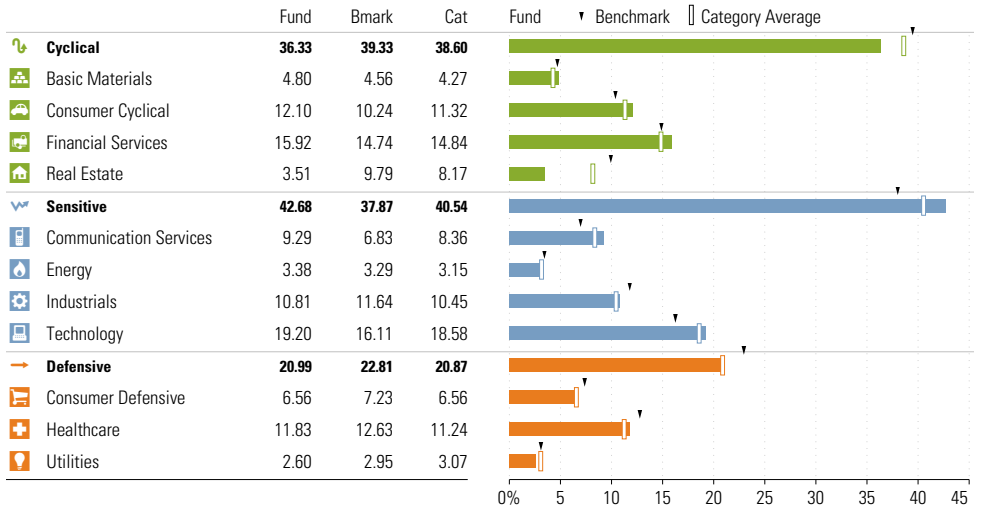

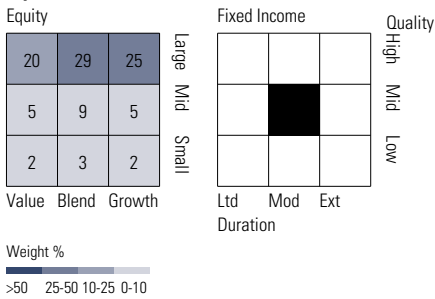

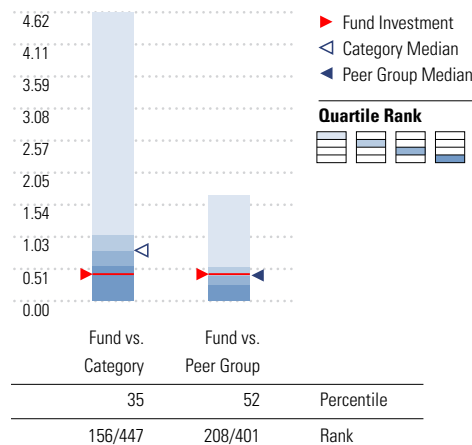
Growth of \$10,000

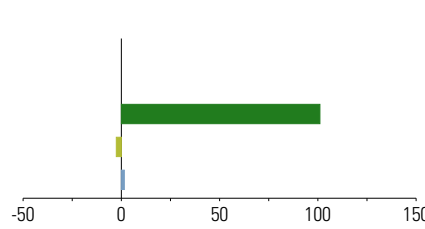

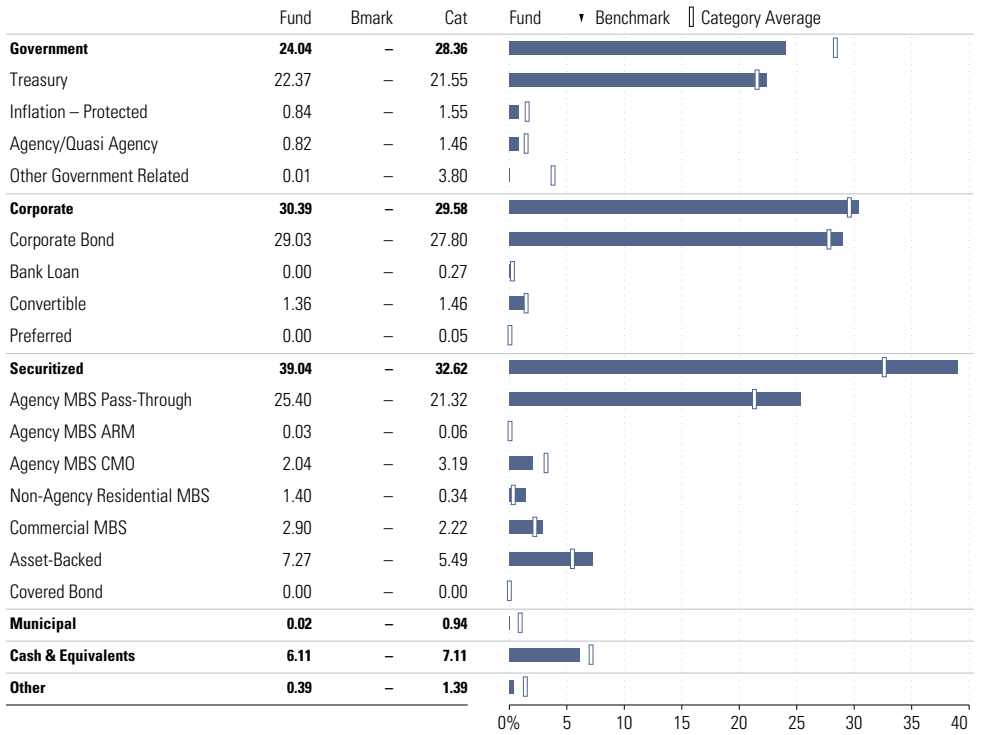
