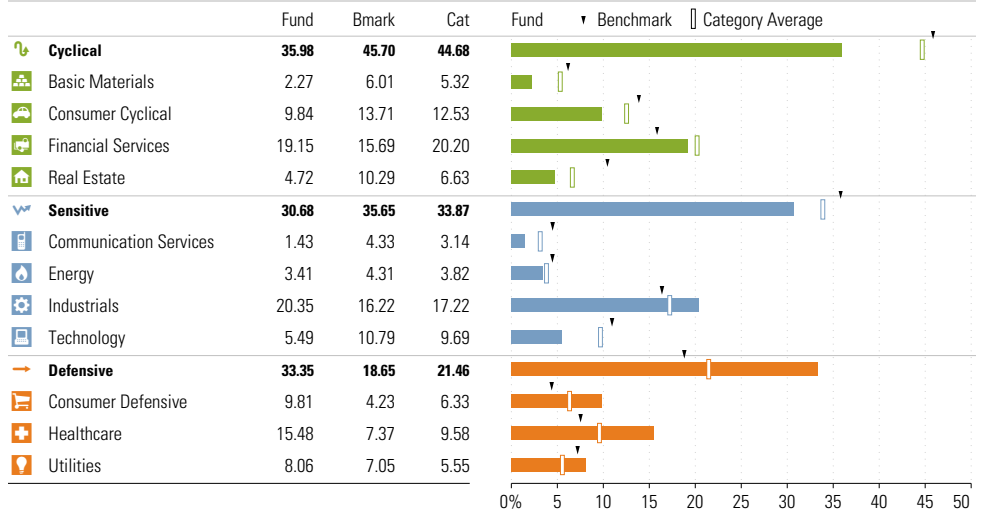

Plan costs are sometimes wrapped into fund fees, but because costs are predictive of a fund's future relative performance, we would still like to see lower overall expenses here.

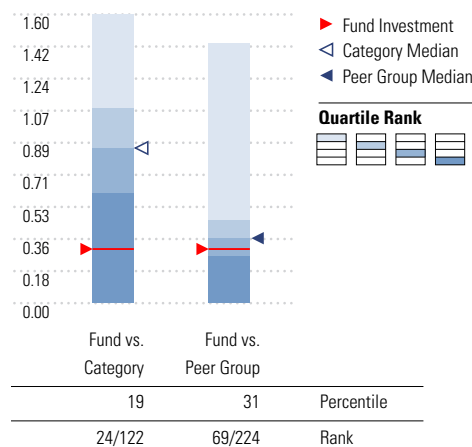
Growth of \$10,000

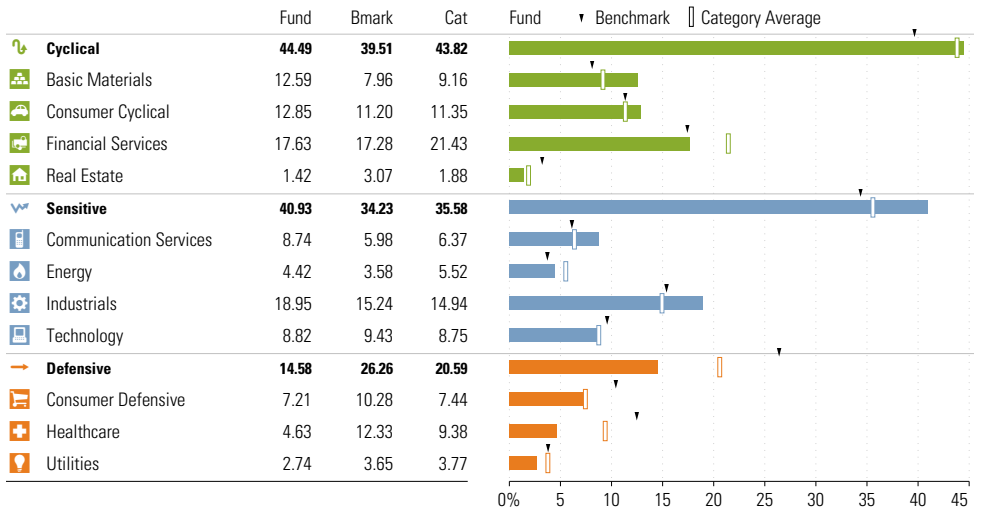


Asset Allocation as of 03-31-2021

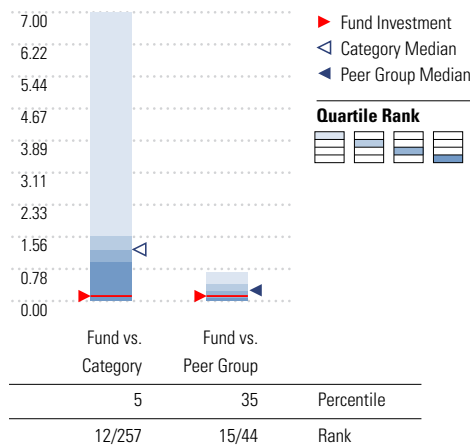
Growth of \$10,000

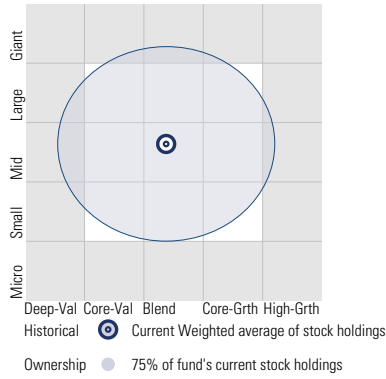

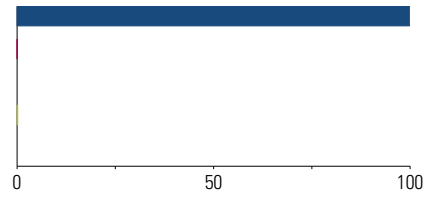

Asset Allocation as of 03-31-2021

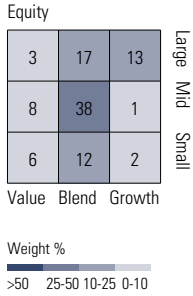
