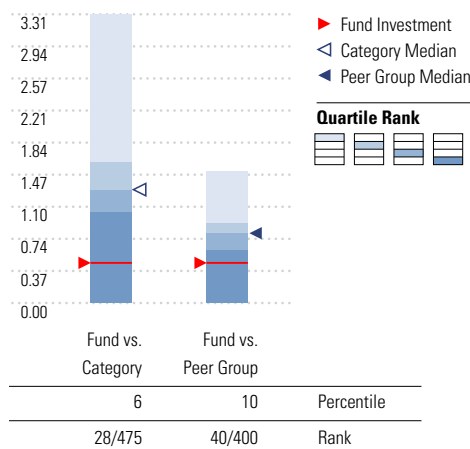

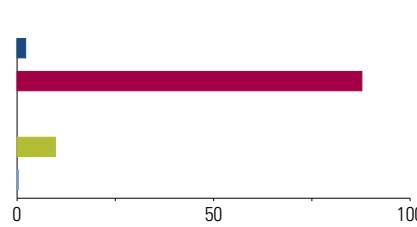

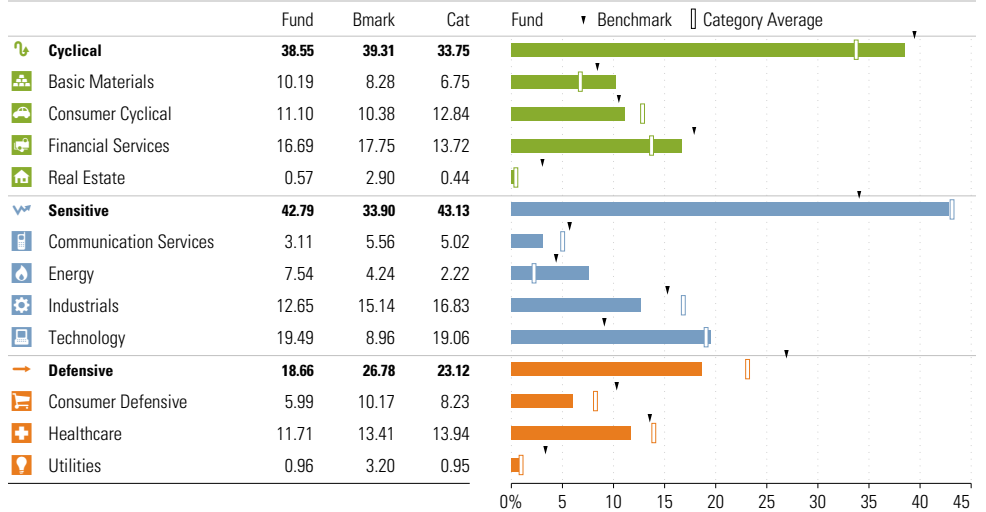

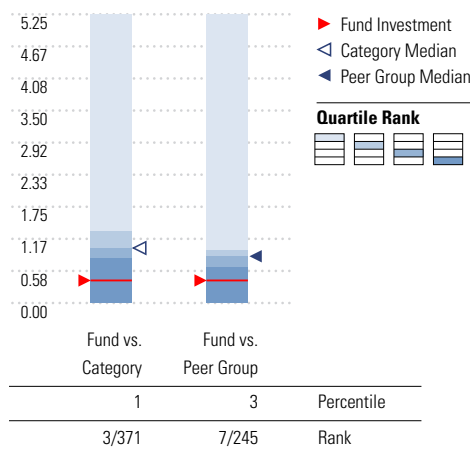

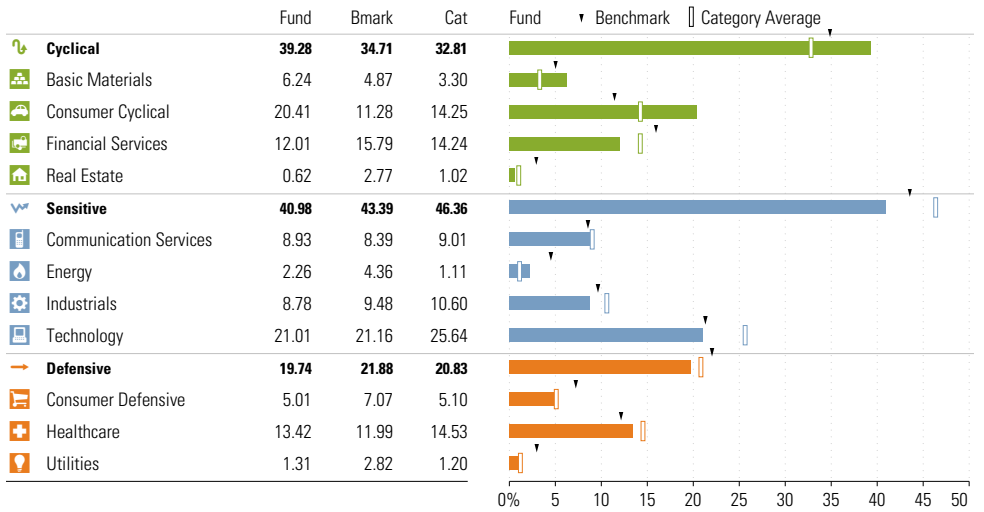

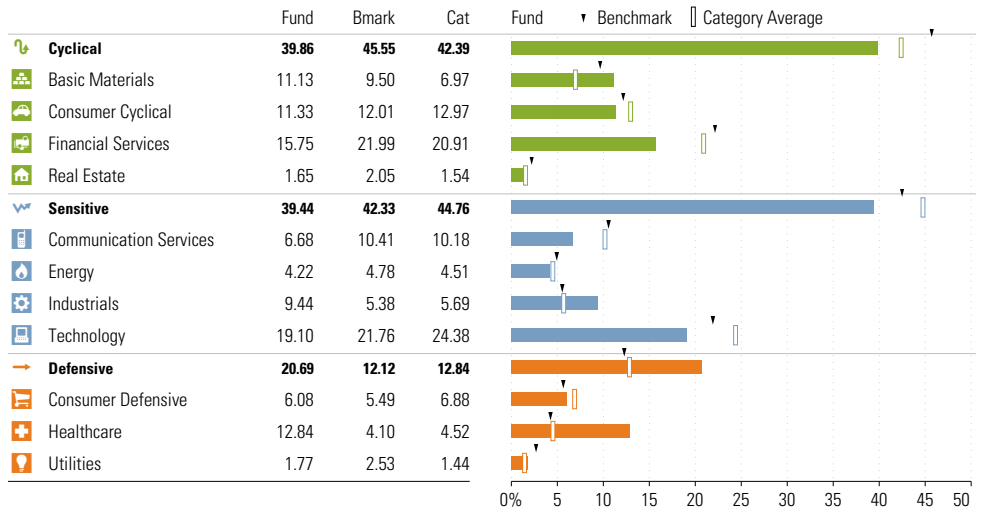

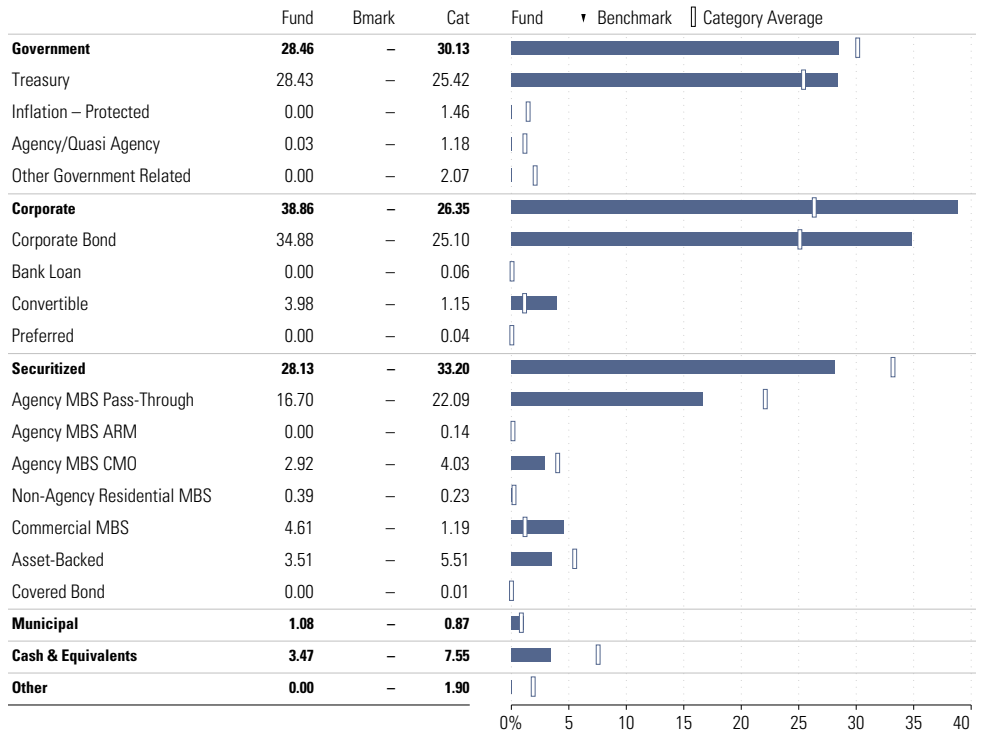

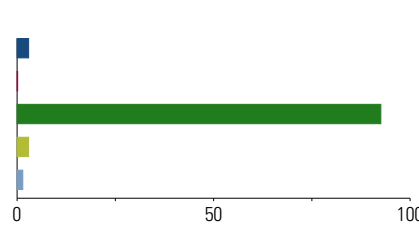

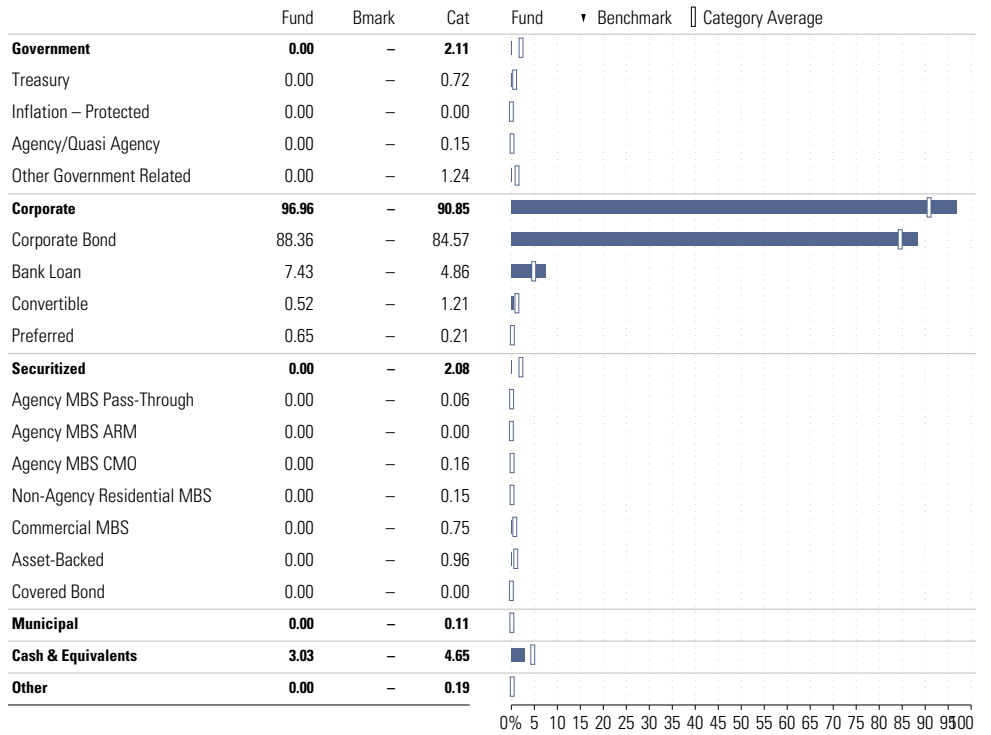

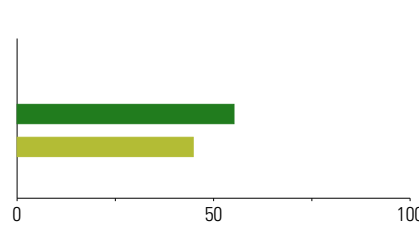

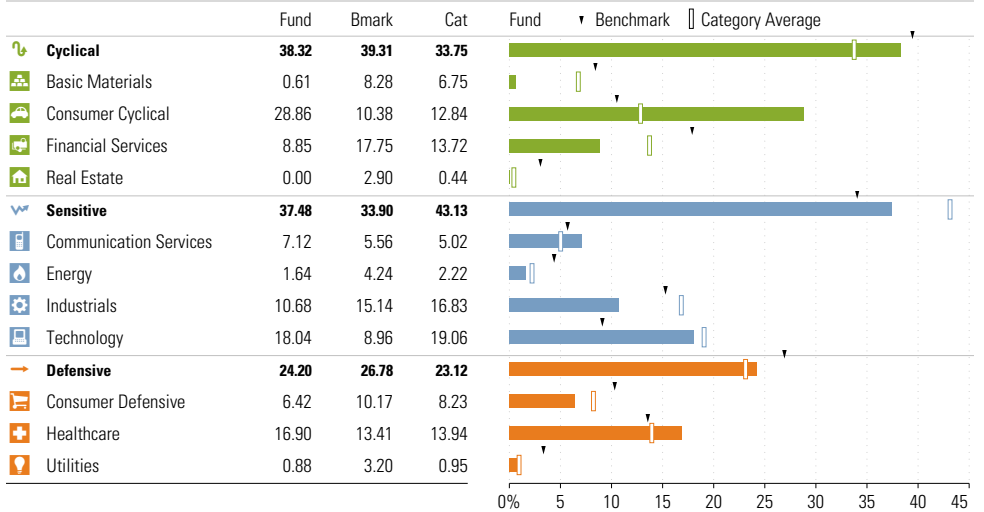

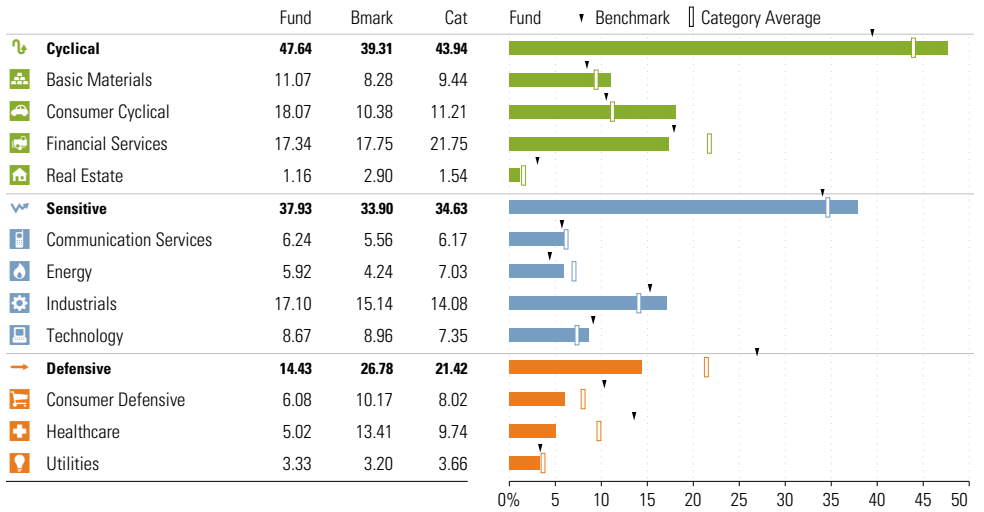

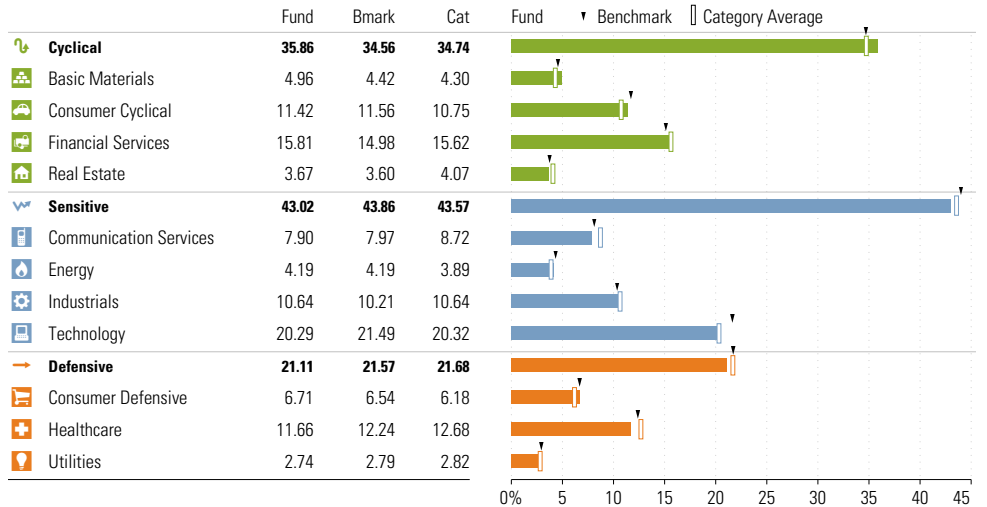

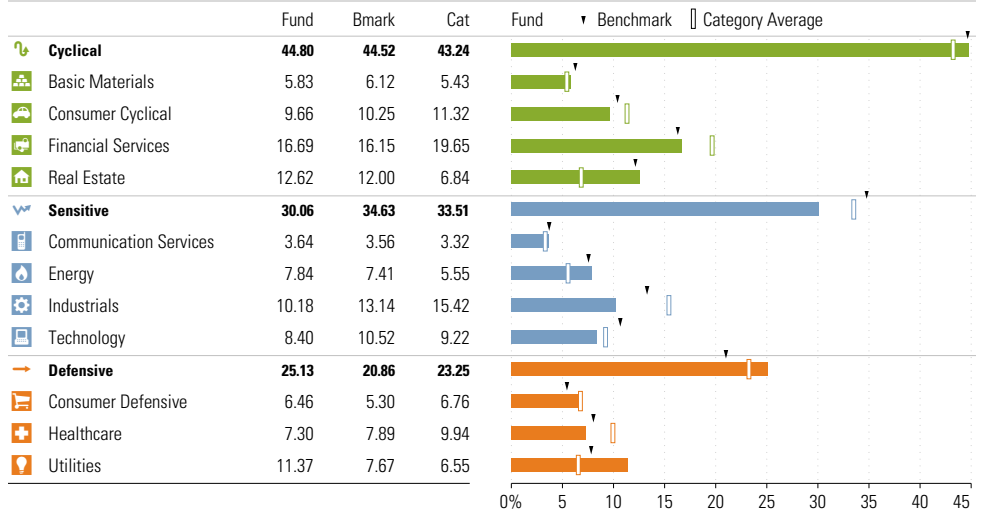

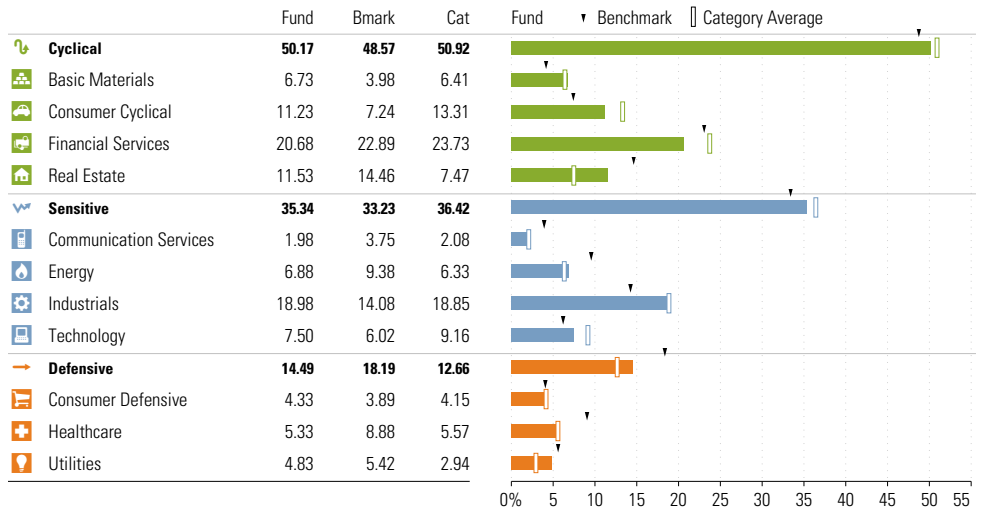
Asset Allocation as of 03-31-2022

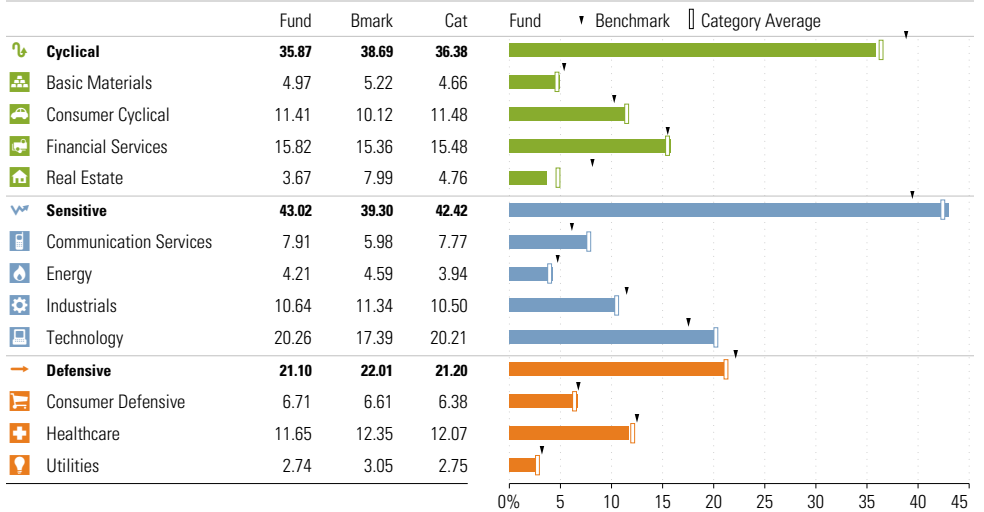

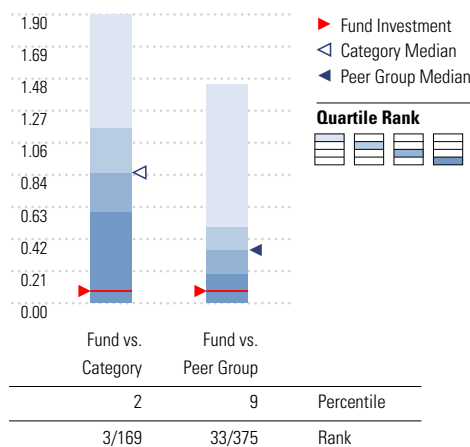

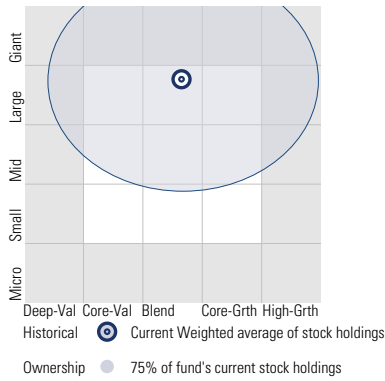

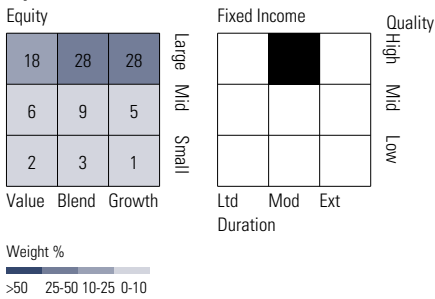

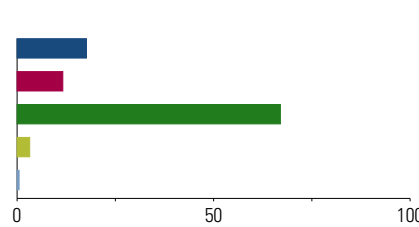

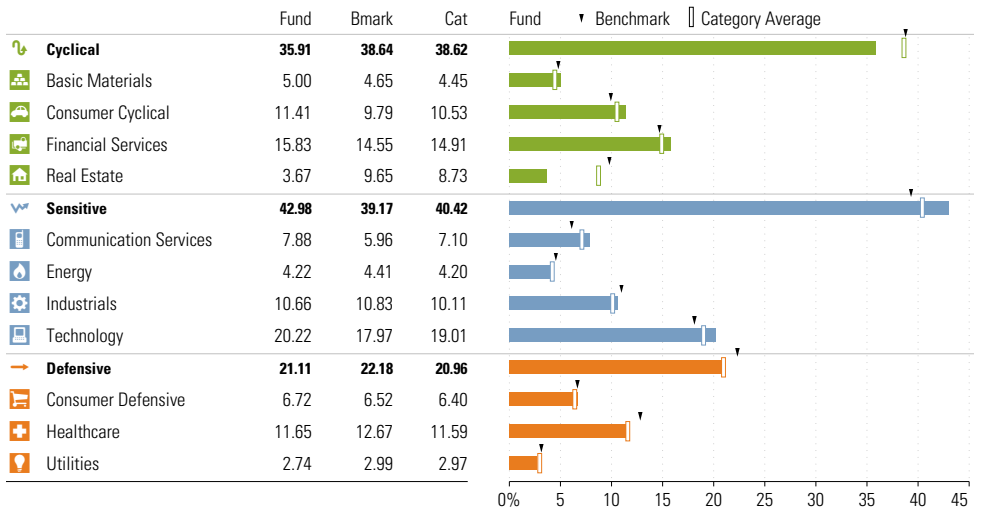


Asset Allocation as of 03-31-2022
