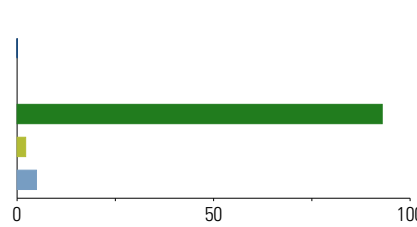

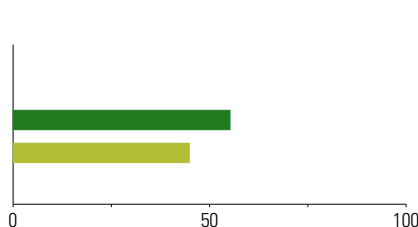

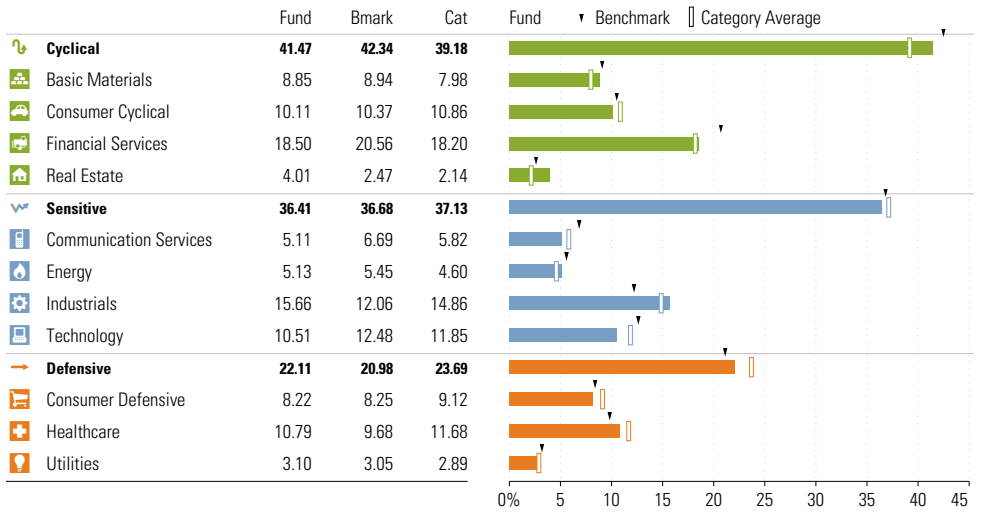

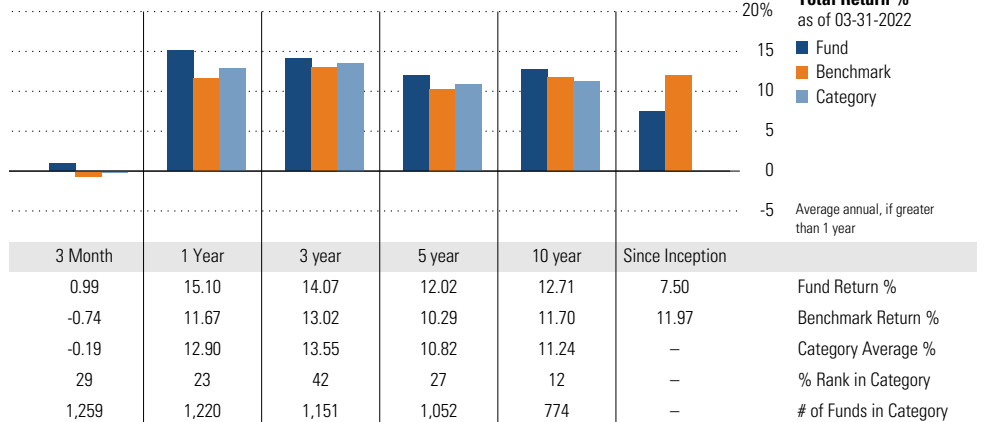

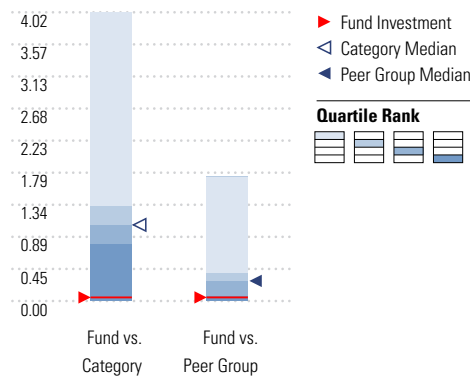

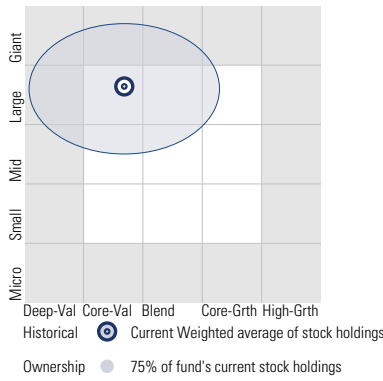

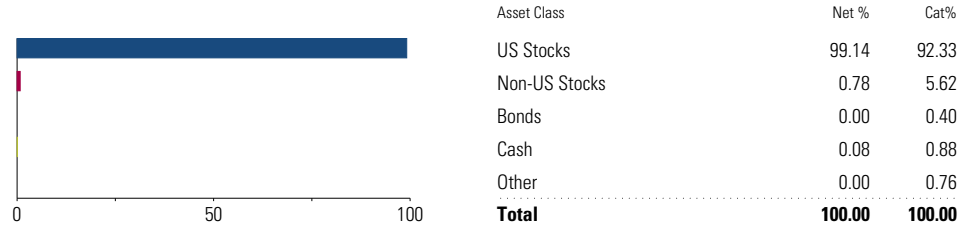

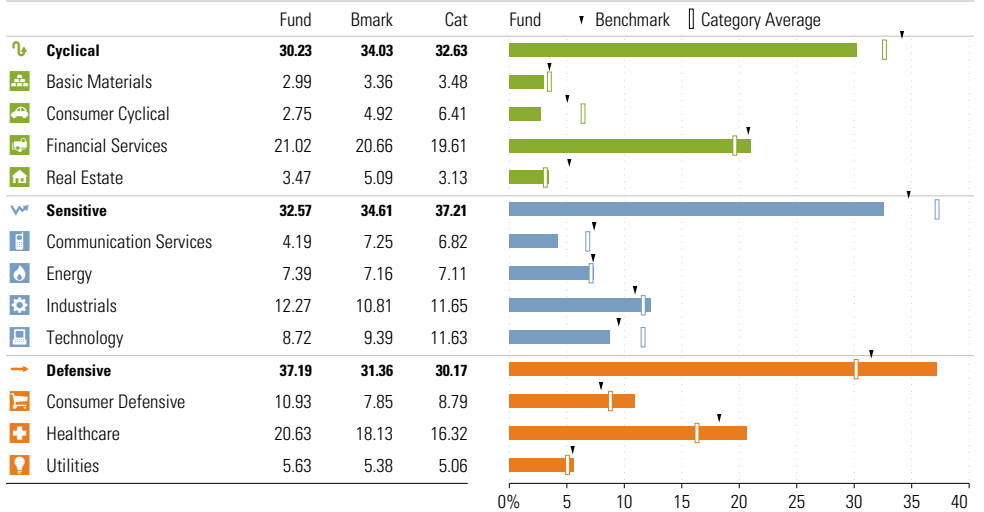
Style Breakdown
