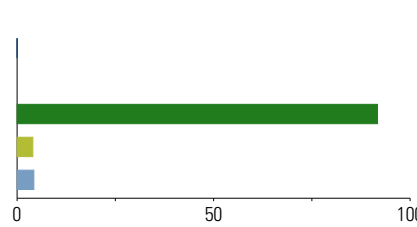

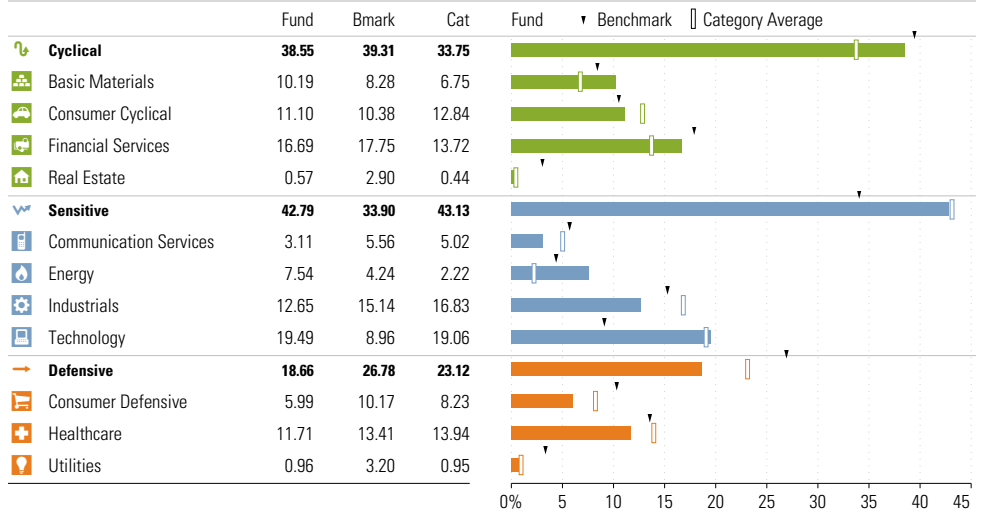

We are placing Loomis Sayles Strategic Income on watch. Although we believe the fund has merits in some uses, it takes on more risk than we would like for a multisector bond fund. The fund can take on up to 40% of assets in high-yield corporate debt and up to 20% in equities. With this enormous flexibility comes similar volatility, and although over the long term the fund has achieved solid returns in exchange for that volatility, we are skeptical of that tradeoff, given the fund's multisector bond Morningstar Category.

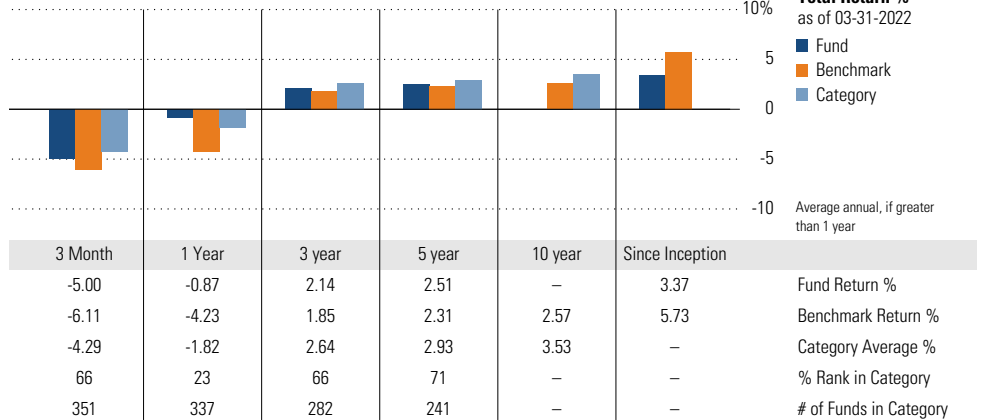

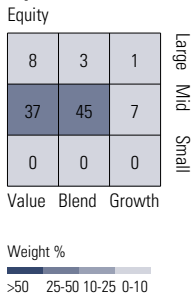
Asset Allocation as of 03-31-2022

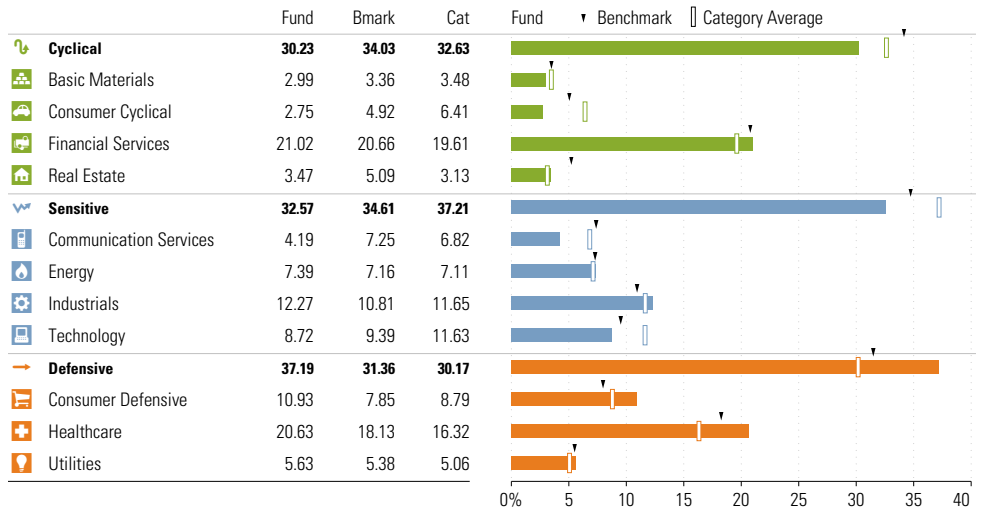
